Readers, utilizing this listing for purposes of correspondence, are advised to include a notation such as "Staff Training Program" on the addressed envelope. This should facilitate delivery of the correspondence to the appropriate person in the agency in the event of personnel changes.

The Correctional Training Resource Center acknowledges that the enclosed listing is not complete. Succeeding issues will continue to update the personnel listing as well as all agencies in the correctional system, both juvenile and adult.
