

POLICY STATEMENT

JUVENILE SERIOUS HABITUAL OFFENDER/DIRECTED INTERVENTION

(SHO/DI)

COLORADO SPRINGS POLICE DEPARTMENT

COLORADO SPRINGS, COLORADO

The juvenile Serious Habitual Offender/Directed Intervention (SHO/DI) program is a systemic information-based process for dealing with the small population of chronic and recidivist juvenile offenders committing serious crimes in our community. Studies have shown that a small number of chronic juvenile offenders commit a disproportionate amount of juvenile crime and these same offenders are likely to continue their criminal careers as adults.

The SHO/DI program is based on the principle that the application of a more systematic approach to information gathering, analysis, planning, and integration of police and juvenile justice activities will increase the effectiveness of the police, prosecutor and juvenile authorities to deal with and reduce serious juvenile crime. Through specialized attention by the juvenile justice system to the exceptional juvenile offender, we seek to better fulfill our obligation to protect the public while insuring the necessary care, guidance, and discipline to assist the child in becoming a responsible and productive member of society.

## BACKGROUND TO THE SHO/DI PROGRAM

In September 1983, the Colorado Springs Police Department was awarded a federal grant from the Office of Juvenile Justice and Delinquency Prevention to develop a program that would effectively deal with serious juvenile offenders and their criminal activity. This program was entitled the juvenile Serious Habitual Offender/Drug Involved Program (SHO/DI). Since 1983, SHO/DI has developed into an operational crime analysis based support program involving the juvenile justice system.

Colorado Springs, Colorado is one of 5 sites selected for the SHO/DI program. Jacksonville, Florida; Portsmouth, Virginia; Oxnard, California; and San Jose, California are the other sites. All sites were original ICAP (Integrated Criminal Apprehension Program) sites. Each of the sites have developed unique programs contingent on their approach in executing ICAP, specific juvenile laws, and cooperation of the various agencies participating in SHO/DI. In Colorado Springs, we have developed the SHO/DI program as a tactical and active system of assisting law enforcement and justice system personnel. Since SHO/DI is based on the fact that a very small percentage of juvenile offenders commit a disproportionate amount of crime, SHO/DI has sought to identify that population of the most serious, repeat offenders who are constantly involved with the police and the components of the juvenile justice system. In our community, we are seeking to impact juvenile criminal activity, help the justice system set priorities for use of existing resources towards those specific juveniles, and track them

through the system. This closer working relationship with the police, prosecutor, courts, probation, and aftercare agencies will enhance the process into a more systematic approach and provide the most effective treatment program for that juvenile offender. and better protect the community.

#### SHO/DI PHASE II

PHASE II, the operations phase of the developing SHO/DI program, began March 1, 1985. During Phase II, the Crime Analysis Unit provided more complete tactical information (and began profiling SHO/DIs) for proactive patrol response and as a tool for police investigations of juvenile crime. Rosters of active SHO/DIs, identified through a point system weighing seriousness and frequency of criminal charges, were provided each month to certain key police operational units and Justice System personnel. This provided a "system alert" when the exceptional juvenile offender comes in contact with the police in field interview situations, criminal investigations, and in charging for crimes. SHO/DI information is used not only by the police but is being provided to the District Attorney, the Probation Department, and the Department of Institutions to aid decisions involving case filing, prosecution, dispositions, placement and even treatment.

The Presiding Judge of the Juvenile Court issued a court order endorsing the SHO/DI program approach in Colorado Springs to system-wide coordination and information sharing.

Memos of Understanding were signed between the Police Department and the District Attorneys Office, Juvenile Probation Department, Division of Youth Services, Department of Institutions. The Memos of Understanding outline inter-agency agreements as to SHO/DI program policy and operating procedures.

We continue to collect SHO/DI performance measures to help in program evaluation. With the aid of this information, we saw a need arise for the SHO/DI information packets and, as a result, there was an increase in more appropriate action taken for the SHO/DI.

One of the Phase II goals was to seek the involvement of the Department of Social Services (DSS) and the school districts in the SHO/DI program. Both DSS and the schools play a significant role in dealing with exceptional juvenile offenders and their crimes. We are presently exploring areas of mutual information exchange that would enhance juvenile system decision-making.

### SHO/DI PHASE III

PHASE III began on September 1, 1986. This phase continued the operations phase of SHO/DI. It also produced a cadre of personnel who are assisting the new cities with on-site technical assistance. In addition to providing continuing support to our local program, we began to prepare to share our skills and experience with new sites. We received numerous requests for presentations from users throughout the system who had been impressed by SHO/DI and wanted to spread the word.

The drug/alcohol abuse requirement was dropped from the criteria, and the national program was renamed Serious Habitual Offender Comprehensive Action Program (SHOCAP). Since our program in Colorado Springs was just beginning to win recognition under the name SHO/DI we felt that a name change might be detrimental. We chose to retain the SHO/DI label locally, changing "Drug Involved" to "Directed Intervention."

The SHO/DI crime analyst continues to provide a variety of juvenile-based crime information products and services to participants throughout the criminal justice system. It is very gratifying to see the respect which our SHO/DI program enjoys not only in the community, but in the state. Adams and Raymond were invited by F. Jerald Adamek, Director, Southern Region. Division of Youth Services, to give a staff presentation on the project Thursday, May 7, 1987. The presentation was well received. We heard praise for the SHO/DI profiles, and actual descriptions of their usefulness to specialists working with children in placement

facilities around the state. One psychologist described the material as "invaluable", and, for all practical purposes, impossible to obtain elsewhere. Raymond and Adams were also invited by Colorado Association of Probation Officers to give a similar presentation at a two day workshop in Breckenridge in September. The presentation gave us many new contacts throughout the state.

The local Juvenile and Adult Probation offices have combined under one director in one location. An immediate result has been an improvement in transfer of information when a problem juvenile becomes an adult at 18. We are also experiencing an increase in interest at the District Attorney's office as more and more serious juvenile offenders are transferred to adult court.

The final touches were put on the new SHO/DI computer file during this quarter. Two dBase files and one Wordstar file which had previously existed in the unit's PC were consolidated into a single all-purpose file on the department main frame computer. Not only does the file simplify data entry and vastly increase the amount of information we can store, but it also allows any number of possible searches on name, physical description, type of criminal activity (arrest, case, field interview), modus operandi, and associates, to name just a few. Printouts are immediately accessible. Much of the SHO/DI profile can be automatically produced by the file.

Printouts from SHO/DI computer files have replaced internally maintained case logs and stats for the Juvenile sergeant. Our unit

provides him with a variety of useful sorts of arrest data including Alpha and Crime Type, which are seen as real time savers. The Juvenile Unit will eventually have direct computer access to the SHO/DI file. Since the entire Detective Bureau has moved to another building some distance from headquarters, this link could not be more timely. Records and identification also have access to this file. We anticipate eventual direct access by officers through a computer network in the future as we go to a more decentralized system.

The project director continues to look for opportunities to build a link with local schools that will lead to information sharing. The new District 11 superintendent has made high-risk children a priority in local schools. We hope to take advantage of this interest. August 7 through 10, 1987, Emily Adams and two patrol officers took part in a STATE (School Team Approach Training Effort) conference in Breckenridge, Colorado. This project, developed by the Colorado Office of Federal Relations and Instructional Services, was developed under the auspices of the U.S. Department of Education. The purpose of STATE is to promote a community based approach to drug and alcohol abuse prevention in the schools. During the training, it became clear that the experts in the field know that violence, crime, and other high-risk behavior have their roots in the same kinds of problems that lead juveniles to substance abuse. This effort, therefore, shares a philosophy with SHOCAP. Dru Raymond and Emily Adams were asked to present a workshop on SHOCAP at a conference for local STATE participants which was hosted by School District 11 on September 17, 1987, in Colorado Springs. We concentrated on a history of

SHOCAP, the benefits in identifying this very special group of high-risk juveniles early, and the legal prohibitions which prevent us from working with the schools. There is a strong desire in the schools to find ways to work with us. We hope to look into legislative changes in the near future. The SHOCAP analyst took part in a panel discussion on High Risk Students at Doherty High School on August 20, 1987.

## SHO/DI COURT ORDER

The Colorado Springs Police Department is engaged in a program dealing with serious juvenile offenders. The juvenile Serious Habitual Offender/Drug Involved (SHO/DI) Program emphasises system-wide coordination and information sharing to aid in early identification and intervention of the serious chronic juvenile offender.


The Court recognizes a need for the Colorado Springs Police Department to provide certain pertinent information on exceptional juvenile offenders to criminal justice agencies. Such information sharing should enhance decision-making which will best serve community safety as well as the most appropriate placement, disposition and treatment of the child.

The Colorado Springs Police Department, using criteria acceptable to the D.A.'s Office, Juvenile Probation Department and the Division of Youth Services has identified a small population of active, serious and chronic juvenile offenders.

The SHO/DIs are identified by name and date of birth on a roster, and profiles are being developed on each SHO/DI. The SHO/DI profile contains information relevant to the child's offending behavior including criminal and traffic arrest history, case summaries, descriptive data, Modus Operandi, police contact information, link analyses depicting criminal associations, drug/alcohol involvement indicators, and pertinent social and school history information.

The Colorado Springs Police Department may provide SHO/DI rosters and profiles of the exceptional offenders to criminal justice agencies. The SHO/DI rosters and profiles are intended to help identify and provide relevant background information on the exceptional offenders to aid those agencies in decision-making that will best serve the welfare of the child and the interests of society.

The CSPD SHO/DI Project Director will exercise due diligence in maintaining and disseminating SHO/DI rosters and profiles in accordance with this court order and applicable state law to insure the security and confidentiality of juvenile criminal justice record information.

## MEMO OF UNDERSTANDING

The Colorado Springs Police Department and the Office of the District Attorney recognize that a small number of chronic juvenile offenders commit a disproportionate amount of serious crimes, and that, in the absence of effective intervention, these juveniles are likely to continue their criminal careers as adults.

The juvenile Serious Habitual Offender/Drug Involved (SHO/DI) program emphasizes juvenile justice system coordination and information sharing to aid in early identification of the serious chronic juvenile offender and intervention of his criminal behavior.

The Colorado Springs Police Department and the Office of the District Attorney will cooperate in the SHO/DI program as follows.

#### Colorado Springs Police Department

The Colorado Springs Police Department (CSPD) is the host agency for the SHO/DI program sponsored by the Office of Juvenile Justice and Delinquency Prevention. The CSPD is responsible for overall program development and operations. CSPD SHO/DI program responsibilities include:

1. insuring information management and coordination of police resources for the SHO/DI program;
2. identifying SHO/DIs using established criteria agreed upon by the DA's office, Juvenile Probation Department, and the Department of Institutions;
3. maintaining active and candidate rosters of SHO/DIs;
4. developing SHO/DI profiles;
5. providing SHO/DI rosters and profiles to authorized juvenile system agencies;
6. enhancing and filing SHO/DI cases with the DA's office;

7. providing tactical and background information support to juvenile system agencies to insure responsible and informed decision-making in SHO/DI cases; and
8. tracking the status of SHO/DI cases in the juvenile justice system.

## OFFICE OF THE DISTRICT ATTORNEY, JUVENILE SECTION

The Office of the District Attorney, Juvenile Section, will provide mutually agreed upon performance measures to the CSPD for program evaluation. SHO/DI case status and dispositional information will also be provided to the CSPD to aid in case tracking. The Office of the District Attorney will utilize the following guidelines for SHO/DI cases.

1. Upon filing, every effort will be made to expedite the case through the judicial system.
2. If the juvenile is detained, every effort will be made to keep him in custody pending trial. If that is unsuccessful, the alternative will be to seek a high bond.
3. For every new case, either a new petition may be filed, or a motion to revoke probation may be pursued, whichever it appears will be more effective. As a general rule, if a youth is on probation and a new fileable case is brought to the District Attorney, that case will be utilized in an attempt to revoke probation. Subsequent new offenses may be filed as new petitions.
4. The Juvenile Section will work closely with the Juvenile Probation Department so that some sanction is imposed for violation of the juvenile's rules of probation. Consideration will be given, where appropriate, to the filing of motions to revoke probation or modify terms of probation.
5. At the dispositional hearing, the District Attorney will be prepared to present any information in aggravation which is known (e.g., SHO/DI profile information).
6. Plea bargaining will continue to be utilized, but the District Attorney will attempt to obtain as favorable a result as appears possible, given the nature of the evidence. When a certain number of counts are dismissed pursuant to the plea negotiations, the District Attorney, as a part of the bargain, will obtain a stipulation if it is supported by the evidence for the record that probable cause existed in the dismissed counts, and that the only reason they are being dismissed is pursuant to the plea negotiations. Restitution will be required on all counts, and a statement put on the record that since probable

cause did exist in the dismissed counts, the prosecution retains the option of utilizing that information in subsequent proceedings, if any, to show the degree of danger to the community posed by the juvenile.

7. Where appropriate and where the evidence supports such a decision, the prosecution will direct file on the juvenile in adult court or shall file a transfer motion and attempt to transfer the child to adult status.
8. At the minimum, an adjudication will be sought for each new petition filed.
9. No plea bargain shall be agreed upon until after the Deputy District Attorney has conferred with at least one of the officers involved in the actual case, and with the detectives in the Juvenile Bureau at the Colorado Springs Police Department, or the police agency in whose jurisdiction the juvenile resides.

9. assisting participating juvenile agencies with SHO/DI performance measure reporting.

## JUVENILE PROBATION

The Juvenile Probation Department works as an agent of the court in performing predispositional reports on juveniles adjudicated by the court. Additionally, the Juvenile Probation Department supervises juveniles who are under the courts authority on probation. SHO/DI profiles are used by Juvenile Probation to help in their responsibilities to the court, the child, and the community.

The Police Department assists Juvenile Probation in expanding their probation supervision of SHO/DI's by sharing field interview contact and charging information with probation officers upon request. The field contact information assists the probation officer in determining if the court-ordered probation rules are being violated.

The Juvenile Probation Department is involved in the following SHO/DI areas:

1. conducts court-ordered SHO/DI predispositional reports;
2. supervise SHO/DIs on probation;
3. provide the Crime Analysis Unit with formal rules of probation for SHO/DIs. These court-ordered terms of probation will be available upon request by officers of the Police Department to assist the Juvenile Probation Department in monitoring compliance;
4. seek sanctions in those cases where SHO/DIs have violated the terms of probation;
5. make regular contact with the Crime Analysis Unit to obtain field interview contact information or any other information which will assist in supervision of SHO/DIs on probation;
6. regularly advise the Crime Analysis Unit of the status on all SHO/DIs under the authority of the Juvenile Probation Department;
7. refer names of possible SHO/DIs (e.g., Inter-state Compact case involving new resident on probation) to the Crime Analysis Unit for qualifying; and,
8. provide the Crime Analysis Unit with SHO/DI profile information, to include status offenses, family criminal history, and other relevant information.

## DIVISION OF YOUTH SERVICES

The state Department of Institutions operates the juvenile detention and correctional facilities as well as juvenile parole services through its Division of Youth Services.

The role of juvenile corrections to securely hold and treat the SHO/DI is as important as the enforcement, prosecution, and judicial roles. Good coordination and communication between juvenile corrections and the rest of the juvenile justice system is necessary if we are to be effective systemically.

Information sharing and coordination between juvenile corrections and the rest of the juvenile justice system aids corrections in making informed decisions about detention, custody, and treatment needs that best benefit society and the child.

The Division of Youth Services will:

1. give SHO/DI's primary consideration for recommendations for secure custody and long-term treatment.
2. maintain active SHO/DI rosters at the Zebulon Pike Detention Center to insure appropriate "system alert";
3. Zebulon Pike will regularly provide the Crime Analysis Unit with SHO/DI population placements and movements in Division of Youth Services facilities statewide, to include detention, commitments, and parole; and
4. request as needed SHO/DI profiles from the Crime Analysis Unit. The Division of Youth Services will utilize the SHO/DI profiles to aid intake decisions concerning detention, reception diagnosis, placement, treatment, and aftercare.

## DEFINITION OF SHO/DI IN COLORADO SPRINGS

SHO/DI (juvenile Serious Habitual Offender/Directed Intervention program) is an information and case management program on the part of police, probation, prosecutor, and corrections authorities that enables the juvenile justice system to give additional, focused attention toward juveniles who repeatedly commit serious crimes with particular attention given to providing relevant case information for more informed sentencing disposition.

SHO/DI is not a numbers game to see how many juveniles are arrested and locked up.

In Colorado Springs, Colorado, a juvenile is selected as a SHO/DI based on criteria consisting of points system (similar to an Adult Career Criminal program) and an evaluation of those more serious and/or violent activities. Points are assessed to a SHO/DI's arrest record based on frequency and seriousness of crime. At least one adjudication and one felony charge are required for inclusion in the SHO/DI program.

The criteria for selection is as follows:

- 6 points = Felony Persons Crime  
e.g., Murder, Sexual Assault, Robbery, Assault
- 5 points = Felony Property Crime  
e.g., Burglary, Larceny (over \$300), Criminal Trespass (1st Degree), etc.
- 3 points = All Misdemeanors and Petit Offenses

A juvenile must have a minimum of 21 points to qualify as a SHO/DI and may be drug/alcohol involved. The SHO/DI is identified as having the most "serious" and/or "violent" crimes of the juveniles in Colorado Springs, CO. To become a SHO/DI from a candidate, the candidate's record is researched carefully before "elevating" to SHO/DI status. If a candidate has 40 points accumulated and one adjudication, he is automatically elevated if there is room. Only 25-30 (maximum) SHO/DIs are kept on the list at all times due to system capacity throughout the CJS. There are 30-35 (maximum) Candidates on a list at any one time.

If a juvenile compiles 21 points in 1 criminal episode, he needs 30 points to qualify as a SHO/DI candidate. Also, if a juvenile commits multiple offenses against a single victim in one criminal episode, only the highest most serious charge is counted. (e.g., the charges of Burglary (5), Theft (5), and Criminal Mischief (3) in a single location/case report/summons would only be 5 points). If there is one case report that has multiple victims in one location for persons offenses (e.g., Sexual Assault, Murder, Menacing, or Harassment cases) they are counted as separate points (6 points each). Property offenses are counted separate only if they have separate case reports or are treated as separate incidents (5 points each). For example, if BMV or a Criminal Mischief is committed to numerous vehicles in one location and was recorded on one case report, then it would only be assessed as 5 points - thus one incident. The only exception to the multiple offense rule is Sexual Assault. There are 6 points for each count (e.g., one victim, but the perpetrator commits an act of incest, child abuse, and sexual assault for a total of 18 points). This

was initiated by the Lieutenant from the juvenile division and the juvenile DA in order to deal more effectively with sex offenders and aid identifying them as early as possible.

A juvenile is no longer a SHO/DI when he turns 18 years of age; SHO/DIs are inactive when there is no new police activity for 6 months, and/or he has been committed to the Department of Institutions. The same rules apply for Candidates.

A SHO/DI or Candidate may be reactivated if he is under 18 years of age, commits a new offense (Misdemeanor or Felony) or there is some indication of new activity (e.g., FIR, escape from an institution).

## SHO/DI PROGRAM OPERATION

The SHO/DI program is designed for early identification of the exceptional juvenile offender and intervention of his criminal behavior.

SHO/DIs are identified through an established point system which takes into account previous offenses, as well as the seriousness and frequency of those offenses. All SHO/DIs have had at least one finding of delinquency, and have been charged with at least one felony. No more than 30 SHO/DIs are on the SHO/DI roster at any time. A candidate list is maintained, and as SHO/DIs become inactivated, the most serious offending candidates are "elevated" to SHO/DI status as slots become available.

SHO/DIs are inactivated when the SHO/DI becomes 18 years of age, are committed to the Department of Institutions, or are inactive for six months.

The current SHO/DI roster provides the Police Department and other juvenile justice agencies with a "system alert" capability. The police, DA, probation, and detention are prompted by the roster whenever a SHO/DI enters their individual system. This allows for immediate agency attention and response to the exceptional juvenile offender.

The system alert is designed to react to SHO/DIs who are already coming in contact with the criminal justice system. The initial system contact is initiated by the exceptional offender, not by the

SHO/DI program. For example, a patrol officer makes contact with juveniles under many circumstances, including suspicious activity field interviews and apprehension for an offense. Once the contact has been made, if the officer runs a Want/Warrant check over the radio, he will be advised through a coded response that the subject is a SHO/DI. The Records and ID Section will also advise officers running name checks if the subject is a SHO/DI. The system alert occurs after the initial contact has been made, and simply alerts the contacting officer that the juvenile has had repeated contacts with the criminal justice system. This is additional information to aid the officer as he exercises discretionary judgment in the contact.

The key tools of the SHO/DI program are the rosters and profiles. The rosters identify active SHO/DIs and are provided to certain Police Department units and to juvenile justice system agencies to aid in system alert. The profiles contain information relevant to the juvenile's offending behavior, including criminal and traffic arrest history, case summaries, descriptive data, Modus Operandi, police contact information, link analyses depicting criminal associations, drug/alcohol involvement indicators, and pertinent social and school history information (when available). The SHO/DI profiles are provided to police officers, the DA's Office, Probation Department, and the Division of Youth Services (detention and commitment).

The profiles are intended to provide police and principal juvenile justice system agencies with a composite of information pertinent to the juvenile's offending behavior history and contacts with the system. Case filings, plea negotiations, detention recommendations, probation evaluations, dispositions, and placements are all critical decisions requiring immediate access to the behavioral and treatment history of the child. The profiles serve to enhance those decisions.

In addition to the rosters and profiles, there are other areas of critical information sharing. To aid in tracking SHO/DI cases, the DA's Office provides us with all dispositions and monthly reports of case filings, dispositions, and placements.

Probation makes available court minute orders which alert us to court hearings in SHO/DI cases. Probation also gives the Crime Analysis Unit terms of probation. Any information on apparent probation violations (e.g., juvenile contacted by field officer after prescribed curfew) is reported to the Probation Department. Probation uses the police field interview contacts to expand their probation surveillance. We are advised that approximately one-half of the field interview contacts on probationers result in some useful application by the Probation Department. This number has increased with the combination of the Adult and Juvenile Probation Departments.

The Division of Youth Services reports SHO/DI population placements and movements to the Crime Analysis Unit to aid in SHO/DI status updating. This information includes detention,

commitments, pre-release and parole, AWOLS/Absconds and Client Management rosters from the system. SHO/DI profiles are utilized by the Division of Youth Services to aid intake decisions concerning detention, reception diagnosis, placement, and treatment.

The SHO/DI crime analyst also provides weekly arrest printouts to the Juvenile Detective Division, as well as printouts of Juveniles arrested for Motor Vehicle Theft to the Auto Theft Detectives and to the TRACC Unit (Career Criminals). Since our computer system has all arrests and case reports by juvenile name, we are also able to provide complete runaway listings to the Juvenile Detectives, YVS, and to the Probation Department. This will be especially beneficial in the future as the CBI (Colorado Bureau of Investigation) System does not use the juvenile's name. Instead, they use the reporting party as the Victim for a Runaway/Missing Party. Our system has the complete runaway history for each juvenile, thus enhancing the potential SHO/DI's record.

## SHO/DI PROGRAM PROCEDURES

### 1. Identification of a SHO/DI:

- a. Crime analysis receives copies of all juvenile charges in the form of Juvenile Complaint and Referrals (JCRs) or municipal Summons and Complaints (M/C). These charges are then entered into a master computer file. The SHO/DI analyst looks through every new charge, then pulls each juvenile's record in order to identify new Candidates and/or SHO/DIs. The juvenile then must meet the SHO/DI criteria, and once he qualifies, he is "worked up" for candidate or SHO/DI. Status offenses and Incident Reports are also received on a daily basis, but are not assessed points.
- b. Other Crime Analysts, police officers, probation officers, district attorneys, or detention personnel may give the SHO/DI analyst names for potential candidates or SHO/DIs. The SHO/DI analyst then reviews the juvenile's record to see if this juvenile qualifies for the program.
  - (1) In addition to identifying SHO/DIs from charges or other people in the system, the SHO/DI analyst can identify potential candidates or SHO/DIs from Field Interview Report (FIR) cards. The analyst must research each juvenile FIR that comes into the unit daily. By pulling each juvenile's record, the analyst creates a "double-check" system for juveniles that may have been previously missed.
  - (2) Once a week, the cumulative juvenile arrest file is printed out. The SHO/DI analyst reviews the printout to look for any other potential candidates (as a final check).
- c. Only 25 SHO/DIs (30 maximum when we have that many) are kept on the active SHO/DI Roster at any one time and only 30 (40 maximum) Candidates are maintained on the active Candidate Roster at any one time. This has been discovered as our "Maximum System Capacity." In other words, this is the maximum workload number the police and CJS personnel can deal with effectively. If the rosters/files are already at maximum capacity, a Candidate will be placed on "stand-by" to be "elevated" to Candidate or SHO/DI when space is available. If the juvenile on "stand-by" has a more serious record than any current active Candidate, the "stand-by" will be put on the list, and the less serious Candidate or SHO/DI is removed or inactivated. These maximum numbers are periodically reviewed and have been moved up when there is no other alternative (i.e., no one can be inactivated and/or bumped.)

2. Current SHO/DIs:

- a. A manual file system is kept for each current SHO/DI, in order by name. The SHO/DI secretary is tasked with pulling all relevant case materials and updating files as needed. The file itself contains a label with the juvenile's name and DOB, color coded by status, e.g., red label is for SHO/DIs and the green label is for Candidate. Inactive SHO/DIs or Candidates have a yellow dot next to their DOB on the respective labels for filing convenience.

Each file contains:

- (1) The Microfiche which is the Criminal History Jacket (CHJ). All of the SHO/DI's charges are on this microfiche.
- (2) A Face Sheet (computer printout) that denotes SHO/DI at the top and contains biographical data, a listing of all offenses, points that have been assessed, current status, approval signatures, distribution, and the confidential statement. (Note: This is also the face sheet of the profile). This information has been taken directly from the SHO/DI's record (CHJ) and relevant cases that are direct-filed.
- (3) Copies of all Case Reports, Summons (JCRs and M/C), and pick-up orders/warrants. This is what is entered into the computer to produce the facesheet.
- (4) Copy of juvenile's photo when available, stapled to back of file. A photo is also reduced in size and taped onto the face sheet of the SHO/DI or Candidate.
- (5) Copies of all court Minute Orders on upcoming court cases taped to front of file. (These are also entered into the main frame computer and run out once a week.)
- (6) Copy of Traffic Record.
- (7) Copy of all Final Dispositions.
- (8) Copy of all Probation Rules.
- (9) Copies of relevant Intelligence Reports or Officer's Memos.
- (10) Link Analysis Diagrams when available.
- (11) An original and a copy of the SHO/DI's Profile. (See Section 8.)

- b. The SHO/DI secretary is tasked with maintaining these files with current information. The SHO/DI analyst is responsible for updating current information such as new charges on face sheets, new case reports, dispositions, minute orders, address changes, current photo, etc. The SHO/DI secretary must enter all the updates onto the current file.
- c. Files are purged once a month and inactives go to the Inactive file. Candidates are elevated as space becomes available, when they qualify. A profile must then be compiled on the new SHO/DIs.
- d. A SHO/DI or Candidate may have an Active or Inactive status.
- e. See sample profiles on page 60-95 for more details.

3. Inactive and Active Status:

- a. A SHO/DI becomes Inactive when he/she has no activity for 6 months or has been committed to the Department of Institutions. The SHO/DI file is placed in the Inactive drawer until further activity reactivates him/her. The SHO/DI secretary is responsible for maintaining these files and the analyst must reactivate and update the file/profile when new activity occurs.
  - (1) Committed means to an actual "Institution" under the control of the Dept. of Institutions/Division of Youth Services. This does not include DSS placement such as Colorado Boys' Ranch, Drug/Alcohol Treatment Centers, Group Homes, or the Colorado State Hospital.
  - (2) Inactive files are kept for 2 years then purged from files. If the purged juvenile commits another offense, the file is reactivated.
- b. A SHO/DI remains in the active file as long as there is continuous/new activity (new offenses), FIRs, etc. When a juvenile is selected as a new SHO/DI, he automatically goes to the active file. The SHO/DI secretary is responsible for maintaining these files, keeping all materials up-to-date, and new offenses entered and the facesheet reprinted. The analyst must update the entire profile.

4. Candidate to SHO/DI:

- a. SHO/DIs must go through a "candidate" phase before being placed on the SHO/DI active list. That is, a Candidate for SHO/DI meets the minimum required points (21) and is just in the beginning stages of creating a serious/habitual record. SHO/DIs remain in the Candidate file until they qualify for SHO/DI and space becomes available to "elevate" them to a SHO/DI or their status becomes Inactive. If a Candidate immediately qualifies for SHO/DI due to extreme violence or many property offenses, he will be moved up to SHO/DI automatically.
- b. When a juvenile has been identified as a new candidate from his current arrest and CHJ, the face sheet is compiled with the "arrest" information, typed into the computer, and printed out, the word CANDIDATE is typed beside SHO/DI at the top of the page. The status is typed in as Candidate-Active.
- c. The candidate's file is then pulled -- relevant cases and summons, his/her current photo, traffic record. Probation Rules and Court Dispositions are placed in the new file. The only difference in a Candidate and and SHO/DI file is that profiles are usually not compiled except through a special request or if there is significant activity without any adjudications.
- d. If there is no space available on the SHO/DI list, and a candidate reaches 40 points, the less serious SHO/DIs will be carefully screened to see if one of them may be "bumped" and the 40 point Candidate can replace this SHO/DI. (The Candidate would then become a SHO/DI and the "bumped" SHO/DI would be temporarily inactivated. We have not had to use this method yet.)

5. Maintenance of SHO/DI Rosters:

- a. The SHO/DI analyst is responsible for maintaining and updating the rosters which are now printed out from the SHO/DI System on the main frame (Unisys System 80). Since new changes automatically update the activity date and total points, the analyst only updates the status (reactivated, new, Inactive, or 18 yoa), any new physical description, and new address.
- b. There are seven lists that are maintained in the computer that must be printed out:
  - (1) SHO/DI (active) List:
    - (a) Consists of alphabetical list of all active SHO/DIs, Activity Date, Zone/Sector, Status (now status is SHO/DI) Points, and CHJ Number.
    - (b) New activity dates are updated (this way we know not to inactivate because of the 6 mos. no activity criteria); Zone/Sector is updated when there is a new address; Status and Points are updated as new charges occur.
  - (2) Candidate (active) List:
    - (a) Same as SHO/DI list, with the exception that status is Candidate.
  - (3) Inactive List:
    - (a) Includes both SHO/DIs and Candidates whose status is inactive (Inactive-S or Inactive-C).
  - (4) Total listing of all SHO/DIs, Candidates and Inactives.
  - (5) 18 yoa listing:
    - (a) Includes all SHO/DIs that have turned 18 and/or older.
  - (6) Monthly Report:
    - (a) This is divided into Additions to SHO/DI and/or the Candidate list, Inactivated and 18 yoa - Out of System to get total SHO/DI changes on a monthly basis.
  - (7) A list of SHO/DIs' and CANDIDATES' addresses are also printed out each month in order to update the Crime Analysis Unit map. SHO/DI locations are placed on the Neighborhood Watch map in the form of orange dots. This gives the officers and civilians a visual aid to detect who is in their neighborhood.

- c. All the above information is taken from the Records and Identification section's Files and is maintained on the SHO/DI Biographical Screen or as the master record. See pages 34-35 for a more detailed explanation of the data entry.
- d. See pages 36-53 for examples.

- (d) SHO/DI secretary
- (e) SHO/DI files (originals)
- (f) Communications (4 copies) - SHO/DI list only
- (g) Case Management
- (h) Crime Stoppers
- (i) Data Processing
- (j) YVS
- (k) Juvenile Section
- (l) TRACC
- (m) Sgts. of Major Crimes Division (MVT, Persons), Property Division, and TEU (Tactical Enforcement Unit)

(2) Outside Agencies (Juvenile Justice System):

- (a) Probation Department (Adult and Juvenile)
- (b) Zebulon Pike
- (c) Division of Youth Services (Department of Institutions)
- (d) Juvenile DA/Limited Adult DAs
- (e) EPCSO (Sheriff's Office) Crime Analyst and Warrants Division.

- b. All rosters are stamped with the Confidential stamp which states:

CONFIDENTIAL INFORMATION: NOT TO BE DISCLOSED OUTSIDE  
JUVENILE JUSTICE SYSTEM (LAW ENFORCEMENT, ALL COURT  
AGENCIES/AGENTS, DEPARTMENT OF INSTITUTIONS

- c. The individuals listed above are responsible for destroying all old lists when given the current list.

7. Maintenance of Files - Monthly Updating:

- a. Each month, after the new rosters are printed and distributed, the files must be updated. The SHO/DI analyst must go through the list and purge all 18 year-olds, and inactivate SHO/DIs and candidates who have no activity for the past 6 months. New arrests, which are reviewed daily increase points and change the activity date; therefore, the new rosters should reflect these changes. Arrests, FIRs, Target Suspect Files, new addresses, etc., are reviewed daily for file maintenance. Before there is an agreement of no activity, all pieces of information must be reviewed. SHO/DIs and candidates are also inactivated if they are committed to DOI.
- b. All new arrests must have been recorded and points assessed for both SHO/DI and candidates to determine if there are any changes. Arrests are reviewed daily for new candidates by the SHO/DI analyst and the profiles are updated as soon as the new information comes in.
- c. If there are not 30 SHO/DIs and/or Candidates, the Candidates can be elevated (if they meet the criteria).
- d. If there is any new arrest, the microfiche must be reviewed, respective cases are pulled, and profiles updated. (Same for updating FIRs, traffic, records, family, suspect, etc., onto the profiles).
- e. Inactives should be made active if there are any new arrests.
- f. Eighteen year olds will go to the 18 yoa file drawers. There is also a notebook maintained by the SHO/DI analyst containing all 18 yoa SHO/DI profiles. These profiles are used constantly for suspect information work-ups when crime patterns are detected, as well as by the TRACC unit. These 18-21 yoa ex-SHO/DIs are well on their way to being Adult Career Criminals.

8. Profiling:

a. SHO/DI profiles are compiled by the SHO/DI analyst.

b. Each profile consists of the following sections:

(1) Face Sheet: This printout contains biographical information, a listing of the offenses, points assessment and total points, status, update dates, approval signature, and distribution sign-offs.

(a) Only charged offenses are recorded on the Profile Facesheets. For demonstration purposes, we printout all entries to include FIRs, Status Offenses, Victim information, and Suspects in crimes. This gives the viewer a chronological review of a SHO/DI's activity.

(b) The points are assessed by the analyst and are taken from the juvenile's permanent record. (The points are part of the criteria and are described in the Operations Manual.) The only "judgment calls" are on Motor Vehicle Theft (usually counted as a Felony unless specifically denoted as a Misdemeanor on the charging document); Escape (Felony if in DOI for a Felony charge -- is counted only if it is an Escape from DOI custody and not from an officer). Probation Violations and Status Offenses do not have points assessed. They are recorded in another section. If there is an unusual charge (not frequently charged) it must be researched in the Colorado Revised Statutes to see if it is a Felony or Misdemeanor, and for points assessment. Total points are automatically updated as each new arrest is entered (see Section 10).

(2) Criminal Arrest History - Associate Listing:

(a) This consists of all associates and their descriptions taken from police documents (e.g., arrests, cases, FIRs, etc.), and the degree of association (e.g., Implicated, Mentioned, etc). The associates are entered for every document entered when mentioned in that document. Therefore the list is automatically printed out with the Facesheet each update. The listing is also the matrix for the Link Analysis Diagram. See pg 99 for a more detailed description of the data entry.

(3) Crime Analysis Information:

- (a) Synopsis -- this consists of the age first arrested/charged, a brief description of types of crimes committed, MO, if any (how he committed the crime), usual criminal specialty such as burglary, robbery, etc., what kinds of property he takes, where he goes, when he does the crime and who he does it to; characteristics of personality if assaultive or sexual offender. If there are specific associates that work with the SHO/DI all the time, they are mentioned here.
  - (b) Drug/Alcohol Involvement--each drug/alcohol incident is recorded here for easy reference. All Summons and Complaints listing the charge of drugs or alcohol, any mention in Case Reports, or in FIRs, or any other police or probation document available to us are recorded in this section.
- (4) Criminal Arrest History--this section records the date, offense, related CR#, M/C-JCR#, and the disposition of the case. Under the offense section the actual charge, the circumstances of the case are described (MO), associates are mentioned, and victim, loss, and location are listed.
- (5) Field Interview Report--this records pertinent information from the FIR card such as the contact #, grid, date, time, location, nature of contact and associates.
- (6) Traffic Arrest History--records all traffic arrests; date, M/C, charge and disposition are the categories.
- (7) Named Suspects in Target Crimes--date, offense, and CR# are the categories. Under offense, a synopsis of the case like in the Criminal Arrest History is written. Under CR# a disposition, if any, is also recorded.
- (8) Biographical Narrative--
- (a) Status Offenses--consists of date, type of offenses committed (e.g., Runaway, Uncontrollable), location of offense, CHJ, CR#, and Date Found/Returned, canceled, etc.
  - (b) Victim File--victim of any crime, sexual assault, child abuse/neglect, etc., date, CR#, case synopsis are given here. Type of case is under case synopsis.

- (c) Active Warrants--records date all warrants issued on subject, and when they were served or inactivated. (CAD is used to retrieve a printout on each escape or runaway.)
  - (d) Outside Agency Arrests--any other arrests other than our Department are researched through the CBI files.
  - (e) School/Employment History--where subject attended school or worked, and any narrative on school attendance, problems recorded/taken from Probation reports.
  - (f) Current Status in Juvenile Justice System--taken from minute orders, probation rules are the next court dates, and if he is in detention or placement, etc.
  - (9) Family Criminal Background--denotes all family members with criminal and/or traffic records, charges, dates, summons or CR#s, and dispositions.
- c. With the exception of the Facesheet and associate pages (printed out from the main frame), the profile is then typed into the computer using WORDSTAR and run out for dissemination. See pages 60-95 for sample profiles.



9. Profile Dissemination and Maintenance of List:

Upon completion of profiles, copies are made for the following:

- a. Juvenile DA (1 copy)
- b. Probation (1 copy) (Municipal Court Probation when appropriate)
- c. Juvenile Detention (1 copy)
- d. Division of Youth Services - DOI Diagnostician and Client Managers (1 copy)
- e. EPCSO Analyst (if current investigation and is requested)
- f. City Attorney for municipal violations (pending)
- g. Individual police officers when requested

All recipients' names must be recorded on the profile.

10. Arrest File Procedures:

- a. All juvenile complaints/summons are received from the data processing unit. Once the summons are copied and coded, they are entered into the SHO/DI System main frame program in order to get a weekly printout of all arrests. The printouts are sorted by name, zone-sector, and vehicle color. We also run special printouts of all juveniles arrested for Motor Vehicle Theft, and all juvenile runaways/missing persons. The screen display and definitions of field names are included (pg 98).
- b. Brief MO codes and descriptions are also entered for each offense.
- c. When there are associates to the offense, their master number is entered and their record is automatically updated as well. The only thing that must be changed is the summons number, point assessment (when appropriate), and degree of association. (See pg 99 for screen display.)
- d. There are also many ways we can search for information within the SHO/DI system. For example, if we are entering a juvenile arrest and want to see if he is associated to someone previously arrested, we can search for a common case number or summons. We can also query information by Name, Race, Hair, Status (SHO/DI or Candidate), Zone/Sector, and MO codes. (See pg 99 for an example of the query screen.)

11. Officer Packets - Tactical Support:

- a. When an officer places a request for suspect information, the SHO/DI analyst is tasked with compiling all juvenile suspects who have recent activity in the particular area requested.
  - (1) An Information Request usually contains:
    - (a) recaps or description of current target activity;
    - (b) a list of adult and juvenile suspects (particularly SHO/DIs and Candidates), their description, DOB, CHJ#, Locations, associates, and current activity is included. If there are SHO/DIs listed, a copy of their profiles are included (if requested).
- b. The SHO/DI information is also included in Directed Activities, Bulletins, and in the Crime Analysis Newsletter for officer use. See pages 105-106 for an example of the Crime Info Sheet.
- c. SHO/DI information is also included in the Colorado Springs monthly presentation to Colorado Crime Analysis Association meetings. This association includes all "Front Range" police agencies who share crime patterns that occur in their individual areas.
- d. Daily requests may come from officers by a phone call, at roll call or someone stopping by. These requests include information like an FIR check, whether a juvenile is or isn't a SHO/DI, physical descriptions, warrant information, last known addresses, associates, activity, criminal specialty, etc.

12. FIR Reports to Juvenile Probation:

Currently, the Probation Officer calls us and asks for FIR checks on their probationers. We return the call with the information and maintain a list of all calls and information provided. Copies of the list are sent to the Lieutenant of the Juvenile Unit and the Director of the Probation Department. We also hand carry over daily copies of all Juvenile FIRs to the Probation Department for dissemination to officers working active cases, and provide them with monthly printouts. (See pages 112 and 113 for memo authorizing this dissemination.)

13. FIR Reports to Juvenile Parole/Division of Youth Services:

The FIRs and any current case report are sent over to the Parole Officer and client Managers on all active juvenile parolees/clients. The FIR only is sent over on adult parolees (those still on Juvenile Parole but are 18-21 yoa). See pages 114 and 115 for memoranda documenting the use of FIRs by Parole.

14. SHO/DI Performance Measures Report, and SHO/DI Collective Profile:

- a. A monthly performance measure package was provided to us by the SHO/DI evaluators. The analyst is responsible for completing the items required in the packet.
- b. The SHO/DI analyst completes a collective profile each month on all SHO/DIs. This consists of all biographical data, criminal history information, current status in CJS, and family criminal history. This information gives us a picture of our average SHO/DI in Colorado Springs.
- c. Both a and b are currently being combined to provide a more concise report to the grant personnel. We will soon be able to get a majority of this information from the TQL program of the SHO/DI system.
- d. Based on the information above, the SHO/DI program manager then compiles a brief summary of our results and submits these statistics to our supervisor. The analyst is also responsible for submitting statistical information to the grant quarterly report, and a monthly stat report for the juvenile sergeant's report to his supervisor.

15. Operations Manual for SHO/DI:

- a. It shall be the SHO/DI staff's responsibility to maintain an up-to-date manual reflecting SHO/DI procedures. This manual shall include:

SHO/DI Definition and Criteria  
Procedures for SHO/DI case handling (Policy)  
Letters of Agreement  
Pertinent Memos to Staff  
SHO/DI Status Reports  
SHO/DI Profile Prototype  
Police General Orders pertaining to SHO/DI  
Current SHO/DI list  
Performance Measures  
Any other Special Projects pertaining to SHO/DI

- b. This manual has been reproduced for dissemination to local justice system personnel and provided as a Technical Assistance tool for new participating agencies.
- c. The new edition date update shall be placed on the title page.



Although Officer Hall worked these cases diligently and identified some good suspects, the victims failed to ID any of them. However, the pattern stopped abruptly after Hall began working it. Who'd you scare off, Terry?

In the last few weeks we have had an unusual number of incidents in the north east in addition to those involved in the laundromat pattern. These include flashings, gropings and three rapes. To the left is a map of these incidents and a list of cases. (Note: These do not include any cases in the laundromat pattern.) Suspect descriptions do not suggest that many of these are related. All of these involve strangers. As soon as we have more information, we will get it out to you.

To insure security of protected criminal justice records information involving juveniles, the following procedures will be followed in the dissemination of SHO/DI rosters and profiles:

1. SHO/DI rosters and profiles will not be disclosed or released to any person or agency outside of the criminal justice system. Criminal justice agencies include the Police Department, DA's Office, Juvenile Probation, Courts and the Department of Institutions.
2. All SHO/DI rosters and profiles will bear a red stamped statement: "CONFIDENTIAL INFORMATION--NOT TO BE DISCLOSED OUTSIDE JUVENILE JUSTICE SYSTEM (LAW ENFORCEMENT, ALL COURT AGENCIES/AGENTS, DEPARTMENT OF INSTITUTIONS)."
3. All SHO/DI rosters and profiles provided to authorized users will bear the name of the recipient and his agency (e.g., Mr. Gary Holmes, Juvenile Probation Department).
4. All SHO/DI rosters and profiles will be hand delivered to the designated recipients.
5. SHO/DI rosters and profiles designated for agencies or persons outside the Police Department will be initialed by the receiving person.
6. All SHO/DI rosters and profiles distributed will be accounted for in a log maintained by the Crime Analysis Unit. The log will document the specific item released, the recipient and agency, and the date of release.

The CSPD Crime Analysis Unit maintains field interview information on persons who have been contacted by police officers under suspicious and other circumstances where no actual arrest results. This information generally represents an observed statement of an event, i.e., the officers recorded observations of the suspicious circumstances, description of the individual contacted, associates, locations, time/date of the contact, and other relevant information.

The Juvenile Probation Department (JPD) is charged with conducting evaluations of juveniles under the jurisdiction of the Juvenile Court, as well as supervising the court-ordered probation of juveniles. Police field contacts represent valuable documented information on juveniles which can enhance the evaluations and probation supervision of the JPD. For example, a field contact with a juvenile may occur which documents a violation of the probation rules imposed on the child by the court. According to the JPD, present limited access to our Field Interview Report (FIR) information has resulted in assisting probation officers with their supervision responsibilities.

To facilitate JPD access to this useful information, the Crime Analysis Unit will regularly provide copies of juvenile FIR contact information to the JPD. The copies contain basic information such as name, address, location of contacts, associates and type of contact. The JPD will insure that FIR information used by probation officers be the factual, stated observations by the police officer. Opinions, hearsay, or other unsubstantiated information from the FIR information will not be used by the probation officers without verification by the reporting officer.

The JPD will report to the Crime Analysis Unit the frequency and type of use of the FIR information to include number of FIR contacts of probationers. Any actions taken by probation officers involving use of the FIR information (e.g., adjusting probation terms, petitioning for a revocation of probation, etc.) will be reported to the Crime Analysis Unit.

SUBJECT: Juvenile Task Force Meeting

At the Juvenile Task Force meeting on June 4, 1986, Mr. Jerry Adamak of the Division of Youth Services (Juvenile Corrections) advised of the approved replacement detention facility for Zeb Pike.

A 32 bed facility will be constructed at the new Criminal Justice Center jail site, and should be completed within three years. The present Zeb Pike facility will be razed.

Also of interest to us is the DYS emphasis on community corrections for residential placement of juveniles from the Department of Institutions.

While our SHO/DI program currently is monitoring police contacts (arrest and FIR) with juvenile parolees in Colorado Springs, it will become even more critical as the parolee population increases to ensure police contact feedback to the Division of Youth Services.

The issue of expanding community corrections for juveniles has been controversial in some areas of the state. Jefferson County officials, for example, are concerned that there is no local control over which juvenile offenders are being placed in their community. While local corrections boards have power to screen adults being placed in community programs, the state Division of Youth Services controls juvenile placements.

I believe that our SHO/DI monitoring of juvenile parolees gives Colorado Springs an edge on parolee supervision that probably does not exist elsewhere in the state.

I understand that the Division of Youth Services will be advising the Criminal Justice Advisory Committee of the expanding of community corrections for juveniles.

The Crime Analysis Unit, as part of the juvenile Serious Habitual Offender/Drug Involved (SHO/DI) program, is now monitoring police contacts, both arrest and FIR, of juvenile parolees in Colorado Springs.

At this time, there are 27 juvenile parolees in Colorado Springs, who have been released from the Department of Institutions. Any police contacts with these persons are reported to the Division of Youth Services' (DYS) Juvenile Parole Officer. SHO/DI profiles are currently in use by DYS in risk assessment of juvenile parolees in this area.

As DYS expands the community corrections concept of residential placement of committed juveniles, it will become more important that police contacts with these juvenile parolees are reported to the supervising parole officials.

The Crime Analysis Unit, in cooperation with the Juvenile Section, has identified a group of serious juvenile offenders who have had repeated contacts with the criminal justice system. The juveniles have had at least one finding of delinquency, and have been previously charged with at least one felony. We are initiating the operations phase of this program, the juvenile Serious Habitual Offender/Drug Involved (SHO/DI) program.

The purpose of the SHO/DI program for Patrol is to provide an early alert to the field officer that a particular individual he is dealing with may be a repeat juvenile offender. To help the field officer know that a juvenile is a SHO/DI, both the Communications Section and the Records and ID Section will have current SHO/DI rosters by Friday, May 10, 1985.

Officers who query the Wants/Warrants channel with a name and DOB of a SHO/DI will be advised that subject is a Code 17. A Code 17 means that the subject is a SHO/DI or an exceptional juvenile offender. No term other than Code 17 will be used over the air that might identify the juvenile as a previous offender.

In Records and ID, a yellow dot will appear on the Master Name Index card and arrest microfiche cover to identify SHO/DIs to police officers and records personnel.

Officers are requested to make an FIR on any field contact with a SHO/DI. Depending on the nature of the contact, the officers may wish to obtain additional information on the subject from Records and ID, Crime Analysis, or the Juvenile section to assist in the Officer's investigation.

The Crime Analysis Unit has information on the SHO/DIs, including previous police contacts, MO, associates, terms of probation, and present status in the juvenile justice system.

Critical information on the SHO/DIs is provided by the Crime Analysis Unit to the DA, Juvenile Probation, and Zeb Pike to make them aware of the child's previous police contacts, aggravating

factors from previous offenses, and other pertinent details of the child's offending behavior history. These agencies have agreed to use this information to aid in decisions affecting the child and community safety.

The Police Department is initiating the operations phase of the juvenile Serious Habitual Offender/Drug Involved (SHO/DI) program. The purpose of the SHO/DI program is to deal more effectively with the serious repeat juvenile offender.

It is critical to the effectiveness of the SHO/DI program that field officers have an "early alert" system to advise when they are dealing with an exceptional juvenile offender.

As we agreed, the current SHO/DI list will be made available for placement at the dispatch consoles.

An officer running a want/warrant check would be advised by the dispatcher that the subject is a Code 17 if the subject's name and DOB appear on the SHO/DI list. No other term may be used over the air that would identify the child as a SHO/DI ("SHO/DI", "Offender", etc.).

Updated SHO/DI lists will be provided to Communications to replace old ones. Because of the special protection afforded juvenile offender's names, it is important that the SHO/DI list be maintained confidentially within the Communications Section. Please destroy old SHO/DI lists as new replacements are provided.

The attached SHO/DI list contains our current active SHO/DI's. You will receive new rosters as they are updated. Destroy the old SHO/DI lists as they are replaced.

I've also attached a proposed SHO/DI procedure for your consideration to aid your dispatchers.

Thank you and your staff for assisting in this important part of the SHO/DI program.

## SHO/DI SURVEY RESULTS

### JUVENILE SERIOUS HABITUAL OFFENDER/DRUG INVOLVED PROGRAM COLORADO SPRINGS POLICE DEPARTMENT

A survey evaluation of the Colorado Springs Police Department's juvenile Serious Habitual Offender/Drug Involved (SHO/DI) program was recently conducted by Ms. Kathy Ward, a doctoral student at U.C.C.S. A total of 52 criminal justice agency personnel from the following areas participated in the evaluation.

- 1) Police Department
- 2) Juvenile Diversion
- 3) Juvenile Probation
- 4) District Attorney's Office -  
Juvenile Division
- 5) Zebulon Pike Detention Center
- 6) Judiciary
- 7) Public Defender's Office
- 8) Private attorney specializing in  
juvenile defense

The general results of the evaluation were favorable to the SHO/DI program.

- \* Juvenile justice system employees found SHO/DI to be a valuable component of the overall system.
- \* Improved communications among juvenile agencies was perceived as a valuable aspect of the program.
- \* The increased information available to agencies regarding serious juvenile offenders was a positive effect.
- \* SHO/DI information was frequently utilized to aid in determining the treatment plan of juvenile offenders.
- \* There was agreement for the early identification of juveniles who commit serious crimes.
- \* Tracking serious juvenile offenders through the system was seen as a positive benefit.
- \* The need for greater involvement of agencies such as schools and the Department of Social Services was reported as a means of extending and providing more information pertaining to juvenile offenders.
- \* The respondents agreed that continuing the SHO/DI program would be of great value to this community.
