## INTRODUCTION

### History of Pennsylvania's Juvenile Court Statistics

Data collection was initiated in 1970 in Pennsylvania as a cooperative effort between the then Governor's Justice Commission and the Juvenile Court Judges' Commission (the Commission). During this period statistical cards were forwarded to the Commission, checked for accuracy and then forwarded to the Governor's Justice Commission for input, throughput and output. In 1977 the entire responsibility for the data collection system was shifted to the Commission. In the early 1980s the statistical card was revised so that the information collected was a more accurate reflection of the juvenile court process. The changes to the reporting card were made in conjunction with the Pennsylvania Council of Chief Juvenile Probation Officers. In 1983 a restructuring of data bases began so that critical variables could be tracked longitudinally in order to facilitate the ability to conduct trend analysis and research projects. The system provides reports in an in-depth and timely manner to the Commission's various data consumers. For instance, data are provided to federal, state and county agencies for use in budget decision making. The authority for the Commission to collect these data is found in Title 11, Chapter 3, Section 270-4(4) of the Pennsylvania statutes.

### Data Collection Methods

The juvenile courts in Pennsylvania have jurisdiction over delinquency and dependency cases and interstate compacts. Dependency cases include abused, neglected, truant, ungovernable youth and those juveniles under age ten who commit delinquent acts. Murder cases are not originally handled in juvenile court but may be transferred from the criminal court to juvenile court for processing.

In 64 of the 67 counties data are recorded on the Juvenile Court Statistical Card (see Appendix I) for delinquency cases, and placement and dispositional review hearings involving youth ages 10 to 18. (Dependency cases are not reported to the Commission.) These forms are completed by local intake or probation officers after the disposition of a case. A case involves a referral, which can contain one or more offenses, disposed either informally at intake or formally at a hearing by a judge or master. The forms are forwarded on a monthly basis to the Commission for input. The forms are keyed into a microcomputer twice to check for keying errors. The data are then sent to a mainframe computer at which time validation checks are run. If questions concerning the data arise at any time during the process the county is contacted for clarification. In Allegheny, Delaware and Philadelphia counties data are sent to the Commission on computer tapes once a year. These data have been converted by the county to the state format.

### Publications

Each year the Commission has published a report summarizing juvenile court handling of delinquency cases based on data collected by the Juvenile Court Statistical Card program. (*Pennsylvania Juvenile Court Dispositions*, Juvenile Court Judges' Commission, Series J-2.)

### Archived Data Files

Each year the National Juvenile Court Data Archive asks the Commission to create a data file containing a record for each referral disposed during the previous calendar year and reported to the Commission. The data files received by the Archive contain an individual record on each delinquency case disposed. Placement and dispositional review hearings are removed from the archived file because these are not new referrals to the court.

Delinquency cases processed formally (with a petition) and those handled informally (without a petition) are included in the Archive files. Each record includes demographic, care pending disposition and case processing information. The National Juvenile Court Data Archive staff has checked the data for invalid or inconsistent code values. When found, such codes were replaced with missing data code values. The Archive staff created variable PA064, Most Serious Intake Charge, by ranking the offenses found in the four intake charge fields (variables PA019, PA021, PA023 and PA025) and selecting the most serious of the group. The same procedure was used to create variable PA065, Most Serious Substantiated Charge, (based on variables PA043, PA045, PA047 and PA049). The offense ranking developed by Archive staff can be found in Appendix II.

Each case record is 129 characters in length and contains 65 variables. The data are stored in single year files. The number of case records on each calendar year data file is as follows:

## USING THE CODEBOOK

The information that follows is based on a study of available documentation from the data supplier (e.g., *Statistical Card Procedures*, Juvenile Court Judges' Commission, 1984), interviews with the data supplier and court personnel, and diagnostic analyses performed by the Archive staff. The example below is a reproduction of information appearing in the codebook for a typical variable. The numbers in brackets do not appear in the codebook, but are references to the descriptions which follow this example.

- [1] The starting location and width of the variable in the machine-readable data file. This is the format information needed to read the data into other systems.
- [2] The variable number. The variable number is used as a variable name when the file is processed by systems which use alphabetic variable names (e.g. SPSS).
- [3] The variable label used by statistical systems to identify the variable or program output.
- [4] A description of the variable contents.
- [5] The code values occurring in the data for the variable.
- [6] The textual definitions of the codes. The first 20 characters form a short value label which some systems use to document the output of analysis programs. A longer description follows the short label when necessary.
- [7] The designation of missing data. The Archive staff has replaced any out-of-bounds codes with missing data codes. Many analysis packages require that certain types of data which are usually excluded from analysis be designated as "missing data". Fields with no entry were left

blank and "( ) No entry" is listed as a code value. Some variables also have response options representing "unknown" which are also listed as code values.


