

Introduction

The Family Violence Prevention and Response Act of 1986 created Family Violence Intervention Units within the Family Division of the Superior Court. These units accept referrals of family violence cases from judges or prosecutors. The Intervention Units are responsible for: preparation of reports for presentation by the next court date; provision or arrangement of services to victims and offenders; administration of service contracts; and provision of a monitoring system for all restraining and protective orders.

The 1986 Act requires that monthly statistical summaries of Intervention Unit activity be submitted to the Crimes Analysis Unit of the Department of Public Safety which compiles annual reports. The following is the 1988 Annual Report for the Family Division.

The reader should note that not all family violence cases are referred to the Family Violence Intervention Units. More serious cases are handled by Part "A" of the Superior Court.

This report includes a summary of Intervention Unit activity for 1988, giving the total number of Cases Referred, Cases Disposed and Cases Open. The yearly summary is followed by information concerning the Nature of Charges, Nature of Violence, Relationship of Parties Involved and Type of Final Disposition Given.

1988 Statistical Summary

- ✓A total of 26,561 cases were referred to the Family Violence Intervention Units during 1988. This represents a 7.0% increase in the total cases referred during 1987 (24.831).
- √15,239 cases were Disposed Of.
- ✓23,179 cases were pending at the end of 1988. 11,857 cases remained open at the end of 1987. Some of the cases Disposed Of during 1988 were undoubtably cases which were pending at the end of 1987. However, there is no way to determine how many of the 23,179 open cases are still open from 1987 and how many were 1988 cases.
- ✓Most cases (79.7%) referred to the Intervention Units involved: Unmarried Couples/Live-ins (46.7%); Spouses (30.4%); or Former Spouses (2.5%).
- √Two-thirds of the Cases Referred (66.7%) involved Physical Violence.
- √38.7% of Charges Filed were for Assault. One-quarter (23.3%) of Charges Filed were for Breach of Peace and 19.7% were for Disorderly Conduct.
- √In three-quarters of the Cases Disposed Of (74.7%) the final Type of Disposition was Nolle Prosequi.
- √8.6% of the Cases Disposed Of involved the Rearrest of the defendant on another charge.
- √8.4% of the defendants in the Cases Disposed Of were Fined (4.2%) or received a Suspended Sentence with Probation.

Definitions

ACCELERATED REHABILITATION: The court may use its discretion to invoke accelerated rehabilitation on motion by the defendant or prosecutor if they have good cause to believe the defendant will not offend again; and has no previous record of conviction of a crime.

When granted, the defendant is released to the custody of the office of adult probation, under whatever conditions the judge requires, for a period of up to two years. If the defendant violates any of the conditions of the probation, s/he is brought to trial.

Upon successful completion of probation, the defendant or the court may apply for dismissal of the charges against him/her, which is granted if the judge deems the probation successful. Upon dismissal, all records of the charges are erased.

CASES DISPOSED OF: Cases closed by a judge rendering a decision or prosecutor's Nolle Prosequi.

CASES OPEN: Cases pending adjudication. This category includes cases disposed of in which the disposition has yet to be recorded.

DISPOSITION GIVEN: Most serious consequence given to the defendant.

FAMILY VIOLENCE INTERVENTION UNITS: The Family Violence Intervention Units were formed by the Family Violence Prevention and Response Act of 1986. Intervention Units accept referrals of less serious offenders from state's attorneys and judges. Intervention Unit staff must prepare reports on each case by the next court date, provide or arrange for services to victims and offenders, administer service contracts and provide a monitoring system for protective and restraining orders. They are also charged with establishing centralized reporting procedures.


NOLLE PROSEQUI: A case is "Nolled" when a prosecutor decides not to pursue prosecution. Although counted as a final disposition, the case may be reopened at any time during the following thirteen months for prosecution.

OTHER CHARGES: Other charges include Burglary; Robbery and Arson.

RELATIVE: Includes brothers; sisters; aunts; uncles; inlaws; cousins; etc.

UNMARRIED COUPLE/LIVE-IN: Persons presently residing together; or who have resided together in the recent past; and persons who share a child in common.


FAMILY VIOLENCE CASELOAD 10/1/86 THROUGH 12/31/88


RELATIONSHIP OF PARTIES JANUARY 1 THROUGH DECEMBER 31, 1988


