#### I. INTRODUCTION

It is commonly known that child maltreatment is a major problem in Washington. What is not known is the exact nature of the problem. The answer to the question of who is doing what to whom is important for policy makers at the state and local levels. It is only with a clear understanding of the relationships involved that effective prevention and intervention programs can be developed.

How we treat our children determines what kind of society we are. There is a well established correlation between how children are treated and what kind of adults they become. The Governor's Juvenile Justice Advisory Committee (GJJAC) has had a long term interest in the maltreatment of children because the relationship between child maltreatment and later delinquent behavior has also been well established. Children who are the victims of violence often grow up to become delinquent, so anything that successfully addresses violence against children will work to reduce later criminal activity.

In 1986 the GJJAC retained Gordon Bunker, law enforcement consultant, to review data kept by local law enforcement agencies on contacts with juveniles. In the course of his review, Mr. Bunker discovered that a great deal of information is kept locally on crimes against children. Local law enforcement agencies expressed interest in the availability of specific data about this widely acknowledged but little studied problem. There has traditionally been no central repository for data about crimes against children. The information has not been available to state policy makers in distinct and separate form. Information about crimes against children are grouped with crimes against adults when entered into the Uniform Crime Reporting data base.

In 1987 the chair of the GJJAC ordered the creation of a special ad hoc committee on child abuse reports to law enforcement. The purpose of the committee was to devise a method by which information on crimes against children could be collected and analyzed. The mission of the committee was not to pursue a hypothesis about the data, but rather to determine what child abuse data is available in each community. Because of the interest of local law enforcement agencies, the Washington Association of Sheriffs and Police Chiefs expressed willingness to the agency responsible for making local information available in a form that could be used by public policy makers. They requested and received permission from their membership to take a leadership role in this project. Funding assistance was provided by the GJJAC. The Attorney General's Office supported the project by offering the resources of its information services section to review and analyze the collected information.

### III. STUDY DESIGN AND METHODS

This is a study of reports of crimes against children reported to local law enforcement agencies in Washington from January 1, 1988 through June 30, 1988. The universe of what happens to children that is dangerous and destructive can be conceptualized as a large box. The box contains two major categories; unintentional injuries and inflicted injuries. In the inflicted injury category are three smaller boxes; inflicted injuries that do not violate community standards, inflicted injuries that are proven to be damaging to the child's health, well-being or safety (those that fall under the purview of RCW 26.44) and inflicted injuries that violate criminal statutes. Please see figure 1 below.

The problem of the maltreatment of children can be further segmented in a variety of ways. There is a pool of acts destructive to children and known only to the parties involved. These situations are not reported to either local law enforcement or state Child Protective Services. The extent of this pool of unreported incidents is unknown. Another pool of incidents of child abuse are reported to Child Protective Services. These incidents may or may not constitute an alleged violation of relevant criminal statutes codified in RCW 9 or 9A. Some sources reported that this pool may have involved as many as 20,000 children during the period of this study. A third pool is that of those incidents reported to both local law enforcement and state Child Protective Services. It is unknown how many of the incidents analyzed in this study also involved Child Protective Services.

The Governor's Juvenile Justice Advisory Committee (GJJAC), having recognized the need for reliable data on child abuse reports handled by law enforcement agencies directed its staff to organize an ad hoc committee to develop the methods and processes by which such a study could be conducted.

The committee proceeded to develop a three step protocol to achieve it's goals. Step 1 was to create a data collection device. To minimize confusion the data collection form was constructed to be similar to the supplemental homicide data form currently in use by local law enforcement agencies. A copy of the guidelines and data collection form are included as Appendix A.

Step 2 of the protocol began when the Washington Association of Sheriffs and Police Chiefs requested that their membership participate in the study. Of the approximately 175 agencies that participate in Uniform Crime Reporting, 146 (83%) were involved in this study. The study includes data from 80% of the population base of Washington. Participating agencies by county are listed in Appendix B.

Step 3 of the protocol was to analyze the data reported by local law enforcement agencies. The Washington Association of Sheriffs and Police Chiefs hired a data entry person with experience in the Uniform Crime Reporting system. A priority of the committee was to insure that the study was based on reliable data. Some of the reports received involved school yard fights and other incidents that are not generally considered child abuse. Any questionable report was eliminated from the data base. Of the 5,647 incidents reported during the study period, 323 were deleted and not analyzed. The Office of the Attorney General supported the study by providing data analysis services.

### IV. STUDY RESULTS

While it was not in the domain of the ad hoc committee to make comparative conclusions about the results of the study, the data are compelling and disturbing. Highlights of the results include:

\*Of the 5,324 incidents analyzed:

- . 1,701 were physical abuse (homicides, aggravated assaults, and simple assaults);
- 2,485 were sexual assaults (incest, rape, indecent exposure, molestation, statutory rape, child prostitution, and child pornography);
- and 1,138 were neglect (failure to provide a safe environment, neglect, and abandonment).

\*Within the physical abuse category:

- . there were 11 homicides, all of the victims were age 7 or under.
  - The 13 alleged offenders included 4 fathers, 4 mothers, 1 brother, 1 father's girlfriend, 1 mother's boyfriend, 1 babysitter and 1 unknown.
  - there were actually 13 homicides of children statewide during the study period. The two not included in the study data base occurred in agencies which did not participate in this study.

\*There were 515 aggravated assaults also in the category.

. The 468 alleged offenders included 149 fathers, 177 mothers, 23 stepfathers, 30 mother's boyfriends and 10 acquaintances.

\*There were 1,168 victims of simple assault.

. Alleged offenders included 325 fathers, 324 mothers, 88 stepfathers, 15 stepmothers, 108 mother's boyfriends and 72 other known persons.

\*In the sex abuse category there were 2,485 victims.

1,585 incidents of child molestation were included.

The alleged offender profile includes 231 fathers, 218 acquaintances, 153 other known persons, 108 stepfathers, 92 mother's boyfriends, 85 babysitters and 84 unknown persons.

550 children were rape victims.

- the 491 alleged offenders included 98 acquaintances, 35 babysitters, 42 mother's boyfriends, 34 neighbors, 48 stepfathers and 58 other known persons.
- Of the 198 incest victims, 181 were female and 17 male.
  - Alleged incest offenders were overwhelmingly male, 163 of 165.
     74 were fathers, 49 brothers, and 5 grandfathers.
- 77 children were victims of indecent exposure.
- 83 children were statutory rape victims.
- 16 children were victims of child pornography.

\*Law Enforcement investigated 1,138 allegations of neglect.

- Mothers dominated the alleged offender profile of neglect cases.
- Of the 334 failure to provide a safe environment reports, 162 of the 251 alleged offenders were mothers and 51 were fathers.
- The 635 neglect incidents included 328 mothers, 78 fathers, 11 mother's boyfriends and 10 other relatives.
- There were 175 victims of abandonment; 96 of the 116 alleged offenders were mothers, 12 were fathers.

### V. SUMMARY

Little was known about the subset of child maltreatment that involved law enforcement until the release of this study. The scope of the larger problem includes those families with whom state Child Protective Services is concerned as well as those that come to the attention of law enforcement. It could have been predicted that law enforcement is primarily concerned with assaults by persons not acting in the role of parent or care giver. Had that prediction been made, it would have been wrong.

It is clear from this study that the major source of risk to children in Washington comes from within the family and from other known persons. Stranger-related assaults comprise a small portion of what happens to children that damages them. It is also clear that other known persons and fathers emerge as the principle alleged offenders in sexual assault related incidents. Mothers emerge more often in neglect-related incidents. A surprising number of mothers also emerged as alleged offenders in physical assault related incidents.

Based on this study it is possible to develop a first generation risk rate for children in Washington. By taking the incidents for each county and factoring in the percent of the population of the county represented by participating agencies and comparing that information to the number of children in the county, a chart of risk can be created. That chart is included as Appendix C. It must be kept in mind, when viewing the data presented in this report, that the study collected data on three distinct subjects: incidents, victims and offenders. Totals, therefore, cannot be comparable.

For example, one incident involved 11 victims and 7 offenders, obviously producing different totals for the three categories. In all offense tables throughout this report the following codes may be used in Victim's Age listings:

NB - birth to one week

### BB - one week to one year

Victim's Age reporting guidelines are included in Appendix A.





King County generates such large numbers of cases that other counties appear to lose significance when shown on a graph scaled to accommodate the King County reports. Therefore, a second graph, excluding King, was produced. This makes it possible to see, for example that the number of occurrences in Snohomish, Pierce or Yakima exceeds that of Spokane by a fairly substantial margin. Similarly, one can assume that if Pierce County agencies had reported at anywhere near the same rate as Snohomish County agencies, that the former would clearly have far exceeded the latter in number of occurrences.




Child Abuse by Victim Age

### CHILD ABUSE BY RELATIONSHIP

To show the significance of the non-family member in reported cases of child abuse, particularly sexual abuse, we combined the categories: neighbor, acquaintance and other known into a single "Other Known" category and bar on Graph 3. While "Other Known" accounts for only six percent of physical abuse cases and a mere one percent of neglect cases, it is the largest single offender category for sexual abuse, 35% of reported cases.














Victim Age

# HOMICIDE

"...the unlawful and malicious killing of one human being by another; any killing done while committing another felony."

"A person is guilty of homicide by abuse if, under circumstances manifesting an extreme indifference to human life, the person causes the death of a child or person under sixteen years of age..., and the person has previously engaged in a pattern or practice of assault or torture of said child..." (RCW 9A.32).

### HOMICIDE

As pointed out in the Summary, all of the juvenile victims of homicide during the reporting period were age 7 or younger.

All alleged homicide offenders were age 30 or younger; 5 were under 21.

In 9 of the 12 instances in which the identity of the alleged offender has known, the offender was a member of the victim's immediate family. In two of the three remaining instances the alleged offenders were "mother's boyfriend" and "father's girlfriend."

# AGGRAVATED ASSAULT

"Serious physical injury by other than accidental means, which causes death, disfigurement, major skin bruising, impairment of physical or emotional health or loss or impairment of any bodily functions. (Examples: broken bones, fractured skull, burst spleen, blindness from shaking, immersion burns.")

### AGGRAVATED ASSAULT

- More than one-third of reported victims were less than six years old.
  - There appears to be a very significant decline in aggravated assault victimizations beyond the age of 14.

Seattle/King County, with about one-third of the state's juvenile population covered by the reporting agencies, accounted for about 53% of the reported cases.

Blacks were disproportionately represented among both victims (16.1%) and offenders (16.5%). Blacks constitute about 3% of the states population.

The younger offenders included in this table were alleged to have assaulted infants or very young children. Inclusion of a young offender does not indicate one who had injured a peer.

Instances of aggravated assault involved a much broader span of victim/offender relationships than did homicide, but it is evident that serious assaults, like homicides, tend to be a family affair. Less than 10% of reported aggravated assaults were allegedly perpetrated by someone outside the extended family.

# SIMPLE ASSAULT

"Simple assault resulting in minor physical injury not requiring hospital treatment (excluding reasonable parental discipline which is not injurious to a child's health.)"

### SIMPLE ASSAULT

As indicated in the definition, any instances in which assault against a child might be considered "reasonable parental discipline" were deleted from the data base.

One-third of the victims of simple assault were under six years of age.

Simple assault, like other forms of physical abuse, tends to be perpetrated within the extended family. Mothers and fathers accounted for nearly 60% of the cases of alleged simple assault. Family members (including father's girlfriend and mother's boyfriend) accounted for about 90% of the reported cases.

Males were the alleged offender in a greater proportion of the simple assault cases (58.3%) than in other forms of physical abuse.

King County/Seattle accounted for 54% of the reported cases.

# **SEXUAL ABUSE**

#### SEXUAL ABUSE

In the sexual abuse category, there are 531 children who were rape victims. The 483 alleged offenders included 95 acquaintances, 35 babysitters, 42 mother's boyfriends, 33 neighbors, 48 stepfathers and 58 other known persons.


There were 1,564 victims of molesting. The alleged offender profile includes 229 fathers, 215 acquaintances, 153 other known persons, 108 stepfathers, 91 mother's boyfriends, 85 babysitters and 83 uncles.

Of the 190 incest victims, 174 were female and 16 male. Alleged incest offenders were overwhelmingly male, 159 of 161. 74 were fathers, 49 brothers, and 5 grandfathers.


77 children were victims of indecent exposure.




Sexual Abuse by Victim Age

Sexual Abuse by Relationship



# RAPE

"Sexual intercourse or attempted sexual intercourse with a person, forcibly and against their will."

- One-hundred fifty-nine rape victims, nearly 30% of the total, were under 6 years of age.
- Twenty-two percent of the victims of rape were male, 78% were female.
- Minorities, as both alleged offenders and victims, were at a level consistent with their population of the total population of the state.
- Seventy-six of the alleged offenders, about 16% of the total, were under the age of 16.
  - The largest category of alleged offenders was composed of persons outside the family, but known to the victim. The group, including neighbor, acquaintance and other known, accounted for 190 offenses, 39% of the total. If babysitters are added, this category accounts for 225 offenses, 46% of all reported rapes of children.
  - Males are the alleged offenders in 93% of the cases.
    - King County/Seattle accounted for fewer reported rapes than their proportion of the state's population would lead us to expect.

# STATUTORY RAPE

"Carnal knowledge or attempted knowledge of a person with no force used and the victim is under the legal age of consent."

### STATUTORY RAPE

- Victims in about two-thirds of the reported cases were 13 to 15 years old.
- Eighty-four percent of the victims of this offense and 8 percent of the offenders are female.
  - The alleged offenders in three-fourths of the reported cases of statutory rape were known to the victim, but were outside the extended family.
  - Offender ages tend to be clustered in the 19 through 22 age group (28 offenders or 33% of the total).

There was no discernible geographical pattern to this offense. Although the city of Vancouver and Thurston County agencies appeared to have reported a disproportionately high number of offenses, total numbers were too small to be of significance.

# **MOLESTING** (Indecent Liberties)

"... knowingly causes another person who is not his spouse to have sexual contact with him or another:

a) By forcible compulsion; or

(b) When the other person is less than fourteen years of age; or

c) When the other person is less than sixteen...and the perpetrator is in a position of authority over the person;"

# MOLESTING (INDECENT LIBERTIES)

- This offense appeared to have a higher proportion of offenders with multiple victims than did other physical and sexual offenses.
- More than one-fourth (27.2%) of the victims were under six years of age.
- About three-fourths of the victims of this offense were female.
- Ages of alleged offenders as a percentage of total offenders:

Forty-one percent of the known offenders were persons known to the victim but outside the extended family. Fifty-nine percent were members of the extended family.

# **INCEST**

"Sexual intercourse between persons who are so closely related that they are forbidden by law to marry."

#### INCEST

- Females were the victims in 92% of the reported cases of incest.
- Males were the offenders in 99% (159 of 161) of the cases.
- Whites were victims in 89% of reported cases. Whites comprise 90% of the state's population.
- Most victims (63%) were age 10 or older at the time the offense was reported.
- Fifteen percent of victims were under age 6.
- In cases where race of the alleged offender was known, Whites comprised 86% of identified offenders.
  - In cases where the age of the alleged offender was known, one-third of the identified offenders were under 18 (44 of 136).
  - The next largest age grouping of offenders was 30-39 with 40 of 136 or 29% of the identified offenders.
    - Thurston County appeared to have had a disproportionately high number of incest cases reported during the study period.

- Twenty-five of twenty-six victims whose ages were known were age 15 or younger.
- All identified offenders were male.
- Offenders ages tended to be under 30 (39%) or over 50 (50%).
- Only one of the alleged offenders was identified as a member of the victim's immediate family (step-father).
  - Three of the 18 jurisdictions in which reported offenses occurred were served by sheriff's departments, the remaining 15 (83%) were urban areas, reported by police departments.



- There were 175 victims of abandonment, 96 of the 116 alleged offenders were mothers, 12 were fathers.








# Neglect by Victim Age

### ABANDONMENT

- Fifty-one percent of reported victims of abandonment were male, 44% were female.
- Forty-nine percent of reported victims were White, 37% were Black, four percent were Native American.
- Fifty-seven percent (100 of 175 reported victims) were under six years old, 47 or 27% of the total were less than two years of age. Only six percent were 13 or older.
- Ninety-nine of the 116 alleged offenders were female (85%).
- More than one-third of the alleged offenders were 20 to 29 years old.
  - One aunt, one uncle, and two other known persons were the only non-parent figures of the 113 known offenders. Parent figures accounted for 96.5% of the instances in which the identity of the alleged offender was known.

#### NEGLECT

- Fifty-three percent of the reported victims of neglect were male, 44% female. In three percent of the cases the sex of the victim was unknown.
- Sixty-two percent of reported victims were white, 17% black, six percent other minorities and 14% unknown.
- Three hundred sixty-nine victims, 58.5% of the total, were less than six years old.
- More than three-fourths of the offenders in reported cases of neglect were females (344 of 445, 77.3%). Mothers were accused in more than 73% of the cases.
  - Racially, Whites were the alleged offenders in 63% of the cases, Blacks 13%, Native Americans 5%. In 17.5% of the cases the race of the offender was unknown.
  - Offenders were concentrated in the age range 19 through 30, indicating that young mothers of young (under 6) children constituted the most frequent offender group.
- Forty-four percent of the reported incidents of neglect took place in King County. Seattle, alone, accounted for 24% of the reports.
- Bellingham, Walla Walla and Port Angeles appeared to be high, proportionately, in reports of neglect during the study period.
  - Everett was unique among cities of comparable size with only one report.

- Sixty-three percent of victims were White, 21% Black, six percent other minorities.
- Fifty-seven percent (189 of 332) of victims were less than six years old. Only 7.5% were over the age of 12.
- Nearly three-fourths (71%) of alleged offenders were female, 162 or 66% were mothers.
- As with neglect, the cities of Bellingham, Walla Walla and Port Angeles appeared to have had a disproportionately high number of Failure to Provide reports during the study period. Aberdeen, which did not appear high in neglect complaints joined the other three cities in appearing to have a high rate of Failure to Provide reports.
  - Seattle accounted for nearly one-fourth of the cases reported.

By virtue of a grant from the Governor's Juvenile Justice Advisory Committee WUCR will collect from law enforcement agencies (on a voluntary basis) child abuse data from January -June 1988.

The following are some guidelines for reporting. Please call if you have <u>any</u> questions.

1. DEFINITION: CHILD - CHILD ABUSE RCW 26.44.020 (1987), (6), (12).

(6) "Child" or "children" means any person under the age or eighteen.

(12) "Child abuse or neglect" shall mean the injury, sexual abuse, sexual exploitation, or negligent treatment or maltreatment of a child by any person under circumstances which indicate that the child's health, welfare, and safety is harmed thereby. An abused child is a child who has been subjected to child abuse or neglect as defined herein: Provided, that this subsection shall not be construed to authorize interference with child-raising practices, including reasonable parental discipline, which are not proved to be injurious to the child's health, welfare, and safety:

And provided further, that nothing in this section shall be used to prohibit the reasonable use of corporal punishment as a means of discipline. No parent or guardian shall be deemed abusive or neglectful solely by reason of the parent's of child's blindness, deafness, developmental disability, or other handicap.

#### GENERAL GUIDELINES

The Supplementary Child Abuse Report (SCAR) is an adaptation of the UCR Supplementary Homicide Report. There are <u>some</u> changes:

#### IMPORTANT:

Complete your monthly regular UCR forms in the usual manner. Part I, Child Abuse Offenses, (homicide, rape, assault, etc.) Clearances and Arrests and Part II, arrests should be classified, scored and tallied in the usual manner, then complete Supplementary Child Abuse Report (also monthly), with detail on <u>all</u> child abuse offense incidents. This is a <u>supplementary</u> report to identify and separate child abuse.

#### I. HOW TO COMPLETE THE FORM

A. BOTTOM OF FORM

Complete all spaces - month, year, agency ID, etc.

B. ZERO CHILD ABUSE TO REPORT FOR THE MONTH

CHECK ZERO BOX in the upper right-hand corner if child abuse incidents are zero. SEND REPORT. This is very important and will save inquiring whether you have zero or did not report.

#### C. MULTIPLE FORMS

Agencies who have more incidents of child abuse than one form will accommodate should use as many as needed. CHECK THE MULTIPLE FORM BOX (upper right hand corner) AND STATE NUMBER OF FORMS USED FOR THE MONTHLY REPORT AND STAPLE.

- II. EXPLANATION OF COLUMNS (Columns will not be numbered on form. Numbered on sample for instruction only).
- A. COLUMN 1 INCIDENT #

Please number each incident sequentially 1, 2, 3, etc.

This column is to separate # of incidents from # of victims/offenders in one incident.
