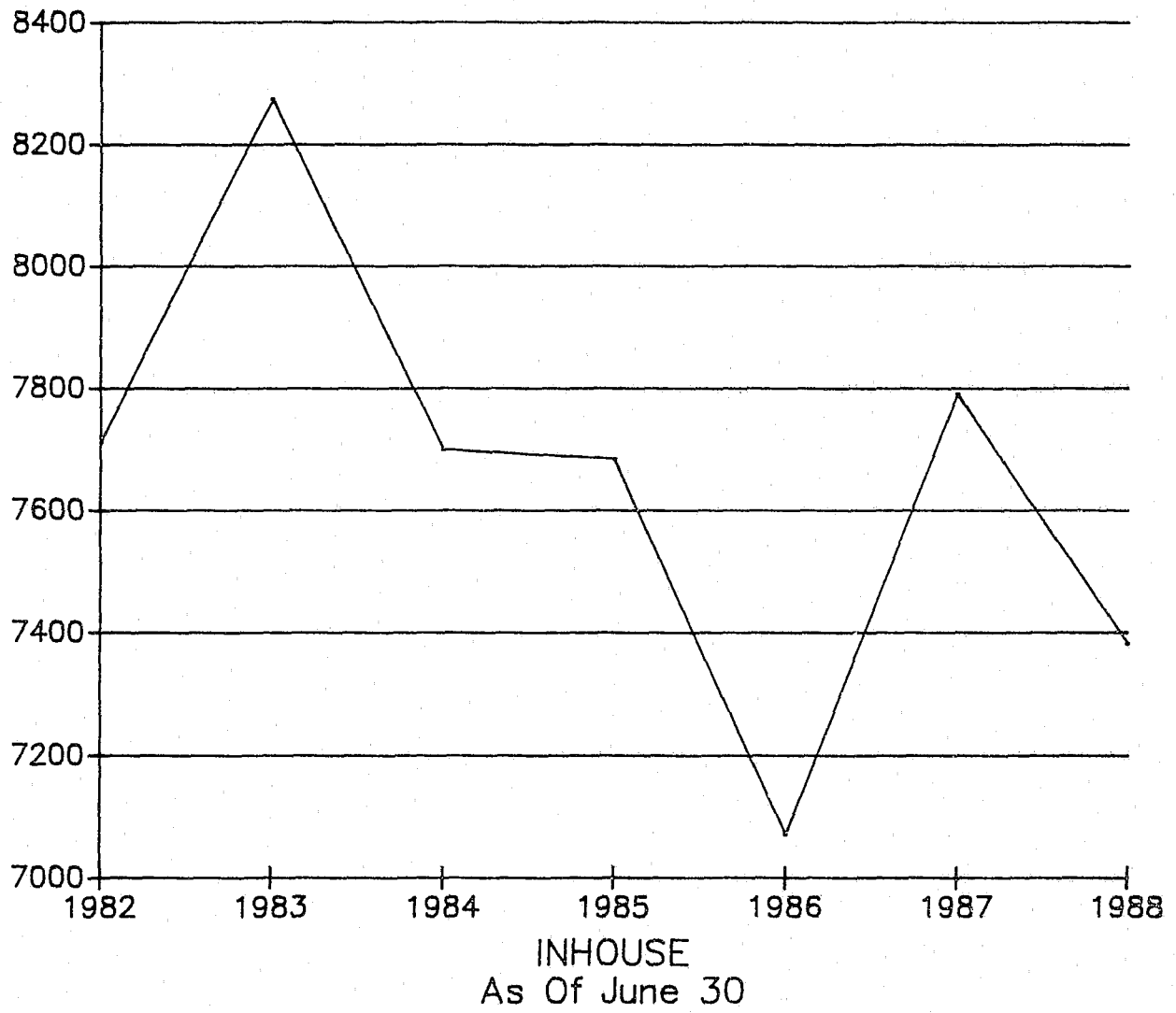

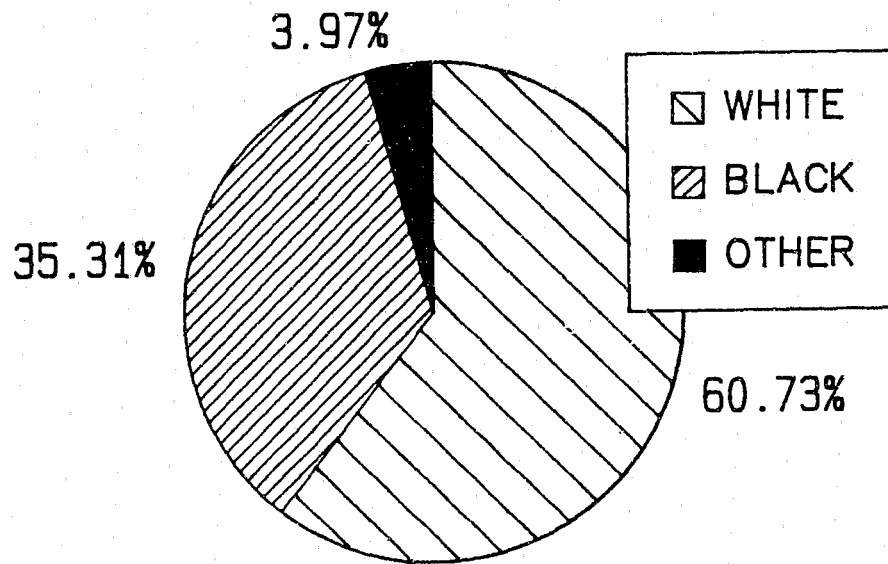

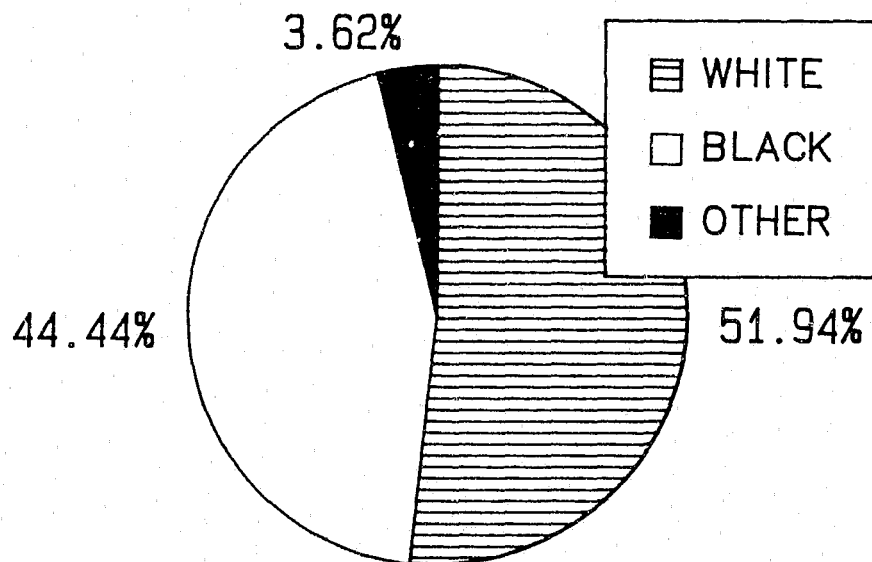
## INMATE POPULATION GROWTH

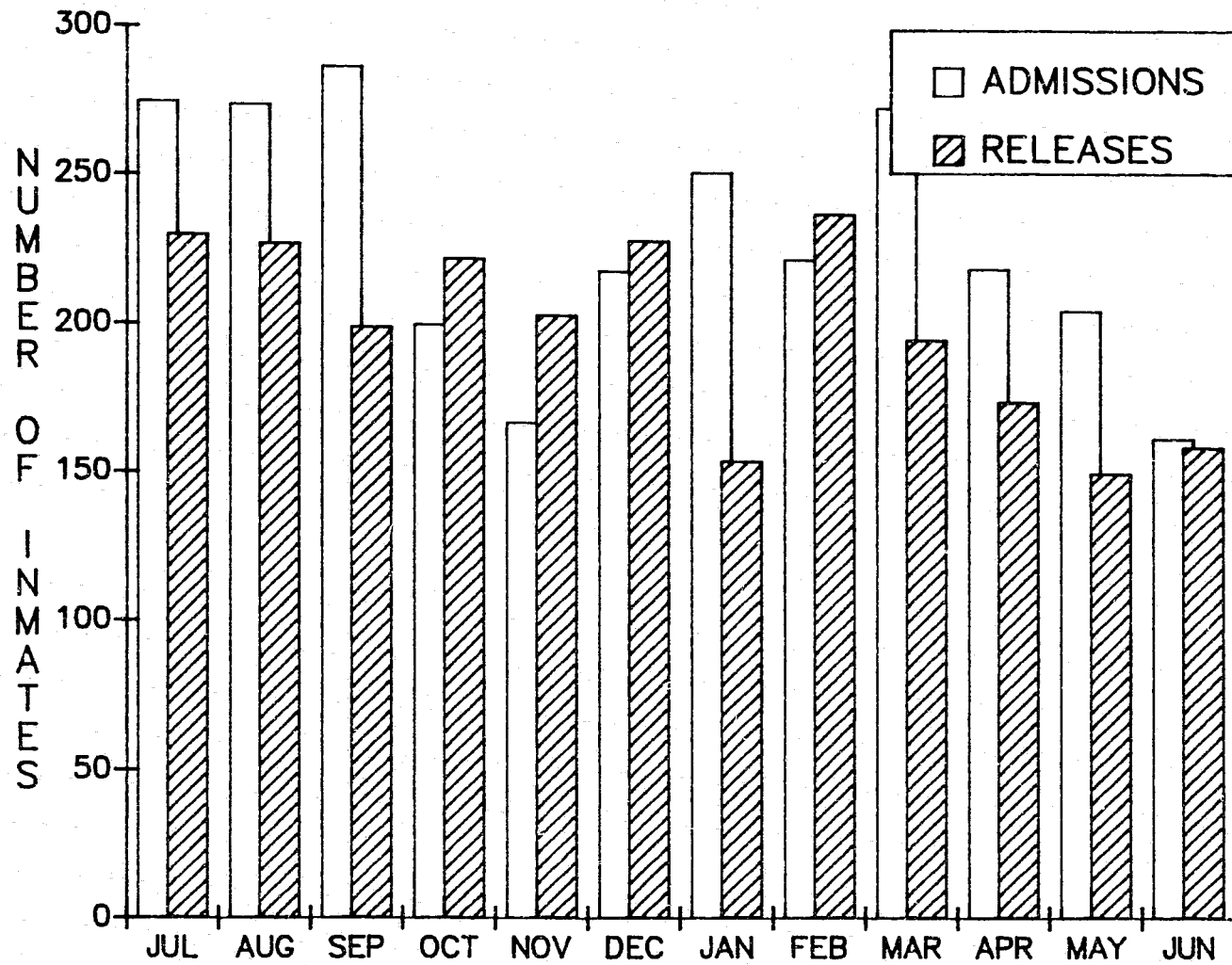

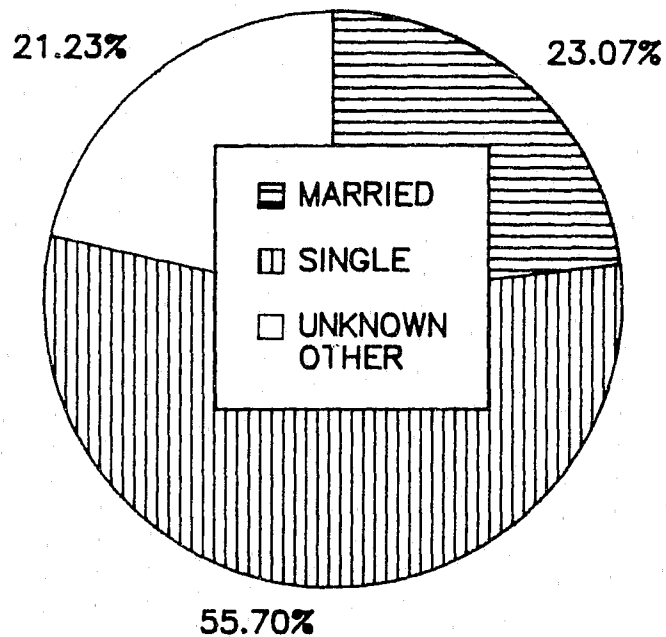

## ADMISSIONS BY MARITAL STATUS



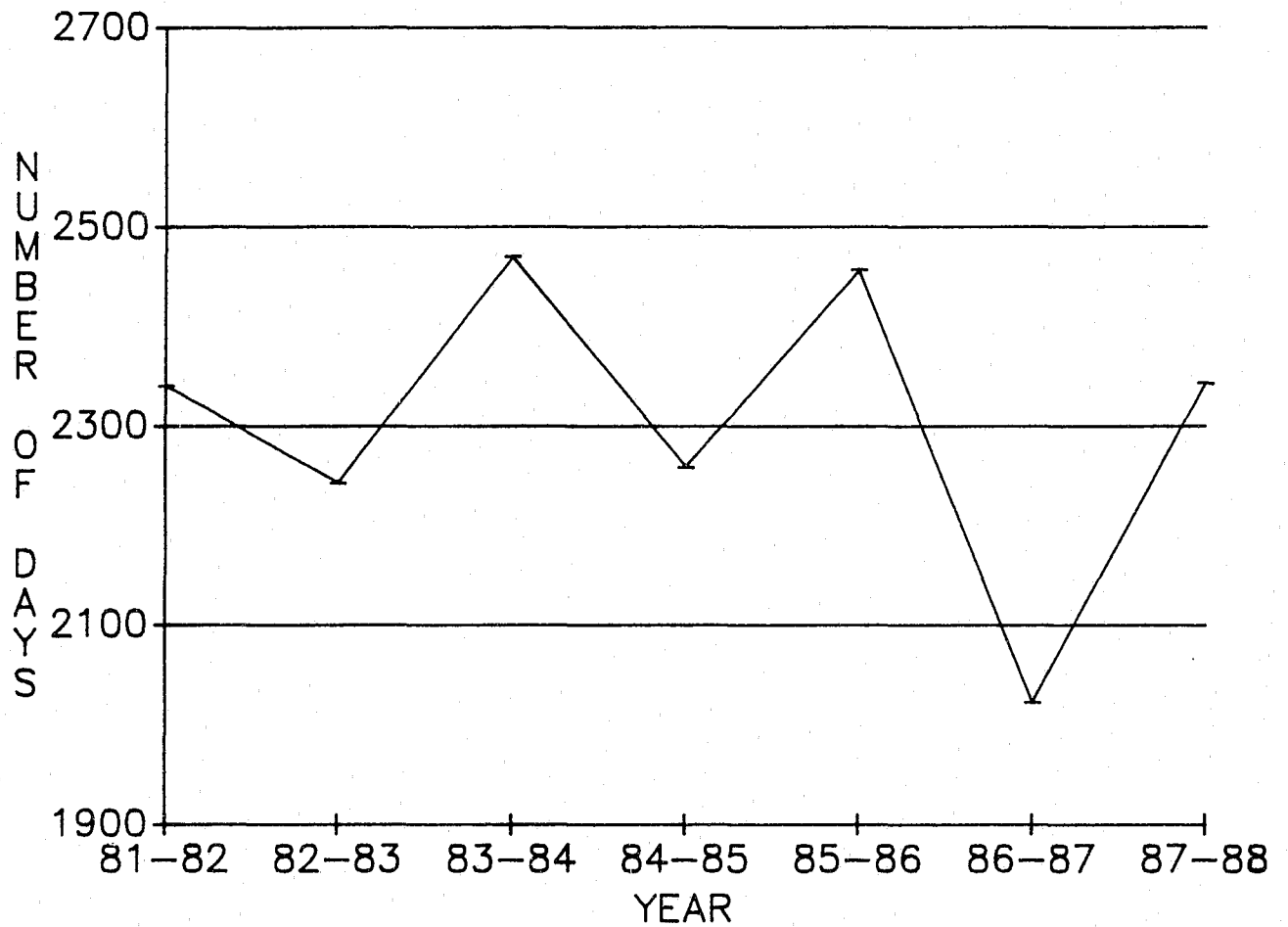

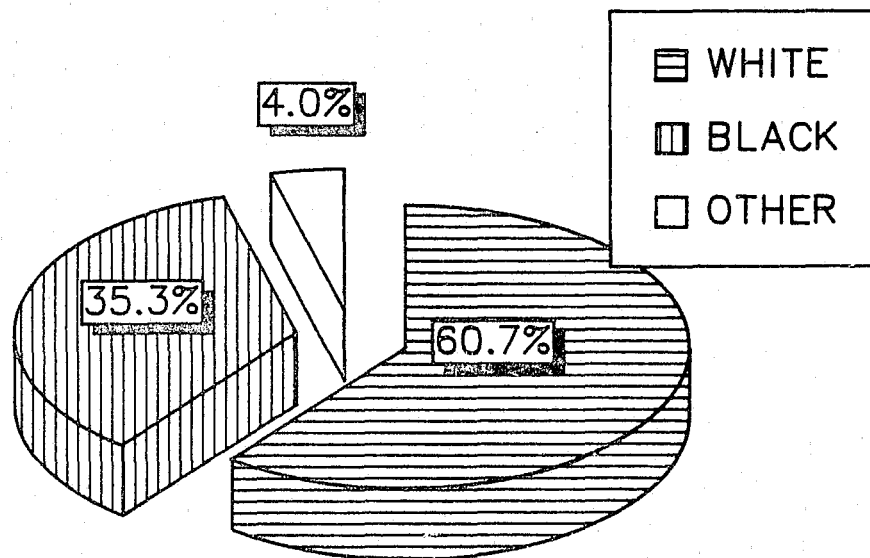

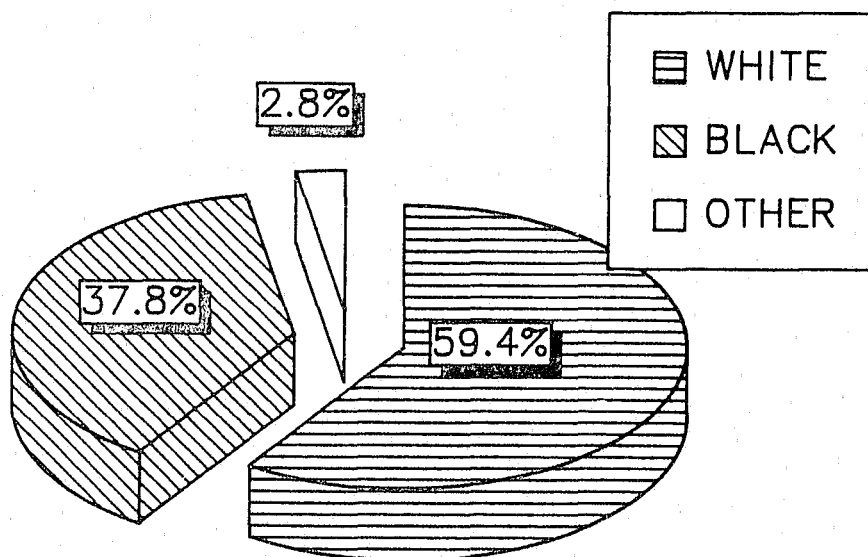
AVERAGE MAXIMUM SENTENCE GIVEN  
FY 1981-82 Through FY 1987-88



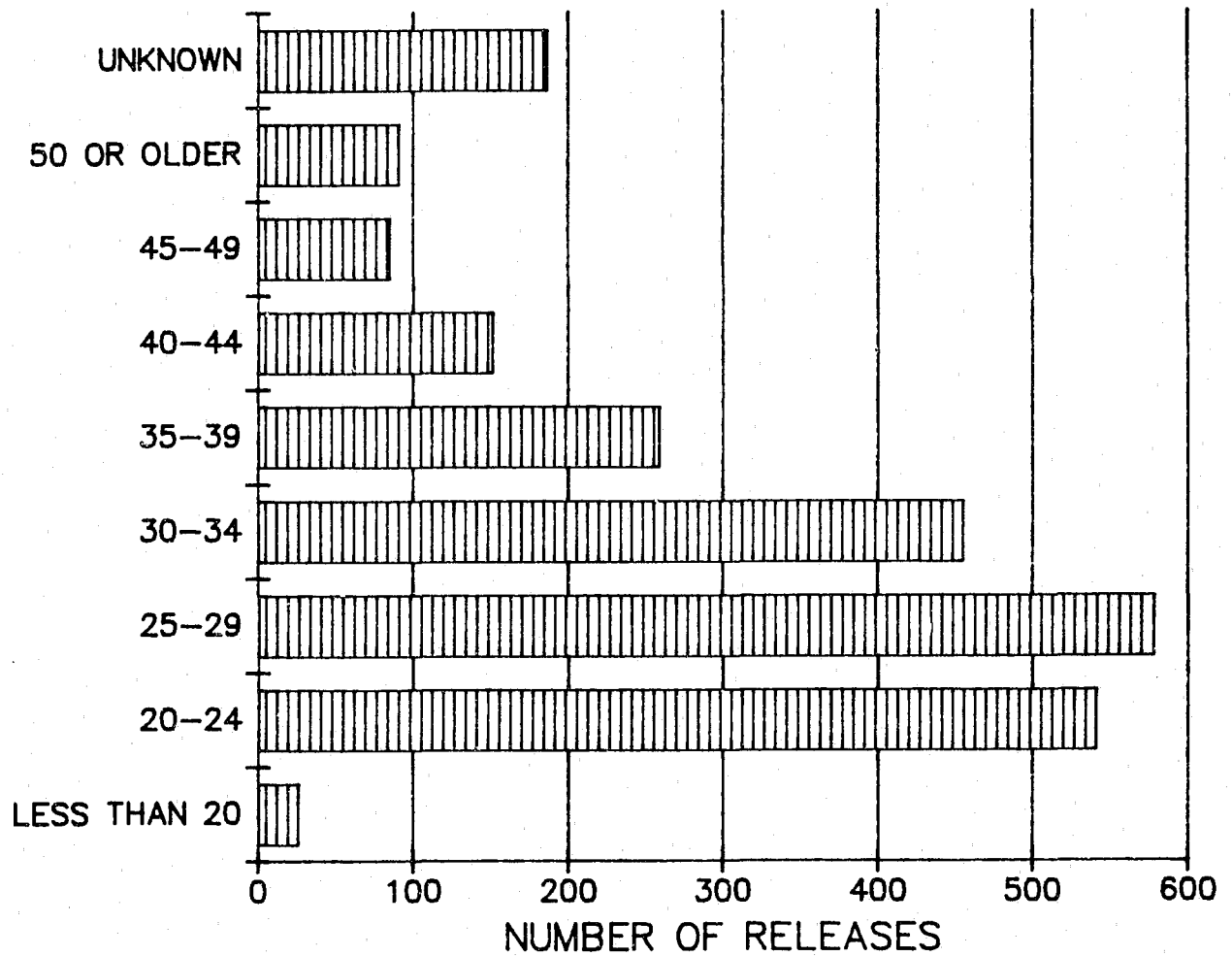
MALE RELEASES BY RACE

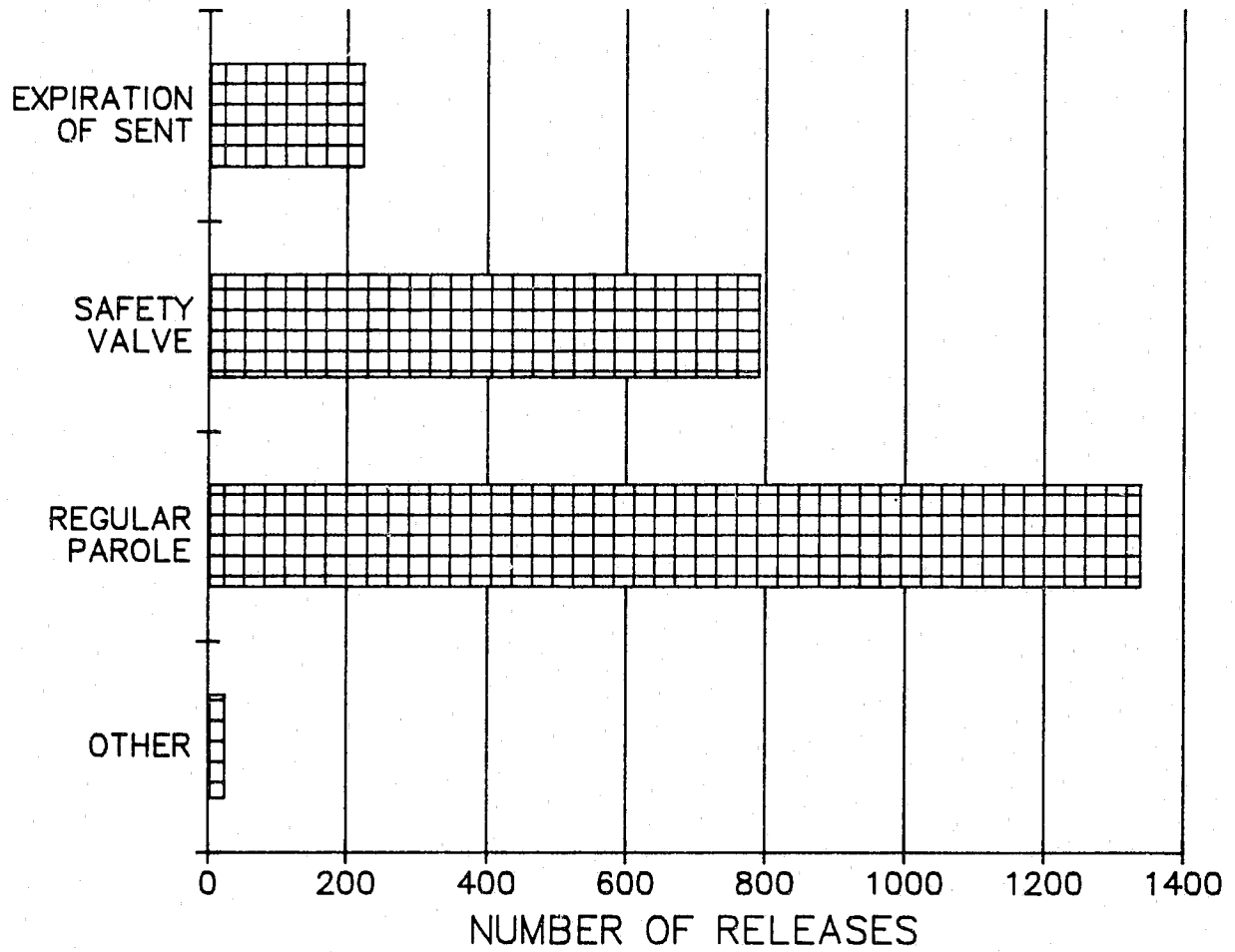

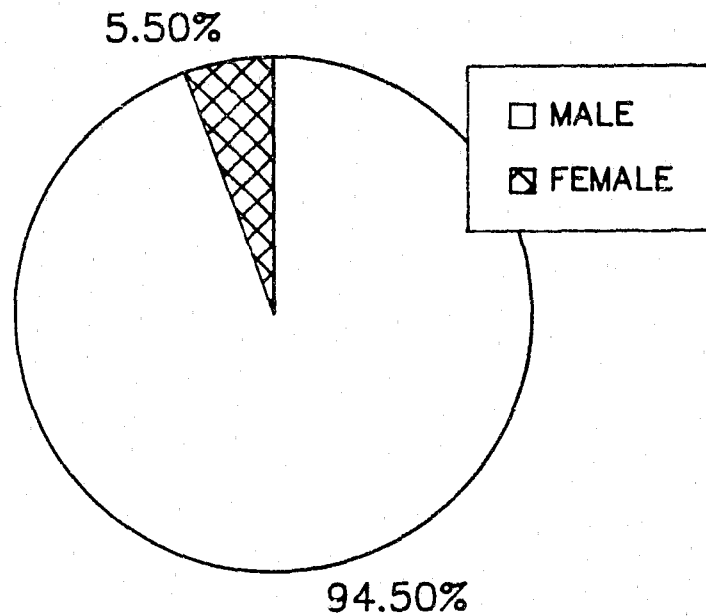

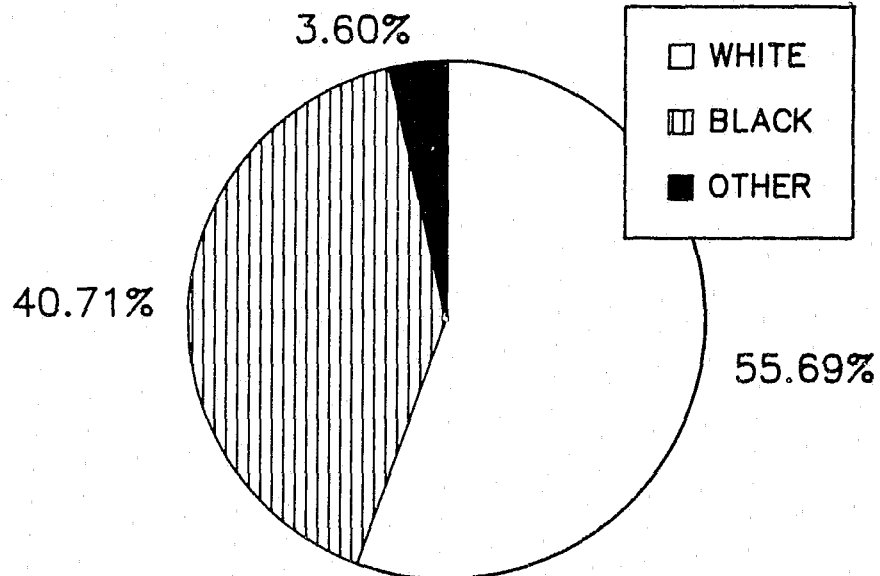

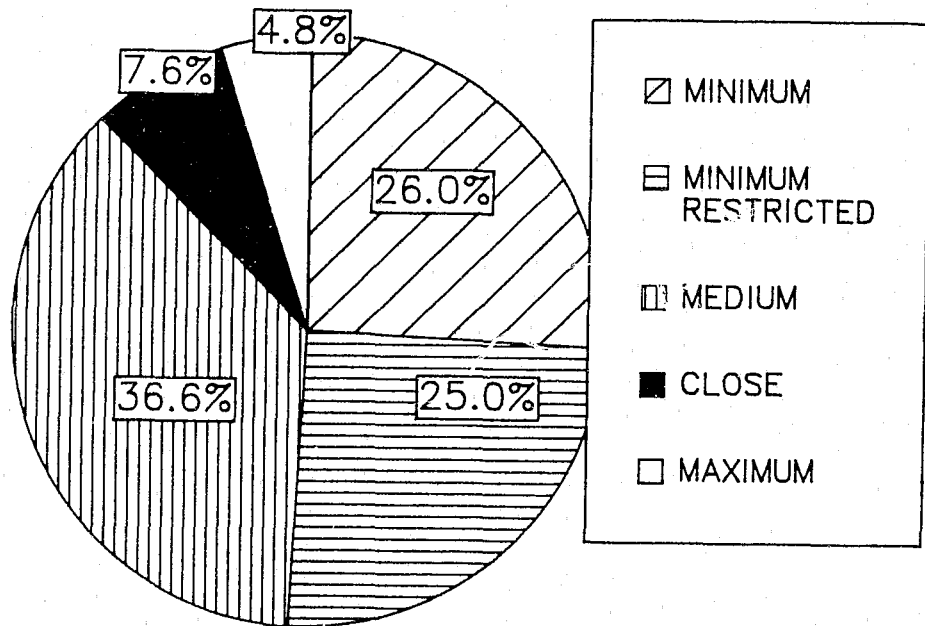
**INMATE POPULATION BY SEX  
As Of June 30, 1988**



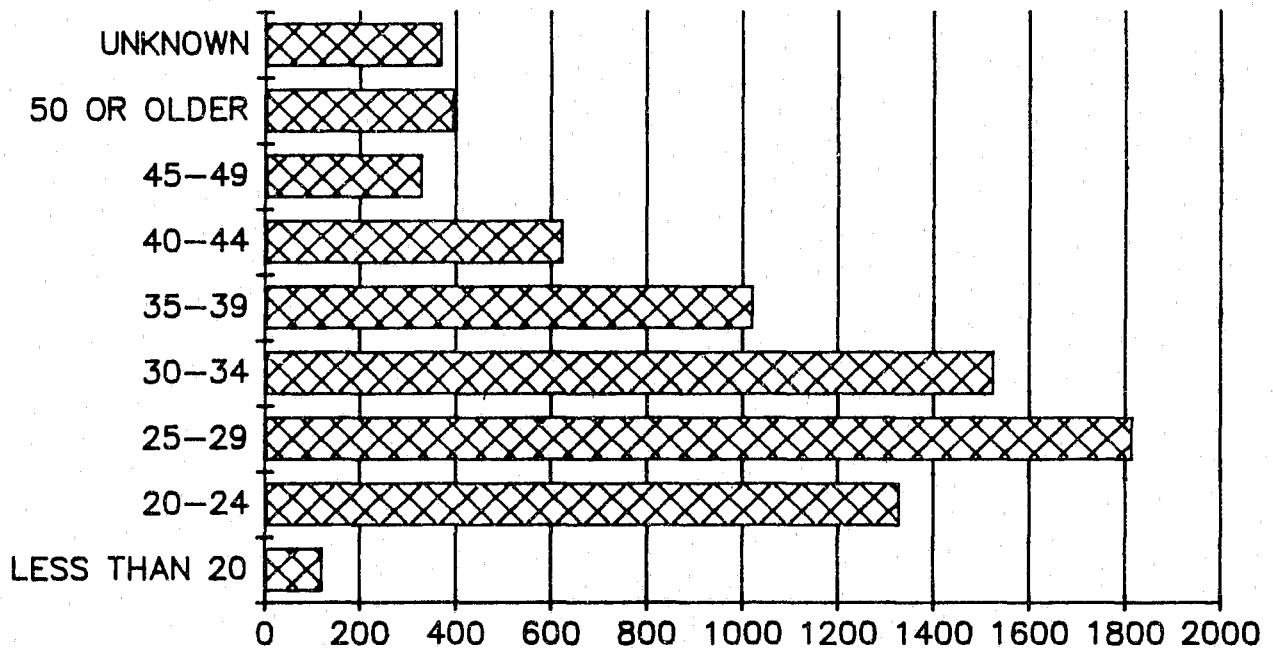
**INMATE POPULATION BY RACE  
As Of June 30, 1988**



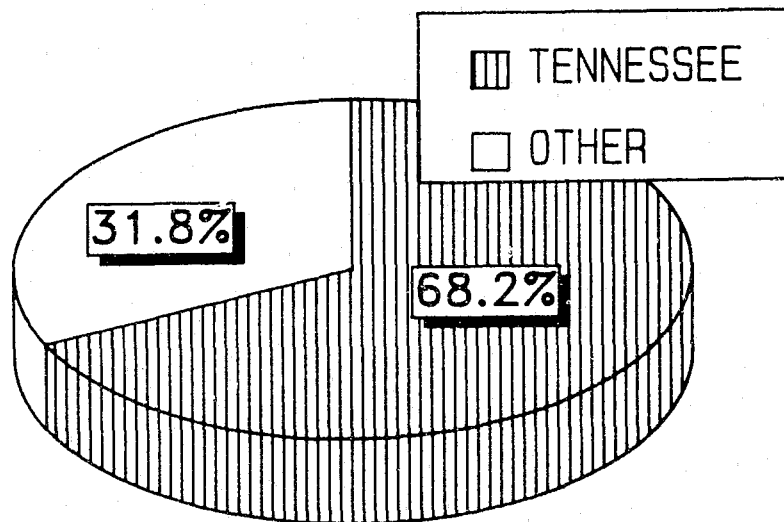
# INMATE POPULATION BY CUSTODY LEVEL As Of June 30, 1988



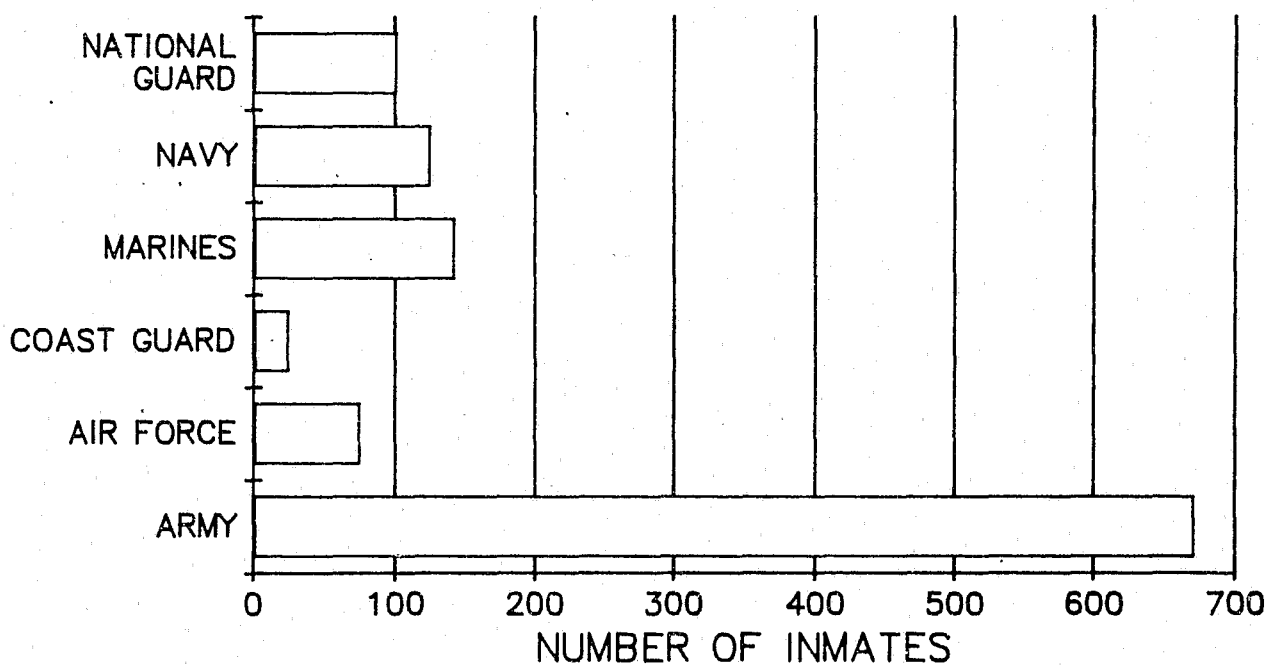
# INMATE POPULATION BY AGE As Of June 30, 1988



# OFFENDERS BY STATE OF BIRTH As Of June 30, 1988



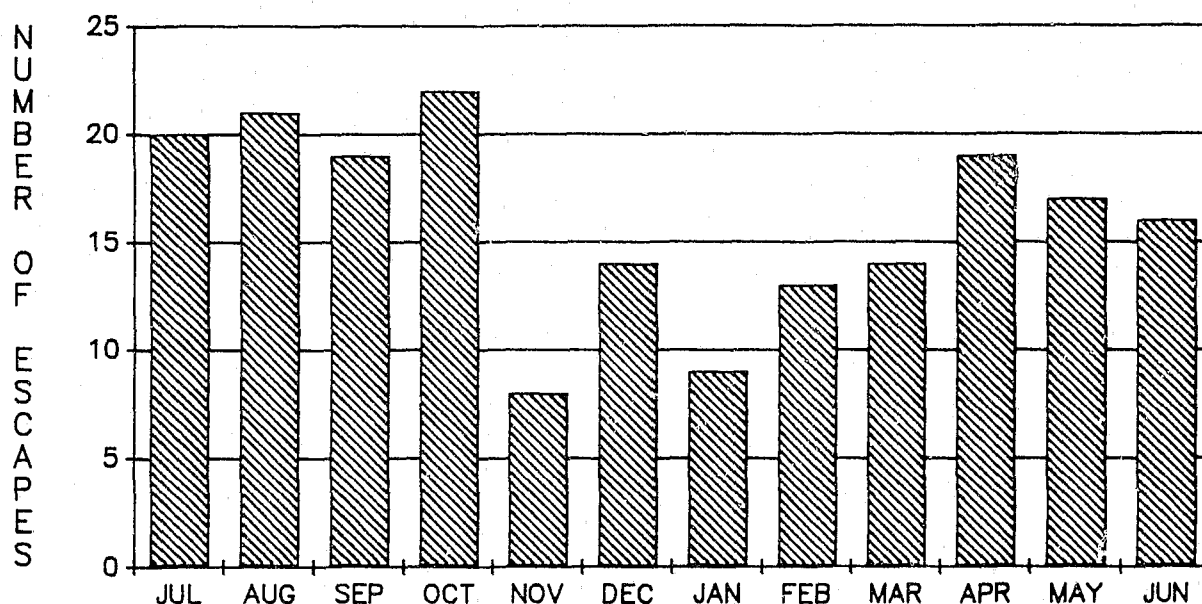

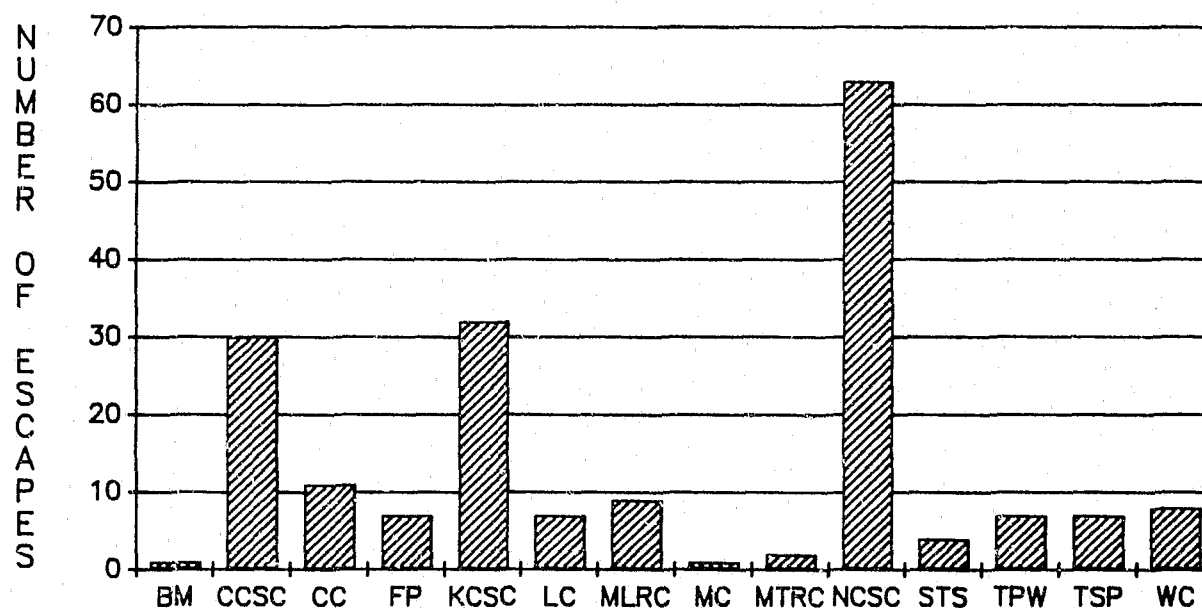

## ESCAPES FROM ADULT INSTITUTIONS By Month (FY 1987-88)

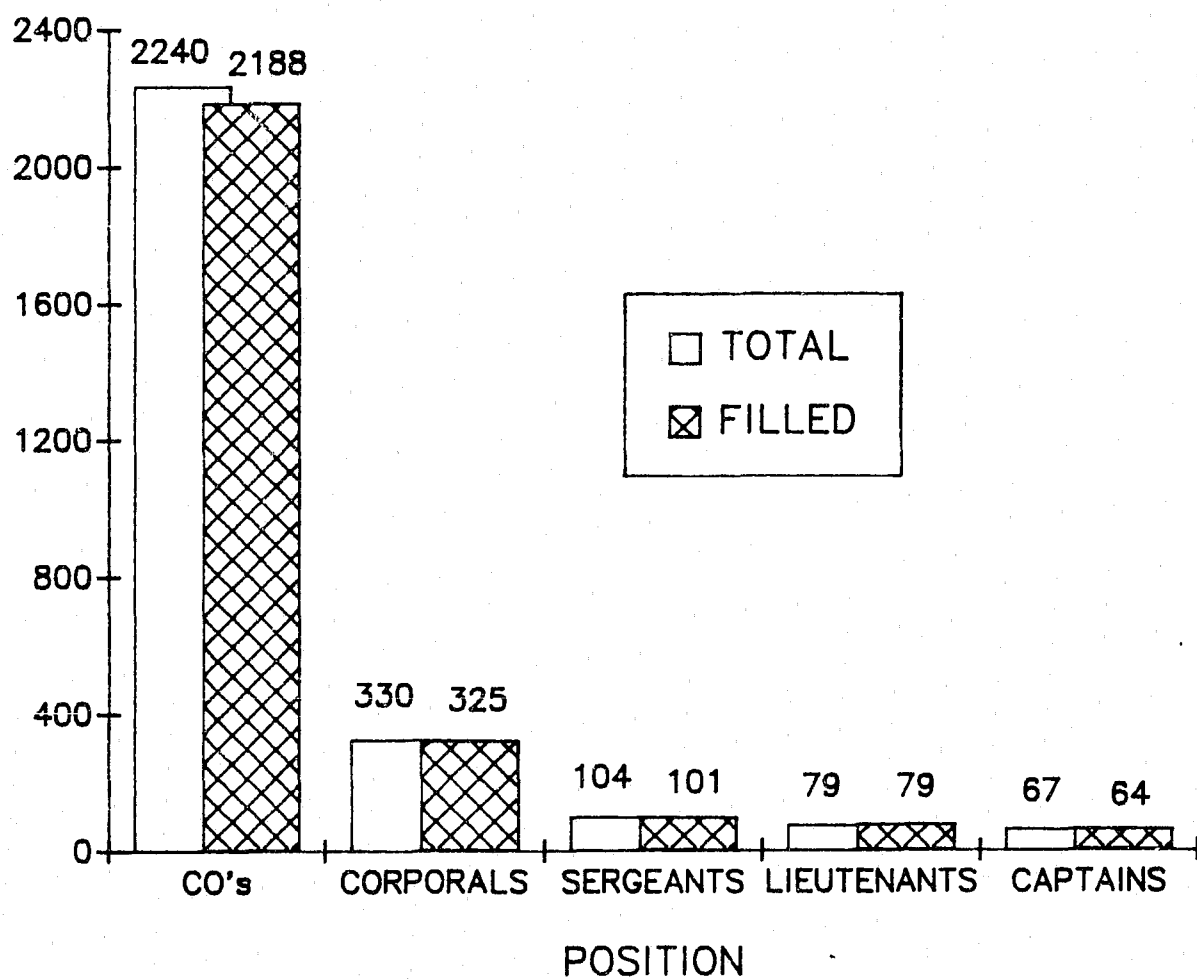


## ESCAPES FROM ADULT INSTITUTIONS By Institution (FY 1987-88)

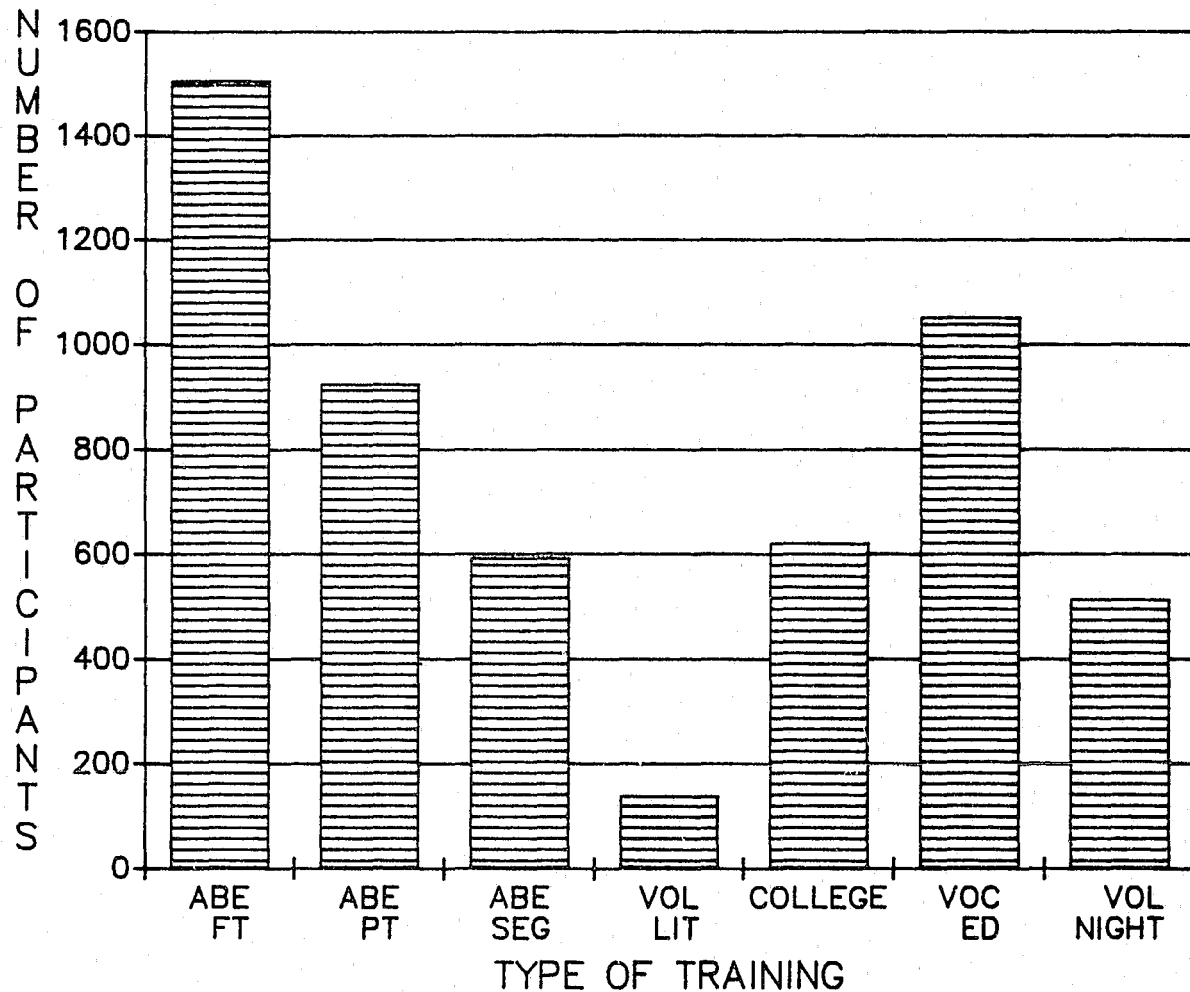

# ADULT INSTITUTION SECURITY POSITIONS As Of June 1988

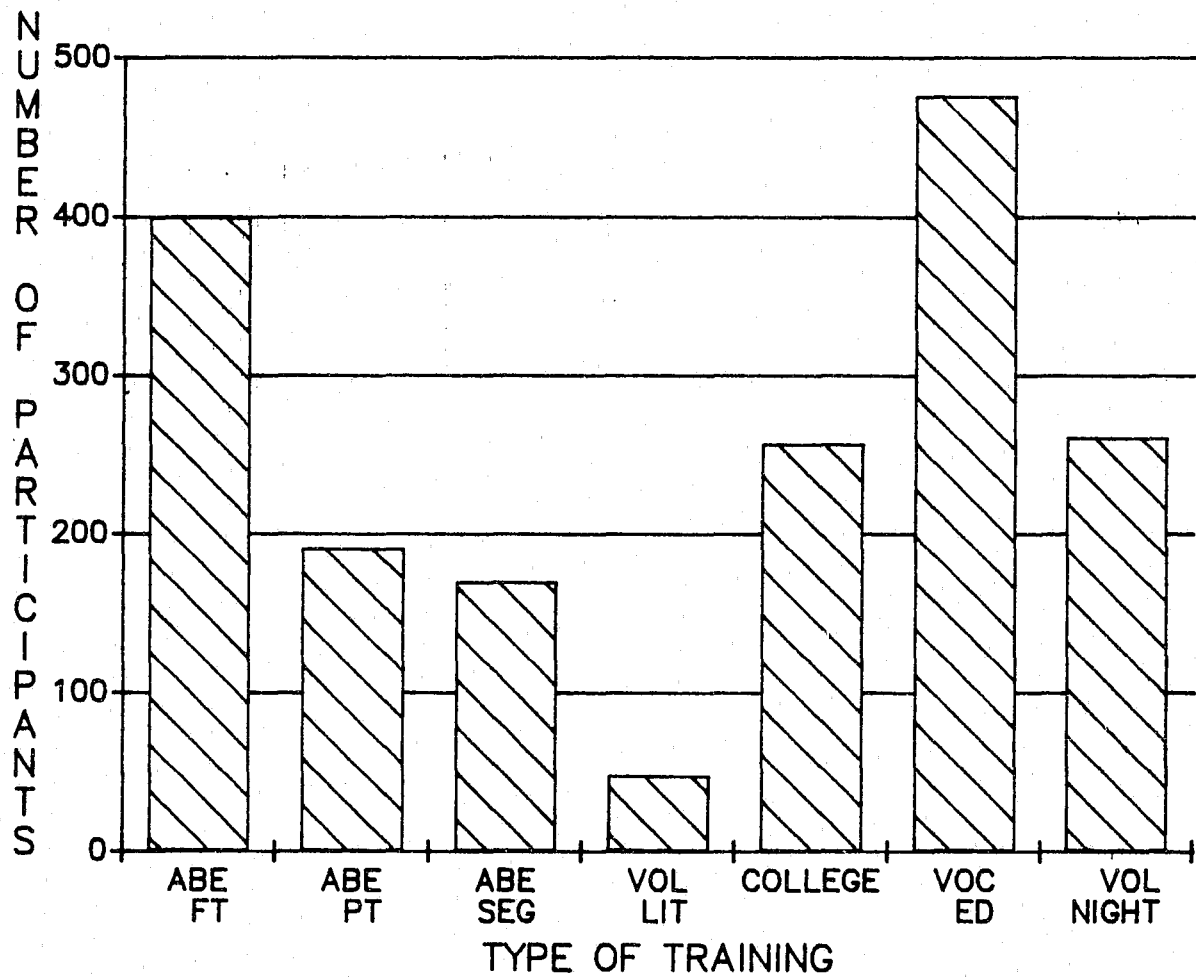


# CUMULATIVE SCHOOL ENROLLMENT Adult Institutions FY 1987-88

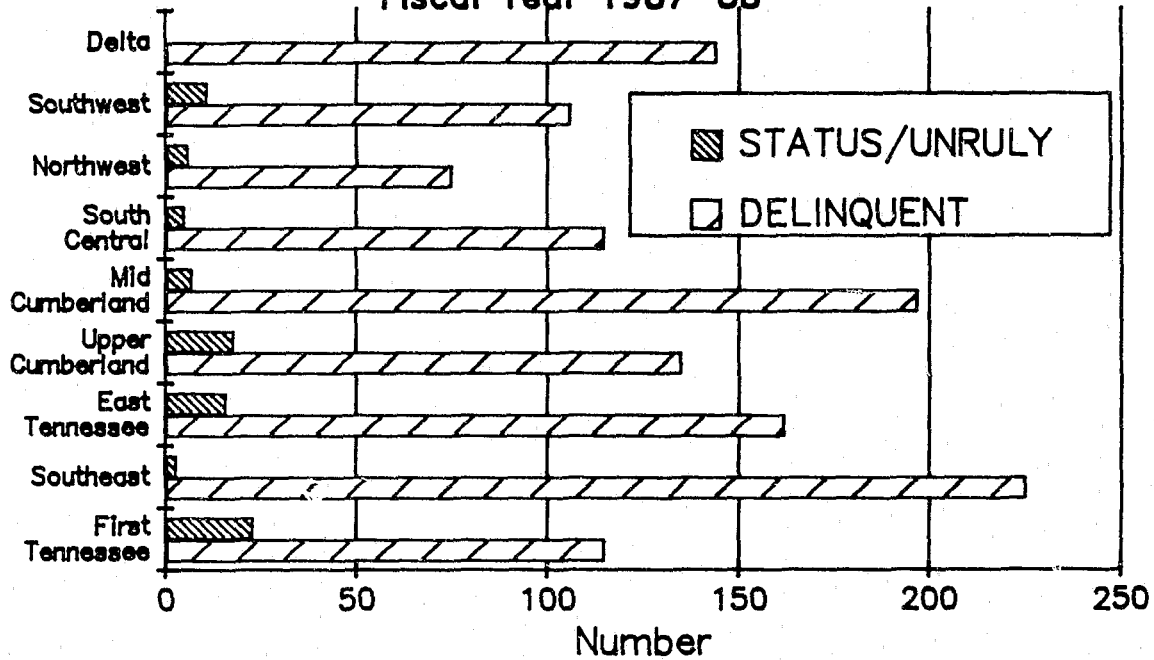

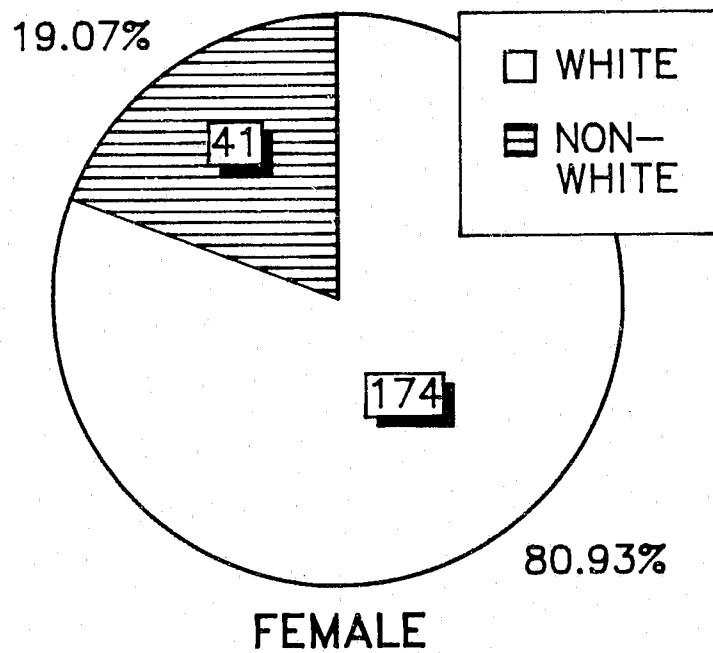
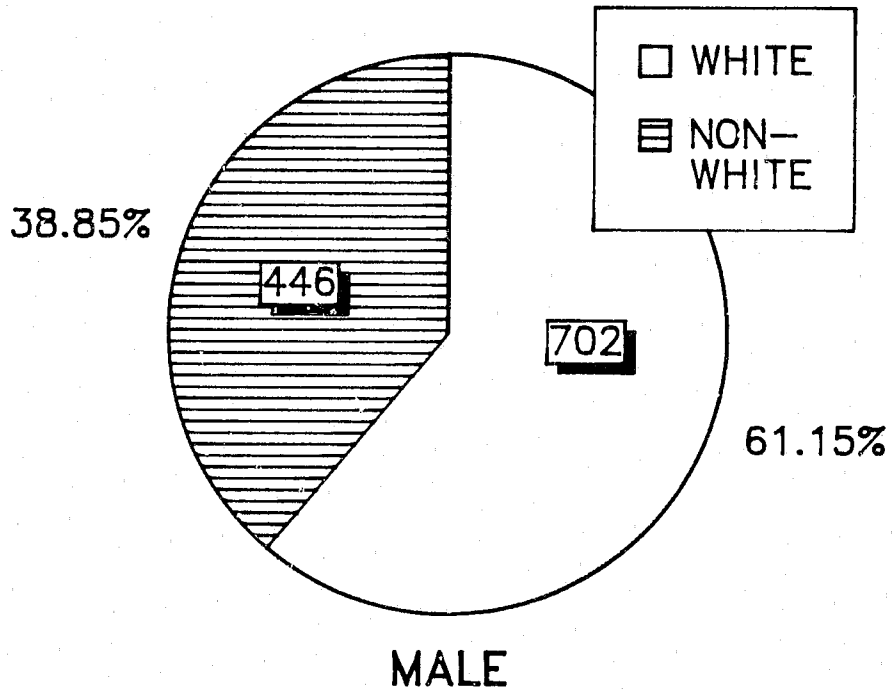


**TOTAL COMMITMENTS AND RECOMMITMENTS

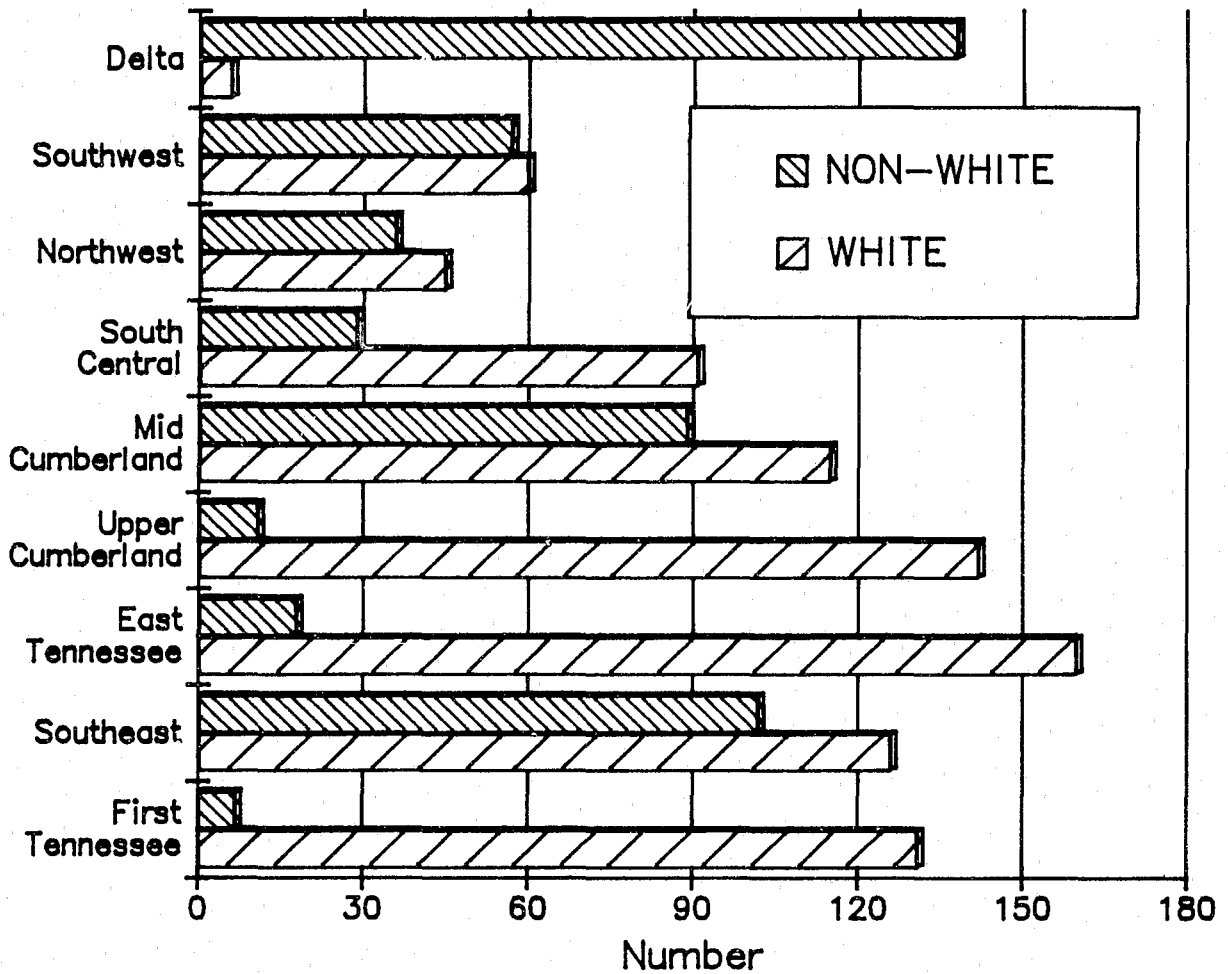


# JUVENILE COMMITMENTS BY RACE

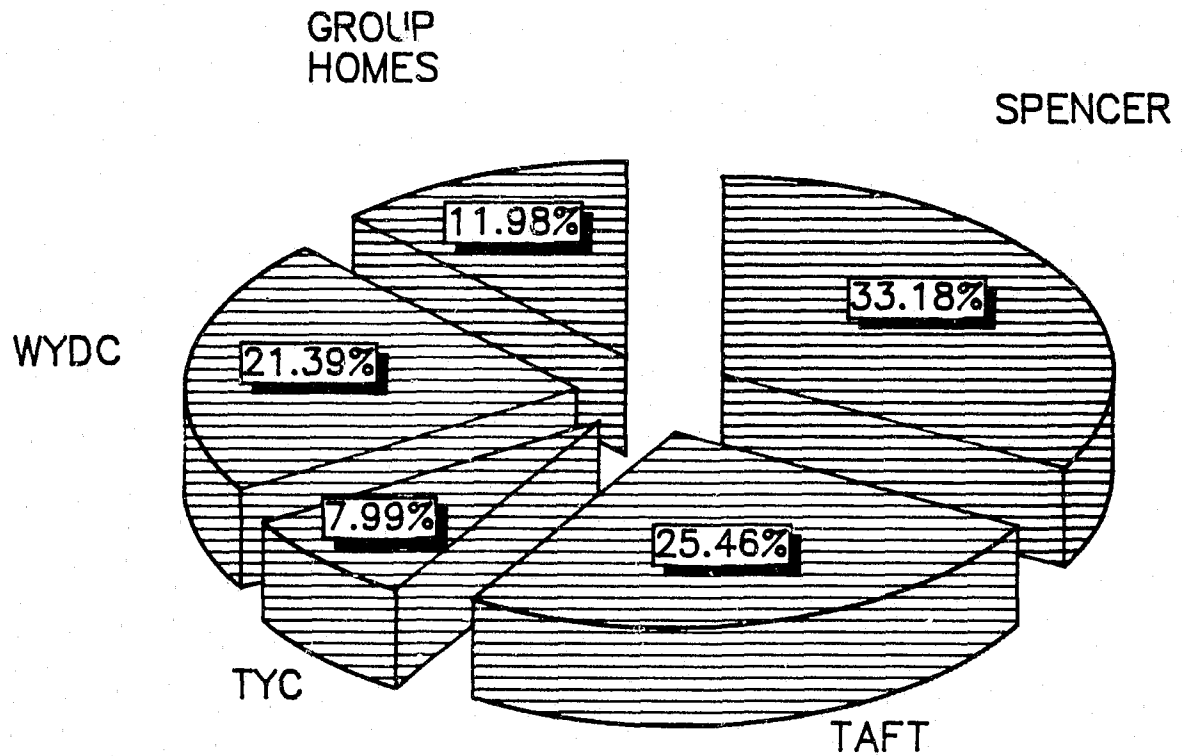

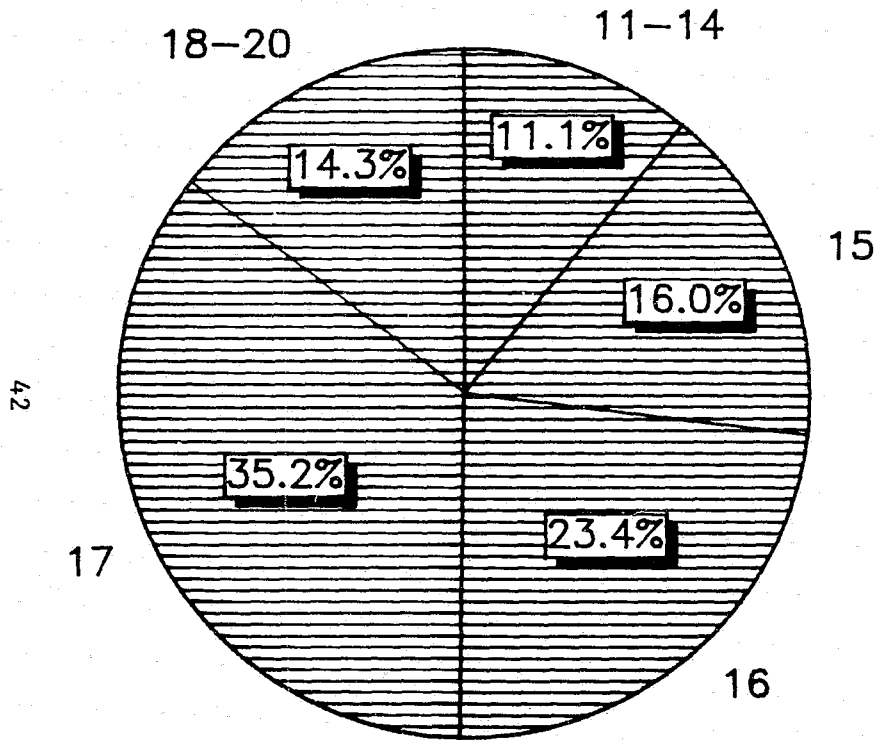

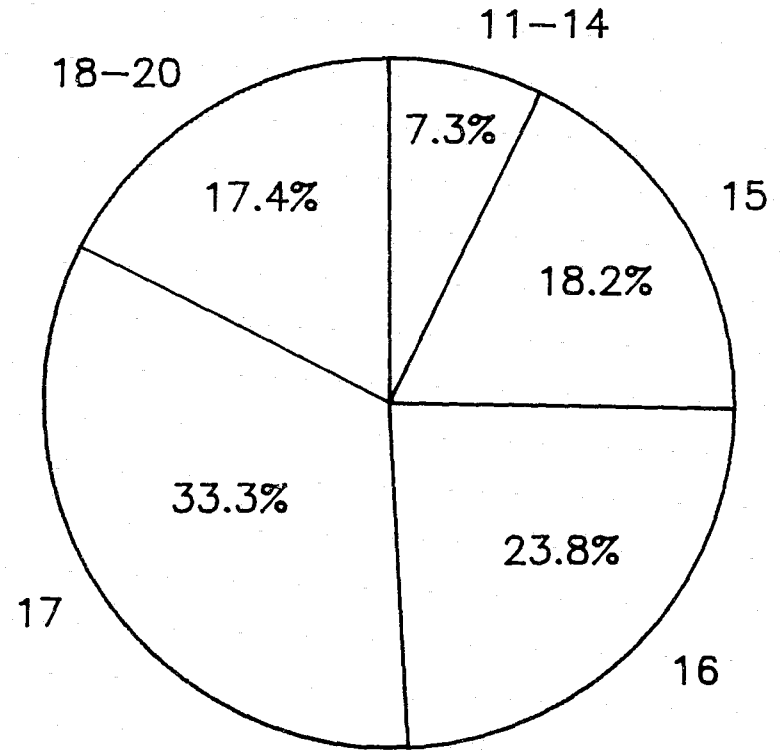
**AVERAGE DAILY IN-HOUSE POPULATION

June 30, 1988**

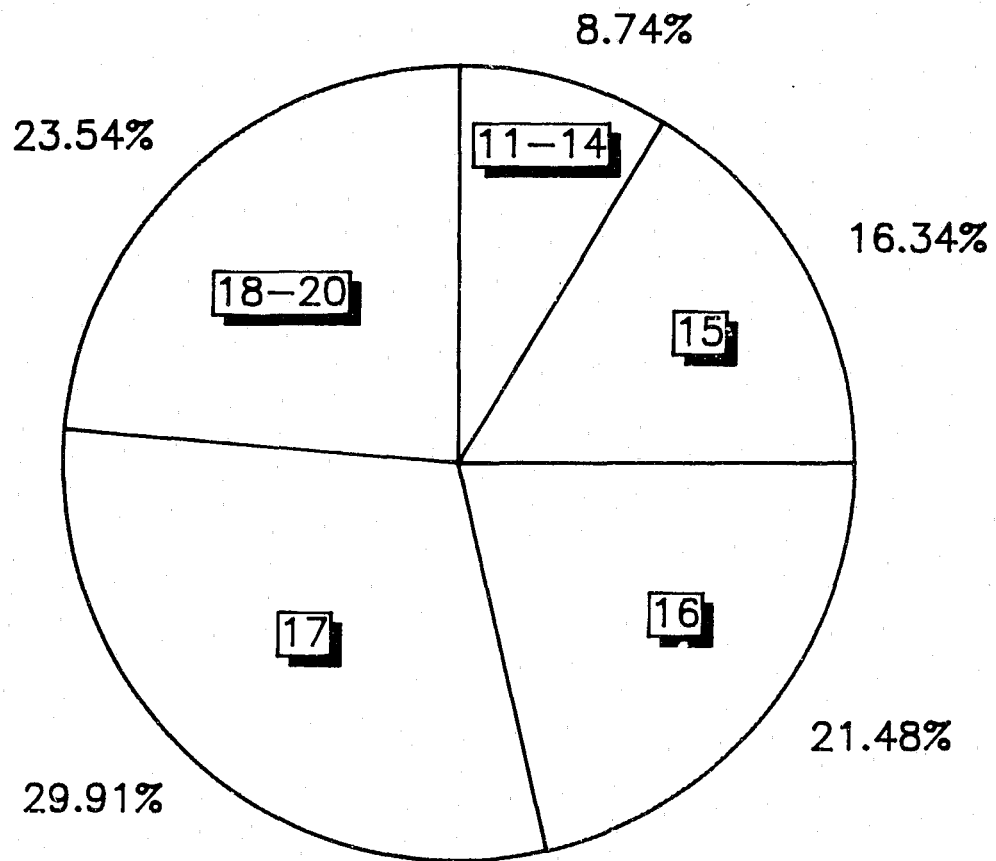

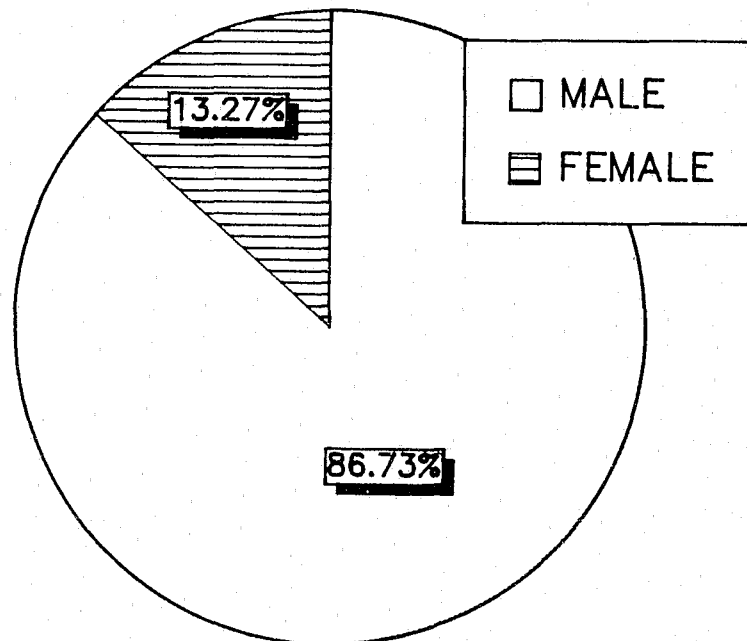

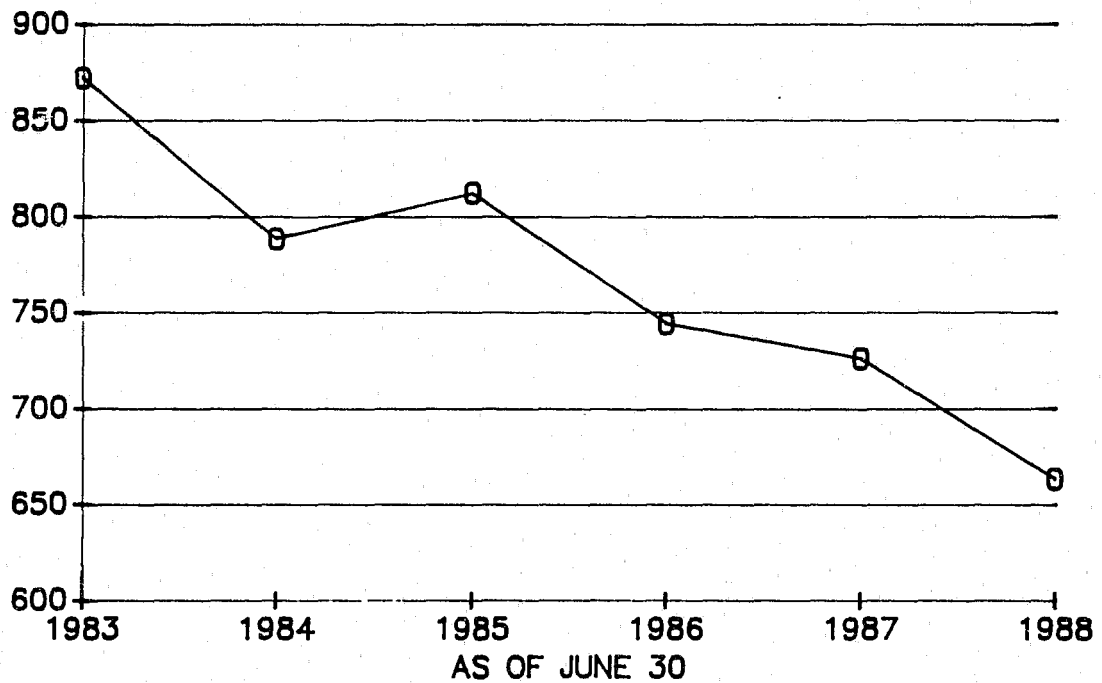
**TOTAL JUVENILE POPULATION BY SEX**

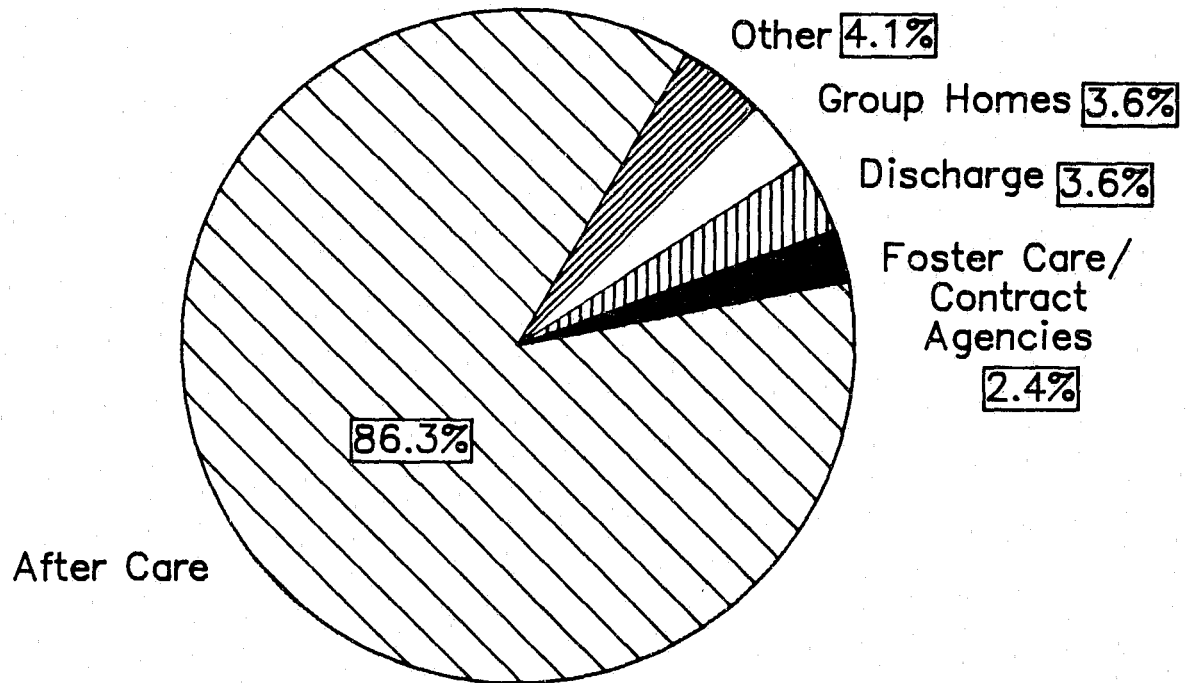
# YEAR END POPULATION VS. CAPACITY As of June 30, 1988

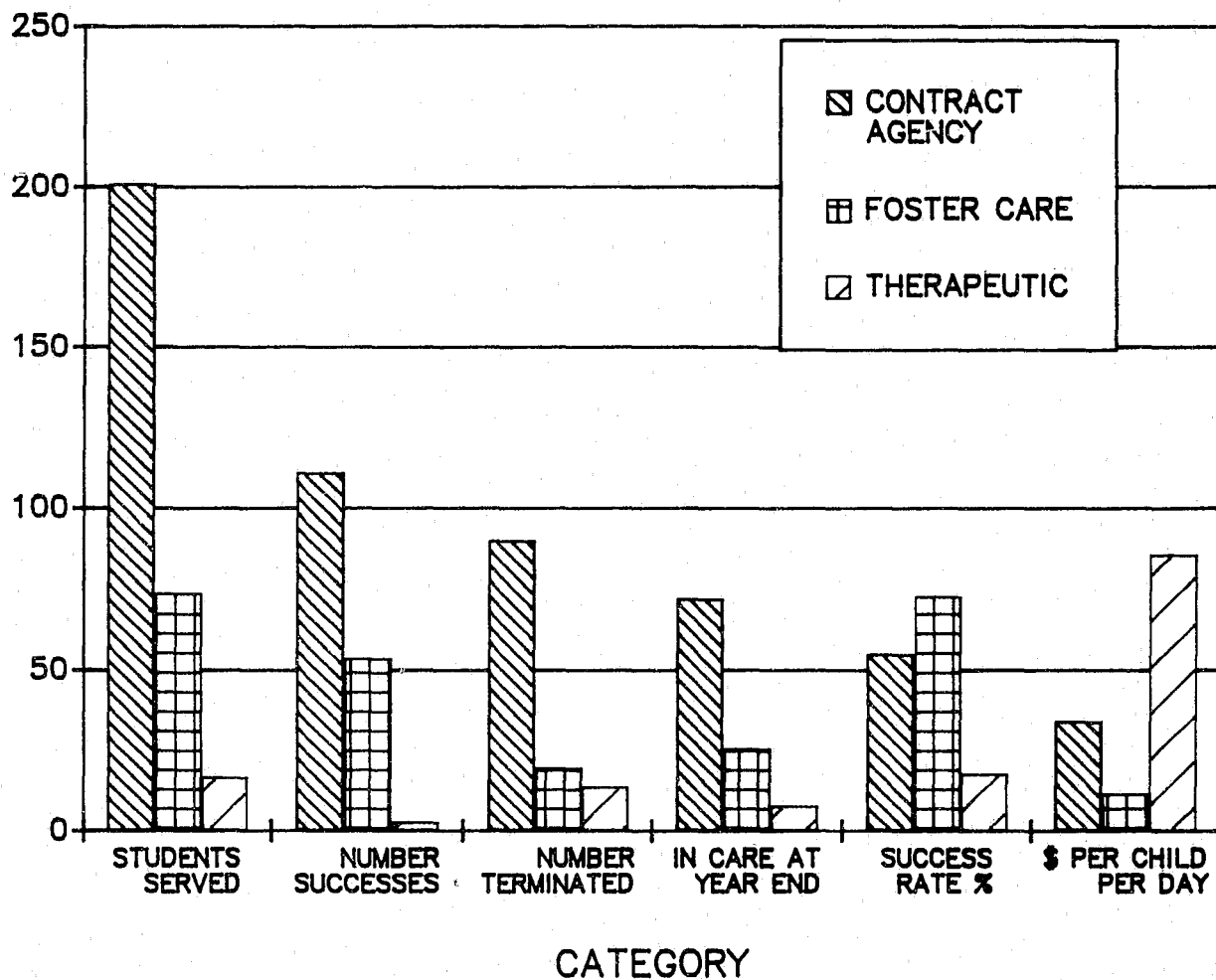

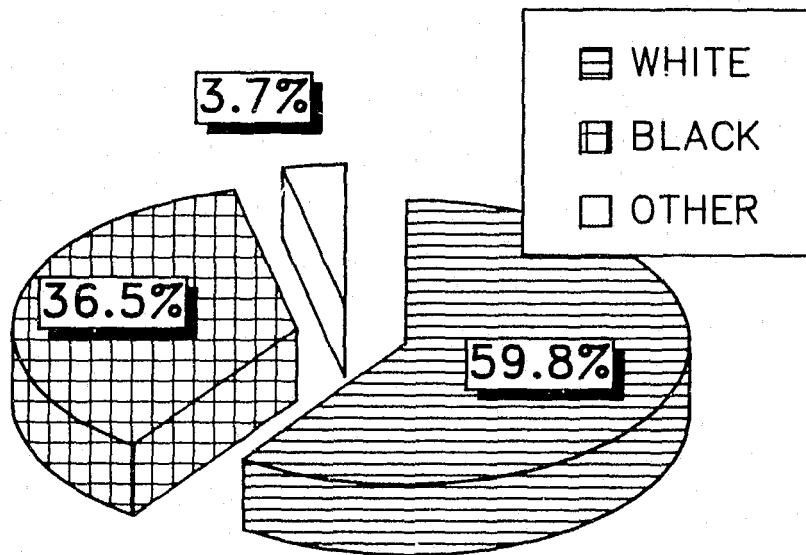
### MALE ADMISSIONS BY RACE 1988



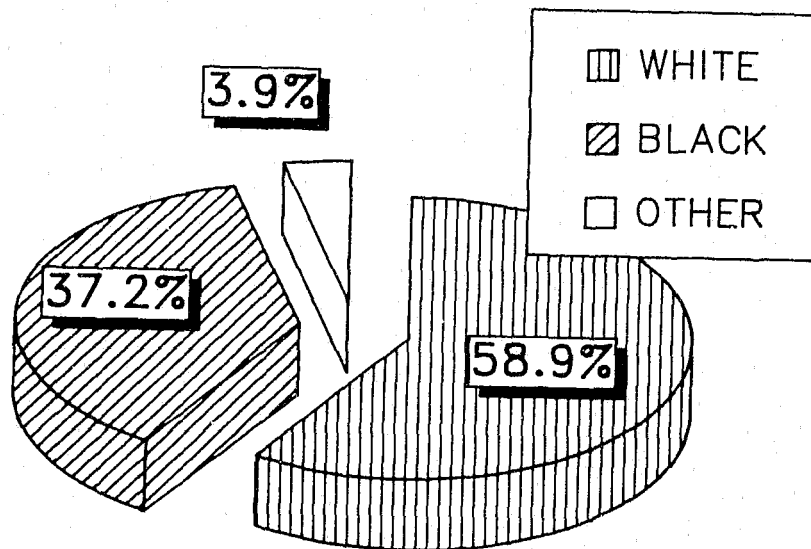
### FEMALE ADMISSIONS BY RACE 1988



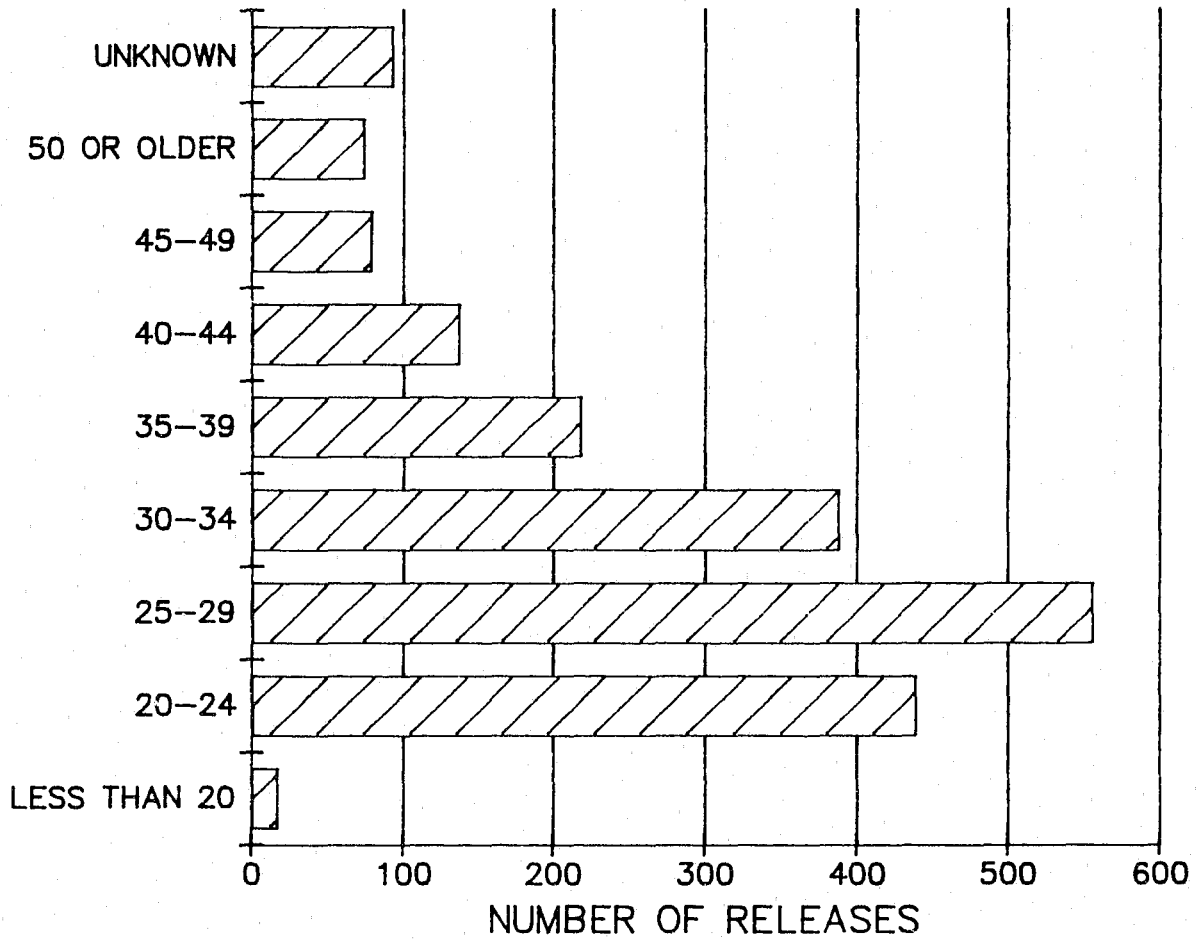

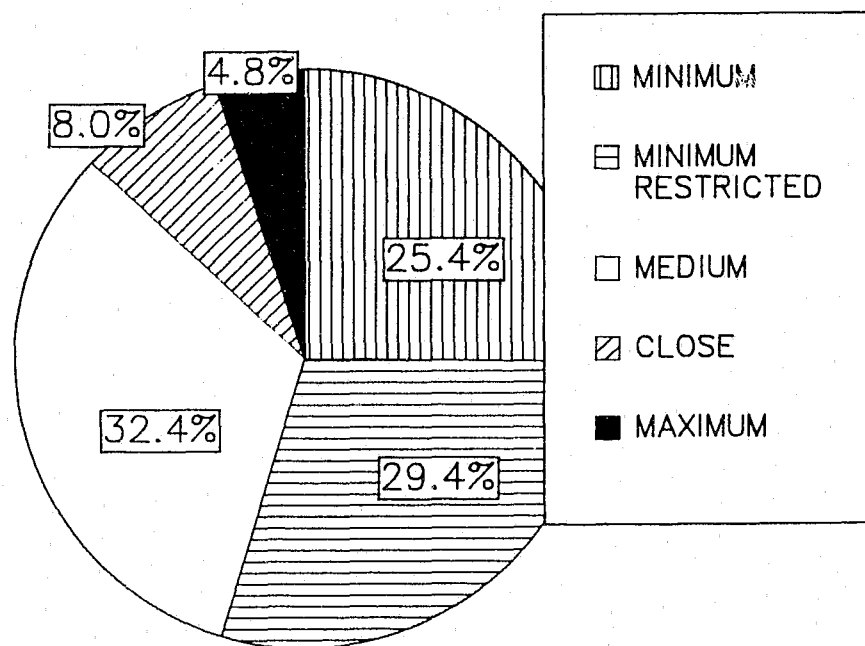


**INMATE POPULATION BY SEX**

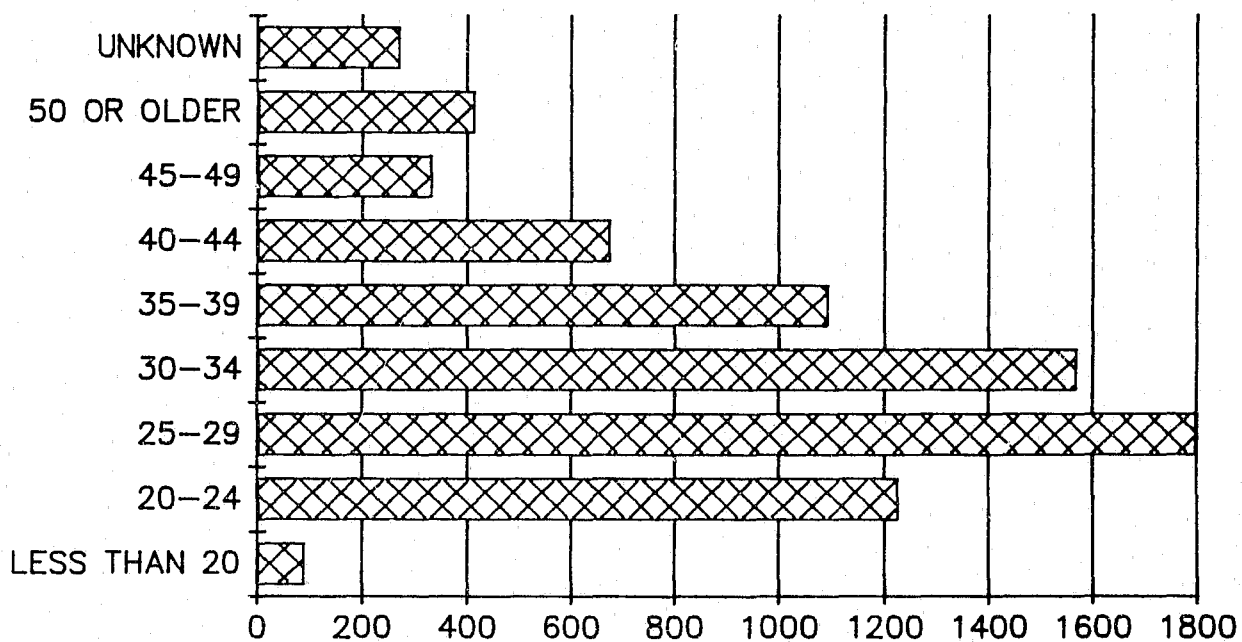




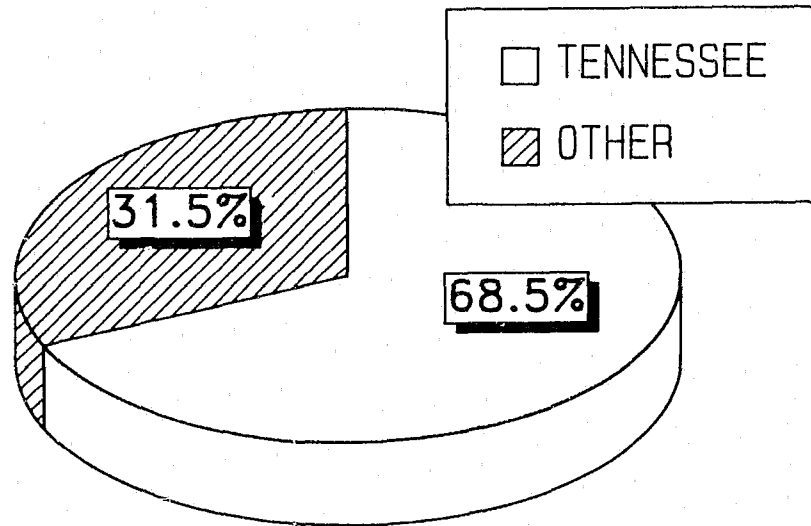
# INMATE POPULATION BY CUSTODY LEVEL As Of December 31, 1988



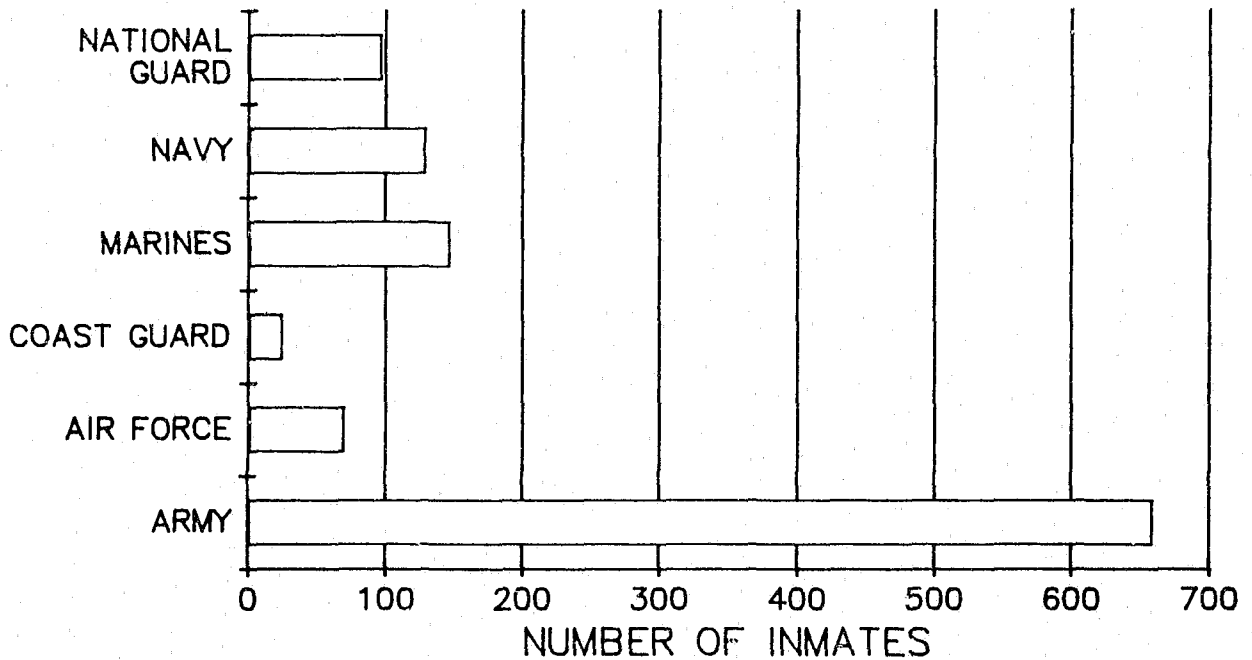
# INMATE POPULATION BY AGE As Of December 31, 1988

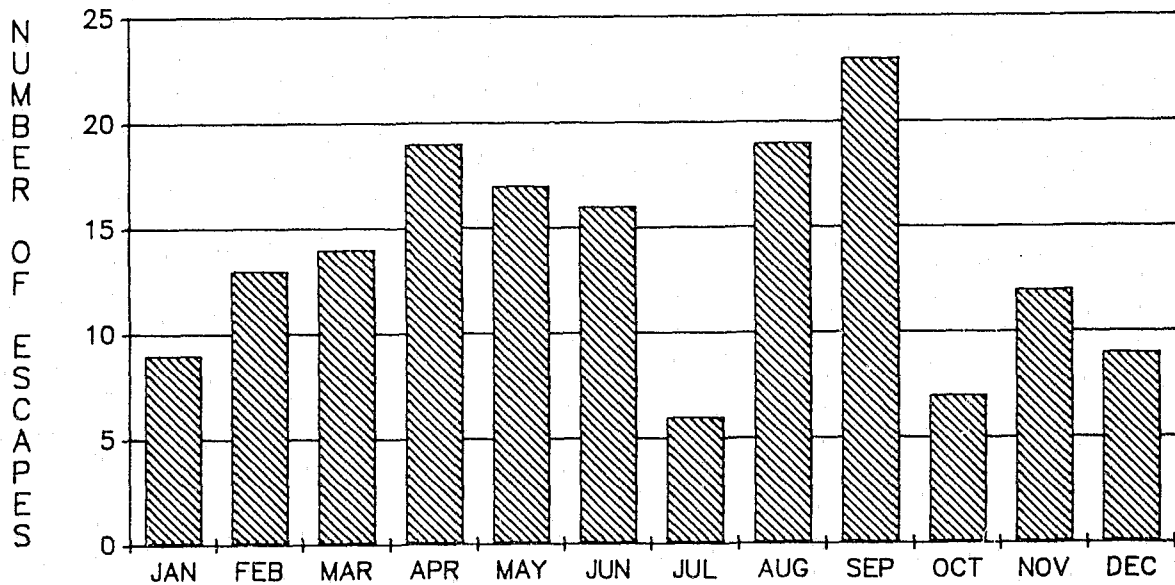

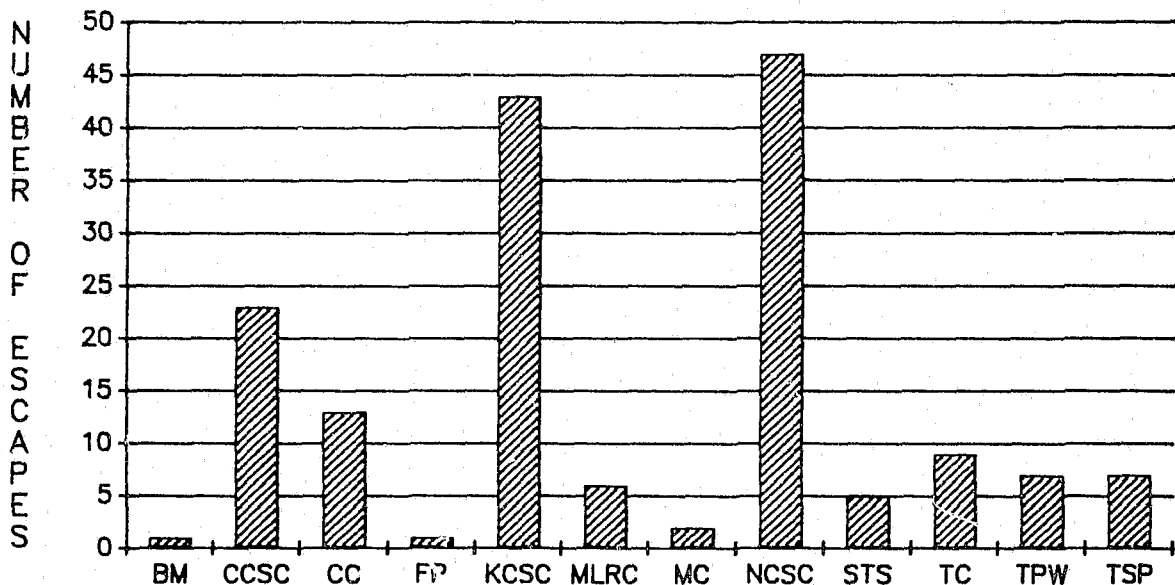

## ESCAPES FROM ADULT INSTITUTIONS By Month (1988)

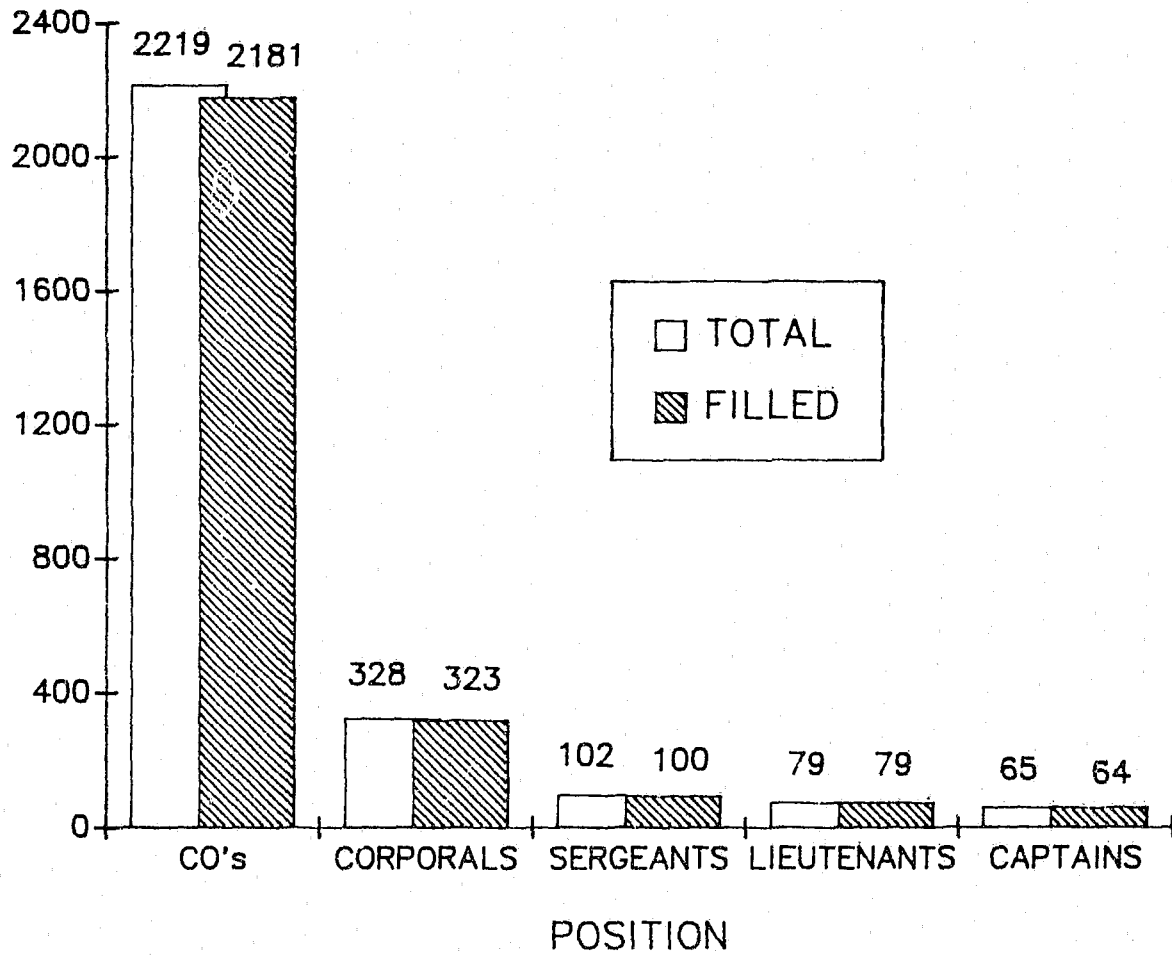


## ESCAPES FROM ADULT INSTITUTIONS By Institution (1988)

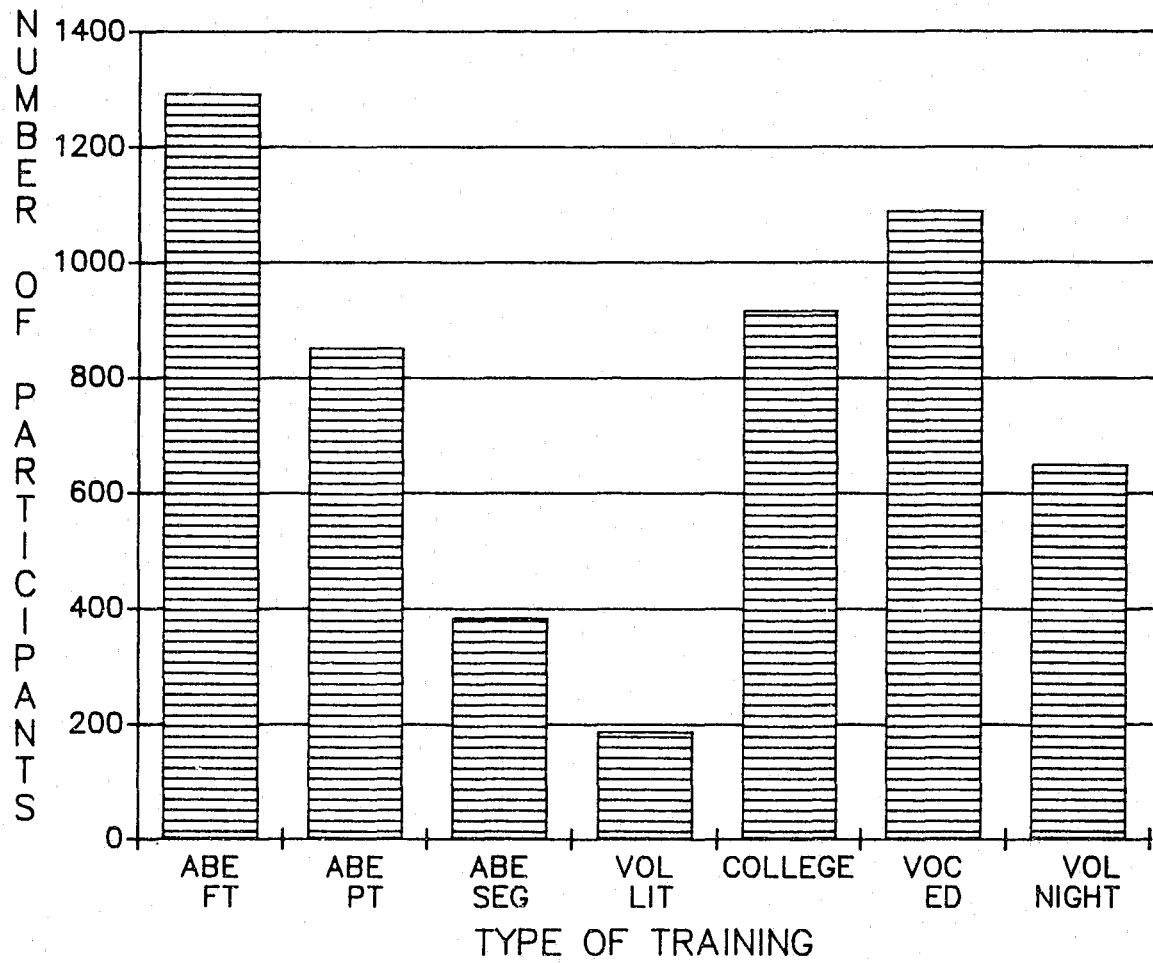

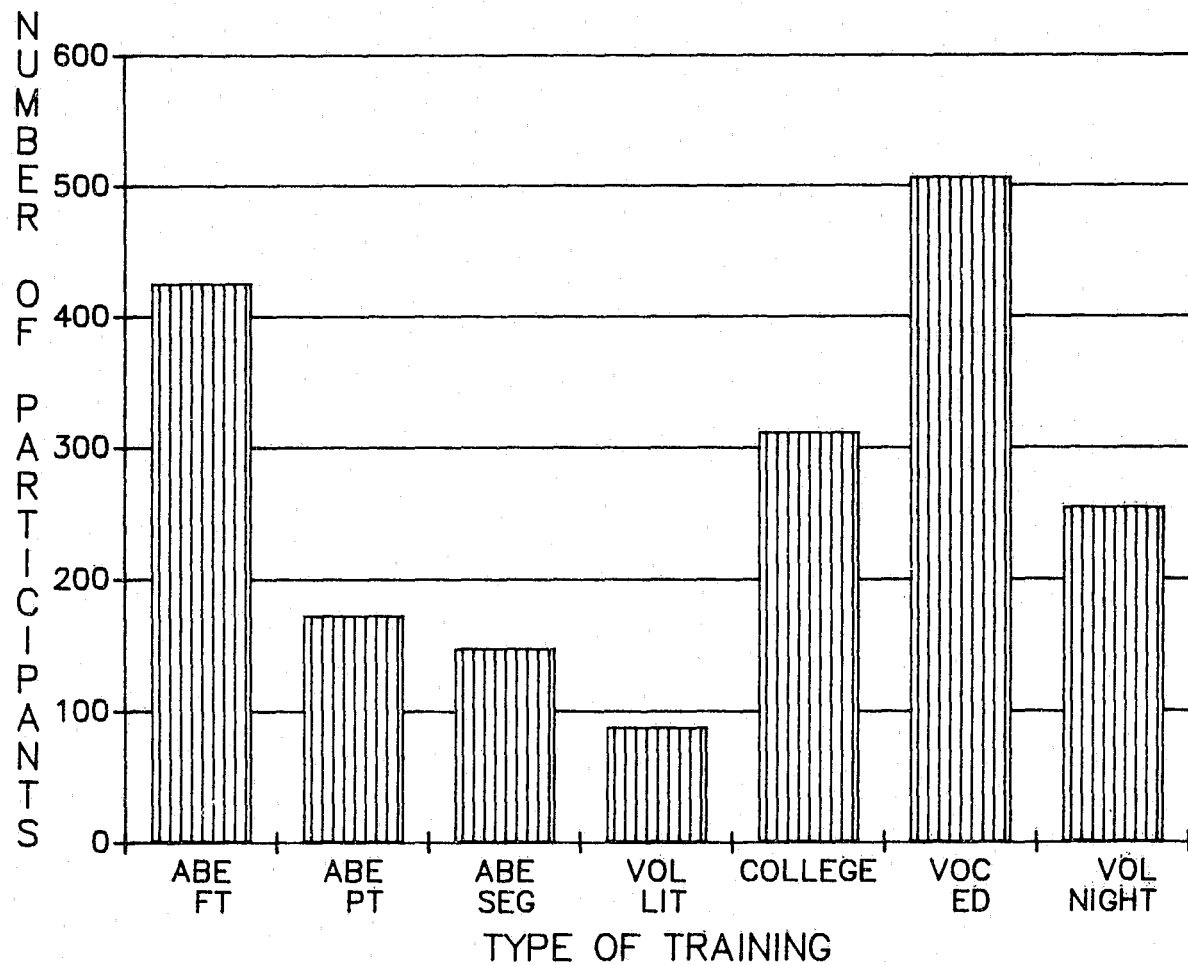
## ADULT SECURITY POSITIONS As Of December 1988

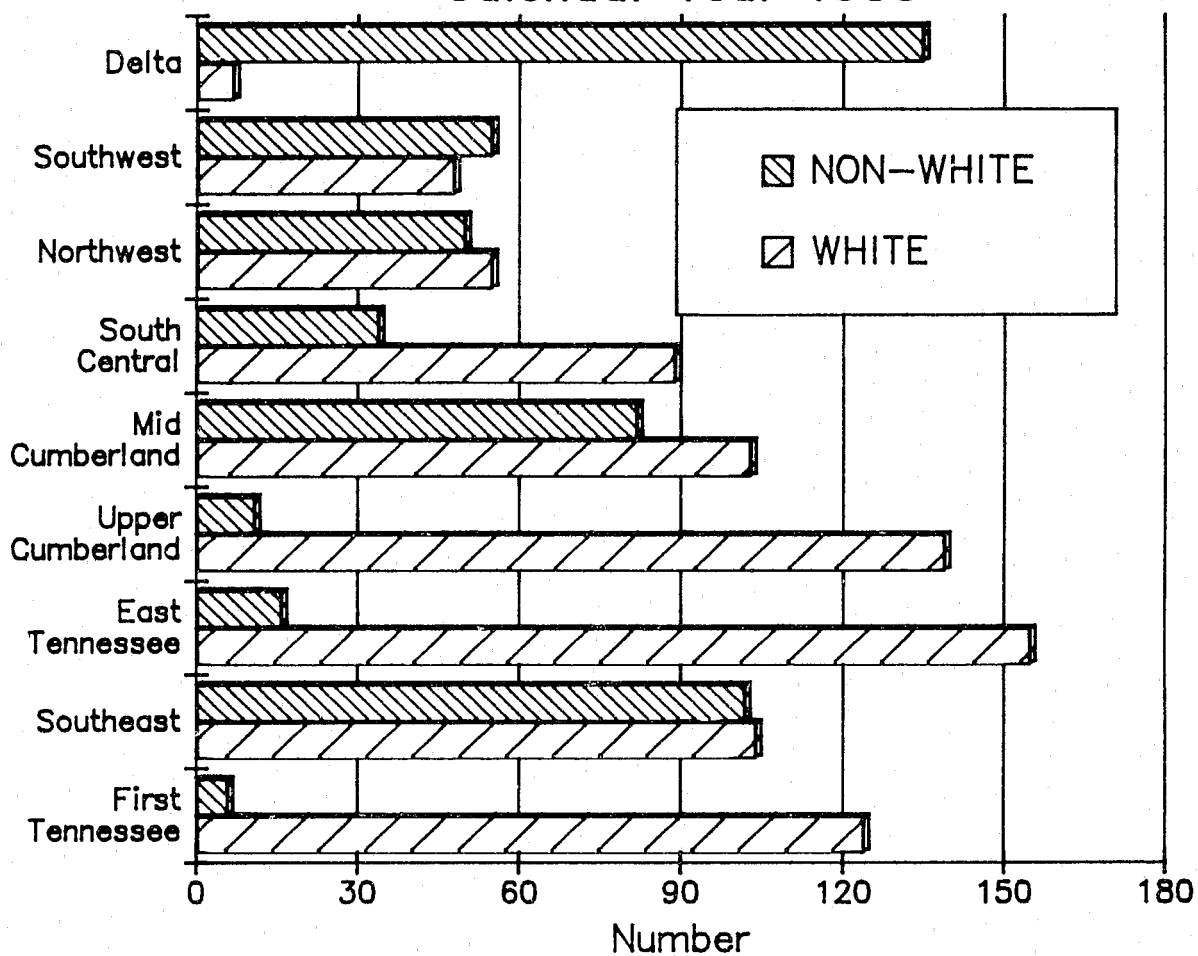

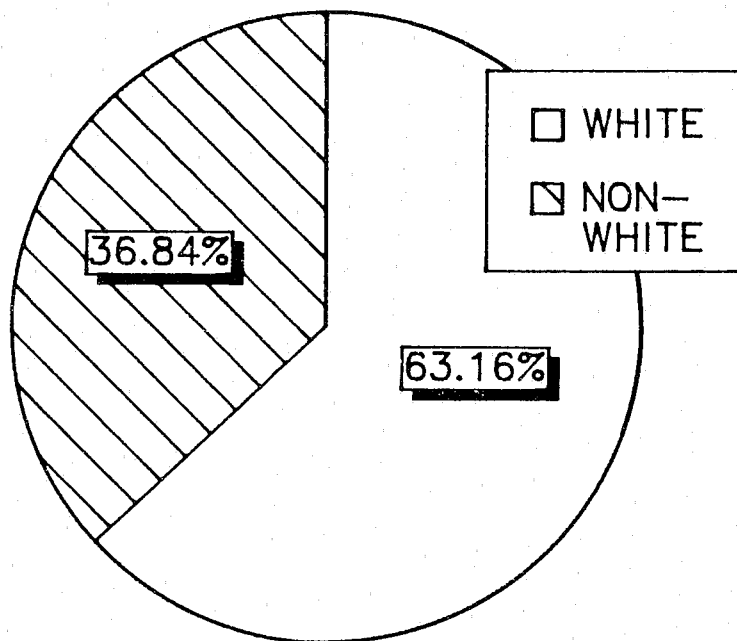
## AVERAGE DAILY POPULATION Calendar Year 1988



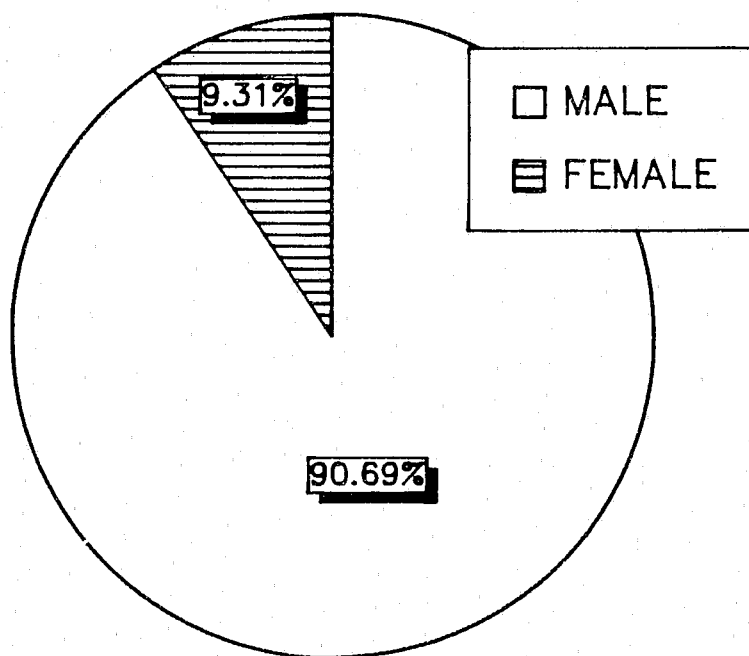
## YEAR END POPULATION VS. CAPACITY As of December 31, 1988



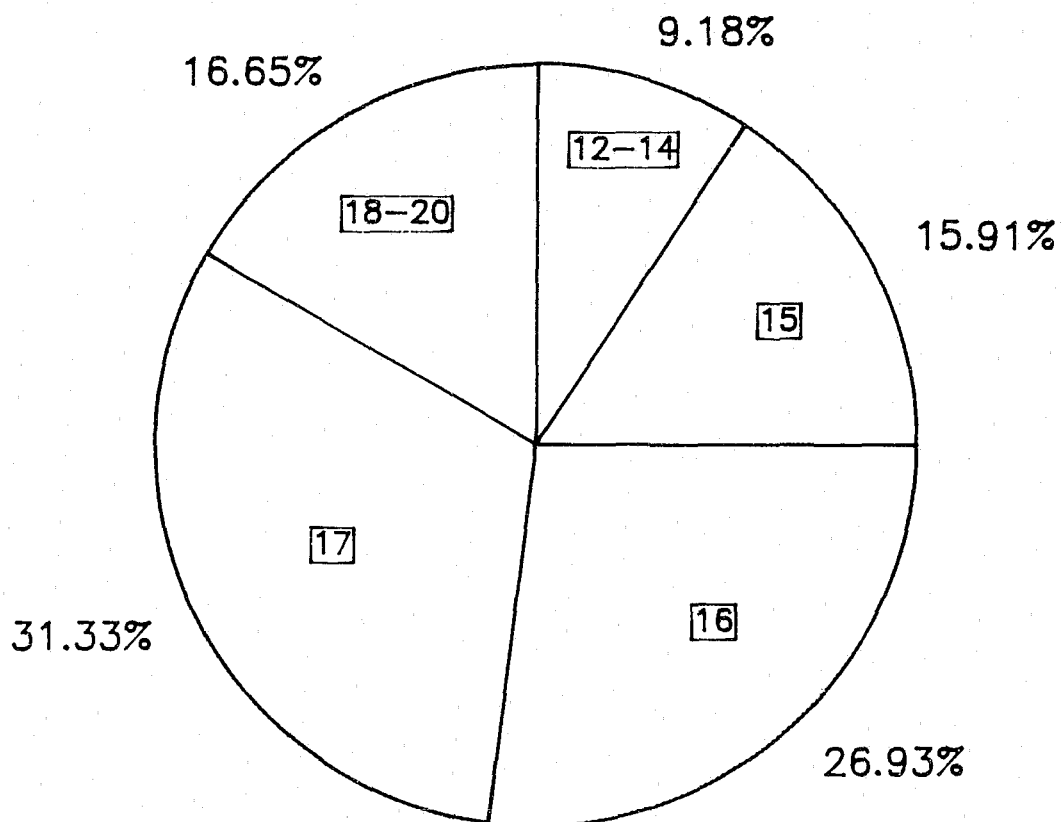

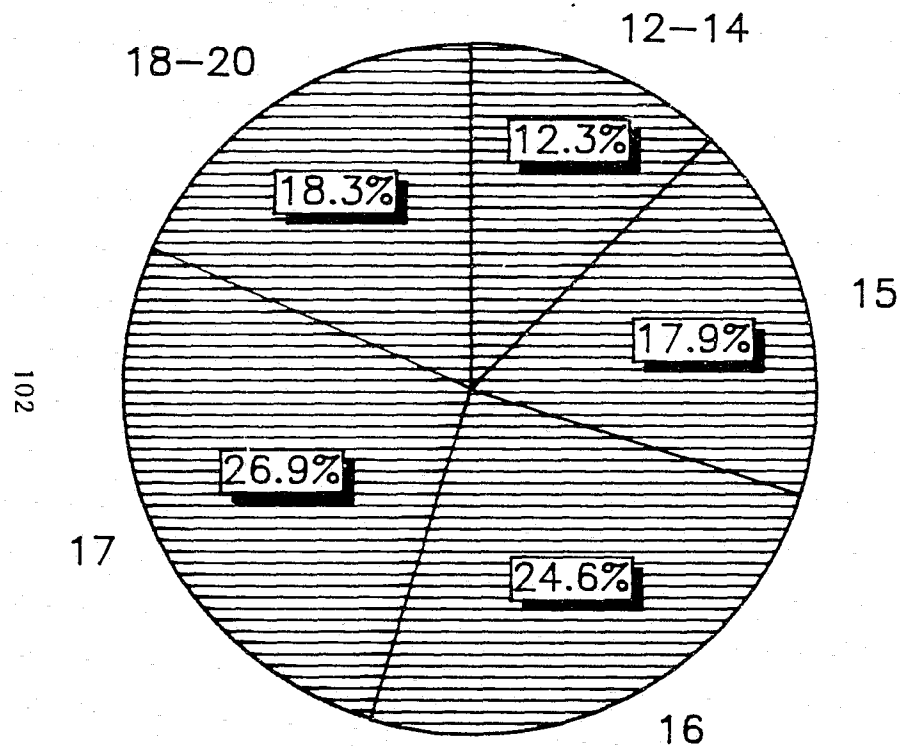
**TOTAL JUVENILE POPULATION BY SEX**

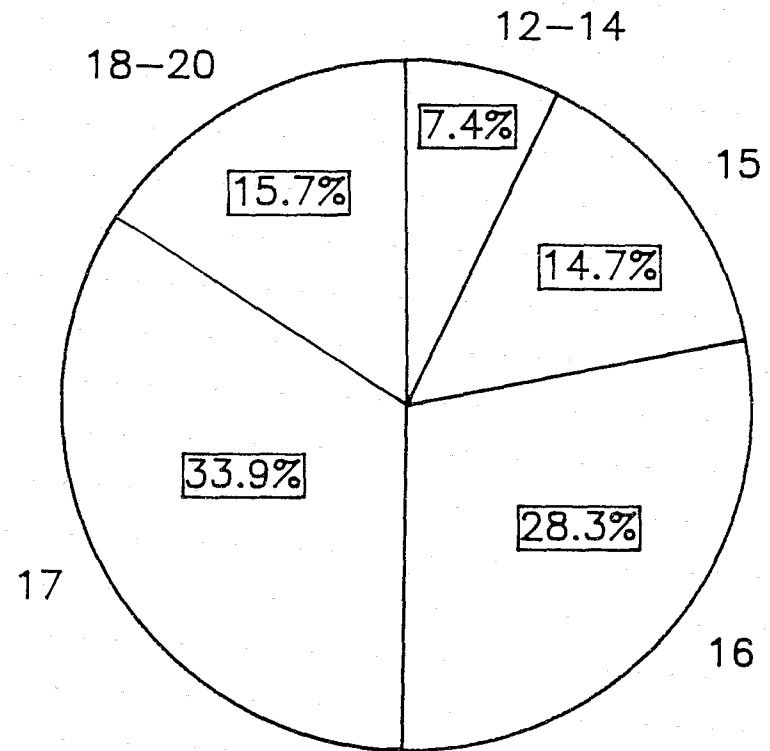

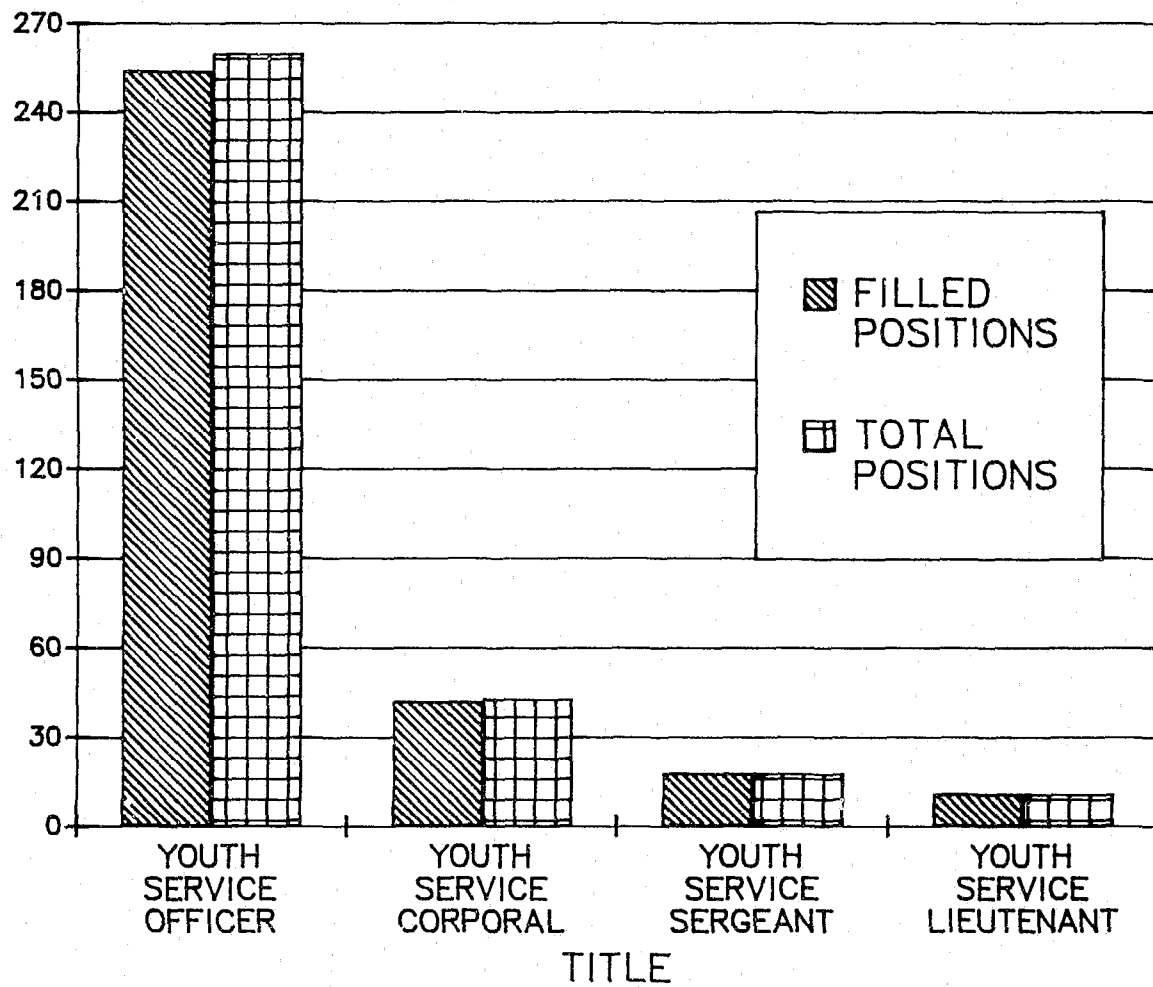

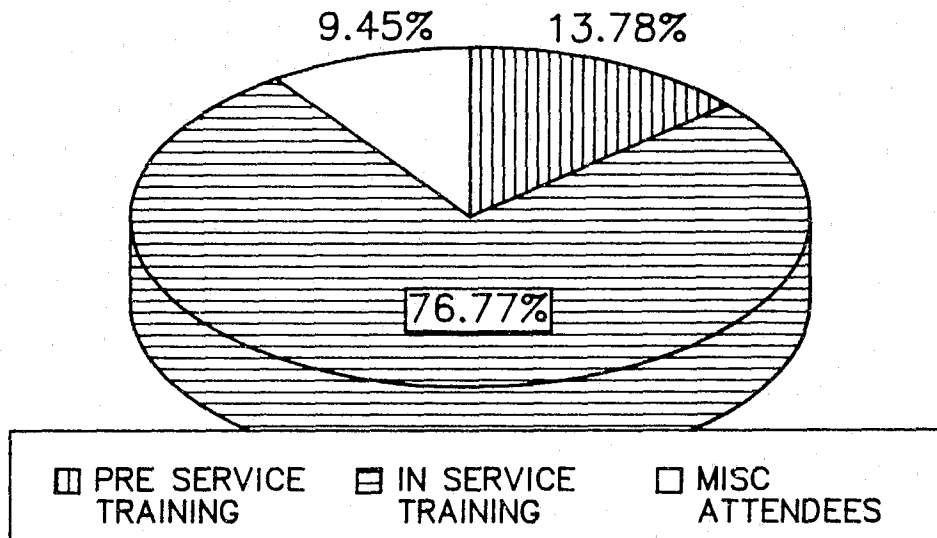
# JUVENILE SECURITY POSITIONS As of December 31, 1988
