INTRODUCTION

This report has been developed to provide information regarding selected offender characteristics in each correctional complex, major institution, satellite housing unit and halfway house under the jurisdiction of the New Jersey Department of Corrections on December 31, 1987. The selected characteristics compiled in this report are Base Offense at Admission, Total Term at Admission, Ethnicity, Age, County of Commitment, and Mandatory Minimum Terms.

The Prison Complex includes the New Jersey State Prison, East Jersey State Prison, Bayside State Prison, Riverfront State Prison, Mid-State, Southern State, Northern State Prison and males house at the Edna Mahan Correctional Facility for Women. The Adult Diagnostic and Treatment Center and Edna Mahan Correctional Facility for Women, although a part of the Prison Complex are combined with Newark and Essex House.

The Youth Correctional Complex consists of the Garden State Reception and Youth Correctional Facility, the Albert C. Wagner Youth Correctional Facility, and the Mountainview Youth Correctional Facility. The Juvenile Facilities include the New Jersey Training School for Boys, the Lloyd McCorkle Training School for Boys and Girls and the Juvenile Medium Security Facility.

On December 31, 1987 there were approximately 1847 State sentenced offenders temporarily housed in County Facilities awaiting transfer into the State Prison System. Characteristic data on these offenders are not included in this report. Similarly, the 1498 Prison and Youth Reception residents, Juvenile Group Center Residents, Halfway Houses, County Contract, County Assistance and Central Medical Unit residents are not included in these tabulations.

"Not Coded" are records on offenders in the correctional system in which admission characteristic data has not been entered into the computerized information system as of December 31, 1987.

ACKNOWLEDGEMENTS

The preparation of this report entailed the assistance of numerous individuals and reporting units. The extensive data collection effort was significantly enhanced by the assistance of the Correctional Information and Classification Services Data Base, the Prison and Youth Reception Units and the Correctional Institutions that report data to the Data Base daily. Special acknowledgement is given to Mrs. Terry Lihvarcik, Head Statistical Clerk of the Office of Policy Analysis and Planning for the compilation of data and the layout of the report format.

HIGHLIGHTS

Sixty-two percent (62%), or 5437 out of 8794, of all offenders in the Prison Complex were committed for crimes against persons, which include Homicide, Sexual Assault, Assault, Robbery, Sodomy, Sexual Abuse and Other Person Offenses. Fifty-eight percent (58%), or 8095 out of 13860, of all New Jersey Offenders were committed for Crimes Against Persons. These figures reflect base or controlling offense at admission, only, and do not include offenses in addition to the base offense in the case of multiple sentences at admission, nor are additional sentences imposed following initial admission to the State Correctional System included in the data.

Almost 50% (6587 out of 13,860) of all New Jersey Offenders were committed with maximum statutory sentences of 10 years or more. Of these, 10% or 677 offenders are serving Life Sentences and 28 offenders are under Capital Sentences.

Fifty-nine percent (59%) of New Jersey's offender population is black, while 26% are white and 15% are Hispanic.

Fifty-three percent (53%) of all offenders in the New Jersey Department of Corrections are under 29 years of age.

Of the 21 New Jersey counties, five (Essex, Passaic, Camden, Monmouth, and Union) account for more than half (55%) of Total State Correctional Commitments. Essex County is the highest contributor with nineteen percent (19%).

Fifty-three percent (53%) of the offenders housed in the Prison Complex have mandatory minimum sentences.

Fifteen percent (15%) of all Department of Corrections offenders have been committed for narcotics law violations including possession, sale and distribution.

ON DECEMBER 31, 1987 BY BASE OFFENSE

In these tabulations, the Base Offense for an offender is that which is the most serious offense at the time of admission. These figures reflect base or controlling offense at admission only, and do not include offenses in addition to the base offense in the case of multiple sentences at admission, nor are additional sentences imposed following initial admission to the State Correctional System included in the data.

Violent Crimes include homicide, sexual assault, aggravated assault, robbery, and other sex offenses i.e. incest, carnal abuse, sodomy and impairing the morals of a minor.

Other Persons Offenses include simple assault, weapons offenses, coercion, larceny from a person and negligent manslaughter.

Property Offenses include burglary, arson, breaking and entering, theft, forgery, embezzlement, auto theft and receiving or possessing stolen property.


Public Policy Offenses include racketeering, gambling, violation of probation, prostitution, corruption, perjury, escape, bail jumping, juvenile or family related offenses and conspiracy.

Narcotics Violations include distribution, manufacture and possession/use of drugs.

Nearly 60% of the offenders in the Prison Complex have been convicted of a crime of a violent nature which includes homicide, sexual assault, robbery, sex abuse/sodomy and other person offenses.


Twenty-seven percent of violent crime offenders in the Prison Complex have been convicted of homicide.

Almost one third (31%) of all offenders at New Jersey State Prison have been convicted of homicide.











































This means that an offender must serve the entire minimum sentence before becoming eligible for parole consideration. Mandatory minimum terms are not reduced by earned credits (commutation, minimum security or work).

Forty-seven percent (47%) of the total Prison and Youth Complex offenders have mandatory minimum sentences (5755 out of 12,218). Seven hundred forty-nine offenders (13%) with mandatory minimum terms have minimums of 15 or more years. Fifty-five percent of all mandatory minimum cases fall within the 2 to 5 year range (3175 out of 5755).



Albert C. Wagner Youth Correctional Facility has 500 offenders with mandatory minimum terms. This constitutes almost one half of the total of mandatory minimum offenders in the Youth Complex.

Garden State Reception and Youth Correctional Facility houses 381 (35%) of the Youth Complex's total mandatory minimum offenders and Mountainview Correctional Facility has 167 (15%).
