# CRIME AND ARRESTS

# IN WISCONSIN

## 1989 PRELIMINARY REPORT

WISCONSIN UNIFORM CRIME REPORTING PROGRAM APRIL 1990

### Executive Summary

- 1. Overall crime increased by 5.2% in 1989, caused by increases in all crime categories except aggravated assault.
- 2. The increase of 8.2% in adults arrested for total Index crimes was due to increases in arrests of adults for each of the eight Index crimes.
- 3. The increase of 9.4% in juveniles arrested for all Index crimes was due to increases in arrests of juveniles for each of the eight Index crimes except arson and burglary.
- 4. Clearance rates increased for each Index offense except that of theft which remained the same as in 1988. The violent crime clearance rate of 59.9% represents the highest such clearance rate since 1978.
- 5. While reported violent crime has increased by 9.4 percent during the past five years, reported property crime has increased by 5.9 percent.
- 6. Arrest trends for adults and juveniles have been very different during the past five years. While the number of adults arrested for Index crimes has increased by 22.2 percent since 1985, juvenile arrests have increased only 1.2 percent.
- 7. The total amount of property stolen increased by 25.9 percent in 1989. In addition, the percentage of stolen property which was recovered increased from 36.5 percent to 40 percent in 1989.
- 8. While the increase in total and property crime was greater in Wisconsin than in the Midwest and the entire United States, the increase in violent crime was somewhat less than that experienced by the Midwest and the United States.
- 9. During 1989 the violent crime rate in Wisconsin was two to three times less than corresponding rates for the Midwest and the United States. Property and Total crime rates in Wisconsin were ten to fifteen percent less than Midwest rates and about twenty-five percent less than rates in the United States.

### A. Introduction

This report summarizes crime and arrests in Wisconsin for 1989 and compares the figures with those of past years. All 1989 figures are estimates based upon nearly complete reporting from 288 law enforcement agencies throughout Wisconsin. The complete report on these crime and arrest data will be published in July, 1990.

### B. Comparison of 1988 and 1989 Figures

Table 1 compares reported Index offenses in 1988 to those of 1989.

The increase of 5.2% in overall crime was caused by increases in all crime categories except aggravated assault. The relatively sharp increases in murder, robbery, and motor vehicle theft should be noted.

<sup>1</sup> Data in this and subsequent tables are estimates based on data from over 99 percent of reporting jurisdictions. Data may not sum to totals due to rounding.

Table 2 compares the number of adult arrests during 1988 and 1989.

The increase of 8.2% in adults arrested for all Index crimes was due to increases in arrests of adults for each of the eight Index crimes.

<sup>&</sup>quot;Other offenses" which showed substantial increases in the number of adult arrests include simple assault, drug law violations, liquor law violations and disorderly conduct. The increases in adults arrested for aggravated assault, simple assault, and disorderly conduct likely reflect the impact of mandatory arrests in domestic violence situations.

Table 3 compares the number of juvenile arrests during 1988 and 1989.

The increase of 9.4% in juveniles arrested for all Index crimes was due to increases in arrests of juveniles for each of the eight Index crimes except arson and burglary.

<sup>&</sup>quot;Other offenses" which showed substantial increases in the number of juvenile arrests include simple assault, weapons laws, and disorderly conduct.

Table 4 compares the clearance rates for Index offenses for 1988 and 1989. The clearance rates are rounded off to the nearest percent except for the Violent, Property and Total rates.

Clearance rates increased for each Index offense except that of theft which remained the same as in 1988. The violent crime clearance rate of 59.9% represents the highest such clearance rate since 1978.

### C. Five Year Trends in Crime and Arrests


Table 5 together with Graphs 1 and 2 show trends in reported offenses and arrests in Wisconsin during the past five years.



While reported violent crime has increased by 9.4 percent during the past five years, reported property crime has increased by 5.9 percent.

Arrest trends for adults and juveniles have been very different during the past five years. While the number of adults arrested for Index crimes has increased by 22.2 percent since 1985, juvenile arrests have increased only 1.2 percent.

#### D. Property Stolen and Recovered

Table 6 shows the value of property stolen and recovered during both 1988 and 1989.

The total amount of property stolen increased by 25.9 percent in 1989. In addition, the percentage of stolen property which was recovered increased from 36.5 percent to 40 percent in 1989.

#### E. Offense Rates

Table 7 shows changes in the number of offenses over the past two years. The jurisdictions compared are Wisconsin, the Midwest, and the entire United States. (Note: the Midwest includes the twelve states of Illinois, Iowa, Indiana, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin).

While the increase in total and property crime was greater in Wisconsin, the increase in violent crime was somewhat less than that experienced by the Midwest and the entire United States.

Table 8 shows the effect of these changes in reported crime on the crime rates of these jurisdictions. Crime rates are used to permit comparison among jurisdictions with different population levels and consist of the number of reported crimes per 100,000 residents. The 1989 figures for the United States and the Midwest are estimates based upon preliminary data.

During 1989 the violent crime rate in Wisconsin was two to three times less than corresponding rates for the Midwest and the United States. Property and Total crime rates in Wisconsin were ten to fifteen percent less than Midwest rates and about twenty-five percent less than rates in the United States.
