

#### **Executive Summary**

#### **Officers Assaulted - 1989**

- During 1989, three Wisconsin law enforcement officers lost their lives in accidents while in the performance of their official duties.
- \* Nearly sixty percent of assaults occurred during the nighttime hours from 8 p.m. through 4 a.m.
- \* Three types of circumstances (disturbance calls, handling prisoners, and attempting an arrest) were involved in over seventy percent of the assaults reported in 1989.
- \* The percentage of officers assaulted who were assigned to a two person vehicle declined from 26.4 percent in 1988 to 18.3 percent in 1989.
  - Nearly 95 percent of assaults involved personal weapons (hands, feet or fists) rather than firearms, knives or other dangerous weapons.
  - Of the 932 assaults reported in 1989, 917 or 98 percent were cleared by arrest.

#### Officers Assaulted - Six Year Trends, 1984 - 1989

- \* While three Wisconsin law enforcement officers have been killed feloniously from 1984 through 1989, nine officers lost their lives in accidents while in the performance of their official duties.
- \* The number of officers assaulted in Wisconsin has increased by over thirty percent from 1984 (715 assaults) to 1989 (932 assaults).
- \* Assaults on law enforcement officers were most frequent during the eight hour period from 8 p.m. through 4 a.m.
- \* There has been an increase in the percentage of assaults while officers were responding to disturbance calls, and a decrease in assaults of officers attempting an arrest or making a traffic stop.
- \* There has been an increase in the percentage of assaults while officers were assisted in either a one person vehicle or an other assignment. Also, there has been a decrease in assaults of officers assigned to a two person vehicle.
- \* While the number of assaults involving a personal weapon increased steadily during the past six years, assaults involving all other weapon categories showed little change.
- \* The percentage of assaults which resulted in an injury to the law enforcement officer has decreased during the past six years.
- \* There has been a slight increase in the percentage of assaults on law enforcement officers which have been cleared. However, the overall clearance rate exceeded 95 percent even in 1984, the first year of the six year period.

#### I. Introduction and Methodology

This report presents information on Wisconsin law enforcement officers assaulted from 1984 through 1989. Law enforcement agencies in Wisconsin report such assaults as part of their participation in the Uniform Crime Reporting (UCR) Program. Assaults which are reported include assaults which resulted in serious injury or in which a weapon was used which could have caused serious injury or death. Assaults are recorded only if they involved more than verbal abuse or minor resistance to an arrest. The form used to report assaults upon law enforcement officers is included as Appendix A.

The first section of this report focuses on assaults reported in 1989 with comparisons to patterns in the previous year. The next section presents data on all assaults occurring between 1984 and 1989. Both sections contain information on the timing of the assault, circumstances of the assault, assignment of the officer, weapon use, injuries, and clearances. Appendix B provides more detailed information on 1989 assaults for each law enforcement agency in Wisconsin which reported at least four assaults during the year.

#### II. Assaults on Law Enforcement Officers - 1989 vs. 1988

#### Officers Killed in the Line of Duty

During 1989, three Wisconsin law enforcement officers lost their lives in accidents while in the performance of their official duties. One officer was accidentally killed in the line of duty during 1988. No officers were feloniously killed in either year.


#### Month

There were 932 reported assaults on Wisconsin law enforcement officers in 1989, a 0.3 percent increase compared to the 929 reported assaults in 1988. Table 1 and Graph 1 show the month in which assaults occurred during the past two years.


Graph 1: Law Enforcement Officers Assaulted, by Month



Patterns in the month of assault were very similar in 1988 and 1989. The two months of September and October accounted for nearly twenty percent of all assaults in the two year period, while the six months from May through October accounted for fifty-five percent of all assaults.

#### Time of Day

Graph 2 and Table 2 show the time of day in which officers were assaulted in 1989.

Note: The time periods in the graph are expressed in terms of the first hour in a twenty-four hour clock (e.g., period 0 with 171 assaults includes the two hours between midnight and 2 a.m.).

Nearly sixty percent of assaults occurred during the nighttime hours from 8 p.m. through 4 a.m. Patterns in the timing of assaults were very similar in 1988.

Table 3 shows the circumstances under which officers were assaulted during 1989.



Three types of circumstances (disturbance calls, handling prisoners, and attempting an arrest) were involved in over seventy percent of the assaults reported in 1989.

As shown in Graph 3, patterns in the circumstances surrounding assaults reported in 1988 were very similar.





Graph 5 shows the number of assaults in 1988 and 1989 according to the assignment of the officer. There were changes in the number of assaults by officer assignment during the two year period. For example, the percentage of officers assaulted who were assigned to a two person vehicle declined from 26.4 percent in 1988 to 18.3 percent in 1989.

#### **Injuries and Weapons**

As shown in Table 5, injuries resulted from somewhat more than half of reported assaults in 1989

Nearly 95 percent of assaults involved personal weapons (hands, feet or fists) rather than firearms, knives or other dangerous weapons. Injury patterns and weapon use were very similar in 1988 assaults.

#### Clearances

There were 932 assaults reported in 1989; 917 or 98 percent of these were cleared by arrest. In 1988, approximately 96 percent of the 929 reported assaults were cleared by arrest.

#### III. Officers Assaulted - Six Year Trends

#### Officers Killed in the Line of Duty

Table 6 shows the number of Wisconsin law enforcement officers killed in the line of duty from 1984 through 1989.



While three Wisconsin law enforcement officers have been killed feloniously from 1984 through 1989, nine officers lost their lives in accidents while in the performance of their official duties.

Graph 6 shows the total number of officers assaulted in Wisconsin since 1984.

The number of officers assaulted in Wisconsin has increased by over thirty percent from 1984 (715 assaults) to 1989 (932 assaults).

#### Time of Day

Assaults on law enforcement officers were most frequent during the eight hour period from 8 p.m. through 4 a.m. The summed percentage of these three categories ranged from a low of 58.9 percent in 1986 to a high of 63.9 percent in 1984.



Major trends during the six years include an increase in the number of assaults while officers were responding to disturbance calls or handling prisoners together with a decrease in assaults when making a traffic stop.

Since the total volume of assaults has increased substantially during the past six years, focusing on the number of assaults by differing circumstances may not be the best method of illustrating changes over time. Instead, Graph 7 shows changes in the percent of assaults involving different circumstances.



Graph 7: Circumstances at the Time of the Assault


The percentage of assaults involving response to a disturbance call increased from 31.6 percent in 1984 to 39.4 percent in 1989. However, the percentage of assaults involving an arrest attempt, traffic, and the handling of prisoners declined from 1984 to 1989 or remained essentially unchanged.

#### **Types of Assignments**

Table 9 shows trends in the number of assaults on law enforcement officers by the type of assignment.

There has been an increase in the percentage of assaults while officers were assisted in either a one person vehicle or another assignment. Also, there has been a decrease in assaults when officers were assigned to a two person vehicle. Graph 8 shows changes in the percent of assaults involving different assignments.

Wisconsin Law Enforcement Officers Assaulted 1984 - 1989

While the percentage of assaults involving a one person vehicle has increased from 50.1 percent in 1984 to 63.2 percent in 1989, the percent involving a two person vehicle has decreased from 33.7 percent in 1984 to 18.3 percent in 1989.

#### Weapons

Table 10 shows trends in the use of weapons in assaults on law enforcement officers during the past six years.

While the number of assaults involving a personal weapon increased steadily during the past six years, assaults involving all other weapon categories showed little change.

#### Injuries

The percentage of assaults which resulted in an injury to the law enforcement officer has decreased during the past six years.

#### Clearances
