### ALTERNATIVE PROGRAM PROFILES

OF

CALIFORNIA COUNTIES

1990

These informal profiles were supported by the Nevada County Probation Department and the Northern California Corrections Association. These comparative informal studies are an attempt to present the current status of the Work Furlough, Work Release, and Electronic Monitoring programs within California's fifty-eight counties and how they function. Other than community service, these programs appear to be the only intermediate sanctions that punish, offset the cost of incarceration, and/or do not involve incarceration in this State. Some of the general informational areas queried relate to program duration, fee structures, contact standards, staffing, employment criteria, housing/program population, and other areas of interest.

Although the individual county program answers appear to be specific "yes" and/or "no" responses, it was realized through collation and very limited verification of the information gathered that these answers were general or generalized in nature. Further, late responses, incomplete questionnaires, and the late discovery that some counties had dual programs administered by different departments which were not queried, make these profiles incomplete. Unfortunately, time constraints and lack of manpower hours did not allow for further verification, analysis, and definition so necessary in any survey, profile, or study. This informal survey is by no means structured with research or evaluation mechanics to be definitive in nature. It was initiated in an attempt to compare what other counties are doing and to assist others in their continuing effort to expand, revise, and further develop intermediate sanctions and alternatives to incarceration. Individual followup verification is encouraged when using the information contained in the attached profiles.

The cooperation of all who responded to the questionnaires was greatly appreciated. Those of you I spoke with expressed interest in this project and were very encouraging. It is hoped these informal program profiles will continue to encourage all alternative programming providers to expand their networking of information, issues, and questions either through the Northern California Corrections Association and/or on an all inclusive individual basis. As always, the answering of general questions begs the answers to more specific queries, criteria, and situations. The broad spectrum of information gathered in this informal study was time consuming and somewhat difficult to present due to similar yet unique program designs throughout this State. Hopefully, other members of the Northern California Corrections Association or the general membership as a whole through a committee will be encouraged and motivated to continue surveying policies, mechanics, and other areas of interest in the intermediate sanctions we provide. There appears to be a need to focus on the individual programs specifically and possibly develop conferences and/or workshops to deal with issues and comparative policies or mechanics. For example, Electronic Monitoring is rapidly expanding in this State and the wide use of County Parole is also occurring and expanding. Work Furlough and Work Release programs are becoming more complex regarding guidelines and/or criteria used to determine eligibility due to the challenging of these guidelines or criteria by attorneys and quite possibly the general public.

The basis for quality programs, such as those mentioned, and the foundations on which they are built are the personnel who create, build, or expand upon them. It is hopeful that the Alternative Program Profiles can be used as a foundation to assist in creating a program or to assist in expanding an existing one.
