



HIGHLIGHTS

During the 1981-1990 period, more than half of the adult felony arrests resulted in a conviction. (page 6)

Adults arrested for property offenses were more likely to be convicted than those arrested for violent or drug offenses. (page 8)

Of the major arrest offenses examined, burglary had the highest conviction rate. (page 12)

Since 1982, over half of the adult felony arrest convictions have resulted in sentences to probation with jail. (page 18)

With the exception of assault, the most frequent sentence given to those convicted of a violent offense was state institutions. (page 20)

The proportion of drug offenders sentenced to state institutions was nearly five times greater in 1990 than in 1981 (32.4 versus 6.7 percent). (page 28)

Conviction rates were higher in the smaller county population groups than in the larger county population groups. (page 40)

INTRODUCTION

The Offender-Based Transaction Statistics (OBTS) system in California describes the processing of adults arrested for felony offenses from arrest through *final* disposition. Data on Chart 1 pertain specifically to the 258,734 adult felony arrests which received final dispositions in 1990.

What is a Final Disposition?


In the OBTS system, the term "final disposition" refers to a specific legal action which takes place following an adult felony arrest. A final disposition can occur at the law enforcement, prosecutor, lower court, or superior court level. For example, if an arrestee is released by a law enforcement agency or by a prosecutor who has determined that there is not enough evidence to justify the filing of a complaint, this release is recorded as a final disposition. If an arrestee is referred to court for adjudication, the outcome (i.e., dismissal, diversion dismissal, acquittal, or conviction) is also recorded as a final disposition. "Intermediate" dispositions (e.g., placements into diversionary programs) are not available.

How are OBTS Data Reported?

OBTS data are taken directly from the State's Automated Criminal History System (ACHS). All arrest information is entered into ACHS from fingerprint cards while most disposition data are entered from "Disposition of Arrest and Court Action" (JUS 8715) forms received by the Department of Justice.



ADULT FELONY ARREST DISPOSITIONS, 1990



Dispositions of adult felony arrests were reported by almost 1,100 agencies in 1990. These agencies include the law enforcement, prosecutor, lower court, and superior court levels of the California criminal justice system. It is estimated that JUS 8715 forms were processed for approximately 60 percent of all adult felony arrests receiving final dispositions in 1990. (See page 78, "Data Limitations", for additional information.) These final dispositions provide an overview of the statewide processing of adult felony arrestees through California's criminal justice system.

How are Data Presented?

The data presented in this report are based upon the number of final dispositions, not the number of arrests. Since the OBTS Report File represents a sample — albeit large — of all adult felony arrest dispositions in California, the data are shown in a percent format.

The OBTS data are displayed in a variety of ways in order to give the broadest possible picture of the criminal justice system. Charts showing comparative data are used throughout this report to describe variables such as offenses committed, sentences given, and the offender's sex, race/ethnic group, and age.

When interpreting these data, one should remember that a person arrested for a particular offense can be convicted of an entirely different offense. Also, although dispositions are based on adult felony arrests, the resulting convictions include both misdemeanors and felonies.

ARREST DISPOSITIONS

Final dispositions can be rendered at the law enforcement, prosecutor, or lower or superior court levels. The Arrest Dispositions section describes final dispositions of all reported adult felony arrests through 1981-1990 trends and 1990 arrest offense categories.

Comparing 1981 to 1990,

As a percent of all reported adult felony arrest dispositions:

- Law enforcement releases decreased from 10.3 to 6.0 percent.
- Prosecutor complaints denied decreased from 15.3 to 12.9 percent.
- Dismissals and acquittals decreased from 17.6 to 15.6 percent.
- Convictions increased from 56.8 to 65.5 percent.

Chart 3, the "system fallout" chart, provides a graphic presentation of the type of final disposition received in 1990. For example, beginning at the upper left-hand corner of the chart, 100 percent represents total felony arrest dispositions. Moving to the right, 6.0 percent of the final dispositions were law enforcement releases. The line then drops 12.9 percent for complaints denied. It continues to drop the appropriate percentage for each type of disposition and type of sentence category until all 100 percent are accounted for.


In 1990,

- 6.0 percent of the arrestees were released by law enforcement agencies. The most common reason for release was insufficient evidence (3.5 percent).
- 12.9 percent of the arrestees were released at the prosecutor level with the largest portion being released because of a lack of sufficient evidence (5.2 percent).
- 15.6 percent of the arrestees were released by the courts.
- 65.5 percent of the arrestees were convicted.


ADULT FELONY ARREST DISPOSITIONS, 1981-1990 By Type of Disposition

ARREST DISPOSITIONS

DISPOSITIONS BY ARREST OFFENSE CATEGORY

The arrest offense categories include only felonies. The violent offense category includes homicide, forcible rape, robbery, assault, and kidnapping. The property offense category includes burglary; theft; motor vehicle theft; forgery, checks, and access card offenses; and arson.

Comparing 1981 to 1990,

- The largest change was in dispositions for drug offense arrests which increased from 20.6 to 32.7 percent.
- Dispositions for property offense arrests decreased from 42.2 to 32.9 percent.
- Adult felony arrest dispositions for violent offense arrests remained fairly stable.

In 1990,


Of 258,734 adult felony arrest dispositions:

- Drug offense arrests showed the greatest percentage of law enforcement releases (7.4 percent).
- Violent offense arrests showed the largest percentage of complaints denied (20.3 percent).
- Property and "all other" offense arrests showed the highest rates of conviction (72.7 and 75.6 percent, respectively).

Adults arrested for property offenses in 1990 were more likely to be convicted than those arrested for violent or drug offenses.

DISPOSITIONS OF VIOLENT OFFENSE ARRESTS

Comparing 1981 to 1990,


- Over half of the adult felony arrest dispositions for violent offenses resulted in a conviction.
- Law enforcement releases decreased from 11.2 to 6.0 percent.

in 1990,

- Persons arrested for forcible rape had the highest proportion of law enforcement releases (9.3 percent).
- Felony arrests for assault and forcible rape had the highest proportion of complaints denied by the prosecutor (21.1 and 20.6 percent, respectively).
- The combined proportion of lower and superior court dismissals and acquittals was highest for assault (19.6 percent).
- The proportion of violent offense arrests resulting in a conviction was highest for homicide (72.6 percent) and lowest for assault (53.7 percent).




ADULT FELONY ARREST DISPOSITIONS, 1981-1990 By Type of Disposition for Violent Offense Arrests

DISPOSITIONS OF PROPERTY OFFENSE ARRESTS

Comparing 1981 to 1990,


- The proportion of property offense arrests resulting in a conviction has been on the increase (62.1 to 72.7 percent).
- The largest decrease was in the law enforcement release category (11.1 to 5.4 percent).

In 1990,


- The proportion of law enforcement releases and complaints denied was much higher for motor vehicle theft arrests than for any of the other property offense arrests (11.9 and 20.3 percent, respectively).
- The combined proportion of lower and superior court dismissals and acquittals was highest for arson offense arrests (17.0 percent).
- The proportion of property offense arrests resulting in a conviction was highest for burglary (79.8 percent) and lowest for motor vehicle theft (58.0 percent).

DISPOSITIONS OF DRUG OFFENSE ARRESTS


Comparing 1981 to 1990,

- There has been a fairly constant growth in the proportion of drug offense arrests resulting in a conviction (45.6 to 62.9 percent).
- In 1990,
- Six out of ten drug offense arrests resulted in a conviction (62.9 percent).
- Less than two out of ten (17.4 percent) of the drug offense arrests were released prior to the court level.

The proportion of drug offense arrests resulting in a conviction has grown from 45.6 percent in 1981 to 62.9 percent in 1990.




ADULT FELONY ARREST DISPOSITIONS, 1981-1990 By Type of Disposition for Drug Offense Arrests

CONVICTIONS

Two different conviction rates are displayed in Chart 12:

- Conviction rates based on total adult felony an est dispositions describe the overall treatment of offenders by the criminal justice system. This focuses on the proportion of defendants who are convicted out of the total number of offenders who are arrested.
- Conviction rates based on total complaints filed describe the courts treatment of defendants. This eliminates law enforcement releases, prosecutor complaints denied, and petitions to revoke probation (areas over which the court system has no control) from the computational formula.

Comparing 1981 to 1990,

- Conviction rates remained relatively stable.
- Conviction rates based on complaints filed were, on the average, about 20 percentage points higher than those based on total adult felony arrest dispositions.


Conviction rates displayed in Chart 13 graphically show the proportion of defendants tried and convicted in lower courts and superior courts during the 1981 through 1990 period.

Comparing 1981 to 1990,

Superior court conviction rates increased from 88.6 to 95.0 percent while lower court conviction rates decreased from 70.1 to 68.5 percent.





CONVICTIONS

CONVICTED OFFENSE CATEGORIES

OBTS is a system of adult **felony** arrest dispositions. However, convicted offenses resulting from those adult felony arrests may be either felonies or misdemeanors. The violent offense category includes homicide, forcible rape, robbery, assault, and kidnapping. Property offenses include burglary; theft; motor vehicle theft; forgery, checks, and access card offenses; and arson.

Comparing 1981 to 1990,

As a percent of total convictions:

- The largest proportion of convictions was for property offenses.
- The greatest increase occurred in convictions for the drug offense category (13.6 to 30.0 percent).
- The proportion of violent offense convictions remained relatively stable (18.3 to 17.9 percent).

TYPE OF SENTENCE


Comparing 1981 to 1990,

As a percent of total convictions:

- The greatest proportion of sentences was to probation with jail. Since 1982, probation with jail has accounted for more than half of the sentences.
- State institution sentences increased from 14.3 to 19.9 percent.
- Probation sentences decreased from 27.6 to 12.5 percent.
- Jail sentences continued to decrease to a ten-year low of 6.4 percent in 1990.




ADULT FELONY ARRESTEES CONVICTED, 1981-1990 By Convicted Offense Category

SENTENCES

The Sentences section displays type of sentence by convicted offense and by convicted offense categories. The conviction data include convictions for both felony and misdemeanor offenses.

SENTENCES FOR VIOLENT OFFENSE CONVICTIONS

Comparing 1981 to 1990,

As a percent of adult felony arrestees convicted of violent offenses:

- Probation with jail was the most frequent sentence given and increased from 42.6 to 59.1 percent.
- Sentences to state institutions decreased 8.8 percentage points (31.8 to 23.0 percent).


From 1981 to 1990, assault convictions accounted for 71.5 percent (162,432) of the 227,110 violent offense convictions. The sentence pattern for the violent offense category is greatly influenced by the high volume of assault convictions. Therefore, Chart 17 is provided to display the sentence distribution for violent offense convictions excluding assault.

Comparing 1981 to 1990,

As a percent of adult felony arrestees convicted of violent offenses (excluding assault):

Seven out of ten were sentenced to state institutions.
Two out of ten were sentenced to probation with jail.


20 ADULT FELONY ARREST DISPOSITIONS

SENTENCES FOR VIOLENT OFFENSE CONVICTIONS - (continued)

In 1990,

As a percent of adult felony arrestees convicted of violent offenses:


- State institutions was the most frequent sentence given for violent offense convictions. Assault convictions were the exception with only 9.0 percent receiving state institution sentences.
- Jail sentences accounted for less than one percent of the sentences for each of the violent offenses, except assault.
- The proportion of sentences to probation with jail were much greater for assault convictions than for the other four violent offenses (68.8 versus 5.3, 22.4, 28.4 and 36.4 percent).

The total violent offense category is heavily influenced by the volume of assault convictions.

State institutions was the most frequent sentence given for four of the five violent offenses.

SENTENCES

SENTENCES FOR PROPERTY OFFENSE CONVICTIONS

Comparing 1981 to1990,

As a percent of adult felony arrestees convicted of property offenses:

- Probation with jail was the most common type of sentence (55.4 to 62.6 percent).
- Sentences to state institutions increased from 14.4 to 19.5 percent.
- Sentences to probation and sentences to jail decreased (19.5 to 10.7 percent and 10.7 to 7.2 percent, respectively).


In 1990,

As a percent of adult felony arrestees convicted of property offenses:

- Probation with jail was the most frequent sentence given, regardless of offense.
- The highest proportion of sentences to state institutions was for burglary offense convictions (33.4 percent).
- The highest proportion of sentences to probation was for forgery, checks, and access card offenses (19.1 percent).




ADULT FELONY ARRESTEES CONVICTED OF PROPERTY OFFENSES, 1981-1990 By Type of Sentence

SENTENCES FOR DRUG OFFENSE CONVICTIONS

Comparing 1981 to1990,

As a percent of adult felony arrestees convicted of drug offenses:

- State institutions sentences tripled (increasing from 7.1 to 21.5 percent).
- Probation with jail sentences increased from 48.8 to 65.0 percent.
- Jail sentences decreased from 10.0 to 4.7 percent.
- Probation sentences decreased from 34.1 to 8.9 percent.

ln 1990,


As a percent of adult felony arrestees convicted of drug offenses:

- Probation with jail sentences were given for the majority of these convictions (65.0 percent).
- Jail sentences were given for only 4.7 percent of these convictions.

Although there was a large increase in the proportion of sentences to state institutions for drug offense convictions, the majority of those convicted were sentenced to probation with jail.




ADULT FELONY ARRESTEES CONVICTED OF DRUG OFFENSES, 1981-1990 By Type of Sentence

Comparing 1981 to1990,

When state institution sentences were analyzed by convicted offense category, it was found that:

. **R**

- Sentences to state institutions for violent offense convictions decreased from 40.6 to 20.7 percent.
- Conversely, sentences to state institutions for drug offense convictions increased from 6.7 to 32.4 percent.

Comparing 1981 to 1990,


When probation with jail sentences were analyzed by convicted offense category, it was found that:

- Sentences to probation with jail for property offense convictions decreased from 50.2 to 36.1 percent.
- Probation with jail sentences for drug offense convictions increased from 13.9 to 31.8 percent.

From 1981 to 1990, the proportion of sentences to state institutions for violent offense convictions was cut in half (40.6 to 20.7 percent) while similar sentences for drug offense convictions were almost five times greater (6.7 to 32.4 percent).



SENTENCES

Comparing 1981 to 1990,

When jail sentences were analyzed by convicted offense category, it was found that:

- The largest change in jail sentences was in the proportion of drug offense convictions (up from 13.1 to 22.0 percent).
- Property offense convictions accounted for the largest proportion of sentences to jail.


Comparing 1981 to 1990,

When probation sentences were analyzed by convicted offense category, it was found that:

- The proportion of violent offense convictions increased from 11.9 to 18.6 percent.
- As a percent of all probation sentences, "all other" offense convictions decreased from 40.9 to 29.9 percent.




ADULT FELONY ARRESTEES CONVICTED AND SENTENCED TO JAIL, 1981-1990 By Convicted Offense Category

OFFENDER DEMOGRAPHICS

The Offender Demographics section describes the type of disposition, convicted offense category, and the type of sentence by sex, race/ethnic group, and age of the offender. Offender characteristics by type of disposition are displayed as a proportion of all adult felony arrest dispositions reported in 1990. Characteristics by convicted offense category and type of sentence are displayed as a proportion of the total lower and superior court convictions.

SEX BY TYPE OF DISPOSITION

ln 1990,

 A slightly larger proportion of females than males were convicted (66.1 versus 65.3 percent).

SEX BY CONVICTED OFFENSE CATEGORY

In 1990,

- Males were more than twice as likely to be convicted of a violent crime than females (19.6 versus 8.5 percent).
- The proportion of females convicted of a property crime was higher than the proportion of males (48.4 versus 32.9 percent).


SEX BY TYPE OF SENTENCE

In 1990,

 Regardless of sex, probation with jail was the type of sentence given most often.




ADULT FELONY ARREST DISPOSITIONS, 1990 Sex of Offender by Type of Disposition

OFFENDER DEMOGRAPHICS

RACE/ETHNIC GROUP BY TYPE OF DISPOSITION

In 1990,

- Whites (not Hispanic) and Hispanics were more likely to be convicted than blacks (67.5 and 69.4 versus 59.2 percent, respectively).
- Law enforcement releases and complaints denied occurred more frequently among blacks (26.4 percent) than among whites (not Hispanic) and Hispanics (13.8 and 18.0 percent, respectively).

RACE/ETHNIC GROUP BY CONVICTED OFFENSE CATEGORY



- A greater proportion of convictions was for drug offenses among those in the 20-29 and 30-39 age groups than for those in the under 20 and over 40 age groups (31.0 and 32.1 versus 19.5 and 28.6 percent, respectively).





OFFENDER DEMOGRAPHICS

CHARACTERISTICS OF GENERAL AND CONVICTED POPULATIONS

The demographic portrait of convicted adult felony arrestees is very unlike California's general population.


When comparing the characteristics of California's 1990 population and the adult felony arrest convicted population:

- The proportion of males among the convicted population was almost twice as great as the proportion of males in the general population (84.4 versus 48.7 percent, respectively).
- The proportion of blacks among the convicted population was about four times as great as the proportion of blacks in the general population (26.2 versus 6.7 percent, respectively).
- The proportion of those 20-29 years of age among the convicted population was more than twice as great as the proportion of 20-29 year olds in the general population (48.2 versus 21.3 percent, respectively).


The proportion of males, blacks, and persons 20-29 years of age is greater in the convicted population than in the general population.

DISPOSITIONS BY COUNTY SIZE

In 1990,

As a percent of all adult felony arrest dispositions:

- Law enforcement releases and prosecutor complaints denied were more frequent in the more populous county groups.
- Convictions were slightly more frequent in the two less populous county groups than in the two larger county groups (69.4 and 70.9 percent versus 62.3 and 65.2 percent).

CONVICTED OFFENSE CATEGORIES BY COUNTY SIZE

In 1990,

As a percent of total convictions:

- Regardless of county size, convictions for property offenses were the most frequent.
- Convictions for drug offenses occurred more often in the two larger county groups (32.4 and 27.1 percent versus 23.0 and 23.2 percent).

SENTENCES BY COUNTY SIZE

ln 1990,

As a percent of total convictions:

- Regardless of county population group size, probation with jail was the most frequent sentence.
- The 100,000 to 500,000 population group had the smallest proportion of sentences to state institutions (15.7 percent).



ADULT FELONY ARREST DISPOSITIONS, 1990 County Population Group by Type of Disposition



ADULT FELONY ARRESTEES CONVICTED, 1990 County Population Group by Convicted Offense



ELAPSED TIME

ELAPSED TIME FROM FELONY ARREST TO FINAL DISPOSITION

The average amount of time from date of arrest to the date of final disposition is called elapsed time, which is measured in days. Elapsed time figures are determined by calculating the sum of the days from arrest to the specific type of disposition and then dividing by the total number of dispositions in that specific disposition category. Elapsed time is not calculated for law enforcement releases or final dispositions occurring more than two years after the date of arrest. (These exclusions account for less than ten percent of the total dispositions.)

When elapsed times for 1981 and 1990 are compared:


Increases were noted in all except superior court dispositions.

For 1990:

- The elapsed time is greater for nonconvictions than for convictions.
- Nonconvictions in lower court took the longest time (227 days), while prosecutor complaints denied took the least time (17 days).






DISPOSITION TREE - PART A DISPOSITIONS OF ADULT FELONY ARRESTS, 1990 Police and Prosecutor Processing



APPENDIX

GLOSSARY

ACQUITTAL: a judgment of a court, based either on the verdict of a jury or a judicial officer, that the defendant is not guilty of the offense(s) for which he was tried.

ADULT: a person 18 years of age or older.

ARREST: "... taking a person into custody, in a case and in the manner authorized by law. An arrest may be made by a peace officer or by a private person." (P.C. 834)

AUTOMATED CRIMINAL HISTORY SYSTEM (ACHS): a centralized, automated system containing criminal history summary information on persons arrested and fingerprinted in California.

CALIFORNIA DEPARTMENT OF CORRECTIONS (CDC): the state agency which has jurisdiction over the California Rehabilitation Center and the California prison system.

CALIFORNIA REHABILITATION CENTER (CRC): an institution operated by the California Department of Corrections which is designated for the treatment of persons addicted to narcotics or in imminent danger of addiction. Commitment to the facility is by civil procedure only.

CALIFORNIA YOUTH AUTHORITY (CYA): the state agency which has jurisdiction over and maintains institutions as correctional schools for the reception of wards of the juvenile court and other persons committed from justice, municipal, and superior courts.

CIVIL COMMITMENT: a type of commitment in which criminal proceedings are suspended while a defendant undergoes treatment at the California Rehabilitation Center (CRC) as a narcotic addict.

COMMITMENT: a warrant, order, or process by which the court directs a judicial officer to take a person to a correctional facility.

COMPLAINT: a verified written accusation, filed by a prosecuting attorney with a local criminal court, which charges one or more persons with the commission of one or more offenses.

CONVICTION: a judgment, based either on the verdict of a jury or a judicial officer or on the guilty plea of the defendant, that the defendant is guilty.

CORRECTIONS: those agencies or facilities concerned with the custody, confinement, supervision, or treatment of alleged or adjudicated offenders. See also, California Department of Corrections.

COURT: an agency of the judicial branch of government, authorized or established by statute or constitution, having one or more judicial officers on its staff. A court has the authority to decide upon controversies in law and disputed matters of fact brought before it.

CRC: see California Rehabilitation Center.

CRIMINAL COMMITMENT: a type of commitment which results when a defendant is sentenced to prison or the California Youth Authority.

CYA: see California Youth Authority.

DEFENDANT: a person against whom a criminal proceeding is pending.

DEFERRED PAROLE REVOCATION: action taken by a prosecutor to revoke the parole status of a subsequent offender to return the subject to state prison in lieu of filing new charges.

DISMISSAL: a decision by a judicial officer to terminate a case without a determination of guilt or innocence.

Disposition - Court: an action taken as the result of an appearance in court by a defendant. Examples would be: adults -dismissed, acquitted, or convicted and sentenced; juveniles -dismissed, transferred, remanded to adult court, placed on probation, or sentenced to the California Youth Authority.

DISPOSITION - LAW ENFORCEMENT: an action taken as the result of an arrest. Examples of police dispositions are: adults - released by law enforcement, referred to another jurisdiction, or a misdemeanor or felony complaint sought.

DISPOSITION - PROSECUTOR: an action taken as the result of complaints which were requested by the arresting agency. Dispositions include granting a misdemeanor or a felony complaint, or denying a complaint for such reasons as lack of corpus, lack of sufficient evidence, interest of justice, complainant refuses to testify, witness unavailable, inadmissible search, deferred parole revocation, prefiling deferral and other. FELONY: a crime which is punishable with death or by imprisonment in the state prison for 16 months or two or three years (unless otherwise stated). (P.C. 17 & 18)

FILING: a document filed with the municipal court clerk or county clerk by a prosecuting attorney alleging that a person committed or attempted to commit a crime.

FINE: the penalty imposed upon a convicted person by a court requiring the payment of a specified sum of money.

JAIL: a county or city facility for incarceration of sentenced and unsentenced persons. Also known as a medium-maximum or type I or II facility (Section 1006 California Code of Regulations). See Medium-Maximum.

LOWER COURT: municipal or justice court.

MISDEMEANOR: a crime punishable by imprisonment in a county jail for up to one year or jail and fine.

MUNICIPAL OR JUSTICE COURT: the court of original or trial jurisdiction for the prosecution of persons accused of misdemeanor or certain felony offenses. Also, municipal and justice courts conduct preliminary hearings to determine probable cause in the case of felony offenders who are subject to jurisdiction of superior courts - the felony trial court.

OFFENDER-BASED TRANSACTION STATISTICS (OBTS): a system designed to collect statistical information on the various processes within the criminal justice system that occur between the point of arrest

and the point of final disposition.

OFFENSE: the charged offense is the crime for which the defendant was arrested or filed on by the district attorney. The convicted offense is the offense the defendant was convicted of or pled guilty to in court.

PETITION TO REVOKE PROBATION: action taken by a prosecutor to revoke the probation status of a subsequent offender to return the subject to county jail or state prison.

PRISON: a state correctional facility where persons are confined following conviction of a felony offense.

PROBATION: a judicial requirement that a person fulfill certain conditions of behavior in lieu of a sentence to confinement but sometimes including a jail sentence.

PROBATION WITH JAIL: a type of disposition rendered upon conviction which imposes a jail term as a condition of probation status.

PROBATION REVOCATION: see Petition to Revoke Probation.

PROSECUTOR: an attorney employed by a governmental agency whose official duty is to initiate and maintain criminal proceedings on behalf of the government against persons accused of committing criminal offenses.

SENTENCE: the penalty imposed by a court upon a convicted person.

STATE INSTITUTION: a facility for housing defendants who are under the jurisdiction of state correctional or treatment programs.

STATE SUPERVISION: the state correctional system provides confinement, rehabilitation, and parole services (prison, YA, state hospital) through California Department of Corrections (CDC), California Youth Authority (CYA), California Rehabilitation Center (CRC) and California Department of Mental Health (CDMH).

STRAIGHT PROBATION: probation granted to adults with no condition or stipulation that the defendant serve time in jail as a condition of probation.

SUPERIOR COURT: the court of original or trial jurisdiction for felony cases and all juvenile hearings. Also, the first court of appeal for municipal or justice court cases.

YA - YOUTH AUTHORITY: see California Youth Authority.

APPENDIX

OFFENDER-BASED TRANSACTION STATISTICS (OBTS)

KNOWN DATA LIMITATIONS

- These data reflect dispositions resulting from adult felony arrests. There is an important difference between arrest and OBTS data. Arrest data are grouped by the year in which the arrest took place. OBTS data are grouped by the year of disposition regardless of the year in which the arrest occurred.
- OBTS data are taken directly from the state's Automated Criminal History System (ACHS). All arrest information is entered in ACHS from the fingerprint card, while most disposition information is entered from the "Disposition of Arrest and Court Action" form (JUS 8715). In order for a disposition to be entered to ACHS, and subsequently appear on an offender's "rap sheet" and be available for statistical purposes, an arrest event fingerprint card MUST be received. A disposition which cannot be linked to a fingerprint card will not appear on the OBTS file.
- It is estimated that, in 1990, at the statewide level, about 60 percent of the adult felony arrests which were reported to BCS by law enforcement agencies on the Monthly Arrest and Citation Register were reported on the JUS 8715 form. In spite of this underreporting, the arrest dispositions received generally describe "statewide" processing of adult felony arrestees through California's criminal justice system. Comparisons of county and local data should be made with caution since the level of reporting may vary between jurisdictions and from year to year.
- These data do not represent the total number of adult felony arrest dispositions that occurred during the year. For example, thousands of adult felony arrests are disposed of by revoking the arrestee's probation or parole status in lieu of filing charges on the new arrest. These new arrest offense dispositions may not be reported as a final disposition on the JUS 8715

form. Any arrestees who are turned over to other states or to federal jurisdictions are not included in OBTS data. "Intermediate" dispositions (such as reporting a person being placed into a diversion program, suspended proceedings, reopenings, retrials, or subsequent actions) are also not included. Only the final disposition of an arrest event is selected for statistical purposes.

- If a person is arrested for multiple offenses, OBTS selects only the most serious offense, based on the severity of possible punishment. If there are multiple court dispositions, OBTS selects the most serious court disposition and the associated offense. Therefore, the arrest offense and the disposition offense may not necessarily correspond.
- OBTS data on state institutional commitments may vary from information compiled and reported by other state agencies because of differences in the data collection systems. For example, the California Department of Corrections (CDC) counts the number of defendants actually received in CDC institutions, even though a defendant may have been convicted and sentenced in two or more counties. OBTS counts each commitment.
- The adult felony arrest disposition file includes persons whose age at disposition was under 18. These minors received a final disposition in adult court under provision of the Welfare and Institutions Code, Sections 602, 707(a), 707(b), 707(c), and 707.1(a).
- In 1988, several new data elements were added to the OBTS system (i.e., petition to revoke probation, prefiling deferral, deferred parole revocation, and diversions dismissed).
