EXECUTIVE SUMMARY

The following report provides information on inmates under custody on February 24, 1990 who have been identified as substance abusers. The information on substance abuse reflects self-reported drug use six months prior to incarceration and scores of 9 or above on the Michigan Alcohol Screening Test (MAST).

Based on available self-report data on drug use and MAST scores, 73 percent (37,913) of the total inmate population of 51,737 may be identified as substance abusers. Seventy-four percent of 49,191 male inmates can be identified as substance abusers. Additionally 63 percent (1,601) of 2,546 female inmates can be identified as substance abusers.

It should be noted that the above percentage of identified substance abusers in the inmate population must be considered a conservative estimate of the extent of substance abuse. The numbers include both inmates who report no drug use and have MAST scores under 9 (7,388) and inmates with missing data on substance use (6,436). If these missing data cases are excluded, it may be calculated that 84 percent (37,913) of the 45,301 inmates for whom data is available may be classified as substance abusers.

The tables present data on drug and alcohol abuse, type of drug use, crime of commitment, region of commitment, minimum sentence, maximum sentence, second felony status, current age, educational level and ethnic status.



**SECTION I
IDENTIFIED SUBSTANCE ABUSERS**

The following table presents the breakdown of reported substance abuse for those persons held under custody as of February 24, 1990. Overall, 73 percent of inmates under custody are identified substance abusers. Of the 49,191 male inmates under custody, 74 percent (36,312) report using drugs or are classified as alcoholic based on a score of 9 or more on the Michigan Alcohol Screening Test (MAST). Of the 2,546 females under custody 63 percent (1,601) report using drugs or are classified as alcoholic based on a score of 9 or more on the Michigan Alcohol Screening Test (MAST).

PERCENT OF SUBSTANCE ABUSERS IN INMATE POPULATION

Table 2 presents the percentage of identified substance abusers in the inmate population (excluding cases missing data). For inmates for which substance abuse data is available, 84 percent can be identified as substance abusers. For males, 84 percent are identified substance abusers. For females, 70 percent are identified substance abusers.

DRUG AND/OR ALCOHOL ABUSE

Table 3 displays the breakdown of substance use reported by identified substance abusers. Of the identified male substance abusers, 73 percent report drug abuse only, 21 percent abuse both drugs and alcohol and 6 percent are identified as alcoholic according to the MAST (but report no drug use). Of the identified female substance abusers, 69 percent report drug abuse only, 20 percent abuse both drugs and alcohol, and 11 percent are identified as alcoholic according to the MAST.

TYPE OF SUBSTANCE ABUSE

Table 4 presents substance use for inmates identified as drug and/or alcohol abusers. Fifty percent of male inmates reporting substance abuse reported using cocaine or crack, 13 percent reported heroin use, 14 percent other drugs or narcotics 17 percent marijuana, and 6 percent were indicated alcoholics with no drug use. Of the female offenders, 50 percent reporting substance abuse reported using cocaine or crack, 30 percent reported heroin use, 4 percent reported other drugs or narcotics, 5 percent reported marijuana, and 11 percent were identified as alcoholic with no drug use.

SECTION II
COMMITMENT INFORMATION

CRIME OF COMMITMENT

The most common commitment offenses for identified substance abusers are drug offenses. Thirty-three percent of the identified male substance abusers were committed for the sale or possession of drugs. Robbery is the second most common offense (23%) followed by homicide (13%) and burglary (12%). Drug offenses are also the most common commitment offenses for female substance abusers. Sixty percent were committed for drug offenses, followed by robbery (12%) and homicide (9%).

REGION OF COMMITMENT

Region of the state is broken into four categories. Inmates from the New York City region are persons committed from Bronx, Kings, New York, Queens and Richmond counties. The Suburban New York region includes Nassau, Suffolk, Westchester and Rockland counties. Upstate urban reflects commitments from upstate counties that include a population center of 50,000 or more. The eight counties included in this category are Albany, Broom, Erie, Monroe, Oneida, Onondaga, Rensselaer and Schenectady. Upstate rural contains the remaining upstate counties.

The majority of identified substance abusers are from the New York City area. Seventy-three percent of males and 75 percent of females are from New York City. Twelve percent of males and 11 percent of females are from Suburban New York. Eight percent of both the male and female cases are from Upstate Urban areas while 7 percent of males and 6 percent of females are from other Upstate areas.

SECOND FELONY STATUS

The second felony offender law requires that persons, who have been convicted of a felony offense and who have a prior felony conviction, serve a mandatory state prison sentence. The following table provides second felony offender status for identified substance abusers.

Fifty-one percent of the identified male substance abusers were committed as second felony offenders, while 47 percent were committed as first felony offenders. Only two percent of male substance abusers were sentenced as persistent felons. For females, 46 percent of identified female substance abusers were committed as second felony offenders, while 54 percent were committed as first felony offenders.

MINIMUM SENTENCE

Seventy-three percent of identified male substance abusers have a minimum sentence less than six years (72 months). The median minimum sentence is three years (36 months).

For females, the percentage serving less than six years is much higher (92%). The median minimum sentence for females is two years (24 months).

MAXIMUM SENTENCE

Fifty-four percent of identified male substance abusers have a maximum sentence of less than eight years (96 months). Twenty-seven percent have a maximum sentence of 15 years or more or a maximum sentence of life.

Seventy-six percent of females have a maximum sentence less than eight years or less. Only 13 percent have a maximum sentence of 15 years or more or a maximum sentence of life.

SECTION III
DEMOGRAPHIC INFORMATION

The following tables present demographic information for inmates who have been identified as substance abusers. The average age of all identified substance abusers is 30.5 years.

Thirty percent of the male inmates are between 25 and 29 years old, while 22 percent are between 30 and 34 years old. Eighteen percent of the men fall between 21 and 24 years of age.

Similarly for females, 32 percent are between 25 and 29 years old, while 25 percent are between 30 and 34 years old. Seventeen percent are between 21 and 24 years of age.

EDUCATIONAL LEVEL AT RECEPTION

Thirty-four percent of identified male substance abusers report having a high school education or above. Thirty-six percent have less than a 10th grade education and 20 percent have an 8th grade education or less. For females, 32 percent report having a high school education or above. Thirty-five percent have less than a 10th grade education, and 18 percent have an 8th grade education or less.

ETHNIC STATUS

Forty-eight percent of identified male substance abusers are Black. Thirty-five percent are Hispanic and 17 percent are White. For females, 45 percent are Black, 40 percent are Hispanic and 14 percent are White.

CONCLUSION

As demonstrated by this report, the majority of incarcerated offenders in New York State are identified substance abusers. Of the offenders for which the Department has substance abuse data, 84 percent report using drugs or have a MAST score of 9 or greater. The most commonly reported drug used was cocaine/crack, with 50 percent of both males and females reporting usage. Marijuana was the second most frequently reported drug for males, however for females, heroin was the second most frequently reported drug.

The crime of commitment for identified substance abusers also reflects drug involvement, especially with women. Sixty percent of the females identified as substance abusers were committed for drug offenses. In contrast, only 33 percent of males were committed for drugs. However, in the case of both males and females, the most frequent commitment category was drug offenses.

Demographic information reveals the majority of substance abusers are from the New York City region, are Black or Hispanic, and average 30.5 years of age.

Educational level varies with approximately 30 percent reporting a high school education or above. However, 35 percent reported less than a 10th grade education.
