Preface

This report has been compiled to provide a detailed statistical profile of the adult offenders within the Kansas correctional system and to describe offender commitment and release trends for the state.

Each year since Fiscal Year 1980, the data for this report have been obtained through an on-line computerized offender information system in which information is gathered systematically during the entire period that an individual is in the custody or control of the Department of Corrections. The number of offenders for which information could be obtained varies among the items of information being reported. For this reason, each percentage reported is based on the number of individuals for whom the data were available, and not necessarily on the total number in the population being described.

The Kansas correctional facilities to which reference is made include the following: Kansas State Penitentiary (KSP), Kansas State Industrial Reformatory (KSIR), Kansas Correctional-Vocational Training Center (KCVTC), State Reception and Diagnostic Center (SRDC), Kansas Correctional Institution at Lansing (KCIL), Toronto Honor Camp (THC), El Dorado Honor Camp (EHC), Wichita Work Release Center (WWRC), Hutchinson Work Release Center (HWRC), Norton Correctional Facility (NCF), Winfield Correctional Facility (WCF), Osawatomie Correctional Facility (OCF), Forbes Correctional Facility (FCF), Topeka Correctional Facility (TCF), Ellsworth Correctional Facility (ECF), Hutchinson Correctional Work Facility (HCWF) and Stockton Correctional Facility (SCF). Inmates were also housed in FY 1989 at one contract work release facility (Fort Scott Work Release Center), at the Dillon security unit of Larned State Hospital (LSH), in contract jail placement (CJP), and at two community residential centers (Topeka CRC and Wichita CRC). Data pertaining to the small facilities of the same type often are combined for purposes of clarity in presentation.

Several new correctional facilities began operation in FY 1989:

- Ellsworth Correctional Facility (on line July, 1988);
- Hutchinson Correctional Work Facility (on line January, 1989);
- Stockton Correctional Facility (on line November, 1988);
- Topeka Community Residential Center (contracted program, on line July, 1988);
- El Dorado Community Residential Center (contracted program, on line August 1, 1988). The location of this facility was changed to Wichita in April 1989 and was renamed the Wichita CRC.

In July of 1989 both community residential centers were closed and the inmate residents assigned to other correctional facilities.

Introduction

The purpose of this statistical profile report is to summarize information regarding offender population levels, commitment trends, and characteristics of the offender population. The four major sections of the report include: a description of the pattern of growth in the offender population; a summary of admission and release activities occurring during Fiscal Year 1989; a detailed description of the characteristics of the inmate population confined on June 30, 1989; and a description of the June 30, 1989 population of offenders on supervised release. In the past several years there have been several modifications in Kansas criminal statutes which have produced significant changes in various attributes of the offender population. For this reason emphasis has been placed on comparisons of current information with that of prior years (particularly for data pertaining to type of criminal offense, sentencing patterns, and length of time served).

The detailed statistical tables and graphs of each section of the report are preceded by a summary of the highlights which identify significant trends and developments that occurred during FY 1989.

. SECTION I

Offender Population Levels and Institutional Capacity for
Fiscal Year 1989

Components of the System-wide Offender Population

- Primary components of June 30, 1989 system population of 12,137 are as follows:
 - Inmates confined in Kansas correctional facilities numbered 6,172 or 51% of the system population.
 - Offenders on supervised release -- Kansas offenders on parole/conditional release and compact parole/probation --numbered 5,481 or 45% of the system population.
 - Offenders in other locations, such as those in out-of-state correctional facilities and those returned for court appearance, numbered 484 (4%).
- System population increased by 7% from FY 1988.

Inmate Population Trends

- Year-end inmate population has more than doubled in the past decade, from 2,416 in FY 1979 to 6,172 in FY 1989.
- Average yearly increase in inmate population during the past ten-year period is 376.
- The month-end inmate population fluctuated during FY 1989, with population increases in seven months and decreases in five months.
- Although there has been substantial growth in the inmate population over the past several years, the average monthly increase has fluctuated markedly.

Current Inmate Population

- On June 30, 1989 the total inmate population was 6,172, an increase of 159 (2.6%) from June 30, 1988.
- The number of inmates in facilities operated by the Department of Corrections was 5,668, a decrease of 202 (3.4%) from FY 1988. With the opening of the two community residential centers at Topeka and El Dorado (later Wichita), the population in contracted facilities was 504, up 361 from 143 in FY 1988.
- The FY 1989 average daily population was 6,048, an increase of 194 (3.3%) from FY 1988.

- Total inmate population has decreased by 442 in the period June 30, 1989 through September 30, 1989. Much of the decrease is due to the implementation of the Senate Bill 49 provision that increased the amount of good time earned by most inmates. This provision was effective August 1, 1989, and was retroactive, thus applicable to all eligible

inmates in the existing population as well as to new entries to the system. As a result, 165 inmates received "early" conditional releases on August 1, 1989. Also, the parole eligibility dates for most of the remaining inmates were moved forward -- hence a large increase in the number of paroles in August, 1989.

- The decrease in the number of contract placements is due to the closing of the two community residential centers on July 31, 1989.

Capacity of Correctional Facilities

- The operating capacity for all existing KDOC facilities will be 5,485 as of January 1, 1990.
 - The operating capacity total excludes 515 beds categorized as temporary or special use (such as segregation and infirmary beds).
 - On January 1, 1990, the combined 2,207-bed operating capacity of Kansas State Penitentiary and Kansas State Industrial Reformatory will represent 40.2 percent of the total.
- The January 1, 1990 capacity for placement of inmates at non-DOC facilities will be 172. This total includes placements at Larned State Hospital and contract jail facilities.

Kansas Inmate Population Fiscal Years 1978-1989




. SECTION II

Admissions and Releases During Fiscal Year 1989

Information pertaining to admissions and releases of offenders during FY 1989 is summarized in this section. The basic data are presented in Table 4, the format of which is explained in the footnotes accompanying the table. Detailed information on court-related admissions to the system is presented by felony class of offense and county of commitment. Also included as part of this section is information on two topics which are central to the discussion of admissions and releases -- rate of parole and offender recidivism.

Summary of Admission and Release Activities

- Both admissions and releases in FY 1989 were the highest observed in the past decade.
- Total number of admissions during FY 1989 was 3,523, up 523 (17.4%) from FY 1988. This represents an increase of 31.7% in the past two years.
 - As in previous years, court commitments accounted for most of the FY 1989 admissions (76%).
- Total number of releases during FY 1989 was 3,408, up sharply (744 or 27.9%) from FY 1988. This was due primarily to an increase of 661 in the number of paroles, which in turn reflects the following law and policy changes.
 - Accelerated parole eligibility and advancement of parole hearing dates resulting from the liberalized good time provisions of Kansas House Bill 3079 which became law in May, 1988.
 - Increase in the rate of decisions to parole by the Kansas Parole Board.
- Since FY 1980, admissions have consistently and substantially outnumbered releases, producing the observed increases in inmate population.
- In recent years admissions for technical violations of parole and conditional release have increased substantially and have accounted for larger proportions of total admissions. Conversely, admissions via violations for new sentences have decreased somewhat and have accounted for smaller proportions of total admissions.

Admissions by Court Actions

- The distribution of the 2,539 FY 1989 court admissions by felony class is very similar to that of the past several years:

- The distribution of the FY 1989 court admissions by county of commitment indicates that as in prior years, the four most populous counties (Johnson, Sedgwick, Shawnee, and Wyandotte) collectively account for well over half the total (58%).
- In FY 1989 there were 86 admissions of offenders under age eighteen at the time of offense, up 12 (16%) from FY 1988.

Rate of Parole

Rate of parole reflects Kansas Parole Board decisions only and not actual parole exits from correctional facilities. The length of the period of time between the decision to parole and the actual release varies among cases.

- The rate of parole for FY 1989 was 53% -- up substantially from recent years (FY 88, 45%; FY 87, 43%; FY 86, 51%).
- The estimated rate of parole for the early 1980's is 80%. The lower rates of parole experienced in recent years have contributed significantly to the high rate of inmate population growth.

Offender Recidivism

The rate of offender recidivism has been operationally defined by the Department as the rate of return to Kansas prisons by offenders released via parole or conditional release. In deriving the data on this measure each offender is tracked individually for the specified length of the follow-up period. Separate rates are calculated for those returning with new sentences and those returning because of technical violations of the conditions of release. Table 9 contains a summary of the return rates for each yearly cohort of releases (Fiscal Years 1983 - 1988).

- "Combined failure rate" (combined returns via new sentence, technical violation, and new commitment after discharge) for the release cohorts was as follows:

Three	37% - 46%
Four	41% - 46%
Five	43% - 47%

- In general there appears to be the same trend in these data as noted in the admissions and releases section of this report:

- Considerably higher rate of technical violation returns for the later years (FY 1986 - FY 1988) as compared to the earlier years (FY 1983 - 84).
- Somewhat lower rate of new sentence returns for the later years.



. SECTION III

Profile of the Inmate Population: June 30, 1989

This section provides a description of selected characteristics of the inmate population confined within Kansas correctional facilities on June 30, 1989, the last day of FY 1989. The focus of this profile information is on the demographic attributes and social backgrounds of the offenders, the nature of the offenses for which incarcerated, the sentences imposed, and the criminal histories of the offenders. The inmate population was composed of 5,872 males and 300 females, for a total of 6,172.

Characteristics of the Inmate Population

- The list below summarizes some of the basic characteristics of the inmate population on June 30, 1989. Each of the following characteristics was observed in a majority of the inmates upon admission to the correctional system (or, as in the case of "length of current confinement," the status as of June 30, 1989):
 - Sex - Male
 - Racial/ethnic Group - White (40% non-white)
 - Age - 30 or under (average age - 29.2)
 - Religion - Protestant
 - Formal Education - Less than high school or G.E.D. (53%)
 - Formal Vocational Training - None
 - Employment Status - Not employed full-time
 - Longest Period of Employment - One year or less
 - Type of Admission - New court commitment
 - Type of Offense (most serious) - Person crime

- Length of Sentence (minimum) - Four years or less
 - Duration of Current Confinement (through 6-30-89) - Two years or less
 - Prior Felony Convictions - One or more
 - Prior Felony Incarcerations - None
- The Kansas State Penitentiary and the Kansas Industrial Reformatory together house about half (51.1%) of the total population.
 - There is considerable difference among the correctional facilities with regard to the demographic and criminal history characteristics of the inmate population housed. To a great extent this reflects the assignment of housing according to the security needs of the inmates, as well as their needs for particular correctional programs and services.
 - The more secure facilities such as KSP and KSIR house proportionately more inmates with serious offenses and longer terms to be served.
 - Among offenders by felony class, the group of inmates with Class D felonies have the highest proportion with at least one prior felony conviction (55% vs. 45% to 50% in the other felony class groups). The proportion with at least one prior felony incarceration ranges from 27% for Class C to 36% for Class B.
 - The distribution of the population by inmate security classification was as follows on June 30, 1989:

Inmate Employment Status and Program Assignments

- On June 30, 1989, 4,843 or 78% of all inmates had full-time work, academic or vocational assignments -- an increase from 70% on June 30, 1988.
 - Of the 1,329 inmates without full-time assignments:
 - 790 were not available for employment because they were in some type of segregation, treatment, orientation, or evaluation.
 - 539 were not employed either because no assignments were available (376), or because they were unwilling or temporarily unable to work (163).
- The most common institutional assignments were of the following types: institutional support, maintenance, utility work detail, Kansas Correctional Industries, vocational or academic education, and evaluation status. Additionally, a large number of inmates housed at the smaller facilities were assigned to non-institutional work programs.

Comparison of Female and Male Inmate Populations

- As of June 30, 1989, the inmate population was 95% male and 5% female.
 - The women in the inmate population numbered 300, up 24 (9%) from 276 the previous year.
- The growth in average daily population (ADP) has been different for male and female inmates. Since FY 1980 the growth in ADP has been 213% for women compared to 159% for men.
- As in the past several years, differences have been noted between the female and male inmates on almost all the characteristics compared. Proportionately speaking, in comparison to the male population the female population:
 - contained more blacks
 - had a higher level of formal education upon admission
 - had been committed for less severe offenses
 - had shorter average duration of current confinement

- had less extensive criminal histories
 - fewer had prior felony convictions
 - fewer had prior felony incarcerations
- had slightly greater prevalence of serious problems with drugs
- had less serious problems with alcohol

Characteristics of the New Admissions Population

Although the yearly turnover rate is relatively high among the offenders in the inmate population, at any point in time there is a large proportion of the group that has been counted in the yearly population for a number of years. For the past several years the characteristics of newly admitted offenders have been examined in order to better assess any trends toward change in the composition of the inmate population. Included as new admissions are new court commitments, aggravated juvenile delinquency commitments, and probation violators. Many offenders in this group are also members of the end-of-year inmate population since they were still on hand as of June 30, 1989. Note that the new admissions were not necessarily first-time offenders -- some had been incarcerated previously in other states or had served Kansas sentences from which they had been discharged.

- Compared to the June 30, 1988 inmate population, the FY 1989 new admissions population contained proportionately:
 - more offenders in the younger age groups
 - more whites
 - more women

- more offenders with less serious offenses
- fewer offenders with prior felony convictions
- fewer offenders with prior felony incarcerations
- To some extent the differences noted are due to the type of offense and sentence length. The offenders with more serious offenses, extensive criminal histories, and longer sentences tend to accumulate in the inmate population. Thus, the population on hand contains proportionately more offenders with these and related characteristics than does the population of new incoming offenders.

- For the FY 1989 admissions population, the overall projected average time to serve to earliest possible release, all felony classes combined, is 17.4 months. This represents a 28% decrease from the average of 22.3 months previously projected for FY 1988 admissions. Had the 1989 Legislature not amended statutory provisions for earning good time, the projected average for the FY 1989 admissions would have been 21.1 months -- on the average nearly four more months per offender.





. SECTION IV

Kansas Parolee Population, June 30, 1989

This section provides a brief description of the population of offenders in the correctional system who were on parole or supervised conditional release as of June 30, 1989. Also included is a summary of various parole-related activities occurring during FY 1989.

In years prior to FY 1987 the parole services caseload information that was described in this report was limited to clients in good standing. For the past three years there has been more detailed information available regarding the various categories of clients comprising the caseload. The parole officer caseload consists of Kansas offenders paroled to Kansas locations, as well as out-of-state parolees and probationers received by Kansas for supervision under interstate compact. There are no Kansas probationers included in the caseload since the supervision of this group has been a function of the district courts since June 1, 1979.

Composition of Parole Caseload

- As of June 30, 1989 there was a total of 3,680 offenders under supervision of 70 Kansas parole officers.
 - The total Kansas caseload has increased by 576 (19%) from FY 1988 and by 949 (35%) from FY 1987.
 - By the end of FY 1989, 11 new parole officer positions had been added to the 59 existing positions. However, the average caseload per parole officer remained at 53 - the same as it was at the end of FY 1988.
 - The group of 1,423 Kansas offenders under supervision out-of-state (including those with KDOC warrants), plus another group of 396 absconders, brings the total number of offenders managed by Kansas Parole Services to 5,499 -- up 910 (20%) from FY 1988 and up 1,473 (37%) from FY 1987.

Characteristics of Kansas Parolees

- The basic profile information on the population of offenders on parole and conditional release in Kansas suggests relatively little change in the past several years.
 - One exception is a shift in the composition of the population with regard to felony class of offense.

Noteworthy is the substantial increase in the number and proportion of offenders in felony classes A, B and C (the more serious offenses). The FY 1989 population contained 873 offenders in these classes collectively - some 52% more than the 573 in FY 1988 and 88% more than the 465 in FY 1987. However, felony class D and E offenders still comprise two-thirds of the population.

- There are substantial differences between the composition of the parole population and that of the inmate population:
 - Collectively, Class A and B offenders account for about 30% of the inmate population, but less than 10% of the parole population.
 - Class D and E offenders account for only about 44% of the inmate population, compared to 67% of the parole population.

- As in previous years, the paroles and conditional releases occurring in FY 1989 were concentrated in a few counties/states:
 - Three counties (Sedgwick, Shawnee, and Wyandotte) collectively account for 65% of the total number of in-state paroles and conditional releases.
 - Three states (Missouri, Oklahoma, and Texas) collectively account for 56% of the total number of out-of-state paroles and conditional releases.
- Within the June 30, 1989 parole population there was a total of 933 out-of-state offenders being supervised in Kansas (245 parole cases and 680 probation cases) -- very little change from FY 1988.
- As of June 30, 1989, there was a total of 1,229 Kansas cases being supervised out-of-state (excluding 195 with KDOC warrants), up 325 (36%) from June 30, 1988.
- As in previous years, the amount of compact case activity (compacts received and sent) was especially great in three states: Missouri, Oklahoma, and Texas.


