INTRODUCTION

In 1984, two important steps were taken in an effort to make government and local communities more responsive to the needs of crime victims. First, the Ohio Legislature and the Governor enacted the State Victims Assistance Act (SVAA), and later in the year, the federal Victims of Crime Act (VOCA) was passed by Congress and signed into law by the President.

Together, these two Acts have established the Ohio Crime Victims Assistance Program. Under this program, State and federal financial aid is awarded to qualified local offices and organizations that operate crime victims assistance programs in the state of Ohio.

This report provides a brief synopsis of each Act, details regarding the types of programs that have received support, and a summary of services and other interesting information pertaining to grant recipients. THE STATE VICTIM ASSISTANCE ACT

During the 115th Ohio General Assembly, Substitute Senate Bill 195, now known as the State Victims Assistance Act, was passed by the legislature and signed into law by the Governor of Ohio. This Act established, within the Office of the Attorney General, the Crime Victims Assistance Office.

The Act charges the Crime Victims Assistance Office with two primary responsibilities:

- 1) to determine crime victim service needs and policies for the state, and to improve and exercise leadership in the quality of programs for victims of crime; and
- 2) to determine which victims assistance programs will receive state financial assistance. The financial assistance has been provided through an appropriation by the state legislature from the Crime Victims Reparations Fund.

In addition, the State Victims Assistance Act established the State Victims Assistance Advisory Board. The Advisory Board consists of sixteen (16) members appointed by the Attorney General and four (4) ex-officio members. Each of the appointed members brings to the Advisory Board professional experience or interests in the concerns of victims of crime.

Under the State Victims Assistance Act, the Board serves in an advisory capacity to the Attorney General's Crime Victims Assistance Office in determining victim service needs and policies, and in improving the quality of victim service programs operated throughout the state. An additional responsibility of the Advisory Board is to review

local victim assistance programs and recommend to the Crime Victims Assistance Office which programs should be considered to receive financial aid that has been provided by the state and federal government.

THE VICTIMS OF CRIME ACT OF 1984

The Victims of Crime Act was passed by Congress and signed into law by the President on October 12, 1984, and amended by The Children's Justice and Assistance Act of 1986 and The Anti-Drug Abuse Act of 1988. The original Act was one of the results of recommendations made by the President's Task Force on Victims of Crime. The task force concluded that the needs of crime victims could be adequately met only by the federal, state and local governments, along with the private sector, sharing the responsibility of providing victim assistance. The Victims of Crime Act is a response to the call for action by victims and victims service providers who appealed to the task force for help.

To begin, the Act establishes within the U.S. Treasury a separate account known as the Crime Victim's Fund. The fund is similar to Ohio's Crime Victims Reparation Fund because it is not supported by tax dollars. The fund is generated entirely by fines, penalty assessments, and forfeited appearance and bail bonds collected by the federal government.

Through fiscal year 1994, the fund is permitted to reach a ceiling of \$150,000,000. Forty-nine and one-half percent (49.5%) of the first \$100,000,000 deposited in the fund is awarded to states with eligible crime victims compensation programs and 45% is awarded to states with eligible crime victims assistance programs. Any amounts deposited between \$100,000,000 and \$105,000,000 will be made available for Children's Justice Act purposes. Deposits in excess of \$105,500,000, but not in excess of \$110,000,000, will be made available for victim assistance program grants. Of deposits in excess of \$110,000,000 and up to the ceiling, 47.5% will be awarded for victim compensation grants, and 45.5% will be awarded for victim assistance program grants.

The state of Ohio is eligible for both the compensation grant and the assistance grant. The Court of Claims has been designated as the administrator of the Crime Victims Compensation Grant and the Attorney General has been designated as the administrator of the Crime Victims Assistance Grant.

The Crime Victims Assistance Program is supported by Grant No. 90-VA-GX-0039 awarded by the U.S. Department of Justice, Office of Justice Programs. Each year, through 1994, this agency will award VOCA funds to the state of Ohio based on the total in the Crime Victims Fund and the state's population. During 1994, Congress will review the VOCA Grant Program and determine whether or not funding will continue after 1994.

Eligible programs can be operated by either a public agency or a non-profit organization whose principal mission must be providing services to victims of crime.

Some services furnished by local victim assistance programs may include:

- Crisis intervention services
- Emergency temporary shelter
- 24-hour hotline services
- Justice and court-related services
- Support counseling and guidance
- Temporary day-care services
- Emergency medical services
- Social services and program referrals
- Crisis nursery care
- In-home counseling and homemaker services
- Victim compensation assistance

Applications and guidelines for VOCA Grants are available from the Crime Victims Assistance Office during the month of February each year. Funding determinations are usually made by the end of July; and the twelve (12) month funding period commences in the month of October.


Project Summary:

The Ohio Crime Victims Assistance Program provides financial support to Crime Victims Services, Inc. through a \$15,750 grant from the State Victims Assistance Act and a \$45,089 grant awarded from the Victims of Crime Act. Services provided by the agency include: crisis intervention, victim impact statements, restitution information, transportation, creditor intervention, property return and court escort; paralegal assistance, child care, preparation for court appearance, accompaniment of victims to the hospital, clean-up services, mediation and alternatives to testifying are also included in services.


Project Summary:




Project Summary:


Project Summary:







The Ohio Crime Victims Assistance Program provides financial support to the Auglaize County Prosecuting Attorney through a \$35,000 grant awarded from the State Victims Assistance Act. 
Project Summary:

Sec. 109.91. (A) THERE IS HEREBY ESTABLISHED WITHIN THE OFFICE OF THE ATTORNEY GENERAL THE CRIME VICTIMS ASSISTANCE OFFICE.

(B) THERE IS HEREBY ESTABLISHED THE STATE VICTIMS ASSISTANCE ADVISORY BOARD. THE BOARD SHALL CONSIST OF A CHAIRMAN, TO BE APPOINTED BY THE ATTORNEY GENERAL, FOUR EX OFFICIO MEMBERS, AND FIFTEEN MEMBERS TO BE APPOINTED BY THE ATTORNEY GENERAL AS FOLLOWS: ONE MEMBER WHO REPRESENTS THE OHIO VICTIM WITNESS ASSOCIATION; THREE MEMBERS WHO REPRESENT LOCAL VICTIM ASSISTANCE PROGRAMS, INCLUDING ONE FROM A MUNICIPALLY OPERATED PROGRAM AND ONE FROM A COUNTY OPERATED PROGRAM; ONE MEMBER WHO REPRESENTS THE INTERESTS OF ELDERLY VICTIMS; ONE MEMBER WHO IS A BOARD MEMBER OF ANY STATEWIDE OR LOCAL ORGANIZATION THAT EXISTS PRIMARILY TO AID VICTIMS OF DOMESTIC VIOLENCE, OR WHO IS AN EMPLOYEE OF, OR COUNSELOR FOR, SUCH AN ORGANIZATION; ONE MEMBER WHO IS AN EMPLOYEE OR OFFICER OF A COUNTY PROBATION DEPARTMENT OR A PROBATION DEPARTMENT OPERATED BY THE DEPARTMENT OF REHABILITATION AND CORRECTION; ONE MEMBER WHO IS A COUNTY PROSECUTING ATTORNEY; ONE MEMBER WHO IS A CITY LAW DIRECTOR; ONE MEMBER WHO IS A COUNTY SHERIFF; ONE MEMBER WHO IS A MEMBER OR OFFICER OF A TOWNSHIP OR MUNICIPAL POLICE DEPARTMENT; ONE MEMBER WHO IS A COURT OF COMMON PLEAS JUDGE; ONE MEMBER WHO IS A MUNICIPAL COURT JUDGE OR COUNTY COURT JUDGE; AND TWO MEMBERS WHO ARE PRIVATE CITIZENS AND ARE NOT GOVERNMENT EMPLOYEES.

THE BOARD SHALL INCLUDE THE FOLLOWING EX OFFICIO, NONVOTING MEMBERS: THE CHIEF JUSTICE OF THE SUPREME COURT, THE ATTORNEY GENERAL, ONE MEMBER OF THE SENATE TO BE DESIGNATED BY THE PRESIDENT OF THE SENATE, AND ONE MEMBER OF THE HOUSE OF REPRESENTATIVES TO BE DESIGNATED BY THE SPEAKER OF THE HOUSE.

MEMBERS OF THE BOARD SHALL SERVE WITHOUT COMPENSATION, BUT SHALL BE REIMBURSED FOR TRAVEL AND OTHER NECESSARY EXPENSES THAT ARE INCURRED IN THE CONDUCT OF THEIR OFFICIAL DUTIES AS MEMBERS OF THE BOARD. THE CHAIRMAN AND MEMBERS OF THE BOARD APPOINTED BY THE ATTORNEY GENERAL SHALL SERVE AT THE PLEASURE OF THE ATTORNEY GENERAL. THE CHIEF JUSTICE OF THE SUPREME COURT AND THE ATTORNEY GENERAL SHALL SERVE ON THE BOARD UNTIL THE END OF THE TERM OF OFFICE THAT QUALIFIED THEM FOR MEMBERSHIP ON THE BOARD. THE MEMBER OF THE SENATE AND THE MEMBER OF THE HOUSE OF REPRESENTATIVES SHALL SERVE AT THE PLEASURE OF THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF REPRESENTATIVES, RESPECTIVELY.

(C) THE VICTIMS ASSISTANCE ADVISORY BOARD SHALL PERFORM BOTH OF THE

FOLLOWING DUTIES:

(1) ADVISE THE CRIME VICTIMS ASSISTANCE OFFICE IN DETERMINING CRIME AND DELINQUENCY VICTIM SERVICE NEEDS, DETERMINING CRIME AND DELINQUENCY VICTIM POLICIES FOR THE STATE, AND IMPROVING AND EXERCISING LEADERSHIP IN THE QUALITY OF CRIME AND DELINQUENCY VICTIM PROGRAMS IN THE STATE;

(2) REVIEW AND RECOMMEND TO THE CRIME VICTIMS ASSISTANCE OFFICE THE VICTIM ASSISTANCE PROGRAMS THAT SHOULD BE CONSIDERED FOR THE RECEIPT OF STATE FINANCIAL ASSISTANCE PURSUANT TO SECTION 109.92 OF THE REVISED CODE. THE FINANCIAL ASSISTANCE ALLOCATION RECOMMENDATIONS OF THE BOARD SHALL BE BASED ON THE FOLLOWING PRIORITIES:

(a) PROGRAMS IN EXISTENCE ON THE EFFECTIVE DATE OF THIS SECTION SHALL BE GIVEN FIRST PRIORITY;

(b) PROGRAMS OFFERING OR PROPOSING TO OFFER THE BROADEST RANGE OF SERVICES AND REFERRALS TO THE COMMUNITY SERVED, INCLUDING MEDICAL, PSYCHOLOGICAL, FINANCIAL, EDUCATIONAL, VOCATIONAL, AND LEGAL SERVICES THAT WERE NOT IN EXISTENCE ON THE EFFECTIVE DATE OF THIS SECTION SHALL BE GIVEN SECOND PRIORITY; (c) OTHER QUALIFIED PROGRAMS SHALL BE GIVEN LAST PRIORITY.

(D) AS USED IN THIS SECTION AND SECTION 109.92 OF THE REVISED CODE, "VICTIM ASSISTANCE PROGRAM" INCLUDES, BUT IS NOT LIMITED TO A PROGRAM THAT PROVIDES AT LEAST ONE OF THE FOLLOWING:

(1) SERVICES TO VICTIMS OF ANY OFFENSE OF VIOLENCE OR DELINQUENT ACT THAT WOULD BE AN OFFENSE OF VIOLENCE IF COMMITTED BY AN ADULT;

(2) FINANCIAL ASSISTANCE OR PROPERTY REPAIR SERVICES TO VICTIMS OF CRIME OR DELINQUENT ACTS;

(3) ASSISTANCE TO VICTIMS OF CRIME OR DELINQUENT ACTS IN JUDICIAL PROCEEDINGS;

(4) ASSISTANCE TO VICTIMS OF CRIME OR DELINQUENT ACTS UNDER THE OPERATION OF ANY POLITICAL SUBDIVISION OF THE STATE OR A BRANCH OF THE CRIMINAL JUSTICE SYSTEM SET FORTH IN DIVISION (B)(1), (2), OR (3) OF SECTION 122.21 OF THE REVISED CODE;

(5) TECHNICAL ASSISTANCE TO PERSONS OR ORGANIZATIONS THAT PROVIDE SERVICES TO VICTIMS OF CRIME OR DELINQUENT ACTS UNDER THE OPERATION OF A BRANCH OF THE CRIMINAL JUSTICE SYSTEM SET FORTH IN DIVISIONS (B)(1), (2), AND (3) OF SECTION 122.21 OF THE REVISED CODE.

A VICTIM ASSISTANCE PROGRAM DOES NOT INCLUDE THE PROGRAM FOR THE REPARATION OF CRIME VICTIMS ESTABLISHED PURSUANT TO CHAPTER 2743. OF THE REVISED CODE.

Sec. 109.92. (A) FUNDS MAY BE APPROPRIATED TO THE OFFICE OF THE ATTORNEY GENERAL FOR THE PURPOSE OF PROVIDING STATE FINANCIAL ASSISTANCE TO VICTIM ASSISTANCE PROGRAMS THAT OPERATE IN THE STATE. ANY FUNDS APPROPRIATED FOR

THAT PURPOSE BY THE GENERAL ASSEMBLY SHALL BE USED TO PROVIDE FINANCIAL ASSISTANCE TO VICTIM ASSISTANCE PROGRAMS IN ACCORDANCE WITH SECTION 109.91 OF THE REVISED CODE AND THIS SECTION. THE PROGRAM FOR THE PROVISION OF SUCH FINANCIAL ASSISTANCE SHALL BE ADMINISTERED BY THE CRIME VICTIMS ASSISTANCE OFFICE ESTABLISHED PURSUANT TO SECTION 109.91 OF THE REVISED CODE.

(B) A VICTIM ASSISTANCE PROGRAM MAY APPLY TO THE CRIME VICTIMS ASSISTANCE OFFICE FOR STATE FINANCIAL ASSISTANCE OUT OF FUNDS APPROPRIATED TO THE OFFICE OF THE ATTORNEY GENERAL FOR THAT PURPOSE BY THE GENERAL ASSEMBLY. EACH APPLICATION FOR SUCH FINANCIAL ASSISTANCE SHALL INCLUDE ALL OF THE FOLLOWING INFORMATION:

(1) EVIDENCE THAT THE PROGRAM IS INCORPORATED IN THIS STATE AS A NONPROFIT CORPORATION OR IS A PROGRAM ESTABLISHED BY A UNIT OF STATE OR LOCAL GOVERNMENT;

(2) THE PROPOSED BUDGET OF THE PROGRAM FOR THE PERIOD DURING WHICH THE FINANCIAL ASSISTANCE IS SOUGHT;

(3) A SUMMARY OF SERVICES OFFERED BY THE PROGRAM;

(4) AN ESTIMATE OF THE NUMBER OF PERSONS SERVED BY THE PROGRAM.

(C) WITHIN THIRTY DAYS OF RECEIPT OF AN APPLICATION FOR FINANCIAL ASSISTANCE FROM A VICTIM ASSISTANCE PROGRAM IN ACCORDANCE WITH DIVISION (B) OF THIS SECTION, THE CRIME VICTIMS ASSISTANCE OFFICE, BASED IN PART ON THE RECOMMENDATIONS OF THE VICTIM ASSISTANCE ADVISORY BOARD MADE PURSUANT TO SECTION 109.91 OF THE REVISED CODE, SHALL NOTIFY THE PROGRAM IN WRITING WHETHER IT IS ELIGIBLE FOR FINANCIAL ASSISTANCE AND, IF ELIGIBLE, ESTIMATE THE AMOUNT THAT WILL BE MADE AVAILABLE TO THE PROGRAM AND THE TIME WHEN THE FINANCIAL ASSISTANCE WILL BE MADE AVAILABLE.

(D) EACH VICTIM ASSISTANCE PROGRAM THAT RECEIVES ANY FINANCIAL ASSISTANCE PURSUANT TO THIS SECTION SHALL USE THE FINANCIAL ASSISTANCE ONLY TO PROVIDE THE SERVICES IDENTIFIED IN ITS APPLICATION FOR SUCH ASSISTANCE AS BEING SERVICES IT OFFERED AND TO COVER A REASONABLE COST OF ADMINISTRATION OF THE PROGRAM. EACH VICTIM ASSISTANCE PROGRAM THAT RECEIVES ANY SUCH FINANCIAL ASSISTANCE SHALL MAKE A GOOD FAITH EFFORT TO MINIMIZE ITS COSTS OF ADMINISTRATION.

CRIME VICTIMS FUND

SEC. 1402. (a) There is created in the Treasury a separate account to be known as the Crime Victims Fund (hereinafter in this chapter referred to as the "Fund").

(b) Except as limited by subsection (c), there shall be deposited in the Fund—

(1) all fines that are collected from persons convicted of offenses against the United States except—

(A) fines available for use by the Secretary of the Treasury pursuant to—

(i) section 11(d) of the Endangered Species Act (16 U.S.C. 1540(d); and

(ii) section 6(d) of the Lacey Act Amendments of 1981 (16 U.S.C. 3375(d);

and

(B) fines to be paid into—

(i) the railroad unemployment insurance account pursuant to the Railroad Unemployment Insurance Act (45 U.S.C. 351 et seq.);

(ii) the Postal Service Fund pursuant to sections 2601(a)(2) and 2003 of title 39 of the United States Code and for the purposes set forth in section 404(a)(8) of such title 39;

(iii) the navigable waters revolving fund pursuant to section 311 of the Federal Water Pollution Control Act (33 U.S.C. 1321); and

(iv) county public school funds pursuant to section 3613 of title 18 of the United States Code;

(2) penalty assessments collected under section 3013 of title 18 of the United States Code;

(3) the proceeds of forfeited appearance bonds, bail bonds, and collateral collected under section 3146 of title 18 of the United States Code; and

(4) any money ordered to be paid into the Fund under section 3671(c)(2) of title 18 of the United States Code.

(c)(1) (A) If the total deposited in the Fund during a particular fiscal year reaches the ceiling sum described in subparagraph (B), the excess over the ceiling sum shall not be part of the Fund. The first \$2,200,000 of such excess shall be available to the judicial branch for administrative costs to carry out the functions of the judicial branch under sections 3611 and 3612 of title 18, United States Code, and the remaining excess shall be deposited in the general fund of the Treasury.

(B) The ceiling sum referred to in subparagraph (A) is

(i) \$125,000,000 through fiscal year 1991; and

(ii) \$150,000,000 thereafter through fiscal year 1994.

(2) No deposits shall be made in the Fund after September 30, 1994

(d)(1) Sums deposited in the Fund shall remain in the Fund and be available for expenditure under this subsection for grants under this title without fiscal year limitation.

(2) The Fund shall be available as follows:

(A) Of the first \$100,000,000 deposited in the Fund in a particular fiscal

year—

- (i) 49.5% shall be available for grants under Sec. 1403;
- (ii) 45% shall be available for grants under Sec. 1404 (a);
- (iii) 1% shall be available for grants under Sec. 1404 (c); and
- (iv) 4.5% shall be available for grants as provided in Sec. 1404A.

(B) The next \$5,500,000 deposited in the Fund in a particular fiscal year shall be available for grants as provided in Sec. 1404A

(C) Any deposits in the Fund in a particular fiscal year in excess of \$105,500,000 but not in excess of \$110,000,000, shall be available for grants under section 1404 (a).

(D) Any deposits in the Fund in a particular fiscal year in excess of \$110,000,000 shall be available as follows:

- (i) 47.5 percent shall be available for grants under section 1403;
- (ii) 47.5 percent shall be available for grants under section 1404

(a); and

- (iii) 5 percent shall be available for grants under section 1404 (c)

(1) (B).

(e) (1) Except as provided in paragraph (2), any sums awarded as part of a grant under this chapter that remain unspent at the end of a fiscal year in which such grant is made may be expended for the purpose for which such grant is made at any time during the next succeeding fiscal year, at the end of which year any remaining unobligated sums shall be returned to the general fund of the Treasury.

(2) For the purposes of the application of paragraph (1) to any grant under this chapter with respect to fiscal year 1985, there shall be substituted in such paragraph "two succeeding fiscal years" for "succeeding fiscal year" and "which period" for "which year".

(f) As used in this section, the term "offenses against the United States" does not include—

- (1) a criminal violation of the Uniform Code of Military Justice (10 U.S.C. 801 et seq.);
- (2) an offense against the laws of the District of Columbia; and
- (3) an offense triable by an Indian tribal court or Court of Indian Offenses.

(g) (1) The Attorney General, acting through the Director, shall use 15 percent of the funds available under subsection (d) (2) (A) (iv) to make grants for the purpose of assisting Native American Indian tribes in developing, establishing, and operating programs designed to improve—

- (A) the handling of child abuse cases, particularly cases of child sexual abuse, in a manner which limits additional trauma to the child victim; and
- (B) the investigation and prosecution of cases of child abuse, particularly child sexual abuse.

(2) As used in this subsection, the term "tribe" has the meaning given that term in section 4(b) of the Indian Self-Determination and Education Assistance Act.

(CRIME VICTIM COMPENSATION, SEC. 1403 IS NOT REPRINTED IN THIS REPORT)

CRIME VICTIM ASSISTANCE

SEC. 1404. (a)(1) Subject to the availability of money in the Fund, the Director shall make an annual grant from any portion of the Fund not used for grants under section 1403 with respect to a particular fiscal year, and after any deduction under subsection (c), to the chief executive of each State for the financial support of eligible crime victim assistance programs.

(2) Such chief executive shall—

- (A) certify that priority shall be given to eligible crime victim assistance programs providing assistance to victims of sexual assault, spousal abuse,

or child abuse;

(B) certify that funds shall be made available for grants to programs which serve previously underserved populations of victims of violent crime. The Director after consultation with State and local officials and representatives from private organizations, shall issue guidelines to implement this section that provide flexibility to the States in determining the populations of victims of violent crimes that may be underserved in their respective States.

(C) certify that funds awarded to eligible crime victim assistance programs will not be used to supplant State and local funds otherwise available for crime victim assistance; and

(D) provide such other information and assurances related to the purposes of this section as the Director may reasonably require.

(3) The amounts of grants under paragraph (1) shall be—

(A) the base amount to each State; and

(B) that portion of the then remaining available money to each State that results from a distribution among the States on the basis of each State's population in relation to the population of all States.

(4) If the amount available for grants under paragraph (1) is insufficient to provide the base amount to each State, the funds available shall be distributed equally among the States.

(5) As used in this subsection, the term "base amount" means—

(A) \$150,000 for fiscal years 1989 through 1991; and

(B) \$200,000 thereafter through fiscal year 1994.

(b) (1) a victim assistance program is an eligible crime victim assistance program for the purposes of this section if such program—

(A) is operated by a public agency or a nonprofit organization, or a combination of such agencies or organizations or of both such agencies and organizations, and provides services to victims of crime;

(B) demonstrates—

(i) a record of providing effective services to victims of crime and financial support from sources other than the Fund; or

(ii) substantial financial support from sources other than the Fund;

(C) utilizes volunteers in providing such services, unless and to the extent the chief executive determines that compelling reasons exist to waive this requirement;

(D) promotes within the community served coordinated public and private efforts to aid crime victims; and

(E) assists potential recipients in seeking crime victim compensation benefits.

(2) An eligible crime victim assistance program shall expend sums received under subsection (a) only for providing services to victims of crime.

(c)(1) The Director shall make grants—

(A) for training and technical assistance services to eligible crime victim assistance programs; and

(B) for the financial support of services to victims of Federal crime by eligible crime victim assistance programs.

(2) Of the amount available for grants under this subsection —

(A) not more than 50% shall be used for grants under Paragraph 1(A); and

(B) not less than 50% shall be used for grants under Paragraph 1(B).

- (3) The Director shall—
- (A) be responsible for monitoring compliance with guidelines for fair treatment of crime victims and witnesses issued under section 6 of the Victim and Witness Protection Act of 1982 (Public Law 97-291);
 - (B) consult with the heads of Federal law enforcement agencies that have responsibilities affecting victims of Federal crimes;
 - (C) coordinate victim services provided by the Federal Government with victim services offered by other public agencies and nonprofit organizations; and
 - (D) perform such other functions related to the purposes of this title as the Director deems appropriate.
- (4) The Director may reimburse other instrumentalities of the Federal Government and contract for the performance of functions authorized under this subsection.
- (d) As used in this section—
- (1) the term "State" includes the District of Columbia, the Commonwealth of Puerto Rico, the United States Virgin Islands, and, any other territory or possession of the United States; and
 - (2) the term "services to victims of crime" includes—
 - (A) crises intervention services;
 - (B) providing, in an emergency, transportation to court, short-term child care services, and temporary housing and security measures;
 - (C) assistance in participating in criminal justice proceedings; and
 - (D) payment of all reasonable costs for a forensic medical examination of a crime victim, to the extent that such costs are otherwise not reimbursed or paid;
 - (3) the term "services to victims of Federal crime" means services to victims of crime with respect to Federal crime, and includes—
 - (A) training of law enforcement personnel in the delivery of services to victims of Federal crime;
 - (B) preparation, publication and distribution of informational materials—
 - (i) setting forth services offered to victims of crime; and
 - (ii) concerning services to victims of Federal crime for use by Federal law enforcement personnel; and
 - (C) salaries of personnel who provide services to victims of crime, to the extent that such personnel provide such services;
 - (4) the term "crises intervention services" means counseling to provide emotional support in crises arising from the occurrence of crime; and
 - (5) the term "chief executive" includes a person designated by a chief executive to perform the functions of the chief executive under this section.
