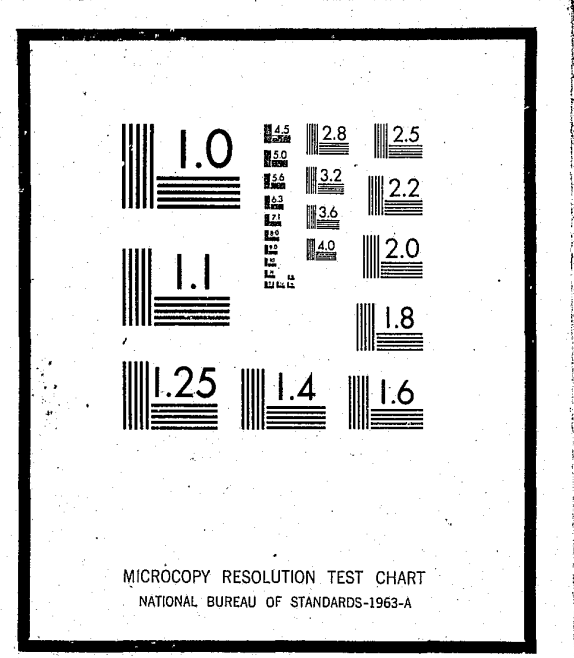

Obviously, this cannot always be done in a timely manner for all requests so there is some dependence on local sources. The State Division of Corrections, local police, and school officials are quite helpful to the Anchorage and Fairbanks offices in such instances.

In making telephone calls to Alaska it should be noted that Anchorage and Fairbanks are two time zones west of other west coast states. Calls should be planned accordingly.
