Preface

This report has been compiled to provide a detailed statistical profile of the adult offenders within the Kansas correctional system and to describe offender commitment and release trends for the state.

Each year since Fiscal Year 1980, the data for this report have been obtained through an online computerized offender information system in which information is gathered systematically during the entire period that offenders are in the custody or control of the Department of Corrections. The number of offenders for which information could be obtained varies among the items of information being reported. For this reason, each percentage reported is based on the number of individuals for whom the data were available, and not necessarily on the total number in the population being described.

In accordance with Kansas Senate Bill 748, effective May 24, 1990, several correctional facilities were consolidated and/or renamed. Subsequent administrative actions taken by the Department of Corrections in August, 1990 and in June, 1991 resulted in further consolidation of facilities. In addition, two new facilities have opened recently, El Dorado Correctional Facility in June, 1991, and Larned Correctional Mental Health Facility in January, 1992. Table A contains a list of the current facilities and unit designations along with the prior names and designations. In addition to the facilities listed, inmates were also housed in FY 1992 at one contract work release facility (Topeka Halfway House), at Larned State Hospital (LSH), and in contract jail placement (CJP).

Introduction

The purpose of this statistical profile report is to summarize information regarding offender population levels, commitment trends, and characteristics of the offender population. The four major sections of the report include: a description of the pattern of growth in the offender population; a summary of admission and release activities occurring during Fiscal Year 1992; a detailed description of the characteristics of the inmate population confined on June 30, 1992; and a description of the June 30, 1992 population of offenders on supervised release. In the past several years there have been several modifications in Kansas criminal statutes which have produced significant changes in various attributes of the offender population. For this reason emphasis has been placed on comparisons of current information with that of prior years (particularly for data pertaining to type of criminal offense, sentencing patterns, and length of time served).

The detailed statistical tables and graphs of each section of the report are preceded by a summary of the highlights which identify significant trends and developments that occurred during FY 1992.

Offender Population Levels and Institutional Capacity for Fiscal Year 1992

Components of the System-wide Offender Population

- Primary components of June 30, 1992 in-state inmate and parole population of 11,814 are as follows:
 - Inmates confined in Kansas correctional facilities numbered 6,193 or 52.4% of the population.
 - Kansas parole caseload -- Kansas offenders on parole/conditional release in Kansas and compact parole/probation cases supervised in Kansas --numbered 5,621 or 47.6% of the population.
- Additional offenders under management include 125 inmates either on in absentia or compact status, as well as 2,578 offenders on parole/conditional release under out-of-state supervision or on abscond status.

Inmate Population Trends

- Year-end inmate population increased in FY 1992, by 10% -- compared to decreases of 1% and 8% during the previous two fiscal years.
- The change in the month-end inmate population was relatively steady during FY 1992, with population increases in 10 of the 12 months.

The average monthly change in inmate population has fluctuated markedly over the past 10 years.

Current Inmate Population

- On June 30, 1992 the total inmate population was 6,193, an increase of 574 (10.2%) from June 30, 1991.
 - The number of inmates in facilities operated by the Department of Corrections was 6,075, an increase of 592 (10.8%) from FY 1991. The population in contract placement was 118, down 18 from 136 in FY 1991.
- The FY 1992 average daily population was 5,870, an increase of 144 (2.5%) from 5,726 in FY 1991.

- Total inmate population on September 30, 1992, was 6,139 -- down 54 from 6,193 on June 30, 1992.

Capacity of Correctional Facilities

- The total operating capacity, including placements in non-KDOC facilities, is 6,621.
 - The operating capacity total includes all 610 beds of the new central unit of the El Dorado Correctional Facility, which opened in June, 1991, and all 150 beds of the new Larned Correctional Mental Health Facility, which opened in January, 1992.
 - Of the total operating capacity, 376 beds have been designated for female occupancy.
- The capacity for placement of inmates at non-DOC facilities is 161. This total includes placements at Larned State Hospital, contract jail facilities, and a contract work release facility (Topeka Halfway House).
- Funding has been approved for the construction of a 75-bed maximum security housing unit for female inmates. The new unit will be located on the grounds of the Topeka Correctional Facility and is scheduled to open in early 1994.

Figure 1 **Kansas Inmate Population** Fiscal Years 1983 - 1992





Figure 2 End-of-Month Inmate Population Fiscal Years 1991 - 1992

Admissions and Releases During Fiscal Year 1992

Information pertaining to admissions and releases of offenders during FY 1992 is summarized in this section. The basic data are presented in Table 4, the format of which is explained in the footnotes accompanying the table. Detailed information on court-related admissions to the system is presented by felony class of offense and county of commitment. Also included as part of this section is information on two topics which are central to the discussion of admissions and releases -- rate of parole and offender recidivism.

Summary of Admission and Release Activities

- In FY 1992, admissions increased and releases decreased from the levels observed in FY 1991.
- Total number of admissions during FY 1992 was 4,051, up 275 (7.3%) from FY 1991.
 - As in previous years, court commitments accounted for most of the admissions (69%).
- Total number of releases during FY 1992 was 3,490, down 367 (9.5%) from FY 1991.
- In recent years, return admissions for violations of parole and conditional release (no new sentence) have increased substantially and have accounted for larger proportions of total admissions. In FY 1992 returns with no new sentences accounted for over one-fourth (28%) of all admissions.

In the past two years, return admissions via violations for new sentences, which had accounted for smaller proportions of total admissions in previous years, have shown a substantial increase -- from 254 in FY 1990 to 325 in FY 1991 to 386 in FY 1992.

Both types of violation together accounted for over one-third (37%) of all admissions in FY 1992.

- The distribution of the FY 1992 court admissions by county of commitment indicates that as in prior years, the four most populous counties (Johnson, Sedgwick, Shawnee, and Wyandotte) collectively account for over half the total (56%).
- In FY 1992 there were 88 admissions of offenders under age eighteen at the time of offense, down 8 (8%) from FY 1991.

Rate of Parole

The information presented on rate of parole reflects Kansas Parole Board decisions only and not actual parole exits from correctional facilities. The length of the period of time between the decision to parole and the actual release varies among cases.

- The rate of parole fell sharply in FY 1992 -- to 45.6% from 57.9% in FY 1991. While the total number of decisions increased by 210 (5%), the number receiving parole decreased by 474 (18%).
- The rates of parole experienced in recent years are substantially lower than the estimated 80% parole rate for the early 1980's.

Offender Recidivism

The rate of offender recidivism has been operationally defined by the Department as the rate of return to Kansas prisons by offenders released via parole or conditional release. In deriving the data on this measure each offender is tracked individually for the specified length of the follow-up period. Separate rates are calculated for those returning with new sentences and those returning with no new sentences. Table 9 contains a summary of the return rates for each yearly cohort of releases (Fiscal Years 1985 - 1991).

"Combined failure rate" (combined returns via new sentence, no new sentence, and new commitment after discharge) for the release cohorts was as follows:

Note that most failures occur in the first three years post-release.

In general there appears to be the same trend in these data as noted in the admissions and releases section of this report:

• Considerably higher rate of returns with no new sentences in recent years.

Such instances arise in cases where offenders are on abscond status for a long period of time (counted in "Abscond Status" group), but later are reinstated on parole in good standing and then discharged. When such reinstatements occur, the affected offenders move from the absconder group to the success group for the latest year.

Profile of the Inmate Population: June 30, 1992

This section provides a description of selected characteristics of the inmate population confined within Kansas correctional facilities on June 30, 1992, the last day of FY 1992. The focus of this profile information is on the demographic attributes and social backgrounds of the offenders, the nature of the offenses for which incarcerated, the sentences imposed, and the criminal histories of the offenders. The inmate population was composed of 5,865 males and 328 females, for a total of 6,193.

Characteristics of the Inmate Population

- The list below summarizes some of the basic characteristics of the inmate population on June 30, 1992. Each of the following characteristics was observed in a majority of the inmates upon admission to the correctional system (or, as in the case of "age" and "length of current confinement," the status as of June 30, 1992):
 - Sex Male (95%)
 - Racial/ethnic Group White (with 45% non-white)
 - Age 32 or under (average age 30.1)
 - Religion Protestant (59%)
 - Formal Education Less than high school or G.E.D. (52%)
 - Formal Vocational Training None (77%)
 - Longest Period of Employment One year or less (54%)
 - Type of Admission New court commitment (70%)
 - Type of Offense (controlling minimum) Person crime (58%)
 - Length of Sentence (minimum) Five years or less (61%)
 - Duration of Confinement To-date (through 6-30-92) 18 months or less
 - Prior Felony Convictions None (61%)
 - Prior Felony Incarcerations None (70%)

There is considerable difference among the correctional facilities with regard to the demographic and criminal history characteristics of the inmate population housed. To a great extent this reflects the assignment of housing according to the security needs of the inmates, as well as their needs for particular correctional programs and services.

- Among offenders by felony class, the proportion with at least one prior felony conviction ranges from 35% for Class E to 44% for Classes A and B. The proportion with at least one prior felony incarceration ranges from 27% and 28% for Classes C and E, respectively, to 35% for Class A.
- The distribution of the population by inmate custody classification was as follows on June 30, 1992:

Inmate Employment Status and Program Assignments

 On June 30, 1992, 4,757 or 78% of the 6,075 inmates in department facilities had full-time work, program, academic or vocational assignments. As a general rule, a full-time assignment means that a single work or program assignment occupies the inmate for more than half the work day, usually for 6.5 hours or more.

Of the 1,318 inmates without full-time assignments:

- 668 were not available for assignment because they were in some type of segregation, treatment, orientation, or evaluation.
- 650 were not assigned because they were in transition between assignments, or because an assignment was not available on the specified date, or because they were unwilling or temporarily unable to be assigned.
- An additional 118 inmates were contract placements (Larned State Hospital, contract jail placement, and contract work release).
- The most common institutional assignments were of the following types: institutional support, maintenance, utility work detail, Kansas Correctional Industries, vocational or academic education, and evaluation status. Additionally, a large number of inmates housed at the smaller facilities were assigned to non-institutional work programs.

Comparison of Female and Male Inmate Populations

- As of June 30, 1992, the inmate population was 94.7% male and 5.3% female.
 - The women in the inmate population numbered 328, up sharply (36%) from 242 the previous year. It should be noted, however, that the 242 observed at the end of FY 1991 was a particularly low point, having dropped from 293 at the end of FY 1990.
- The average daily population (ADP) for FY 1992 is approximately double the level of ten years ago for both male and female inmates. The female ADP is 97% greater and the male ADP is 110% greater than in FY 1982, at which time the female ADP was 144 and the male 2,657. For the past three years there has been relatively little change in ADP for either group.
- As in the past several years, differences have been noted between the female and male inmates on almost all the characteristics compared. Proportionately speaking, in comparison to the male population the female population:
 - contained more inmates from minority racial/ethnic groups
 - had a higher level of formal education upon admission
 - had been committed for less severe offenses
 - had shorter average duration of current confinement
 - had less extensive criminal histories
 - fewer had prior felony convictions
 - fewer had prior felony incarcerations

Characteristics of the New Admissions Population

Although the yearly turnover rate is relatively high among the offenders in the inmate population, at any point in time there is a large proportion of the group that has been counted in the yearly population for a number of years. For the past several years the characteristics of newly admitted offenders have been examined in order to better assess any trends toward change in the composition of the inmate population. Included as new admissions are new court commitments, aggravated juvenile delinquency commitments, and probation violators. Many offenders in this group are also members of the end-of-year inmate population since they were still on hand as of June 30, 1992. Note that the new admissions were not necessarily first-time offenders -- some had been incarcerated previously in other states or had served Kansas sentences from which they had been discharged.

- Compared to the June 30, 1991 inmate population, the FY 1992 new admissions population contained proportionately:
 - more offenders in the younger age groups
 - more women
 - more offenders with less serious offenses
 - fewer offenders with prior felony convictions
 - fewer offenders with prior felony incarcerations
- To some extent the differences noted are due to the type of offense and sentence length. The offenders with more serious offenses, extensive criminal histories, and longer sentences tend to accumulate in the inmate population. Thus, the population on hand contains proportionately more offenders with these and related characteristics than does the population of new incoming offenders.

- Offenders whose most serious offense was a drug crime numbered 867. This represents 14.2% of the population and reflects an increase of 19% from the corresponding figure for FY 1991 (731).
- Distribution of the inmate population by the minimum term of the controlling sentence shows that there is a nearly even split between those with minimums of under five years (49.4%) and those with minimums of five or more years (51.6%). As shown in the second part of Table 17 (cited below) this distribution has remained relatively stable over the past several years.

Kansas Parolee Population, June 30, 1992

This section provides a brief description of the population of offenders in the correctional system who were on parole or supervised conditional release as of June 30, 1992. Also included is a summary of various parole-related activities occurring during FY 1992.

In years prior to FY 1987 the parole services caseload information that was described in this report was limited to that pertaining to clients in good standing. For the past several years there has been more detailed information available regarding the various categories of clients comprising the caseload. The parole officer caseload consists of Kansas offenders paroled to Kansas locations, as well as out-of-state parolees and probationers received by Kansas for supervision under interstate compact. There are no Kansas probationers included in the caseload since the supervision of this group has been a function of the district courts since July 1, 1979.

Composition of Parole Caseload

- As of June 30, 1992 there was a total Kansas caseload of 5,616 offenders under supervision of 70 Kansas parole officers.
 - The total Kansas caseload increased only slightly (2%) from FY 1991, but is still double the corresponding figure for FY 1987.
 - The average caseload per parole officer changed little -- from 79 in FY 1991 to 80 in FY 1992.
 - The group of 1,925 Kansas offenders under supervision out-of-state (including those with KDOC warrants), plus another group of 642 absconders, brings the total number of offenders managed by Kansas Parole Services to 8,183 -- up 166 (2%) from FY 1991.

Characteristics of Kansas Parolees

- The basic profile information on the characteristics of the population of Kansas offenders on parole and conditional release in Kansas suggests relatively little change in the past several years.
 - One exception noted in recent years is a shift in the composition of the population with regard to felony class of offense.

Noteworthy is the substantial increase in the number and proportion of offenders in felony classes A, B and C (the more serious offenses). At the end of FY 1988, only 28% of the population was from A, B, and C collectively. The proportion has increased to 33% in FY 1989, 36% in FY 1990, 38% in FY 1991, and 39% in FY 1992.

- There are substantial differences between the parole population and the inmate population with regard to felony class of most serious offense:
 - Collectively, Class A and B offenders account for about 30% of the inmate population, but only about 11% of the parole population.
 - Class D and E offenders account for about 40% of the inmate population, compared to 63% of the parole population.

- As in previous years, the paroles and conditional releases occurring in FY 1992 were concentrated in a few counties/states:
 - Three counties (Sedgwick, Shawnee, and Wyandotte) collectively account for 67% of the total number of in-state paroles and conditional releases. Sedgwick County alone received 888 or 40% of the statewide total.
 - Three states (Missouri, Oklahoma, and Texas) collectively account for 55% of the total number of out-of-state paroles and conditional releases.
- Within the June 30, 1992 parole population there was a total of 1,375 out-of-state offenders being supervised in Kansas (439 parole cases and 936 probation cases). The number of such cases increased by 82 or 6% from FY 1991.
- As of June 30, 1992, there was a total of 1,947 Kansas cases being supervised out-of-state again the majority (53%) in Missouri, Oklahoma, and Texas collectively.




