FELON NEW ADMISSIONS

HIGHLIGHTS

The number of felon new admissions from court decreased from 39,272 in 1990 to 38,252 in 1991.

The number of Hispanic (Mexican) felon new admissions doubled from 7,286 in 1986 to 14,454 in 1991.

More than half (54.1%) of felon new admissions in 1991 were under the age of 30.

Of the total felon new admissions to CDC, Los Angeles accounted for 41.4% in 1986 and 40.4% in 1991.

The number of felon new admissions for drug offenses increased from 5,500 in 1986 to 12,459 in 1991.

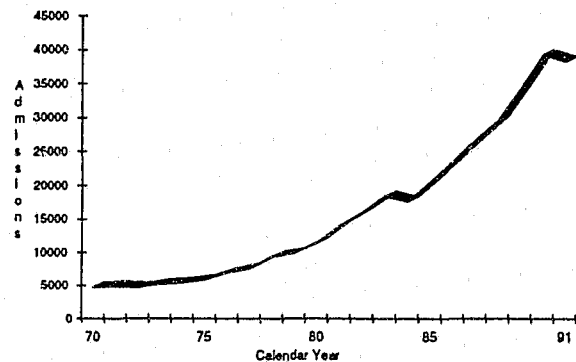
FELON NEW ADMISSIONS

ADMISSIONS

The number of felon new admissions to prison decreased from 39,272 in 1990 to 38,252 in 1991.

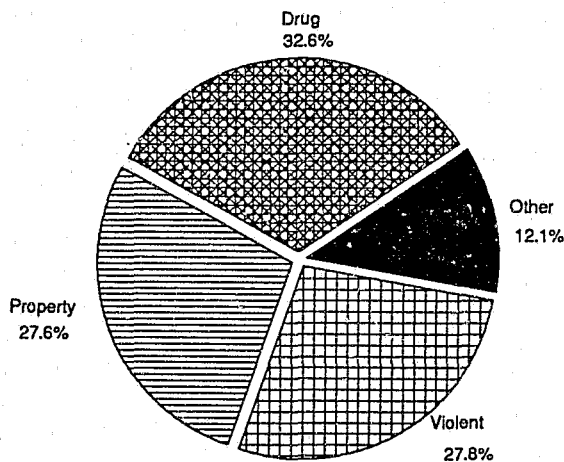
- Felon new admissions have increased 174.6% since 1981, 62.2% since 1986 and decreased 2.6% since 1990.
- The number of male felon new admissions in 1991 was 34,785 and the number of female felon new admissions was 3,467.

OFFENSE CATEGORIES

Drug offenders were the largest offense category for felon new admissions during Calendar Year 1991.

- Violent offenders accounted for 27.8% (10,616) of the felon new admissions.
- Property offenders accounted for 27.6% (10,537) of felon new admissions.
- Drug offenders accounted for 32.6% (12,459) of felon new admissions.
- Offenders who committed other offenses made up the remaining 12.1% (4,628).

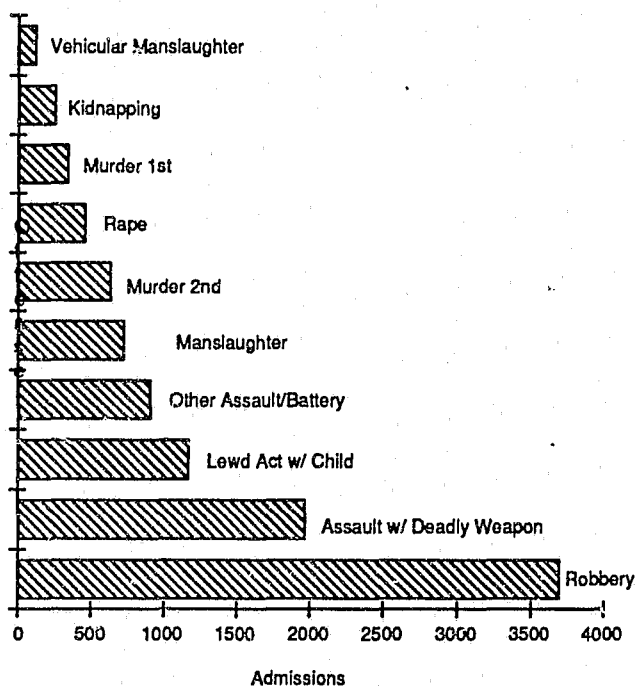
FELON NEW ADMISSIONS

VIOLENT OFFENSES

The number of felon new admissions for violent offenses increased from 8,243 in 1986 to 10,616 in 1991. The percentage of all new admissions that were for violent offenses decreased from 35.0% in 1986 to 27.8% in 1991.

- Homicides accounted for 1,840 (4.8%) felon new admissions. There were:
 - 350 (0.9%) Murder First admissions.
 - 637 (1.7%) Murder Second admissions.
 - 726 (1.9%) Manslaughter admissions.
 - 127 (0.3%) Vehicular Manslaughter admissions.
- There were 3,701 (9.7%) Robbery admissions.
- Assault with a Deadly Weapon accounted for 1,970 (5.2%) of the felon new admissions.
- Other Assault/Battery accounted for 911 (2.4%) felon new admissions.
- Sex crimes accounted for 1,936 (5.1%) felon new admissions. There were:
 - 465 (1.2%) admissions for Rape.
 - 1,171 (3.1%) admissions for Lewd Act with a Child.
 - 300 (0.8%) admissions for other sex crimes.
- Kidnapping accounted for 258 (0.7%) felon new admissions.

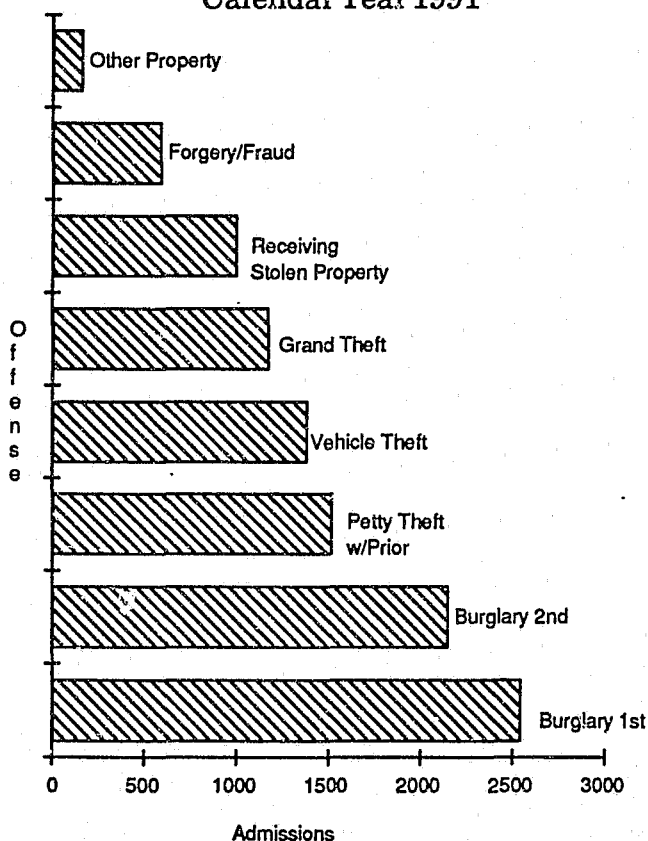
Violent Offenses

PROPERTY OFFENSES

The number of felon new admissions for property offenses increased from 8,865 in 1986 to 10,537 in 1991. As a percentage of all felon new admissions, property offenses decreased from 37.6% in 1986 to 27.6% in 1991.

- Burglary First and Second Degree, the two largest property offense groups, accounted for 4,701 (12.3%) of felon new admissions. There were:
 - 2,547 (6.7%) Burglary First Degree.
 - 2,154 (5.6%) Burglary Second Degree.
- Grand Theft accounted for 1,174 (3.1%) new admissions.
- Petty Theft with a Prior accounted for 1,520 (4.0%) new admissions.
- Receiving Stolen Property accounted for 1,003 (2.6%) new admissions.
- Vehicle Theft accounted for 1,384 (3.6%) new admissions.
- Forgery/Fraud offenses accounted for 591 (1.6%) new admissions.
- Other Property offenses accounted for 164 (0.4%) new admissions.

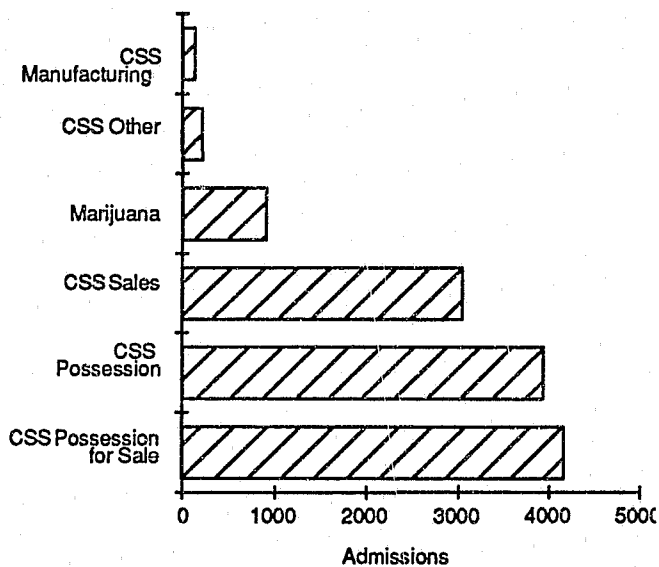
FELON NEW ADMISSIONS

DRUG OFFENSES

The number of felon new admissions for drug offenses increased from 5,500 in 1986 to 12,459 in 1991. As a percentage of all felon new admissions, drug offenders increased from 23.3% in 1986 to 32.6% in 1991.

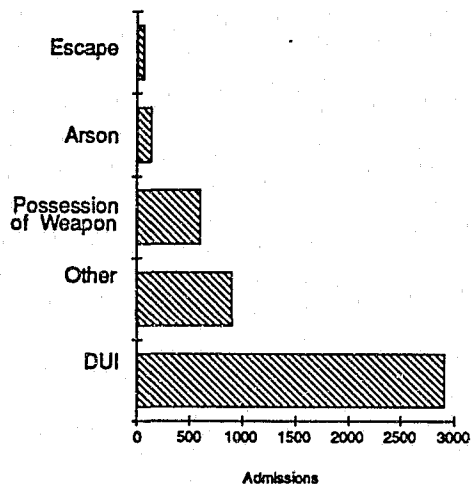
- CSS Possession accounted for 3,943 (10.3%) felon new admissions.
- CSS Possession for Sale accounted for 4,173 (10.9%) felon new admissions.
- CSS Sale accounted for 3,052 (8.0%) felon new admissions.
- CSS Other and Manufacturing accounted for 376 (1.0%).
- Marijuana offenders accounted for 915 (2.3%) felon new admissions.

OTHER OFFENSES

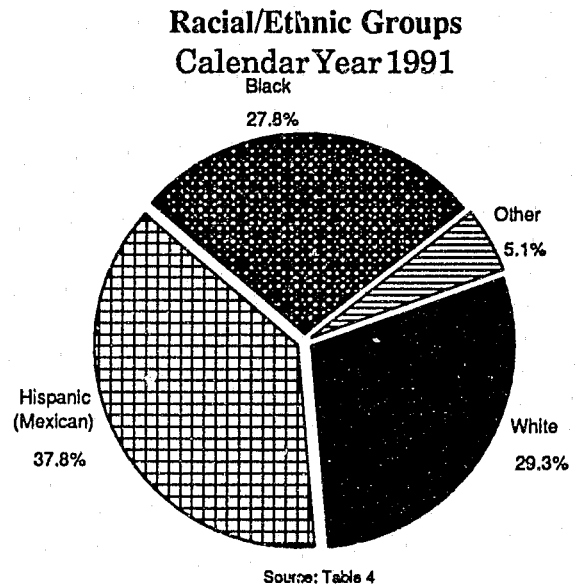
- Escapes accounted for 68 (0.2%) new admissions.
- Driving Under the Influence (DUI) offenses accounted for 2,911 (7.6%) new admissions.
- Arson offenders accounted for 138 (0.4%) new admissions.
- Possession of Weapons accounted for 604 (1.6%) new admissions.
- Other Offenses accounted for 907 (2.4%) new admissions.

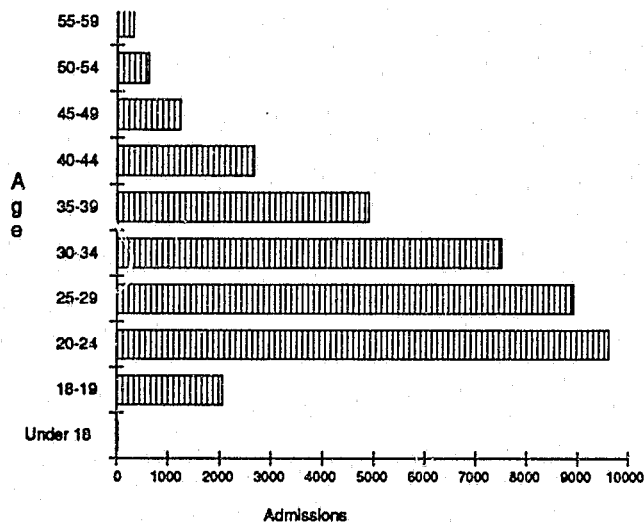
RACIAL/ETHNIC GROUPS

Felon new admissions for Calendar Year 1991 fall into the following racial/ethnic groups:

- White admissions accounted for 29.3% (11,212).
- Hispanic (Mexican) offenders accounted for 37.8% (14,454). They represent they largest racial/ethnic group.
- Black admissions accounted for 27.8% (10,649).
- Other racial/ethnic groups accounted for 5.1% (1,937).

AGE GROUPS

The felon new admissions in 1991 were typically older than those admitted in 1986.

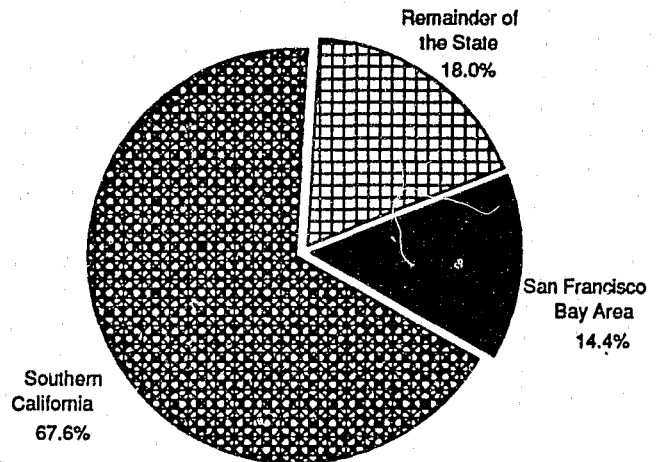
- The largest age group of felon new admissions was 20-24 years of age and accounted for 25.2% (9,632).
- The second largest age group was the 25-29 year olds, accounting for 23.4% (8,932).
- The smallest age group was the under 18 which represented 0.1% (37) of the felon new admissions.
- The median age of felon new admissions increased from 27 in 1986 to 29 in 1991.

AREA OF COMMITMENT

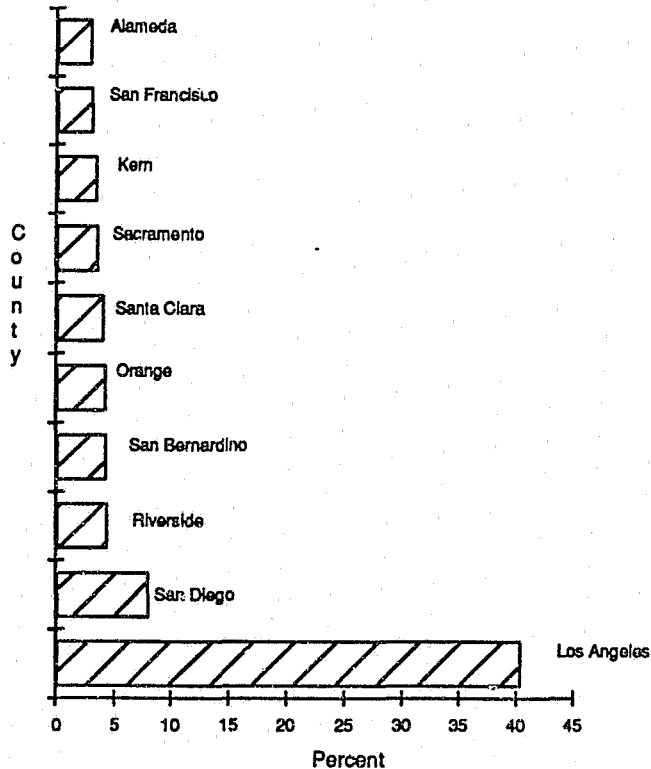
- 25,869 (67.6%) felon new admissions were admitted from Southern California.
- 5,506 (14.4%) felon new admissions were admitted from the San Francisco Bay Area.
- 6,877 (18.0%) felon new admissions were admitted from the remainder of the state.

COUNTY OF COMMITMENT

- Los Angeles County alone accounted for 15,470 (40.4%) of the felon new admissions.
- San Diego was the next largest county of commitment, accounting for 3,098 (8.1%).
- Santa Clara was the highest in felon new admissions from the San Francisco Bay Area, accounting for 1,566 (4.1%).
- Mariposa County, with one felon new admission, sent the fewest to prison.

PAROLE VIOLATORS RETURNED WITH A NEW TERM (PV-WNT)

HIGHLIGHTS

The number of PV-WNTs increased from 14,070 in 1986 to 16,010 in 1991.

The percentage of PV-WNTs with violent offenses has decreased from 22.3% in 1986 to 16.9% in 1991.

The number of drug offender PV-WNTs has increased 292.5%, from 1,179 in 1986 to 4,627 in 1991.

During the last five years, the percentage of PV-WNTs who were white has decreased.

Of the total PV-WNTs returned to prison, Los Angeles County accounted for 43.9%.

The median age of the PV-WNTs has increased from 28 years in 1986 to 30 years in 1991.

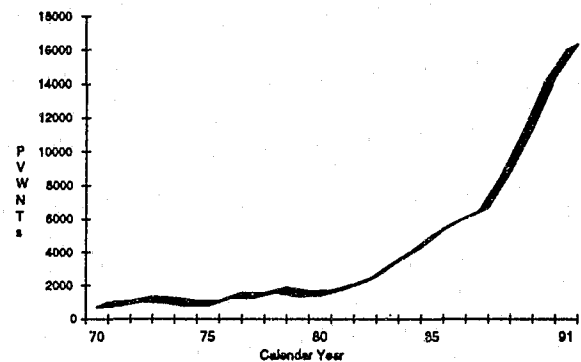

PAROLE VIOLATORS RETURNED WITH A NEW TERM

During Calendar Year 1991, the Parole Violators Returned With a New Term (PV-WNTs) reached an all time high of 16,010.

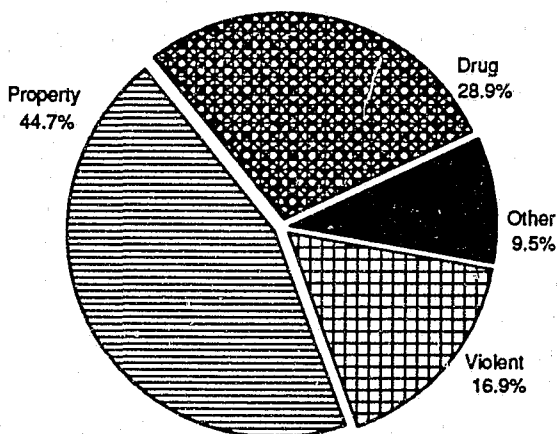
- PV-WNTs increased from 685 in 1970 to 16,010 in 1991.
- There were 14,994 male PV-WNTs and 1,016 female PV-WNTs.

OFFENSE CATEGORIES

Property offenders represent the largest offense category for PV-WNTs received during Calendar Year 1991.

- Violent offenders accounted for 16.9% (2,705) of the PV-WNTs.
- Property offenders accounted for 44.7% (7,156).
- Drug offenders accounted for 28.9% (4,627).
- Offenders who committed other offenses made up the remaining 9.5% (1,522) of the PV-WNTs.

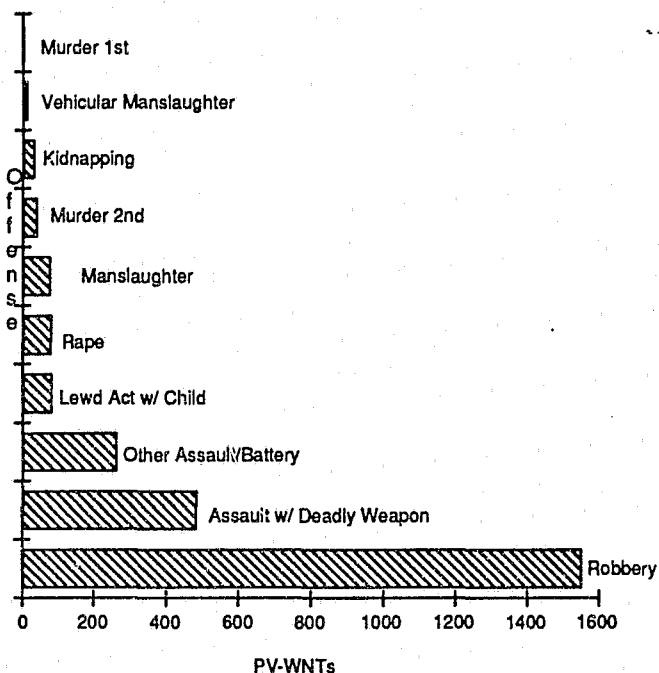
PAROLE VIOLATORS RETURNED WITH A NEW TERM (PV-WNT)

VIOLENT OFFENSES

The PV-WNTs for violent offenses increased from 1,281 in 1986 to 2,705 in 1991. The total percentage of violent offenses decreased from 22.3% in 1986 to 16.9% in 1991.

- Homicides accounted for 136 (0.9%) of the PV-WNTs. There were:
 - 5 (0.0%) Murder First offenders.
 - 41 (0.3%) Murder Second offenders.
 - 77 (0.5%) Manslaughter offenders.
 - 13 (0.1%) Vehicular Manslaughter offenders.
- There were 1,553 (9.7%) Robbery offenders.
- Assaults with a Deadly Weapon accounted for 486 (3.0%) of the PV-WNTs.
- Other Assault/Battery accounted for 265 (1.7%) of the PV-WNTs.
- Sex crimes accounted for 233 (1.3%) of the PV-WNTs. There were:
 - 80 (0.5%) Rape offenders.
 - 82 (0.5%) Lewd Act with a Child offenders.
 - 71 (0.3%) Other Sex crime offenders.
- Kidnapping accounted for 32 (0.2%) of the PV-WNTs.

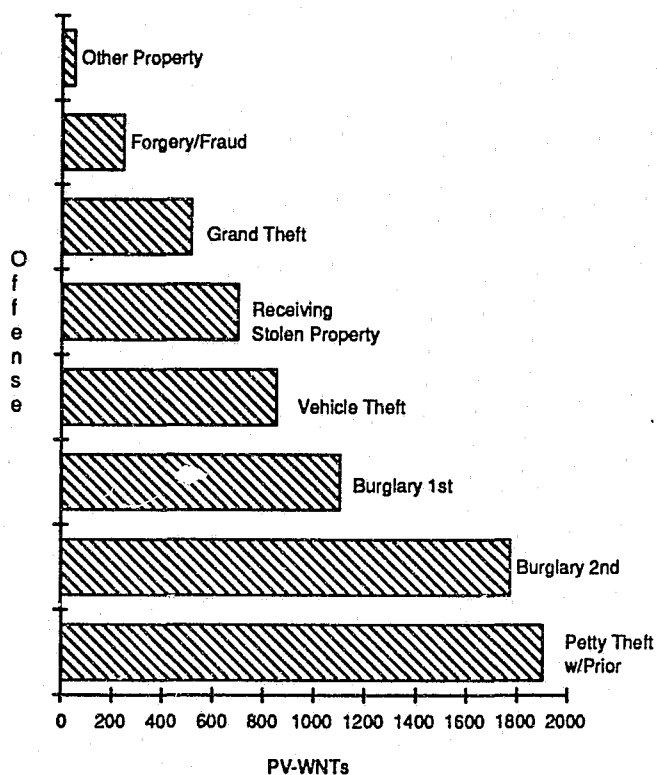
Violent Offenses

PROPERTY OFFENDERS

The number of parole violators returned with a new term (PV-WNTs) for property offenses increased from 2,966 in 1986 to 7,156 in 1991.

- Burglary First and Second Degree accounted for:
 - 1,106 (6.9%) Burglary First Degree
 - 1,776 (11.1%) Burglary Second Degree
- Grand Theft accounted for 516 (3.2%) of the PV-WNTs.
- Petty Theft with a Prior was the largest of the property offense groups with 1,905 (11.9%) returns.
- Receiving Stolen Property accounted for 701 (4.4%) of the PV-WNTs.
- Vehicle Theft accounted for 853 (5.3%) of the PV-WNTs.
- Forgery/Fraud accounted for 247 (1.5%).
- Other Property offenses accounted for 52 (0.3%) of the PV-WNTs.

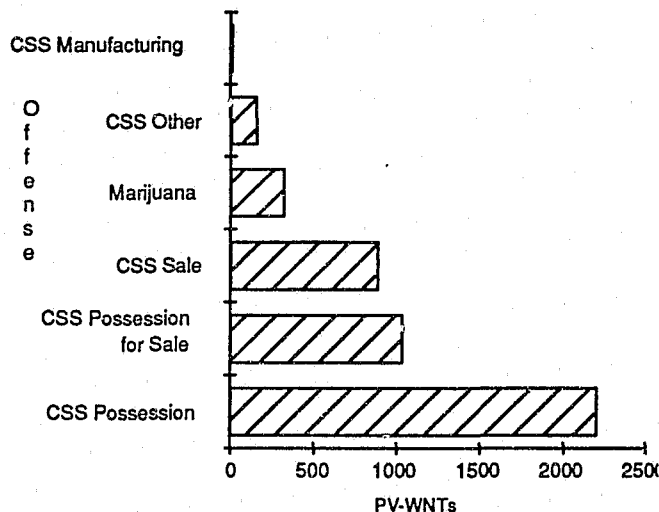
PAROLE VIOLATORS RETURNED WITH A NEW TERM (PV-WNT)

DRUG OFFENSES

The number of parole violators returned with a new term (PV-WNTs) for drug offenses increased from 1,179 in 1986 to 4,627 in 1991.

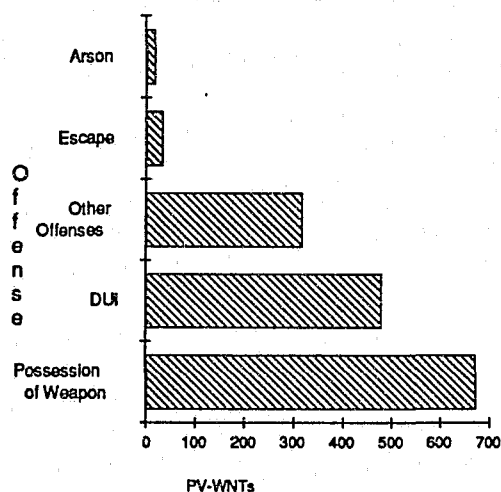
- CSS Possession accounted for 2,205 (13.8%) of the PV-WNTs.
- CSS Possession for Sale accounted for 1,036 (6.5%).
- CSS Sale accounted for 890 (5.6%).
- CSS Sale and Manufacturing accounted for 172 (1.1%).
- Marijuana offenses accounted for 324 (2.0%).

OTHER OFFENSES

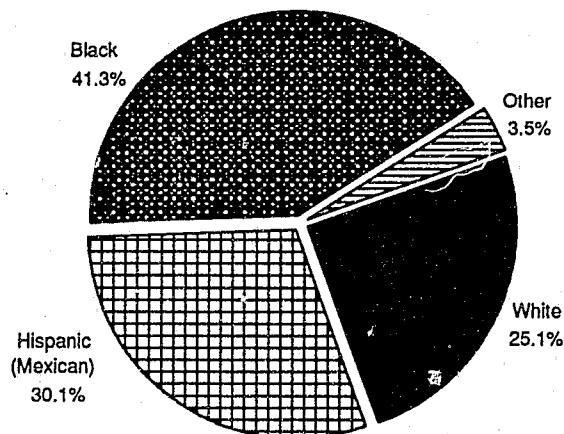
- Escapes accounted for 34 (0.2%) of the PV-WNTs.
- Driving Under the Influence (DUI) accounted for 479 (3.0%) PV-WNTs.
- Arson offenders accounted for 19 (0.1%) PV-WNTs.
- Possession of Weapon offenders accounted for 672 (4.2%) PV-WNTs.
- Other Offenses offenders accounted for 318 (2.0%) PV-WNTs.

RACIAL/ETHNIC GROUP

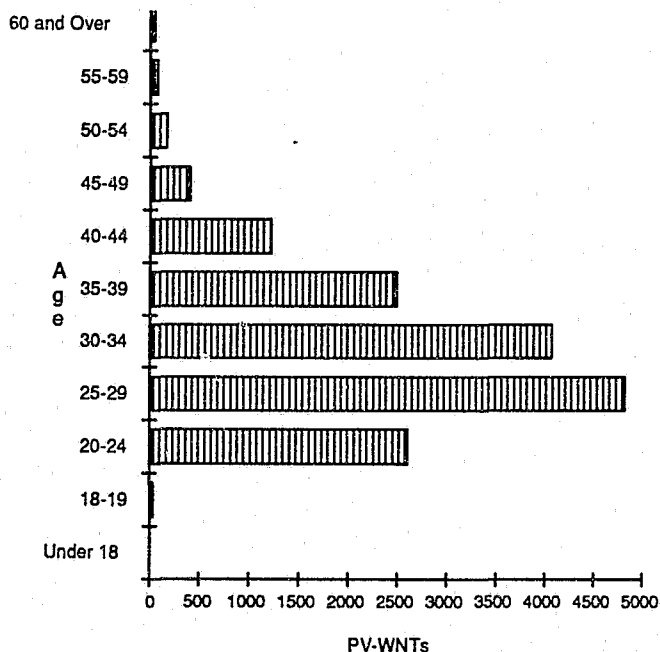
- The number of PV-WNTs who were White increased from 1,595 in 1986 to 4,026 in 1991.
- Hispanic (Mexican) PV-WNTs increased from 1,597 in 1986 to 4,813 in 1991.
- The number of PV-WNTs who were Black increased from 2,369 in 1986 to 6,607 in 1991.
- The Other racial/ethnic groups accounted for 564, or 3.5% of the PV-WNTs during Calendar Year 1991.

AGE GROUPS

During Calendar Year 1991, over half (55.7%) of the PV-WNTs were 25-34 years of age.

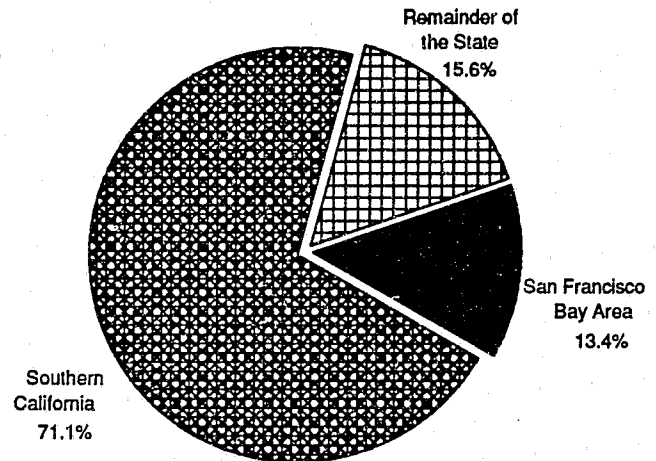
- The largest age group of PV-WNTs, ages 25-29, accounted for 30.2% (4,833).
- The second largest age group was the 30-34 year olds, accounted for 25.5% (4,079) of the returns.
- PV-WNTs 60 and over represented 0.3% (50) of those returned.

PAROLE VIOLATORS RETURNED WITH A NEW TERM (PV-WNT)

AREA OF COMMITMENT

- 11,376 (71.1%) of the PV-WNTs were admitted from Southern California.
- 2,139 (13.4%) of the PV-WNTs were returned from the San Francisco Bay Area.
- 2,495 (15.6%) of the PV-WNTs were admitted from the remainder of the state.

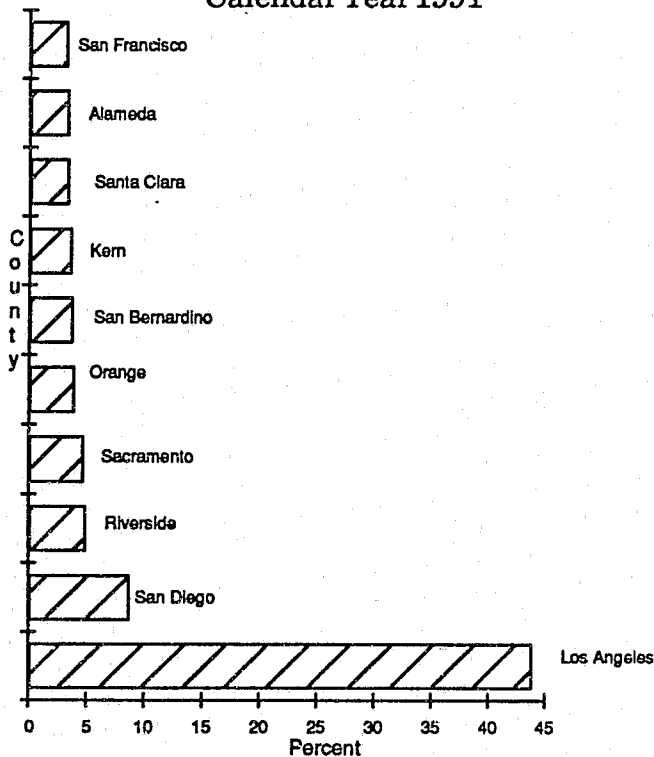
Area of Commitment Calendar Year 1991

COUNTY OF COMMITMENT

- Los Angeles County alone accounted for 7,027 (43.9%) of the PV-WNTs.
- San Diego was the next largest county of commitment, accounting for 1,412 (8.8%).
- Riverside County ranked third in PV-WNT commitments with 796 (5.0%).
- Santa Clara returned the most PV-WNTs from the San Francisco Bay Area, accounting for 543 (3.4%).
- Alpine, Mono and Mariposa returned no parolees as PV-WNTs.
