#### I. BAIL/RELEASE ACTIVITY

The Bail Commission conducted 67,217 interviews in 1991.

Table A reports release/bond activity for the year. Of the total 67,217 interviews conducted during 1991, 65% were conducted at the police station. Of these, 31% were released on written promises to appear or non-surety bonds set by the Bail Commissioners. Another 7% posted the bond set by the Bail Commissioner before arraignment in court. The number of defendants who gain release prior to arraignment, either by non-financial bail or posting bond, is thus almost 38%. At arraignment Bail Commissioners recommended non-financial bail for 49% of those defendants remaining in custody.

Regardless of a slight decrease in the number of interviews, there remains continuous pressure on the system due to the lack of jail space. The net effect of this problem on the Bail Commission is the continued search and utilization of innovative alternatives. The Bail Commission totals for Supervised Release continued to rise during 1991, that indicates more difficult cases are being referred for supervision in lieu of money bail.

#### II. SUPERVISED RELEASE

The Bail Commission continues to do an assessment of pretrial detainees for consideration of all supervised release alternatives. The total number of Supervised Release cases in 1991 was 9,641, an increase of 162 cases from the previous year.

The Bail Commission staff provides supervision for 57% of defendants released pretrial. Bail Commission supervision for such cases includes monitoring conditions of release, providing progress updates to the court, making referrals to substance abuse programs or other social service agencies, providing urine testing, electronic monitoring, shelter referral and in general, assess

defendants needs that if addressed may provide for an alternative to incarceration release. Of the menu of options available approximately 1,800 cases were referred to outside agencies contracted by the Bail Commission. These agencies provide supervision for pretrial referrals representing almost 100,000 "supervision days". In addition the Bail Commission referred over 1,600 cases to alternative incarceration centers.

The Bail Commission developed a program for drug testing effective January 1, 1990 in order to implement legislation authorizing judges to order urine samples from suspected drug defendants. Bail Commission staff gather and forward samples to a testing laboratory for analysis as well as coordinate and distribute the test results to all pertinent parties in court. During 1991 approximately 435 tests were ordered by the court.

The Bail Commission continued to work with the Department of Corrections, Adult Probation, and the Alternative Sanctions unit to coordinate, facilitate, monitor and utilize AIC's and other outside service providers. The Bail Commission has integrated AIC services with existing Bail Commission private contract referral agencies, drug grant programs and the Bail Correctional Center Reinterview Program to provide more comprehensive and effective pretrial alternative release mechanisms. Approximately 70% of the total AIC population originates from Bail Commission referrals.

#### III. BAIL REVIEW AT CORRECTIONAL CENTERS

To further address jail overcrowding and utilization of AIC's, the Bail Commission has continued to implement its program of reinterviewing detained defendants for possible bond modification and release. In 1991, 1,189 defendants unable to post bond were reinterviewed subsequent to arraignment at correctional centers by Bail Commission staff. As a result of jail reinterviews 529 defendants were released. Under the reinterviewing system

information and/or circumstances are elicited which are not readily available at the time of arraignment but prove significant in obtaining release at subsequent court appearances. The correctional center reinterviewing procedure completes the conditional release network which incorporates contract agencies, AIC's and Bail Commission resources to provide an intensive and effective assessment process and supervised release program.

#### IV. CORRECTIONAL CENTER OVERCROWDING

A noteworthy development is that the percentage of persons detained at correctional centers in pretrial status decreased significantly from 16.7% to 13.2% in 1991. This decrease is due in part to continuing efforts by Bail Commissioners to utilize alternatives to jail for pretrial defendants.

#### V. CRIMINAL RECORD CHECKS

The number of criminal record checks performed by data entry operators in the Office of the Chief Bail Commissioner continued to increase in 1991. This was the first full year that all district offices were responsible for conducting record checks.

#### VI. DATA PROCESSING

In conjunction with Judicial Information Systems the Bail Commission processed 51,541 bail commissioner letters (failure to appear notices). Also, during this reporting period COLLECT terminals were installed in New Haven, Bridgeport, Waterbury, New London and Bristol.

#### VII. PRETRIAL ALCOHOL EDUCATION SYSTEM

The Pretrial Alcohol Education System is administered by the Bail Commission. The statistics reflected in Table F indicate

a decrease (11.4%) in the number of applications received for the program. There were no notable trends regarding further treatment, violations or reinstatements.

In 1991 the Bail Commission with Judicial Information Systems implemented an on-line information system for the Pretrial Alcohol Education System. Efforts are currently underway to input more than 100,000 Pretrial Alcohol Education System cases previously maintained in a card file.

#### VIII.

During 1991 the Bail Commission completed the drug testing feasibility study as mandated by P. A. 90-261. As a result of the report completed by Toborg Associates, Inc. universal pretrial drug testing does not appear to be a viable option for Connecticut at the present time.

#### IX. STATISTICS

The tables depicting the activities of the Bail Commission follow at the conclusion of this report.

## Table A - Interview & Release/Bond Activity

The total number of Bail Commission interviews by month are listed along with the following information:

- 1. Interviews conducted at police facilities
- 2. Bail Commission non-financial releases at police facilities.
- 3. Defendants posting a surety bond at police facilities after a Bail Commission interview.
- 4. Defendants arraigned prior to release.
- 5. Defendants whose cases are disposed at arraignment.

- 6. Defendants receiving non-financial bail recommendations at arraignment.
- 7. Court ordered non-financial releases at arraignment.

#### Table B - Conditional Releases

For the reporting period of January 1, 1991 - December 31, 1991, Table B indicates the total number of defendants receiving non-financial releases and the number of new conditional releases (reporting to Bail Commission, enrolling in drug and alcohol programs, etc.).

#### Table C - Criminal Record Checks

The monthly totals of criminal record checks performed in 1991 is shown in Table C (exclusive of district offices).

#### Table D-1 - D-5 - Characteristics of Defendants Interviewed

Tables D-1 through D-5 depict characteristics of the defendants interviewed by the Bail Commission including class of primary charge, age, sex, race, and other pending cases.

#### Table E - Jail Population

Table E sets forth the average daily population of Connecticut's correctional facilities by month as compared to the previous year. The following columns indicate the number of sentenced versus accused inmates and the percent of the total population in accused status.
