Introduction

This publication compares Wisconsin crime rates with those of other states. The crime rate is the number of reported crimes for every 100,000 residents. The crime categories examined are seven of the eight crimes which make up the Crime Index, as defined by the national Uniform Crime Reporting (UCR) program. This report shows state rankings of Index Crime rates. The rankings also show the rates for the United States and the Midwest.

Most of the state data for this publication were obtained from **Crime in the United States**, published by the Federal Bureau of Investigation. State data were available for only seven of the eight index crimes. Data on arson, the eighth index crime, were not uniformly available for all states. Note that the offense rates for Wisconsin were obtained from the <u>State UCR report</u>. While these figures are slightly different from the rates reported in the national UCR report, they are more accurate.

The Crime Index


The Crime Index is made up of eight crime categories which are intended to reflect general crime trends. The Crime Index includes two sub-indices, the Violent Crime Index, consisting of the crimes of murder, forcible rape, robbery, and aggravated assault, and the Property Crime Index, consisting of the crimes of burglary, theft, motor vehicle theft, and arson. Sufficient data were not available to estimate state totals for arson, so they are not included in the Property Crime Index in this publication.

Rankings for the total Crime Index are not provided in this publication because the total Index is heavily dominated by property crime. While property crime made up over 87 percent of the Index in the United States in 1992, it accounted for 94 percent of the Wisconsin total. Wisconsin ranked thirty-seventh in total index crimes in 1992, identical to its thirty-seventh rank for reported property crimes.

Crime Trend Comparisons

Regional crime rate trends for the United States, the Midwest, and the State of Wisconsin for the past six years for both the Violent and the Property Crime Index are shown in the charts below. The Midwest includes the states of Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota and Wisconsin. Violent crime rates for Wisconsin were substantially lower than the rates for both the Midwest and the Nation. Over the past six years the rates for the United States and the Midwest have increased more than the rate for Wisconsin. Property Index Crime rates decreased slightly for Wisconsin, the Midwest, and the United States. However, Wisconsin property crime rates remained nearly ten percent less than those of the Midwest and twenty percent less than those of the Nation.



VIOLENT CRIMES: MURDER, FORCIBLE RAPE, ROBBERY, AGGRAVATED ASSAULT


In 1992, Wisconsin ranked forty-first <u>E</u> in reported violent crimes with a crime rate of 279 offenses per 100,000 residents. This ranking is slightly higher than the forty-third position of Wisconsin in 1990. The state rankings for violent crimes are shown in the table at right.

Wisconsin's rate is considerably lower than both the United States rate of 757 and the Midwest rate of 607. It is less than one-fourth the rate of Florida, the highest ranked state.

The map below shows the distribution of state rankings. States are divided into five categories, according to their violent crime rate ranking.

PROPERTY CRIMES: BURGLARY, LARCENY-THEFT, MOTOR VEHICLE THEFT, ARSON


The State of Wisconsin ranked thirty-seventh in reported property crimes with a rate of 4,081 offenses per 100,000 residents. Although the ranking of Wisconsin is identical to the thirty-seventh position of Wisconsin in 1990, the actual rate of property crimes decreased. The state rankings for property crimes are shown in the table at the right.

Wisconsin's rate is substantially less than the United States' rate of 4,903 and somewhat less than the Midwest rate of 4,368

The below shows map the distribution of state rankings. The states are divided into five categories, according to their property crime rate ranking.

Since 1979, a fourth crime, arson, has been part of the Property Crime Index. However, sufficient data are not 1 available to estimate state totals for arson. Therefore, arson is not included in the Property Crime Index shown here.

Individual Violent Crimes

Murder

During 1992 Wisconsin ranked thirty-fifth in murder and non-negligent manslaughter with a rate of 4.4 murders per 100,000 residents. Although this ranking is identical to Wisconsin's position in 1990, the actual rate of murder has slightly decreased. The state rankings for the crimes of murder and non-negligent manslaughter are shown in the table at the right. The UCR definition of murder is the willful killing of one human being by another.

Wisconsin's rate is considerably lower than both the United States' rate of 9.3 and the Midwest's rate of 7.6. It is also less than one-third the rate of Louisiana, the highest ranked state.

Forcible Rape

During 1992 Wisconsin ranked forty-fourth in forcible rape with a rate of 26.6 per 100,000 residents. This is a moderate rise from the forty-seventh position in 1990. The state rankings for the crime of forcible rape are shown in the table at the far right. The UCR definition of rape is the carnal knowledge of a female forcibly and against her will.

Wisconsin's rate is considerably less than both the United States' rate of 42.8 and the Midwest's rate of 45.5. It is close to one-fourth the rate of Alaska, the highest ranked state.

Robbery

Wisconsin ranked thirty-second in reported robbery offenses in 1992 with a rate of 121 per 100,000 residents. However, its relative ranking has changed little since 1990 due to a rapid increase in rates of other states. The table at the right presents the state rankings for robbery. The UCR program defines robbery as taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence.

Wisconsin's rate is well below both 11. the United States rate of 263 and the Midwest rate of 207. It is about one-fifth the rate of New York, the highest ranked 14. state.

Addravated Assault

1992 Wisconsin ranked In forty-third in reported aggravated assaults with a rate of 127 per 100,000 residents. The ranking is identical to the forty-third position of Wisconsin in 1990. The table at the far right shows the state rankings for aggravated assault. According to the UCR program definition, appravated assault is the unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury.

Wisconsin's rate is considerably lower than both the United States rate of 441 and the Midwest rate of 346. It is less than one-sixth the rate of Florida, the highest ranked state.



Individual Property Crimes

Burglary

1992 Wisconsin ranked In forty-third in reported burglaries, with a rate of 699 per 100,000 residents. This ranking is slightly lower than the forty-first position of Wisconsin in 1990. The state rankings are shown in the table at the right. The UCR program defines burglary as the unlawful entry of a structure to commit a felony or a theft.

Wisconsin's rate is considerably below both the United States rate of 1,168 and the Midwest rate of 964. In addition, Wisconsin's rate is about one-third that of Florida, the highest ranked state.

Theft

Wisconsin ranked twenty-sixth in theft offenses in 1992, with a rate of 2,946 per 100,000 residents. This ranking is slightly higher than the twenty-eighth position of Wisconsin in 1990, although the actual rate of theft slightly decreased . The state rankings for theft are shown in the table at the far right. The UCR program defines theft as the unlawful taking, carrying, leading, or riding away of property from possession or constructive the possession of another.

Wisconsin's rate is somewhat less than the United States rate of 3,103 but slightly higher than the Midwest rate of 2,928. Also, Wisconsin's rate is about 35 percent less than the rate of Florida, the highest ranked state.

Because the volume of reported thefts is high, relative to the other index offenses, theft dominates the Property Crime Index and, in turn, the total index. Wisconsin's moderate rate of reported thefts accounts for its relatively moderate ranking in the rate of reported property crimes.

Motor Vehicle Theft

Motor Vehicle Theft

Wisconsin ranked twenty-sixth in reported motor vehicle theft in 1992 with a rate of 436 per 100,000 residents. This ranking is higher than the twenty-seventh position of Wisconsin in 1990. The state rankings for motor vehicle theft are shown in the table at the right. Motor vehicle theft is defined as the theft or attempted theft of a motor vehicle.

While Wisconsin's rate is somewhat less than the Midwest rate of 476, it is about one-third less than the United States rate of 632. Also, the Wisconsin rate is less than one-half the rate of California the highest ranked state in the rate of motor vehicle thefts.

Arson

Data on arson, the fourth property crime in the Crime Index, are not sufficient to estimate state totals. Therefore, it is not possible to rank states on reported arson offenses.

Trends in State Rankings

This document has been published every other year since 1988, and it is intended that it will continue to be published every two years. Comparing the figures in this publication with the 1990 figures reveals that Wisconsin's position in the state ranking of violent crime rates increased from forty-third in 1990 to forty-first in 1992. However, Wisconsin's position in the state ranking of property crimes remained at thirty-seventh, with a slight decrease in actual property crime rates. The greatest change in Wisconsin's ranking for individual crimes was forcible rape (forty-seventh in 1990 and forty-fourth in 1992). There were only slight variations between the other rankings of individual crimes in comparison to 1990. Nonetheless, an overall conclusion to be drawn from the data is that Wisconsin continues to be a relatively safe place to live, work, and do business, compared to many other states.
