

INTRODUCTION

The Utah Crime Victim Reparations Program has completed its seventh year of operation and has continued to grow in serving crime victims in Utah. The services of the CVR Office have expanded beyond financial compensation to include the administering and monitoring of Victim of Crime Act Assistance grants, networking of victim services across the state, enhanced training, providing staff to the Governor's Council on Victims, establishing a resource library as well as helping to sponsor an annual Victims' Rights Conference.

Over the past seven years, victims of violent crime who have suffered physical and psychological injury as well as dependents of deceased victims have been awarded approximately 15.5 million dollars. The types of covered reparations included medical expenses, mental health counseling, loss of earnings, loss of support and funeral/burial expenses. The number of claims received during this seven year period totaled 8696.

During this fiscal year, Utah received \$551,000 in VOCA victim assistance funding from the Department of Justice Office for Victims of Crime. The funding enables the state, local governments and private non-profit organizations to expand and enhance services to crime victims thus promoting the development of comprehensive services to all victims across the state. Through a public Request for Proposal process, 44 grant applications were received totaling over one million dollars in requests. Twenty-seven programs were funded with grant awards ranging from \$2,838 to \$78,000. The crime categories eligible for VOCA funding include sexual assault, domestic violence, child abuse (physical and sexual), violent crimes, DUI/DWI, homicide survivors and AMACS (adults molested as children.)

The CVR staff and Board are committed to continuing to provide a valuable service to victims of violent crime and are proud to be part of this very positive program.

The following excerpts are from letters that victims have sent to the CVR Office to express their appreciation for assistance they have received.

- * We appreciate so much the large sum of money that has been spent for our family. It has helped so very much! Thank you for your kindness and courtesy and efficiency in handling this case.
- * This note is long overdue. We wanted to thank you for the help you've given! It helped our family a lot to receive the reimbursements for my husband's glasses, medical and travel expenses. Please let those involved know of our appreciation.
- * I want to take this time to thank you and all your staff for helping our family. I don't know what we would have done without the help of Victim Reparations. We do appreciate all the help you have given us in these hard and troubled times.
- * I would like to thank you for the help that you have given to me and my family. Without assistance from Victim Reparations, we could not have received the treatment necessary for our children. The children are improving, they are back in school and are very involved in helping young people who have also been victims of abuse. For the last seventeen months, so many doors have closed on us - the legal systems, insurance companies, family, improper diagnosis by therapists. But Victim Reparations' door has opened and remained opened. For that, we will always be very grateful!
- * Just needed to say thank you for Victim Reparations' services. My little boy was raped and being able to have him attend therapy has been a life saver for us. We could have never afforded it without your programs' help. Even though we have insurance, therapy is very expensive. My son has been helped so much. My heart is very full of my appreciation!

PROGRAM FUNDING

The CVR Trust Fund is funded by:

- * a surcharge on all criminal fines, penalties and forfeitures collected within the state. Beginning January 1, 1992, the CVR Office received 60% of the surcharge after Emergency Medical Services funds were dispersed. On January 1, 1992, the surcharge was increased from 25% to 85% on most fines and 35% on all other fines (generally lower than Class B misdemeanors) except non-moving traffic violations;
- * restitution fines imposed from driving under the influence of alcohol or drugs;
- * funds earned by inmates working for Utah Correctional Industries for the purpose of victim reparations;
- * insurance subrogation and perpetrator restitution monies;
- * interest earned on monies invested for victims with the State Treasurer;
- * federal funding derived from a surcharge on all federal crimes. State compensation programs in compliance with VOCA guidelines are eligible to receive up to 40% of all awards made to victims during the federal fiscal year. During FY 92/93, Utah received federal monies totalling 1.1 million for victim payments made during FY 89/90.

Public tax dollars are not being utilized to fund CVR programs. Expenditures from the Trust Fund include reparations for victims and administrative costs for the CVR Office as appropriated by the legislature.

Annually each state in the nation is eligible to receive a Victim of Crime Act Assistance grant award. These federal monies come from criminal fines, forfeited bail bonds, penalty fines of federal criminals - not from innocent taxpayers. The award received per state is \$200,000 for each fiscal year plus an additional amount based on population. During FY 92, Utah received \$551,000 and for FY 93 \$597,000. In addition, \$20,000 per year was received to provide services in Indian Countries.

ADMINISTRATION

The Crime Victim Reparations Board is composed of seven members appointed by the Governor with the advice and consent of the Senate. The board consists of a member of the bar of this state, a victim of criminally injurious conduct, a licensed physician, a law enforcement representative, a mental health care provider and two other private citizens.

The term of office of each board member is six years. Members serve part-time without pay but are entitled to a per diem reimbursement and actual and necessary expenses incurred in the performance of their duties. The board meets at least once quarterly to adopt rules; establish policies and procedures; advocate the adoption, repeal and modification of laws in the interest of crime victims; review awards and hear appeals as necessary.

The CVR Board and Office are placed within the Commission on Criminal and Juvenile Justice for administrative and support services. For all other purposes, the Reparations Office is an independent and separate state agency.

ACTIVITIES & ACHIEVEMENTS

The Office of Crime Victim Reparations' accomplishments, achievements and activities this past year include the following:

- The compensation program received 1924 victim claims and awarded victim benefit payments totaling \$3,771,333.41. The turnaround time for processing of claims was approximately 30 working days. This is one of the best turnaround time periods in the nation.
- CVR's Sixth Annual Report was completed and dispersed to the Governor and the Legislature.
- Staff development and training was achieved through attendance at local and national conferences and workshops. Some of the conferences attended were the National Association of Crime Victim Compensation Boards, Utah Correctional Association, Annual Four Corners Indian Country

Child Abuse, National Social Work, 14th Annual Conference on Agencies and Organizations Serving Troubled Youth, Second Annual Utah Conference on Violence, Crime Victims and Corrections, Civil Litigation, Annual State Victims' Rights, Western Regional Compensation, NOVA, 1993 State Planning Forum, GRAMA and ADA.

■ CVR programs have been publicized across the state through mailings of brochures, victim information cards, posters, etc. Victim information cards have been printed in Spanish, Vietnamese and Tongan. Speaking engagements, agency training, conference displays, news releases and quarterly newsletters have also played an important part in publicizing CVR programs.

■ HB 151, which provides for HIV testing of convicted sexual offenders and of victims of sexual offenses, was passed. As mandated by this legislation, the CVR Office developed a flyer that has been dispersed to all law enforcement agencies throughout the state to ensure that victims of sexual offenses are informed of their rights.

■ The CVR Board met five times during FY 92/93 to review summaries of claims processed by staff, hear appeals, review VOCA Assistance Grants, discuss contracting for managed care on inpatient mental health claims, discuss proposed statutory revisions, review proposed surcharge distribution, discuss budget requests for the Governor's Council on Victims, review financial status and projections, review results of OVC program audit of CVR programs, establish rules to revise CVR statute and continue to review cost containment saving measures to ensure CVR Trust Fund solvency.

■ SB 83, which clarifies and amends the existing CVR statute by setting a maximum award of \$25,000 for reparations and clarifying collateral sources, definitions, when attorney fees may be part of awards and eligibility requirements for reparations, was passed. This legislation became effective May 3, 1993.

■ The National Office for Victims of Crime made two site visits to review and monitor Utah's administration of VOCA compensation and assistance grants as well as to provide technical assistance. The findings and recommendations from the visits indicate that Utah is in compliance with all eligibility and program requirements. There were

no negative findings and it was noted that Utah's program has instituted a number of laudable features into the administration of CVR programs.

■ 12,565 victims of crime received direct services provided by twenty-seven subgrantee agencies who contracted with and were monitored by the VOCA Victim Assistance program. The FY 92 VOCA Victim Assistance allocation of \$551,000 provided for the enhancement of services to victims of violent crime statewide.

■ Through a public "Request for Proposal" process, the VOCA Victim Assistance program awarded the FY 93 allocation of \$597,000 to 30 programs throughout the state. Improvements in the allocation process began with a four hour training for agency representatives interested in submitting grant applications, a revised application packet and additional time for grant submission.

■ Extensive program monitoring took place which ensures all Federal and State regulations and policies are in place. The monitoring includes programmatic and fiscal monthly, quarterly, and annual reviews.

■ Staff support was provided to the Governor's Council on Victims, a non-partisan volunteer group with statewide representation. The Council meets once every two months to review and propose current/emerging legislative and public policy issues regarding victims' rights and to develop and recommend training. The Council established four working subcommittees which study issues, take action and make recommendations. The committees formed are the Training Committee, Enforcement Committee, Legislative Committee and Constitutional Amendment Committee.

■ During National Crime Victims' Rights Week, the Governor's Council sponsored the Annual Crime Victims' Conference. The Governor signed a Declaration proclaiming April 26 through May 2, 1993, Utah Crime Victims' Rights Week. During that time the "Flag of Victim Justice" flew above the State Capitol. Three hundred twenty-five people attended the conference, which was opened by Lt. Governor Olene Walker and at which Attorney General Jan Graham spoke. During an after dinner ceremony, eleven individuals received awards for outstanding service to crime victims. The conference concluded with a Candlelight Vigil and

musical numbers sung by the Cedar City High School A Cappella Choir.

■ The Council held its second annual retreat at Brianhead during which it studied and took action on exclusionary rule, rape shield, restitution, sentencing commission, victims and witnesses in the courtroom, life story proceeds, stalking law, enhancement penalties and the juvenile courts.

■ CVR staff provided training and educational presentations to criminal justice agencies, social service programs, victim service organizations and state Judicial District Victim Rights Committees covering information on Crime Victim Reparations, VOCA Victim Assistance programs, Victims' Rights Statute (77-37-1-5), available resources and the impact of crime on the victim.

■ CVR staff developed a four hour victimology training program for the POST Academy. Five trainings were conducted during FY 92 with seven planned on an annual basis.

■ CVR has taken the initial steps toward the development of the Victims' Resource Center. Video tapes are available for training purposes as well as numerous educational publications and service brochures.

ACKNOWLEDGMENTS

The CVR staff and Board worked diligently this past year to serve victims of violent crime through reparations awards, victim assistance grants and networking of victim services across the state. The support the CVR office has received from the Governor's Office and the Legislature demonstrates the State's commitment in responding to the needs of victims and their families.

We are grateful for the many individuals and organizations who have contributed to the development and success of a very positive program for the citizens of Utah. Good communication and cooperation is the key to providing the essential services victims need and deserve.

The CVR Office will continue to work in coalition with crime victims, victim service providers, victim advocate groups and other branches and departments of governments to ensure that the rights and concerns of victims are addressed.

**EXAMPLES OF COMPENSATION
AWARDS AND DENIALS**

1. A three-year-old female was beaten to death by her legal guardian. The perpetrator has been charged with murder. Crime Victim Reparations approved the application and has paid out \$2,315.11 in funeral costs.
2. A 14-year-old male was assaulted and injured by three gang members at a middle school. The assault was apparently because the victim had crossed out a gang member's name in the restroom. The three perpetrators have been referred to Juvenile Court. Crime Victim Reparations approved the application and has paid out \$788.88. Insurance paid the majority of the costs.
3. While riding her bicycle home from work, a 17-year-old female was attacked by someone she thought was a jogger. The attacker beat and brutally raped the young girl in a nearby field. He then fled the scene leaving the victim beaten and naked. She walked to a nearby 7-Eleven store where the manager summoned the police and paramedics. CVR approved the application and has paid \$410.00 for the relocation of the victim. Additional payments are pending the participation of the primary insurer. The rapist is still at large.
4. A 22-year-old victim was severely beaten by her husband. The victim is willing to testify against her husband and the US Attorney's Office has filed charges of aggravated assault. Crime Victim Reparations approved the application and has paid out \$1,431.94 at this time.
5. A ten-year-old boy picked up a .22 rifle and pointed it at an eleven-year-old boy and fired, hitting the victim in the upper right chest. All evidence pointed to an accidental shooting with no criminal intent. Crime Victim Reparations denied the application for reparations.
6. A six-year-old female was kidnapped from a playground, raped and sodomized. A suspect has been arrested. Crime Victim Reparations approved the application and has paid out \$2,614.24 at this time.
7. While he was driving, the car of a 23-year-old male was hit by an object. When he pulled to the side of the street to examine the car, he was approached by approximately 20 male adolescents who proceeded to assault him and his passenger with pipes and skateboards. He was taken to the hospital and treated for a possible concussion and bone fractures on the face. CVR has paid \$2,891.76 so far in medical bills and loss of wages.
8. Police were summoned to a Salt Lake City home by family members who were concerned that something may have happened to their mother when she went to talk with her estranged husband and did not return. The family explained that their stepfather was very depressed about their mother's decision to leave him. Accompanied by the police, they went to the stepfather's home where they found the doors locked. With the family's permission, the police forced open the door and found the mother and stepfather dead inside the home. An investigation revealed that the female was murdered by her husband who later shot himself. CVR awarded \$1,009.68 to pay for the female victim's funeral expenses.

9. A 28-year-old single female, 7 months pregnant at the time, was raped and beaten unconscious by her boyfriend's friend. As a result, she suffered a mild stroke and became partially paralyzed on one side of her body. She was exposed to the AIDS virus, which he had. CVR awarded \$1,243.00 for relocation and travel expenses for her to live with a sister in another state.
10. A group of males beat and left lying in an Ogden City alley a twenty-four-year old intoxicated transient. The victim was belligerent, did not cooperate with the police and did not want any action taken against the perpetrators. Crime Victim Reparations denied the application for reparations.
11. Police were called to an unprovoked stabbing that took place at a local store. According to witnesses, the victim was leaving the store when two males approached him. The witnesses said the victim appeared to be arguing with the two males who stabbed him and then fled the scene. It was discovered that the two males were members of a gang and recognized the victim as a member of another gang. CVR approved the application since witnesses to the crime said the victim tried to avoid a conflict. CVR paid the maximum of \$25,000.00 for medical bills.
12. A seven-year-old female was raped by her older brother fifty times over a four month period. The brother was charged with rape of a child in Juvenile Court. Crime Victim Reparations approved the application and has paid out \$3,240.00 in counseling at this time.
13. A 43-year-old male was struck by a truck traveling at a speed of 40 mph. The victim suffered traumatic brain injury and multiple fractures to his left leg. The victim, covered under an insurance plan, had to pay deductibles. Also, he lost several weeks of earnings. CVR has paid for those expenses not covered through his insurance plan and for loss of wages. A total of \$4,251.84 has been paid so far.
14. When a 22-year-old male victim inquired why the suspect had beaten up the suspect's girlfriend, he was told the suspect was angry because she and a male friend had taken too long at the store to purchase beer. The end result was that the suspect got a rifle and shot the victim in the leg. He later had to have his leg amputated. CVR has awarded the maximum of \$35,000 for medical costs and a prosthesis.
15. A 23-year-old female was kidnapped by four males who raped and tortured her for nine hours while riding in their van. She has suffered from post traumatic stress disorder since this incident and has been hospitalized twice. CVR has paid \$15,414.09 for her treatment.
16. Police were summoned to Cottonwood Hospital to interview a victim of a gang assault. The victim said he intervened on the behalf of his brother when a gang threatened his brother because he was dating the former girlfriend of a gang member. As a result of his intervention, the victim was severely beaten, losing his left ear. The police investigated the case and made several arrests. CVR paid \$997.99 toward the victim's medical bills.

17. A 13-year-old female was raped by her boyfriend. Her parents were added as secondary victims and awarded \$1,000.00 each for counseling. Four months after the rape incident, the girl's father sexually abused her. A second claim was opened for the girl and further payment of counseling for her father was denied. CVR has paid \$1,362.74 so far for mental health counseling for the primary victim.

18. An application was filed with CVR by a mother indicating that her 15-year-old daughter had been raped during the "winter of 1991." After an investigation by law enforcement, it was determined there was insufficient evidence to substantiate the occurrence of a crime. This denial was not appealed by the claimant.

19. An 18-year-old male was beaten and then shot and killed by a 17-year-old male gang member. The eighteen year old was not a member of a gang and was approved for reparations. CVR has paid out \$3,777.87 in funeral expenses as well as loss of wages.

20. A 26-year-old female was raped several times by an ex-boyfriend who threatened to kill her if she reported him. After several weeks, she reported him and he was charged with rape. She has experienced post traumatic stress disorder and has been hospitalized for treatment. She has also received outpatient therapy. CVR has paid \$16,482.55.

21. A male drunk driver age 28 was evading police when he ran a stop sign and collided with another vehicle driven by a female age 21. She suffered several fractured ribs. CVR made an award of \$1,108.85 for loss of wages and of \$9,111.59 for medical expenses.

22. A 24-year-old female was raped by a former boyfriend. She has refused to press charges against him. CVR has denied her claim for failure to cooperate fully with law enforcement.

23. The uncle of a 30-year-old male victim came to the victim's home uninvited and allegedly became belligerent, throwing beer cans on the floor and making threatening comments. The victim walked toward his uncle and was stabbed. The uncle stated, "I picked it up and stuck him to show him I wasn't joking." CVR has awarded a total of \$2,469.90 for loss of wages and medical expenses.

24. Police were called to Holy Cross Hospital's emergency room to interview a possible victim of an assault and robbery. The victim stated that he was outside a Smith's shopping center when three males attacked and beat him while trying to take his wallet. The police, upon investigating the alleged crime scene, were unable locate any evidence nor witnesses of the crime. When presented with these facts, the victim changed his story. This case was not pursued by the authorities because of the victim's inconsistent testimony. CVR denied this case due to the victim's failure to cooperate with the police.





FEDERAL AND LOCAL CONTRIBUTIONS




FY/92 VICTIM ASSISTANCE GRANTS FEDERAL AND LOCAL CONTRIBUTIONS




VICTIMS BY SEX
