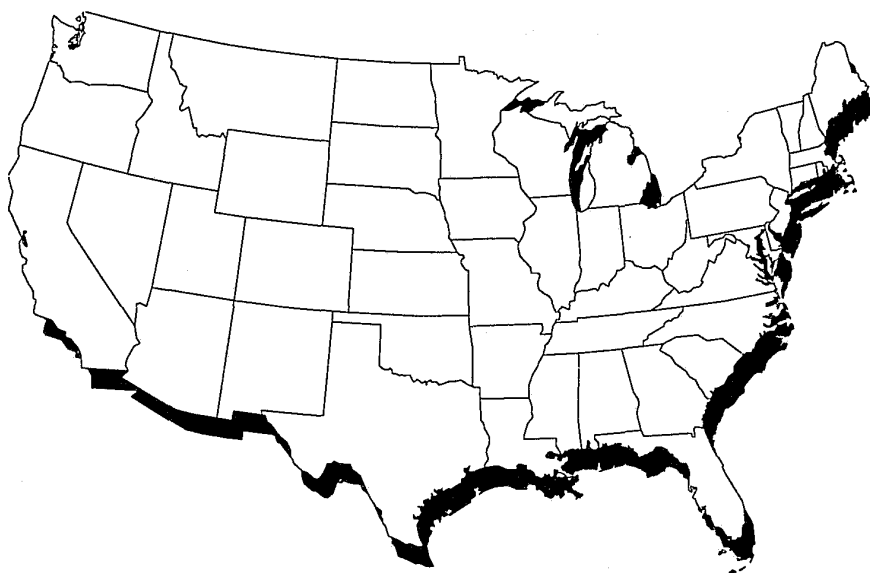

ADMINISTRATOR'S MESSAGE

The Drug Enforcement Administration's (DEA) Domestic Monitor Program (DMP) provides the source area, cost, and purity of heroin being sold at the retail level in 20 U.S. cities. The data contained in this report are based upon actual undercover heroin purchases made by DEA Special Agents on the streets of these cities. Heroin purity at the retail level averaged 35.8 percent in major U.S. metropolitan areas during 1993. Although the average purity in 1993 declined slightly from the 1992 figure of 37 percent, retail-level heroin purity remained well above the single digit purity levels of the early 1980's.

EXECUTIVE SUMMARY

The Domestic Monitor Program (DMP) is a quarterly Special Field Intelligence Program (SFIP) designed, funded, and administered by the Drug Enforcement Administration (DEA). The objective of the DMP is to monitor the retail-level heroin situation. This is accomplished by making undercover heroin purchases that are analyzed for price, purity, adulterants, diluents, and geographic source area. The results are reported to Federal, State, and local authorities.

During 1993, the DMP collected samples in 20 metropolitan areas: Atlanta, Boston, Chicago, Dallas, Denver, Detroit, Houston, Los Angeles, Miami, Newark, New Orleans, New York City, Philadelphia, Phoenix, San Diego, San Francisco, San Juan, Seattle, St. Louis, and Washington, DC. In addition, Baltimore was included in the program on a one-time basis during the July-September quarter. The following summarizes the collected samples:

- During this year, 631 exhibits were purchased, 597 (95%) of which contained heroin. Of these 597 exhibits, 7 were classified as outliers. Outliers are included in Appendix B of this report and defined in Appendix C.
- The purity of the 590 remaining exhibits averaged 35.8 percent, with a low of 0.8 percent in Miami and a high of 98.3 percent in Boston. This average purity is slightly lower than the 37.0 percent reported in the DMP for 1992.
- A total of 96 exhibits was of Southeast Asian origin (SEA) with an average purity of 32.2 percent. SEA heroin was predominant in the northeastern United States and was the primary type of heroin available in cities where Nigerian traffickers were well-established, such as Atlanta and Chicago.
- A total of 37 exhibits was of Southwest Asian origin (SWA) with an average purity of 47.2 percent. This represents a substantial decrease in the number of SWA exhibits compared to the 1992 DMP results. This is due, in part, to the development of the South American (SA) heroin signature, which was first used during the April-June 1993 quarter. Before April 1993, the generally high-purity SA heroin often was classified as SWA. SWA heroin was primarily available in the northeastern United States; this type of heroin was sporadically available in the Southeast and Midwest.
- A total of 160 exhibits was of Mexican origin (MEX) with an average purity of 27.8 percent. MEX heroin was the predominant type available in the western and southwestern United States.

- A total of 48 exhibits was of SA origin with an average purity of 59.3 percent, which is higher than that of any other type of heroin. The 1993 DMP is the first annual DMP to include heroin classified with the SA signature. This heroin was primarily available in the northeastern United States, although isolated exhibits occasionally appeared in other areas of the country.
- A total of 249 exhibits was of unclassifiable origin (UNC), with an average purity of 36.0 percent.
- The average cost per milligram of pure heroin by source area was:

In order to achieve maximum benefit from this report, it should be used in conjunction with other available intelligence indicators. The DMP represents a limited view of the heroin situation due to its concentration in only 20 cities. The number of DMP exhibits that originated in each geographic source area may differ somewhat from those that appear in the Heroin Signature Program (HSP). The HSP is an annual DEA program analyzing random samples of domestic purchases and seizures, as well as all seizures made at U.S. ports of entry, and involves a much broader and more extensive data base.¹

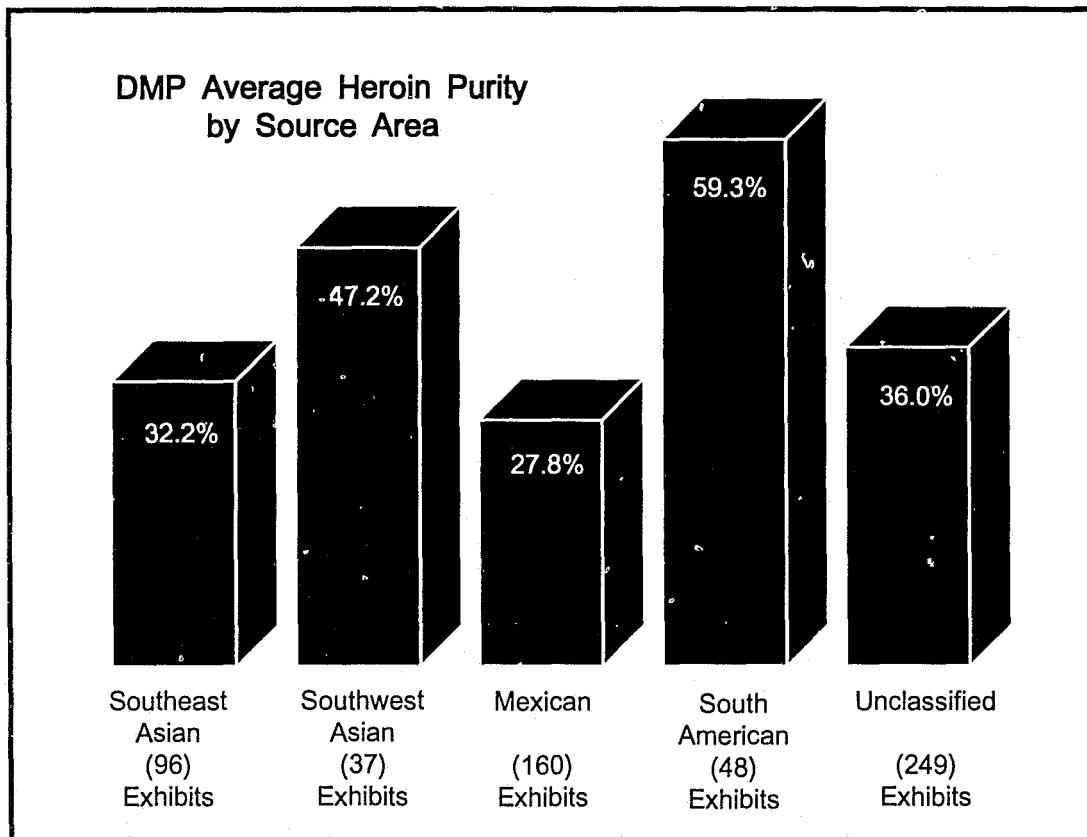

OVERVIEW: CALENDAR YEAR 1993

The Domestic Monitor Program (DMP) is a retail-level heroin purchase program designed to provide Federal, State, and local authorities with intelligence relating to adulterants, availability, diluents, geographic source areas (Signature analysis¹), heroin, price, and purity. The DMP collected samples in 20 metropolitan areas: Atlanta, Boston, Chicago, Dallas, Denver, Detroit, Houston, Los Angeles, Miami, Newark, New Orleans, New York City, Philadelphia, Phoenix, San Diego, San Francisco, San Juan, Seattle, St. Louis, and Washington, DC. In addition, Baltimore was included in the program on a one-time basis during the July-September quarter.

The following information is a result of the analysis of DMP exhibits for calendar year 1993:

A total of 631 exhibits was submitted to DEA's Special Testing and Research Laboratory for Signature analysis. Of these exhibits, 34 (5%) did not contain heroin. Of the 597 exhibits that did contain heroin, 7 were classified as "outliers." Outliers are those samples that have a purity of less than 0.5 percent or a price greater than \$16.00 per milligram pure. Outliers are not used in the calculation of DMP averages or trends.

The purity of the 590 heroin exhibits ranged from a low of 0.8 percent in Miami to a high of 98.3 percent in Boston. Of the 590 exhibits, 249 (42%) were unusable for source area identification. Submissions are unusable when there is insufficient weight to perform all the required tests or when test results are inconsistent. A test result is considered inconsistent when it matches more than one existing profile or when it does not match any of the currently used profiles.

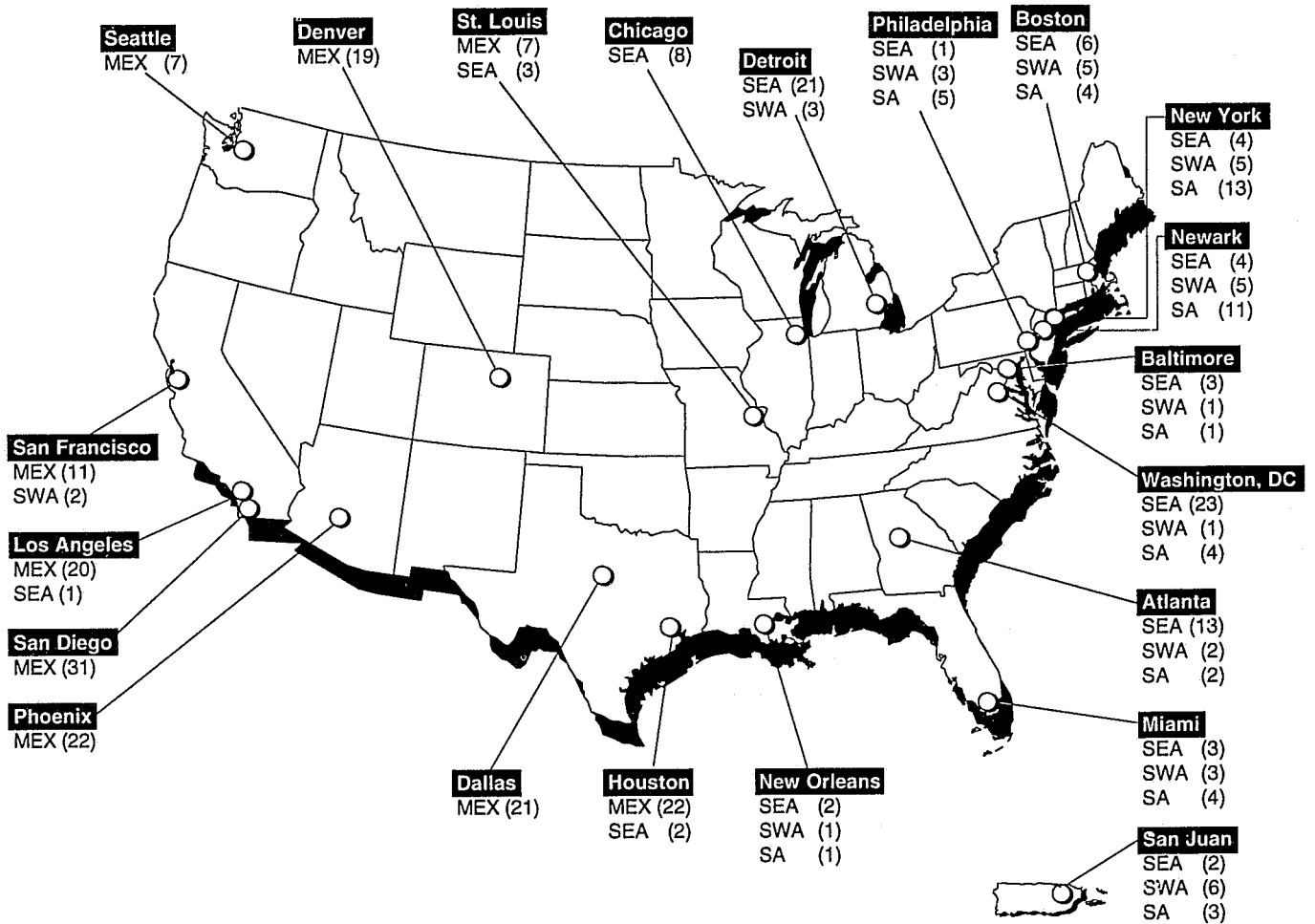
South American Heroin

Since April-June 1993, the DMP has included a new heroin signature classification that identifies heroin produced in South America, generally referred to as Colombian heroin. Before DEA's Special Testing and Research Laboratory developed the South American (SA) signature, heroin from this region usually was unclassified, or classified as Southwest Asian (SWA) because of chemical similarities. This indicates that the extremely high average purity of SWA heroin reported in the DMP over the past year was inflated due to the inclusion of the suspected SA heroin samples under the SWA signature. In addition, SA heroin may be partially responsible for the high number and purity levels of unclassified heroin samples, although it is expected that refinements to the SA signature should make it possible to classify more heroin samples.

DMP Heroin Dominance by Source Area



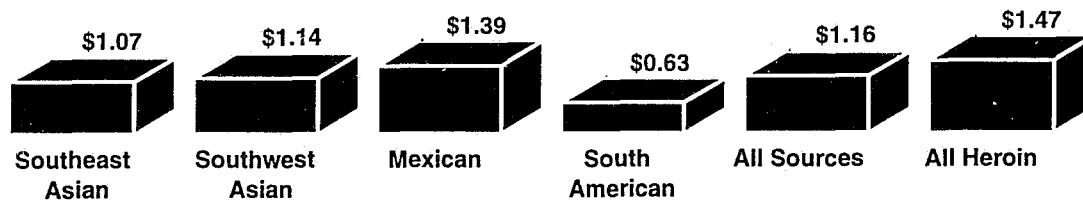

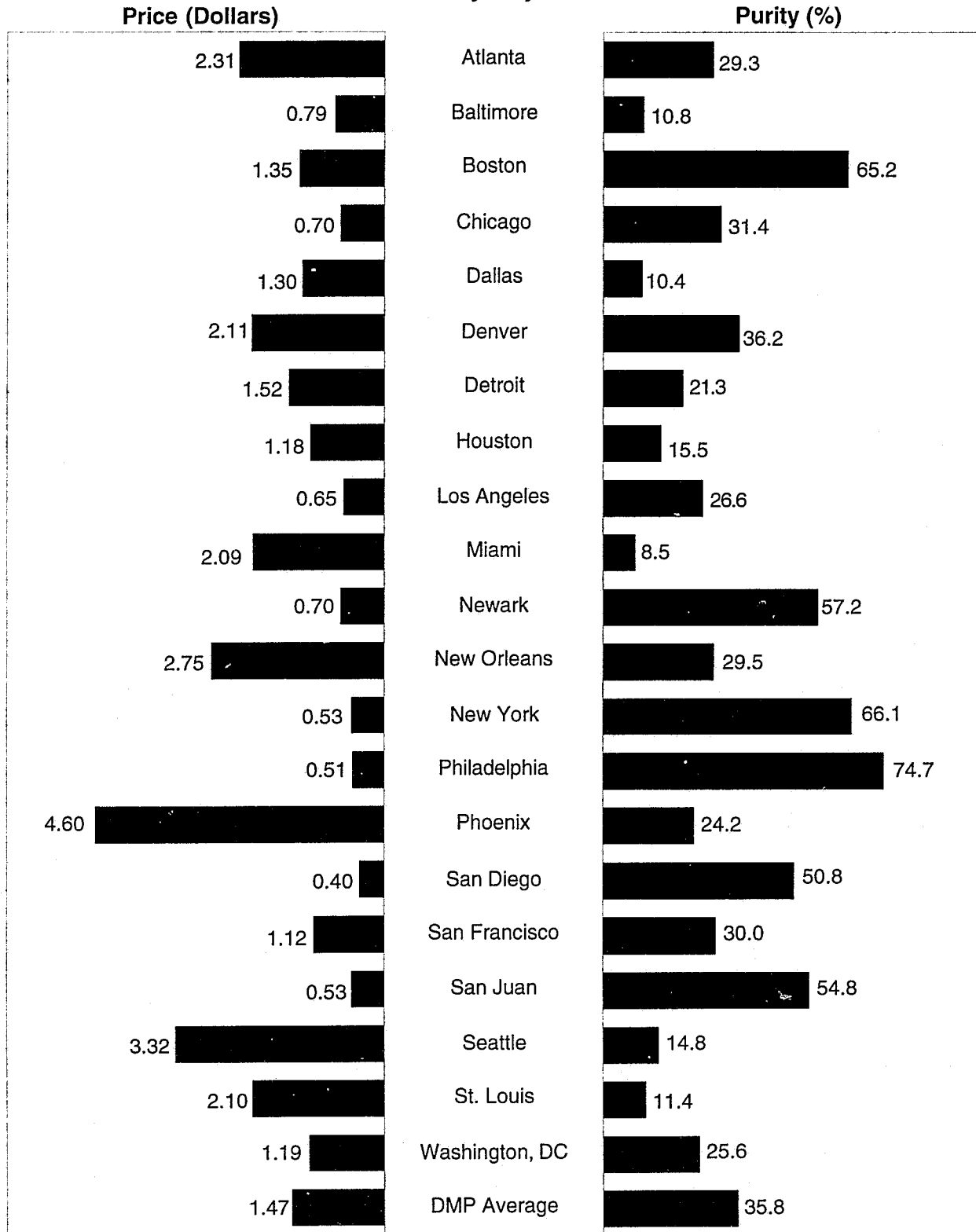

ADULTERANTS AND DILUENTS

Heroin (diacetylmorphine) is produced from morphine by a chemical process known as acetylation. The morphine is extracted from opium, which comes from the opium poppy plant (*Papaver somniferum L.*). Adulterants are organic substances that have physiological consequences and are added to controlled substance mixtures such as heroin. Diluents are organic or inorganic substances that are added to the drug to serve as fillers.

The following tables list adulterants and diluents found in calendar year 1993 DMP exhibits.

BRAND NAMES

Retail packages bearing brand names are encountered frequently in DMP samples. A brand name denotes the trafficking organization or the cutting house where the drug was diluted and repackaged. Within the heroin trade, the use of brand names has become so extensive that some organizations conduct business using counterfeit brand names. When the counterfeit products begin to erode the business of a group, they typically change the name of their product, conduct an extensive advertising campaign, and begin again.

During 1993, brand names were encountered on DMP exhibits obtained in Atlanta, Baltimore, Boston, Detroit, Los Angeles, Miami, Newark, New York City, and Philadelphia. In addition, street names were reported in Washington, DC.

APPENDIX C: DEFINITIONS

Adulterants: Pharmacologically active substances—such as caffeine, monoacetylmorphine, procaine, and quinine—that remain in or are added to the final heroin product at the completion of the heroin conversion process.

Alkaloids: Naturally occurring constituents of opium such as codeine, morphine, noscapine, and thebaine.

Black Tar Heroin: A relatively high-purity heroin made from opium poppies grown in Mexico using techniques classified as Mexican in origin. It may be brown to black in color and sticky like roofing tar or hard like coal. Typically, black tar heroin is a hydrochloride salt and is taken by injection.

Diluents: Pharmacologically inactive substances added to increase bulk—such as lactose, mannitol, starch, and sucrose.

Drug Abuse Warning Network (DAWN): A program—sponsored jointly by DEA and the National Institute on Drug Abuse (NIDA)—to gather, interpret, and disseminate data on drug abuse and overdose deaths. The data is obtained primarily from hospitals and medical examiners in 26 cities.

Gross Weight: The total weight of an exhibit including its packaging material.

Heroin Hydrochloride: A salt of heroin that is water soluble and suitable for injection. This is the type most commonly available to abusers.

Heroin Color: The actual color of the heroin after it has been separated from its adulterants and diluents.

Heroin Signature Classification: The result of Heroin Signature Program analysis. Classifications currently defined include South American (SA), Southeast Asian (SEA), Southwest Asian (SWA), and Mexican (MEX). These classifications are also known as Heroin Signature Profiles. When the results of a Signature analysis are inconclusive, the sample may be listed as “unknown” or “insufficient weight.” For the purposes of this report, the latter two classifications are grouped together under the heading of Unclassified (UNC).

Heroin Signature Program: A program developed by DEA to identify the geographic source area of a heroin sample through the detection of specific chemical characteristics in the sample peculiar to its source area. This program employs special chemical analyses to identify and quantitate selected chemical characteristics and secondary constituents of an exhibit, which ideally is at least 1.5 grams net weight and has a purity of at least 3.0 percent.

Impurities: Naturally occurring constituents of opium or processing chemicals that remain in heroin after the conversion process is completed.

Insufficient Weight: A sample of heroin that is too small for Signature analysis. Ideally, each sample should be at least 1.5 grams net weight (including adulterants and diluents) and should have a purity of at least 3.0 percent. A sample of this minimum weight and purity has a pure heroin weight of at least 45 milligrams. A smaller sample is not classifiable by means of Signature analysis and is labeled as "insufficient weight."

Mexican Heroin: A type of heroin made from opium poppies grown in Mexico using techniques developed by Mexican chemists. This type of heroin is typically the hydrochloride salt form. The purity is usually low and suitable for injection. Mexican heroin appears in several shades of brown and is powdery in consistency. Black tar heroin is also Mexican in origin and typically much higher in purity.

Net Weight: The total weight of the heroin excluding its packaging.

Outlier: Generally speaking, a number or value that is so far removed from others in its category that it is considered to be invalid for inclusion in the calculation of averages. DMP exhibits that are classified as "outliers" are those exhibits that have a purity of less than 0.5 percent or a price greater than \$16.00 per milligram pure. DMP averages do not include outliers.

Pure Weight: The weight of the heroin as determined by multiplying the purity of an exhibit by its net weight.

Purity: The amount of heroin present compared to all other substances in the sample. Purity is expressed as a percent. Purity and salt type are listed in the DMP report when available.

Southeast Asian no. 3 (SEA #3): Heroin made in Southeast Asia that is not as highly refined as SEA #4 heroin; its color ranges from tan to off-white. Although considered a smoking heroin, it also may be injected intravenously. Caffeine and strychnine usually are added to SEA #3 before the heroin manufacturing process is completed.

Southeast Asian no. 4 (SEA #4): Heroin that is made from Southeast Asian opium and produced in the "Golden Triangle" (Burma, Laos, and Thailand). It usually is encountered as a fine white powder.

Southwest Asian Heroin (SWA): Heroin made from opium grown in Afghanistan, Iran, or Pakistan. The quality of this heroin ranges from a highly refined white heroin produced in the European-Mediterranean area to a less refined tan heroin produced in Afghanistan, Iran, Pakistan, and Turkey. Pakistani traffickers also produce a highly refined white heroin for the North American market.

System to Retrieve Information from Drug Evidence (STRIDE): A computerized data base program to record, collate, and display the results of qualitative and quantitative chemical analyses, as well as the physical circumstances surrounding the acquisition of all drug evidence submitted to the DEA laboratory system. STRIDE data is used to monitor drug prices and potencies, to enumerate the number of exhibits examined, and to provide a comprehensive accounting of drug removals.
