






SECURE DETENTION ADMISSIONS AND TRANSFERS IN BY FISCAL YEAR

SECURE DETENTION

ADMISSIONS

Admissions are youth detained and directly admitted to secure detention from intake screening. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 the number of admissions to regional detention centers have increased statewide by 7% (33,056 to 35,499).
- o Year to year increases and decreases are as follows:

Increase of 5% (33,056 to 34,868) from FY 86-87 to FY 87-88.

Decrease of 7% (34,868 to 32,287) from FY 87-88 to FY 88-89.

Increase of 3% (32,287 to 33,395) from FY 88-89 to FY 89-90.

Decrease of 15% (33,395 to 28,237) from FY 89-90 to FY 90-91.

Increase of 4% (28,237 to 29,299) from FY 90-91 to FY 91-92.

Increase of 4% (29,299 to 30,400) from FY 91-92 to FY 92-93.

Increase of 17% (30,400 to 35,499) from FY 92-93 to FY 93-94.

The decrease in admissions to detention centers between FY 89-90 and FY 90-91 was due in great part to implementation of the Juvenile Justice Reform Act of 1990 which established new statutory detention criteria and prohibited certain uses of detention for juveniles. The number of youth being detained for contempt of court decreased 29% during the same period.

TRANSFERS IN

Transfers in are youth transferred to secure detention from another secure detention center or from a non-secure or home detention program.

- o Between FY 86-87 and FY 93-94 the number of transfers in for detention centers has increased 109% from 2,685 to 5,608.
- o Year to year increases and decreases are as follows:

Increase of 73% (2,685 to 4,654) from FY 86-87 to FY 87-88.

Increase of 42% (4,654 to 6,639) from FY 87-88 to FY 88-89.

Increase of 4% (6,639 to 6,950) from FY 88-89 to FY 89-90.

Decrease of 32% (6,950 to 4,706) from FY 89-90 to FY 90-91.

Increase of 11% (4,706 to 5,207) from FY 90-91 to FY 91-92.

Increase of 3% (5,207 to 5,361) from FY 91-92 to FY 92-93.

Increase of 5% (5,361 to 5,608) from FY 92-93 to FY 93-94..

- o Increases of transfers in are mainly due to detention centers trying to maintain population levels at their facility by transferring youth to centers with lower populations.
- A secondary reason for the increase has been the movement of youth from home detention back to secure detention due to new law violations, failure to appear in court, or for technical violations of the Home Detention Contract (see spreadsheet for Home Detention on this issue).
- The decrease in transfers to secure detention centers from FY 89-90 to FY 90-91 is due in great part to implementation of the Juvenile Justice Reform Act of 1990 which established new statutory detention criteria and prohibited certain uses of detention for juveniles. A youth could not be returned to secure detention from home detention for a technical violation unless there were changed circumstances that indicated he was a threat to the community or failure to appear in court.



SECURE DETENTION BED UTILIZATION

Bed utilization is the percentage of beds being used as determined from the average daily population. The percentage of utilization is calculated by dividing the ADP by the number of fixed beds at a detention center then multiplying by one hundred.

- o Between FY 86-87 and FY 93-94 there has been a .6% increase (105.9% to 106.5.%) in the bed utilization rate statewide.
- o Year to year increases or decreases are as follows:

Increase of 4% (105.9% to 110.2%) from FY 86-87 to FY 87-88.

Decrease of 0.9% (110.2% to 110.1%) from FY 87-88 to FY 88-89.

Increase of 5% (110.1% to 116.0%) from FY 88-89 to FY 89-90.

Decrease of 17% (116.0% to 96.7%) from FY 89-90 to FY 90-91.

Decrease of 8% (96.7% to 91.1%) from FY 90-91 to FY 91-92.

Increase of 7% (91.1% to 97.6%) from FY 91-92 to FY 92-93.

Increase of 9% (97.6% to 106.5%) from FY 92-93 to FY 93-94.

- o The major decrease in the utilization rate at detention centers statewide from FY 89-90 to FY 90-91 was due in great part to implementation of the Juvenile Justice Reform Act of 1990 which established new statutory detention criteria thereby reducing the number of admissions while for the last fiscal year retaining the existing number of beds at the centers.
- o An additional factor for this decrease in the bed utilization rate is that the number of beds in secure detention has increased by 5% between FY 86-87 and FY 90-91 with new facilities at Pasco and Brevard Detention Centers.
- The 1990 Special Session of the Legislature reduced the bed capacities at a number of detention centers, with Bay losing 20 beds, Manatee 20 beds, Palm Beach 25 beds, Broward 31 beds, and Dade 30 beds. This reduction will be reflected in the bed utilization rates for FY 91-92.






SECURE DETENTION AVERAGE LENGTH OF STAY BY FISCAL YEAR




SECURE DETENTION AVERAGE LENGTH OF STAY FY 1993-94

SECURE DETENTION

AVERAGE DAILY POPULATION

Average daily populations (ADP) are calculated by dividing resident days by the number of days in the year.

- o Between FY 86-87 and FY 93-94 the average daily population (ADP) statewide at regional detention centers has increased by 2.3% (1425.2 to 1457.9).
- o Year to year increases and decreases are as follows:

Increase of 9% (1425.2 to 1560.5) from FY 86-87 to FY 87-88.

Decrease of 1% (1560.5 to 1544.0) from FY 87-88 to FY 88-89.

Increase of 5% (1544.0 to 1629.8) from FY 88-89 to FY 89-90.

- o Between FY 86-87 and FY 93-94 the ALOS for detention centers statewide has decreased by 10% (14.0 to 12.6).
- o The ALOS remained the same from FY 86-87 through FY 88-89 (14.0) with increases occurring during FY 89-90 (1%) and in FY 90-91 (3%). With the heavy emphasis on reducing overcrowding conditions in secure detention facilities, the ALOS has been steadily decreasing since FY 90-91.









SECURE DETENTION ESCAPES

The following spreadsheets provide data on the actual number of escapes from inside and outside the security perimeter as well as separate rates for escapes inside, outside and total escapes. An escape inside the perimeter is any escape which occurs while the youth is inside the security perimeter (fence) or inside the secure building. An escape outside the perimeter is any escape which occurs when the youth is outside the security perimeter. Escapes outside the perimeter usually occur when the youth is being transported to court or to another facility. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 to FY 93-94 there has been a 70% decrease (123 to 37) in the total number of escapes from inside and outside the security perimeter.
- o Year to year decreases in the total number of escapes are as follows:

34% decrease (123 to 81) escapes FY 86-87 to FY 87-88.

6% decrease (81 to 76) escapes from FY 87-88 to FY 88-89.

16% decrease (76 to 64) escapes from FY 88-89 to FY 89-90.

28% decrease (64 to 46) escapes from FY 89-90 to FY 90-91.

11% decrease (46 to 41) escapes from FY 90-91 to FY 91-92.

2% increase (41 to 42) esc. nes from FY 91-92 to FY 92-93.

12% decrease (42 to 37) escapes from FY 92-93 to FY 93-94.

- o Between FY 86-87 to FY 93-94 there has been a 81% decrease (83 to 16) in the number of escapes from inside the security perimeter.
- o Year to year increases/decreases in the actual number of escapes from inside the security perimeter are as follows:

42% decrease (83 to 48) escapes from FY 86-87 to FY 87-88.

15% increase (48 to 55) escapes from FY 87-88 to FY 88-89.

42% decrease (55 to 32) escapes from FY 88-89 to FY 89-90.





SECURE DETENTION CLIENT ON CLIENT ASSAULTS

Client on client assaults (COC) are defined as physical assaults by clients on other clients which required first aid or medical attention, either by facility medical personnel, detention staff, or which required outside medical attention. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94the number of client on client assaults increased by 295% (311 to 1,229).
- o Year to year increases or decreases are as follows:

174% increase (311 to 851) from FY 86-87 to FY 87-88.

86% increase (851 to 1,585) from FY 87-88 to FY 88-89.

22% increase (1,585 to 1,937) from FY 88-89 to FY 89-90.

32% decrease (1,937 to 1,325) from FY 89-90 to FY 90-91.

3% increase (1,325 to 1,371) from FY 90-91 to FY 91-92.

2% increase (1,371 to 1,394) from FY 91-92 to FY 92-93.

12% decrease (1,394 to 1,229) from FY 92-93 to FY 93-94.

- o Between FY 86-87 and FY 89-90 there was a rapid increase of 523% statewide (311 to 1,937) in the number of client on client assaults.
- o Between FY 86-87 to 89-90 secure detention bed utilization ranged from 105.9% to 116.0%, while many facilities remained under duty post staffed. High populations and low staff/client ratios could lead to increased levels of violence.
- o Part of the 32% decrease from FY 89-90 and FY 90-91 is due to a 16% decrease in ADPs and concomitant resident days.

Rate: In order to provide an equitable approach to reviewing this data, a rate was determined for each facility based on the number of resident days. The number of client on client assaults is compared to the size and utilization of the facility (the greater the size of the facility and the greater the utilization, the higher the number of resident days). The rate was calculated by dividing the number of client on client assaults by the number of resident days, then multiplying by 100.





SECURE DETENTION CLIENT ON STAFF ASSAULTS

Client on staff (COS) assaults are defined as the number of physical assaults by clients on staff which required first aid or medical attention, either by facility medical personnel, detention staff, or which required outside medical attention. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 there has been a 160% increase (58 to 151) in the actual number of reported client on staff assaults statewide.
- o Year to year increases and decreases of the numbers of assaults are as follows:

Increase of 145% (58 to 142) from FY 86-87 to FY 87-88.

Increase of 128% (142 to 324) from FY 87-88 to FY 88-89.

Decrease of 4% (324 to 311) from FY 88-89 to FY 89-90.

Decrease of 45% (311 to 171) from FY 89-90 to FY 90-91.

Increase of 63% (171 to 278) from FY 90-91 to FY 91-92.

Decrease of 28% (278 to 199) from FY 91-92 to FY 92-93.

Decrease of 24% (199 to 151) from FY 92-93 to FY 93-94.

- o Between FY 86-87 and FY 88-89 there was a rapid increase of 458% statewide (58 to 324) in the number of client on staff assaults. The percentage of increase reflects a similar rapid increase in client on client assaults (523%).
- o Between FY 86-87 to FY 89-90 secure detention bed utilization ranged from 105.9% to 116.0%, while many facilities remained under duty post staffed. High populations and low staff/client ratios could lead to increased levels of violence.
- o As with client on client assaults, part of the 45% decrease from FY 89-90 and FY 90-91 is due to a 16% decrease in ADPs and the number of resident days.
- o As the client on staff assaults continue to decrease, management techniques to reduce the number of client on staff assaults appear to be impacting the number of client on staff assaults.

Rate: In order to provide an equitable approach to reviewing this data, a rate was determined for each facility based on the number of resident days. The number of client on staff assaults is compared to the size and utilization of the facility (the greater the size of the facility and the greater the utilization, the greater the number of resident days.) The rate was calculated by dividing the number of client on staff assaults by the number of resident days, then multiplying by 100.





SECURE DETENTION PLACEMENTS IN ROOM CONFINEMENT

Room confinement is defined as the placement of a youth in his or her sleeping room or a room designated as a confinement room for behavioral reasons for a period of time that does not exceed 6 hours excluding sleeping periods. Room confinement replaced the term "isolation" in August 1989. Placements in room confinement are the actual number of placements in room confinement during the fiscal year. A youth may have many placements. The number of youth is the actual number of youth that were placed in room confinement. During a month a youth may be placed in room confinement 3 or 5 times, but he would only be counted as one youth at the end of the month. An incident documents the precipitating event which resulted in a placement of room confinement, there may be one incident where there were three placements, of three youth. During FYs 86-87, 87-88 and 88-89, detention centers reported only the number of placements in isolation (room confinements) at their facilities. In FY 89-90 the reporting of placements in room confinement was expanded to include the number of youth placed and the number of incidents which precipitated the room confinement. The following spreadsheets provide a breakdown of number and rate of placements, the number of youth placed, and the number of incidents that precipitated confinement. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 there was a 3.7% increase (11,480 to 11,904) statewide in the number of placements in room confinements.
- o Year to year increases and decreases in the number of placements are as follows:

22% increase (11,480 to 13,958) from FY 86-87 to FY 87-88.

7% decrease (13,958 to 12,996) from FY 87-88 to FY 88-89.

20% increase (12,996 to 15,620) from FY 88-89 to FY 89-90.

11% decrease (15,620 to 13,915) from FY 89-90 to FY 90-91.

10% decrease (13,915 to 12,503) from FY 90-91 to FY 91-92.

11% decrease (12,503 to 11,166) from FY 91-92 to FY 92-93.

6.6% increase (11,166 to 11,904) from FY 92-93 to FY 93-94.

- o While there was a 16% reduction in the actual number of resident days at the centers between FY 89-90 and FY 90-91, there was not a commensurate decline in the number of placements during that time period resulting in the rate of placements actually being higher in FY 90-91 than in FY 89-90.
- o Between FY 89-90 and FY 90-91 there was a 20% decrease (9,582 to 7,690) in the numbers of youth placed in room confinement.
- Reporting procedures do not identify specific youth being involved in repeated placements in room confinement. While the number of placements decreased 11% compared to the 20% decline in the number of youth involved in room confinements, we can not state as a conclusion at this time that fewer youth were involved in a larger number of confinements.
- o Between FY 89-90 and FY 90-91 there was a 5% decrease (10,997 to 10,424) in the actual number of incidents of placements in room confinement.
- As noted earlier, the same explanation for any analysis of the discrepancy between the number of placements and the number of youth involved applies to the analysis of the number of incidents.

Rate: In order to provide an equitable approach to reviewing this data, a rate was determined for each facility based on the number of resident days. The number of placements in room confinement is compared to the size and utilization of the facility (the greater the size of the facility and the greater the utilization, the higher the number of resident days). The placement rate was calculated by dividing the number of placements by the number of resident days and multiplying by 100. The youth rate was calculated by dividing the number of resident days and multiplying by 100.

The incident rate was calculated by dividing the number of incidents by the number of resident days and multiplying by 100.





SECURE DETENTION PLACEMENTS IN DISCIPLINARY CONFINEMENT

Disciplinary confinement is defined as the placement of a youth in his or her sleeping room or a room designated as a confinement room beyond 6 hours for one or more serious behavioral reasons as identified in HRSM 175-1, Section 9-4. Disciplinary confinement was developed to provide a means for detention staff to safely supervise those youth, who in years past would have been transferred to jail for being beyond the control of detention staff and whose behavior is so egregious as to present an imminent and significant danger to person and/or property if allowed to remain in the general population. Beginning in FY 88-89, detention centers began to document the number of placements in disciplinary confinement. For FYs 89-90 and 90-91, reporting of placements in disciplinary confinement was expanded to include the number of youth placed and whether such placements were warranted or unwarranted. The following spreadsheets provide a breakdown of the number and rates of placements, the number of youth placed, and the number of placements that were warranted or unwarranted. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 88-89 and FY 93-94 there was a 13% decrease (692 to 599) statewide in the number of placements in disciplinary confinement.
- o Year to year increases or decreases in placements are as follows:

Increase of .9% (692 to 698) from FY 88-89 to FY 89-90.

Decrease of 37% (698 to 465) from FY 89-90 to FY 90-91.

Decrease of 6% (465 to 439) from FY 90-91 to FY 91-92.

Decrease of 4% (439 to 420) from FY 91-92 to FY 92-93.

Increase of 43% (420 to 599) from FY 92-93 to FY 93-94.

- o Between FY 89-90 and FY 93-94 there was a 14% increase (664 to 760) in the number of youth placed in disciplinary confinement.
- o Year to year increases or decreases in number of youth placed in disciplinary confinement are as follows:

Decrease of 37% (664 to 418) from FY 89-90 to FY 90-91.

Increase of 25%(418 to 524) from FY 90-91 to FY 91-92.

Increase of 20% (524 to 631) from FY 91-92 to FY 92-93.

Increase of 20% (631 to 760) from FY 92-93 to FY 93-94.

- o Between FY 89-90 and FY 93-94 there was a 8% increase (25 to 27) in the number of unwarranted placements in disciplinary confinements.
- As with placements in room confinement, reporting procedures do not identify specific youth involved in repeated placements in disciplinary confinement. While the number of placements between FY 89-90 and FY 90-91 decreased 33% (698 to 495) compared to a 37% decline in the actual number of youth involved in disciplinary confinements, we can not state as a conclusion at this time that fewer youth were involved in a larger number of confinements.
- o Between FY 89-90 and FY 90-91 there was an 83% decrease (46 to 8) in the number of placements in disciplinary confinement being unwarranted.
- o Between FY 91-92 and FY 92-93, there was a 35% decrease (52 to 34) in the number of placements in disciplinary confinement being unwarranted.
- o Comparison of the two years shows that 6.6% of the disciplinary confinements in FY 89-90 were unwarranted versus 1.7% of the placements in FY 90-91.

Rate: In order to provide an equitable approach to reviewing this data, a rate was determined for each facility based on the number of resident days. The number of placements and the number of youth were compared to the size and utilization of the facility (the greater the size of the facility and the greater the utilization, the greater the number of resident days). The rate for unwarranted was determined by comparing the number of placements in disciplinary confinement to the number of unwarranted placements.



Other than for purposes of routine secure transportation, the use of mechanical restraints (handcuffs, leg cuffs, and restraining belts) by staff will be restricted to those occasions wherein verbal or physical CIT (Crisis Intervention Techniques) has been employed and proven to be insufficient; and when it appears absolutely necessary to prevent escape, to prevent serious injury to a person or damage to real property, or to quell a riot or serious disturbance. Prior to any use of mechanical restraints as a last resort behavior intervention, authorization must be given by the superintendent, or in his/her absence, the individual in charge of the facility. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 the number of youth placed in mechanical restraints statewide increased 73% (from 49 to 13).
- o Year to year increases and decreases in the number of incidents involving the use of restraints are as follows:

18% increase (49 to 58) from FY 86-87 to FY 87-88.

181% increase (58 to 163) from FY 87-88 to FY 88-89.

26% decrease (163 to 121) from FY 88-89 to FY 89-90.

48% decrease (121 to 63) from FY 89-90 to FY 90-91.

41% decrease (63 to 37) from FY 90-91 to FY 91-92.

130% increase (37 to 85) from FY 91-92 to FY 92-93.

85% decrease (85 to 13) from FY 92-93 to FY 93-94.

- At least a portion of the decrease in the use of mechanical restraints by detention centers between FY 89-90 and FY 90-91 can be attributed to a 16% decline in the ADP and the number of resident days which in turn was tied to a 15% reduction in admissions and a 32% reduction in transfers in during that same time period.
- The most recent increase in the use of mechanical restraints may be due to the greater numbers of serious offender youth being held in detention. The detention criteria which was mandated by statute in 1990 required that only the most serious or chronic offenders be placed in secure detention, thereby increasing the liklihood of increased need for the use of mechanical restraints.

Rate: In order to provide an equitable approach to reviewing this data, a rate was determined for each facility based on the number of resident days. The number of youth placed in mechanical restraints is compared to the size and the utilization of the facility (the greater the size of the facility and the greater the utilization, the greater the number of resident days). The mechanical restraints rate was calculated by dividing the number of youth placed in mechanical restraints by the number of resident days and multiplying by 100.



SECURE DETENTION DIRECT FILE, WAIVER OR INDICTMENT

The Federal Juvenile Justice and Delinquency Prevention ACT (JJDPA) provides, in part, that all juveniles shall be removed from adult jails, except those juveniles transferred to the adult court who have been direct filed, waived or indicted for felony charges. The following information pertains to those youth transferred to jail as a result of transfer to adult court. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 there was a % increase (1,286 to 2,254) in the number of youth transferred to jail as a result of direct file, waiver indictment for felony charges.
- o Year to year percentage increases and decreases of youth direct filed, waived or indicted for felony charges are as follows:

38% increase (1,286 to 1,769) between FY 86-87 and FY 87-88.

21% increase (1,769 to 2,139) between FY 87-88 and FY 88-89.

8% increase (2,139 to 2,315) between FY 88-89 and FY 89-90.

9% decrease (2,315 to 2,113) between FY 89-90 and FY 90-91.

1% decrease (2,113 to 2,089) between FY 90-91 and FY 91-92.

9% increase (2,089 to 2,281) between FY 91-92 and FY 92-93.

2% decrease (2,281 to 2,254) between FY 92-93 and FY 93-94.

BEYOND CONTROL

While it is contrary to the JJDPA to place juveniles in jail for being beyond the control of detention staff, the following information pertains to number of juveniles transferred to adult jails who were not direct filed, waived or indicted. It should be noted that it is against department policy and law to transfer youth to adult jails for being beyond control of detention staff. In the cases where it has occurred, it may have been the result of a riot where a local judge has ordered the youth transferred.

- o Between FY 86-87 and FY 90-91 there was a 100% decrease (235 to 0) in the number of youth transferred to jail for being beyond the control of a detention center.
- o Year to year percentage increases and decreases in the number of youth transferred to jail for being beyond the control of a detention center are as follows:

2% increase (235 to 239) between FY 86-87 and FY 87-88.

85% decrease (239 to 37) between FY 87-88 and FY 88-89.

30% increase (37 to 48) between FY 88-89 and FY 89-90.

100% decrease (48 to 0) between FY 89-90 and FY 90-91.

A major reason for the decrease in the number of juveniles placed in jail for being beyond the control of detention staff has been monitoring activities for compliance with Federal laws regarding the placement of youth in jail that were not direct filed, waived or indicted. In August 1990, HRSM 175-2 authorized the use of disciplinary confinement as a means to deal with youth previously transferred to adult jail. Also, effective August 1990, the statutory authority to transfer juveniles beyond control from secure detention to adult jail was eliminated from Florida law.





SECURE DETENTION DEPENDENTS PLACED IN SECURE DETENTION

Through funding from the Federal Juvenile Justice and Delinquency Prevention Act (JJDPA), the department monitors the number of dependent youth, not charged with a law violation, who are placed in secure detention for contempt of court or other reasons. Detention centers did not begin to document the number of dependent youth who were placed in detention for reasons other than contempt of court until FY 88-89. The following information pertains to the number of youth admitted to detention for contempt of court or other reasons. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 the number of dependents placed in secure detention by a contempt of court order has decreased by 94% (1,901 to 115).
- o Year to year decreases in the number of dependents placed in secure detention for contempt are as follows:

29% decrease (1,901 to 1,342) between FY 86-87 and FY 87-88.

60% decrease (1,342 to 541) between FY 87-88 and FY 88-89.

8% decrease (541 to 496) between FY 88-89 and FY 89-90.

29% decrease (496 to 351) between FY 89-90 and FY 90-91.

55% increase (351 to 545) between FY 90-91 and FY 91-92.

63% decrease (545 to 204) between FY 91-92 and FY 92-93.

44% decrease (204 to 115) between FY 92-93 and FY 93-94.

o Between FY 88-89 and FY 90-91 there was a 58% decrease (36 to 15) in the number of dependent youth placed in detention for reasons other than contempt of court. Increases and decreases for the three years that this information has been gathered by detention centers are as follows:

136% increase (36 to 85) between FY 88-89 and FY 89-90.

82% decrease (85 to 15) between FY 89-90 and FY 90-91.


- Combining the numbers of youth placed in detention for contempt of court and other reasons resulted in an increase of .7% (577 to 581) in the total number between FY 88-89 and FY 89-90, and a decrease of 37% (581 to 366) between FY 89-90 and FY 90-91.
- Reasons for the decrease in the number of dependent youth in detention includes changes in the Juvenile Justice Reform Act of 1990 which restricted the admission of some youth into detention and monitoring activities for compliance with Federal laws regarding the de-institutionalization of status offenders (dependents) in secure detention.

SECURE DETENTION DEPENDENTS PLACED IN SECURE DETENTION



Between FY 86-87 and FY 93-94, the hours of overtime at detention centers decreased % (139,396 to 104,832). The hours of overtime are compiled from the detention superintendent reports. These figures may vary from the actual number of hours which are recorded in SAMAS which shows the actual amount of money which was paid in overtime hours.

o Year to year increases and decreases in the hours of overtime at detention centers are as follows:

5% decrease (139,396 to 131,908) between FY 86-87 to FY 87-88.

19% increase (131,908 to 156,721) between FY 87-88 and FY 88-89.

28% increase (156,721 to 200,029) between FY 88-89 and FY 89-90.

32% decrease (200,029 to 135,364) between FY 89-90 and FY 90-91.

27% decrease (135,364 to 99,280) between FY 90-91 and FY 91-92.

11% increase (99,280 to 110,206) between FY 91-92 and FY 92-93.

- o While the attached spreadsheet does not take into account the issue of duty post staffing, an attempt has been made to account for the differences in the number of youth in detention statewide.
- o Using the rate established for hours of overtime, between FY 86-87 and FY 92-93 there was a 3.1 decrease in the rate with a decline of 29,193 resident days statewide.

Rate: In order to provide an equitable approach to reviewing this data, a rate was determined for each facility based on the number of resident days. The hours of overtime were compared to the size and the utilization of the facility (the greater the size of the facility and the greater the utilization, the higher the number of resident days). The overtime rate was calculated by dividing the hours of overtime by the number of resident days and multiplying by 100.





HOME DETENTION

ADMISSIONS

Admissions and youth who were screened for secure detention and directly admitted to home detention from intake screening. It should be noted that this data is reported by each facility in the monthly superintendent's report.

- o Between FY 86-87 and FY 93-94 the number of admissions to home detention has increased statewide by % (566 to 3,217).
- o Year to year changes in admissions to home detention are as follows:

Increase of 42% (566 to 801) from FY 86-87 to FY 87-88.

Increase of 196% (801 to 2,374) from FY 87-88 to FY 88-89.

Increase of 35% (2,374 to 3,217) from FY 88-89 to FY 89-90.

Increase of 10% (3,217 to 3,555) from FY 89-90 to FY 90-91.

Increase of 4% (3,555 to 3,680) from FY 90-91 to FY 91-92.

Increase of less than 1% (3,680 to 3,685) from FY 91-92 to FY 92-93.

Increase of 48% (3,685 to 5,466) from FY 92-93 to FY 93-94.

- The increase in the number of youth admitted to home detention is due in great part to additional funding for positions (community youth leaders) by the Legislature over the past four years and implementation of the Juvenile Justice Reform Act of 1990 which established new statutory detention and home detention criteria.
- o With the additional positions and changes in the law, detention centers were able to concentrate on reducing secure detention population, increasing the number of youth being placed on home detention.

TRANSFERS IN

Transfers in are youth transferred to home detention from a secure detention center or from another home detention or non-secure detention program.

- o Between FY 86-87 and FY 92-93 the number of transfers in for home detention has increased 6% (8,361 to 8,849).
- o Year to year increases and decreases in transfers in to home detention are as follows:

Increase of 27% (8,361 to 10,583) from FY 86-87 to FY 87-88.

Decrease of .5% (10,583 to 10,533) from FY 87-88 to FY 88-89.

Increase of 2% (10,533 to 10,746) from FY 88-89 to FY 89-90.

Decrease of 11% (10,746 to 9,518) from FY 90-91 to FY 91-92.

Decrease of 5% (9,518 to 9,057) from FY 91-92 to FY 92-93.

Increase of 4% (9,057 to 9,404) from FY 92-93 to FY 93-94.

- o While there has been an overall increase in the number of transfers in to home detention over the past five years, the numbers decreased between FY 89-90 to FY 90-91.
- o Implementation of the Juvenile Justice Reform Act of 1990, with the establishment of new home detention and non-secure detention criteria, has resulted in more juveniles being directly admitted to home detention programs versus transfering in after being admitted to secure detention.





HOME DETENTION SLOT UTILIZATION

Slot utilization is the percentage of slots being used as determined by the comparision to average daily population. The percentage of utilization is calculated by idviding the ADP by the number of fixed slots in home detention then multiplying by one hundred.

- o Between FY 86-87 and FY 93-94, there has been a % increase (87.4% to 109.8%) in the slot utilization rate statewide.
- o Year to year increases or decreases are as follows:

Increase of 4.2% (87.5% to 91.7%) from FY 86-87 to FY 87-88.

Decrease of 17.2% (91.7% to 74.5%) from FY 87-88 to FY 88-89.

Increase of 17.0% (74.5% to 91.5%) from FY 88-89 to FY 89-90.

Increase of 1.5% (91.5% to 93.0%) from FY 89-90 to FY 90-91.

Decrease of 8.3% (93.0% to 84.7%) from FY 90-91 to FY 91-92.

Increase of 14% (84.7% to 96.6.%) from FY 91-92 to FY 92-93.

Increase of 13% (96.6% to 109.8%) from FY 92-93 to FY 93-94.

o Many detention centers have addressed the under-utilization of home detention by realigning community youth leaders to secure detention or other areas. During the district assessment visits, district specific issues were discussed.






HOME DETENTION AVERAGE DAILY POPULATION BY FISCAL YEAR




HOME DETENTION AVERAGE DAILY POPULATION FY 1993-94

HOME DETENTION

AVERAGE DAILY POPULATION

Average daily populations are calculated by dividing resident days by the number of days in the year.

- o Between FY 86-87 and FY 93-94 the average daily population (ADP) statewide for home detention has increased by 80% (606.6 to 1.091.8).
- o Year to year increases or decreases in the ADP for home detention are as follows:

Increase of 27% (606.6 to 770.1) from FY 86-87 to FY 87-88.

Increase of 15% (770.1 to 881.9) from FY 87-88 to FY 88-89.

Increase of 22% (881.9 to 1,076.3) from FY 88-89 to FY 89-90.

Increase of 2% (1,076.3 to 1,093.9) from FY 89-90 to FY 90-91.

Decrease of 9% (1,093.9 to 996.2) from FY 90-91 to FY 91-92.

Decrease of 3% (996.2 to 963.6) from FY 91-92 to FY 92-93.

Increase of 13% (963.6 to 1,091.8) from FY 92-93 to FY 93-94.

AVERAGE LENGTH OF STAY

The average length of stay (ALOS) is calculated by dividing resident days by the sum of beginning population, admissions and transfers.

- o Between FY 86-87 and FY 93-94 the ALOS for home detention has increased % (23.4 to 25.2).
- o Year to year increases in the ALOS for home detention are as follows:

No increase between FY 86-87 and FY 87-88, with a 0.4% increase (23.4 to 23.5 from FY 87-88 to FY 88-89.

Increase of 12% (23.5 to 16.4) from FY 88-89 to FY 89-90.

Increase of 7% (26.4 to 28.2) from FY 89-90 to FY 90-91.

Decrease of 6% (28.2 to 26.5) from FY 90-91 to FY 91-92.

Decrease of less than 1% (26.5 to 26.3) from FY 91-92 to Fy 92-93.

Decrease of 4% (26.3 to 25.2) from FY 92-93 to FY 93-94.

o For the five year period studied, the ALOS for secure detention centers statewide has decreased by 10% (14.0 to 12.6) while it increased 12%(23.4 to 26.3 days) for home detention.





HOME DETENTION RETURNED TO SECURE FOR NEW LAW VIOLATION BY FISCAL YEAR



RETURNS TO SECURE DETENTION FROM HOME DETENTION FOR: NEW LAW VIOLATIONS/FAILURE TO APPEAR FOR COURT/OTHER REASONS

The spreadsheet provides the total number of youth returned to secure detention (RTS). This number is delineated into the reasons for return: youth returned for new law violations (NLV), failure to appear for court (FTA), and all other reasons for return (failure to comply with home detention rules, etc.) It should be noted that this data is reported by each facility in the monthly superintendent's report.

- Prior to FY 88-89, statistics for is information were not documented on the superintendent's report. A breakdown of the reasons for return to detention (NLV and FTA) was not tracked until FY 88-89. The "Other" (reasons for return to detention) category was not added until FY 89-90 therefore there was no ability to track the total number of youth returned to secure detention during FY 88-89.
- o From FY 89-90 to FY 93-94, the total number of youth returned to secure detention from home detention increased by 3% (1,880 to 1,939).
- o Year to year increases or decreases are as follows:

Decrease of 19% (1,880 to 1,525) from FY 89-90 to FY 90-91.

Increase of 0.5% (1,525 to 1,533) from FY 90-91 to FY 91-92.

Decrease of 11% (1,533 to 1,367) from FY 91-92 to FY 92-93.

Increase of 42% (1,367 to 1,939) from FY 92-93 to FY 93-94.

NEW LAW VIOLATIONS

- o The number of youth who committed a new law violation while on home detention status has increased by 19% (488 to 582) between FY 88-89 and FY 93-94.
- o Year to year increases or decreases are as follows:

Increase of 27% (488 to 618) from FY 88-89 to FY 89-90.

Increase of 5% (618 to 649) from FY 89-90 to FY 90-91.

Increase of 2% (649 to 662) from FY 90-91 to FY 91-92.

Decrease of 26%(662 to 489) from FY 91-92 to FY 92-93.

Increase of 19% (489 to 582) from FY 92-93 to FY 93-94.

FAILURE TO APPEAR

- o The number of failure to appear has increased 56% (276 to 430) from FY 88-89 to FY 93-94.
- o Year to year increases or decreases are as follows:

Increase of 12% (276 to 309) from FY 88-89 to FY 89-90.

Increase of 97% (309 to 609) from FY 89-90 to FY 90-91.

Decrease of 31% (609 to 418) from FY 90-91 to FY 91-92.

Decrease of 13% (418 to 362) from FY 91-92 to FY 92-93.

Increase of 19% (362 to 430) from FY 92-93 to FY 93-94.




