SUBJECT:

Report Writing Guide

Enclosed herein are the Orlando Police Department's new report writing guidelines. The need for updated reporting guidelines was immediately realized when PACE came online. These guidelines were developed by a project team comprised of members from every bureau within the department.

Input was solicited from all unit sergeants/supervisors within OPD and consultation with the State Attorney's office.

The purpose of these guidelines is to ensure that all necessary and appropriate information is captured at the time the report is taken to provide for effective investigations, prosecutions, and for accurate statistical data.

These guidelines are to be considered requirements for the wide array of reports taken by the Orlando Police Department and will allow all employees who handle report taking (sworn officers, Community Service Officers, PACE operators, and any other employees) to know what information is required in the report.

These guidelines are intended to ensure consistent, uniform, high quality incident reports that will be a positive reflection of the Orlando Police Department.

Please utilize them accordingly.

#### PURPOSE OF REPORT WRITING GUIDE

The Report Writing Guide was developed to:

- Improve the quality of incident reports by providing standards or guidelines that establish the essential elements or information that should be included in a report.
- Provide PACE operators and supervisors with a reference for prompting officers on the elements of a particular incident report.

The Report Writing Guide does not supersede Policy and Procedure, but should be used in conjunction with current P&P's.

It is difficult to set requirements for each report type due to the variations that may occur. Many of the narrative requirements are conditional and are intended to serve as reminders to include information. If certain conditions exist, then other information may be required (i.e., if latents were attempted, then results should be mentioned in the narrative; or if K-9 responded, then the name of the officer and the results of the search should be in the report).

#### ELEMENTS OF A PACE INCIDENT REPORT

The following elements of a PACE Report are listed in the order in which they should be provided to the PACE operator.

#### 1. Basic Incident Information

The officer shall provide the PACE operator with information such as: Report title; Occurred location, if different from Dispatch location; Date and times of occurrence, etc.

#### 2. Event Log Narrative

The officer shall provide a brief synopsis describing the incident following the guidelines in the current Policy and Procedure.

In sexual batteries, the victim's name, details of the offense, or other information that would identify the victim should not be mentioned in the Event Log narrative.

Other information contained in Event Logs may also be confidential or exempt from the Public Records Act. Event logs should be reviewed by the Patrol Operations Bureau Aide or the Legal Advisor prior to release to the public.

#### 3. Case Narrative

The officer shall provide a narrative that addresses the elements of the specific crime and meets the requirements of the Report Writing Guide for the incident type.

The PACE operator shall repeat the narrative to the officer as it was dictated. The officer shall monitor the narrative as repeated and make any corrections or additions as needed.

#### 4. Offense Information

The officer shall provide answers to questions such as: Location type; Occupancy code; Weapon code; Entry and exit points and method, etc.

In this section of the report, the officer shall also provide information on Evidence Collected and Crime Specific information. Crime Specific questions should be answered, if the reporting officer has the information, for the following types of crimes: Burglary, Robbery (including Carjacking and Home-Invasion), Motor Vehicle Theft, Sex Crimes, and Homicides.

The Crime Specific information is used by the Criminal Investigations Division for the development of modus operandi and linking suspects to multiple cases.

#### 5. Principals Information

The officer shall provide information on principals in the following order: Suspects/Arrestees, Victims, Witnesses, Complainants, and Informationals. The Informational subject type should only be used when the person does not fit one of the other categories. The Informational person should be only indirectly associated with the incident and not be anticipated to have any connection to the crime.

When the PACE operator enters each person's name, the computer searches the database for a match (global name search). The operator will review the information on each person with the officer. If there is not enough information to make a POSITIVE match, then the PACE operator will enter the person in the computer (create a new jacket) using the information provided by the officer. If there is enough information to make the match, then the officer should provide PACE with any updated information.

NEVER CHOOSE A PERSON FROM THE COMPUTER DATABASE (GLOBAL NAME) UNLESS YOU ARE SURE IT IS THE SAME PERSON. CHOOSING A PERSON'S JACKET FROM GLOBAL WILL TIE ALL PREVIOUS REPORTS TO THE PERSON LISTED IN THE CURRENT REPORT.

In the principals section of the PACE Report, the officer will provide a physical description and characteristics, as well as victim/offender relationships. A subject narrative can be used to provide additional information that cannot be placed in the fields provided.

### 6. Property Information

The officer shall provide information on any property involved, such as: Value, Description, Style, Model, Color, Serial number, Registration information, VIN number, Caliber, etc.

#### WRITTEN STATEMENTS

The importance of quality written statements to the successful investigation and prosecution of any case cannot be stressed enough. Officers must review victims' and witnesses' statements to insure that they contain all of the information necessary to support probable cause and to identify the suspect responsible. Officers should remember that their own reports and affidavits, unless the crime was personally observed by them, are basically "hear-say".

#### STATEMENTS REQUIRED

Written statements should be obtained whenever possible, but <u>must always</u> be obtained in the following circumstances:

- In misdemeanor and felony cases where the subject responsible for the offense has been identified.
- All cases involving transient victim(s), whether the subject responsible for the offense has been identified or not.

#### VICTIM/WITNESS STATEMENTS

All victim/witness statements must address the elements of the crime at hand. (Most crime specific elements are listed before each crime in this guide; if not, consult your Florida State Statute Book.)

Suspect identification should be as detailed as possible in the statement. If the suspect's name, address, etc. is known, it should be written in the statement. If the suspect is a stranger to the victim/witness, they should describe the suspect with as much detail as possible.

If an officer writes a statement for a victim or witness at their request, the statement must be written verbatim. Each witness statement must contain every fact known to that witness that goes to prove any element of the offense(s). This is done to insure a more successful prosecution. The officer should acknowledge on the statement that it was written with the consent of the subject. The victim/witness must still sign the statement. Officers should read the statement back to the witness and note on affidavit that it was read and acknowledged by witness.

Officers should obtain secondary addresses and telephone numbers (even out-of-state) and social security numbers from victims and witnesses who may move before the trial. This will assist the State Attorney's Office in locating them at that time.

The victim's desire to prosecute must always be clearly stated in their written statement.

The written statements are also the only written material from which victims and witnesses can refresh their memories at the time of the trial, sometimes months after the crime has occurred.

#### SUSPECT/DEFENDANT STATEMENTS

Suspect's/Defendant's statements should be obtained whenever possible at the time of the incident or arrest, in the event that they attempt to add or change their story at the time of the trial. If C.I.D. personnel are involved in the investigation or responding to the scene, then this should only be done with their consent.

#### PROPERTY CASES

These statements should always contain the value of the property taken or damaged. This enables proof of a misdemeanor or a felony and also aids the courts in obtaining victim restitution upon a conviction.

#### REVIEW OF STATEMENTS

After a subject has written a statement, it should be reviewed for legibility and content. If there are problems, then the subject should be asked to clarify or correct the statement in his own words and initial any changes or deletions.

#### GENERAL REPORT REQUIREMENTS

The following requirements apply to all reports.

- 1. In the Narrative, use a person's name if known (i.e. Victim Smith, Suspect Jones). If the name is unknown, use Suspect #1 or Suspect #2.
- 2. In cases involving property, list each item in the Property Section. Groups of the same or similar items may be combined; but items of great value or that may be readily identifiable must be listed separately with specific descriptions provided, when available.

When referring to stolen property in the Narrative, give the location of the property if it helps establish the MO of the perpetrator.

- 3. The total value of all the property taken shall be mentioned in the report Narrative.
- 4. If a juvenile is a principal in a report, parent/guardian and school information shall be obtained and reported in the Principal's Section of the report.
- 5. All subjects mentioned in the report Narrative, shall be listed in the Principals Section of the report. All Subjects listed in the Principals Section, shall be mentioned in the report Narrative.
- 6. All vehicles mentioned in the report Narrative, shall be listed in the Vehicle Section of the report. All vehicles listed in the Vehicle Section, shall be mentioned in the Narrative. If a tag is known on a suspect vehicle, the registration information shall be listed in the Narrative.
- 7. If a subject is not a local resident (tourist, transient), obtain local address information, i.e., motel name, phone number, room number. State when subject is leaving area and when subject will be at permanent address. Include any permanent local contact person.
- 8. The narrative shall contain a synopsis of each principal's involvement in the incident and any statements obtained.
- 9. Detailed descriptions of suspects (even if the name is known) and missing persons shall be included in the Principals Section of the report.
- 10. Any handwritten report shall be completed using the current forms and shall follow the guidelines in this manual.
- 11. All narratives shall be written in chronological order, meaning the incident is described in the order in which the events occurred and not from the perspective of any one witness or the officer.

- 12. When multiple offenses have occurred, the title of the report should reflect the most serious crime or incident.
- 13. Reports that include addresses that refer to large geographical areas, such as apartment complexes, condominiums, hotels, motels, parking garages or shopping malls shall include a specific location of the crime within the large area (i.e. the southeast corner of the parking lot near Sears.). Should also include the name of the complex or business in the narrative of the report.
- 14. The address, phone number, social security number, and photograph of the following persons are protected by Florida State Statute:

Current and retired Law Enforcement Officers, including correctional and correctional probation officers.

Current Firefighters

All Judges

HRS Employees (current and former) who investigate abuse and criminal cases

Spouses and children of above personnel, including their place of employment, school or daycare facilities.

If the individual chooses not to give their home address or phone number, the address and phone number of their employer should be used in the report.

- 15. Include evidence number in the narrative.
- 16. The disposition "A" should only be used for original incident reports.
- 17. If a CST processes the scene, the CST's report will cover most of the evidentiary information. If a CST did not process the scene, it is the officer's responsibility to document evidence information.

#### DOMESTIC VIOLENCE REPORT REQUIREMENTS

The following guidelines apply to all reports involving domestic violence:

"Domestic violence" is defined as "any assault, battery, sexual assault, sexual battery, or any criminal offense resulting in physical injury or death of one family or household member by another who is or was residing in the same single dwelling unit." "Family or household member" means "spouses, former spouses, persons related by blood or marriage, persons who are presently residing together as if a family or who have resided together in the past as if a family, and persons who have a child in common regardless or whether they have been married or have resided together at any time."

Section 741.29(2), F.S., was amended to provide that a law enforcement officer investigating an allegation of domestic violence "shall make a written police report as part of the field arrest and incident reporting form" that "clearly indicates" the alleged offense was an incident of domestic violence. If an arrest was not made, the officer must explain the reasons in the report. The narrative of the report should include the following additional information:

- ♦ A complete description of injuries.
- ♦ A statement that the legal rights and remedies pamphlet was given.
- ♦ A description of the relationship and how it is domestic.
- A description of the elements of the crime and how probable cause was established. If there are co-combatants, state who was the primary aggressor if this can be established.
- A description of evidence that was obtained (photos of injuries should be taken as well as disarray in the home, torn and bloody clothing should be seized as well as weapons, 911 tapes should be preserved, statements should be taken from witnesses including children and neighbors, spontaneous statements should be recorded and medical treatment should be noted as well as names of medical personnel who administered treatment.)
- A statement indicating whether an injunction is in place and the injunction number if known. Also record any known history of violence between the combatants.
- A case disposition (arrest, filed at large, warrant obtained). Do not refer victim to Misdemeanor Intake Unit.

### CHILD ABUSE, CHILD NEGLECT, ELDERLY ABUSE/NEGLECT

#### **ELEMENTS OF CRIME**

<u>CHILD ABUSE/NEGLECT</u> - This report title should be used for incidents of child abuse or neglect on person(s) under the age of 18 by a suspect(s) who is a parent, care giver or who has assumed responsibility for care of the victim on a permanent or temporary basis.

<u>ELDERLY ABUSE/NEGLECT</u> - This report title should be used for incidents of elderly abuse, neglect or exploitation of person(s) 60 years of age or older by a suspect(s) who is a relative, care giver or adult household member.

### NARRATIVE REQUIREMENTS

#### **OCCURRENCE**

• Describe incident in chronological order.

• Describe specifics of abuse, neglect or exploitation and how perpetrated, including any weapons used.

• Describe involvement and synopsize testimony of all subjects included in the principals section.

• If injuries occurred, describe. How inflicted? If medical attention administered, by whom?

How long was victim in suspect's care and control?

#### **SUSPECT**

♦ What is relationship between suspect and victim?

Why is person a suspect?

♦ Can victim or witness identify suspect? Specify individually.

♦ If suspect identified: How (photo line-up, known, street I.D.)? By whom?

♦ If suspect had a vehicle, describe.

♦ If tag number on suspect's vehicle was provided, give registration information.

### ASSAULT, AGGRAVATED ASSAULT

#### **ELEMENTS OF CRIME**

ASSAULT (Including DOMESTIC VIOLENCE) - To intentionally and unlawfully threaten by word or act. Suspect appeared to have the ability to carry out the act. Victim had well founded fear that violence was about to happen. Fear may be established by an objective assessment of the suspect's actions.

AGGRAVATED ASSAULT (Including DOMESTIC VIOLENCE) - The assault was made with a deadly weapon/motor vehicle and was made with a fully-formed conscious intent to commit the crime.

#### NARRATIVE REQUIREMENTS

In domestic violence cases refer to the Domestic Violence Report Requirements.

#### **OCCURRENCE**

• Describe incident in chronological order.

♦ Describe involvement and synopsize testimony of all subjects included in the principals list.

Describe threats to victim with exact quotes.

How was victim placed in fear? Quote victim.

♦ What was distance between victim and suspect?

• If environmental conditions (lighting, etc.) were a factor in the incident, describe.

♦ If weapon used, specify type.

• If victim states that they weren't in fear, but a reasonable person should have been, state why reasonable person would have been placed in fear.

### **SUSPECT**

What is relationship between suspect and victim? Specify clearly in domestic violence cases.

Why is person a suspect?

This report is used for persons taken into custody under the Baker Act who are not suspects in a crime.

If the person is the suspect in a crime, then the report should be titled based on the crime. Information regarding the Baker Act should be included in the crime report.

Describe incident in chronological order.

What behavior or statements were observed to warrant admission? Include information provided by family, witnesses or physicians.

### BATTERY, AGGRAVATED BATTERY, BATTERY ON LEO/FIRE FIGHTER

#### ELEMENTS OF CRIME

<u>BATTERY</u> (Including DOMESTIC VIOLENCE) - To intentionally touch/strike victim without consent of victim, with/without causing bodily harm.

AGGRAVATED BATTERY (Including DOMESTIC VIOLENCE) - To intentionally/knowingly cause great bodily harm or use a deadly weapon, or know/should have known victim was pregnant.

- 3. In cases of burglaries to hotels/motels/hostels or any other non-primary residence, one report with multiple victims should be generated as long as all occurred during the same general time span, with the same MO and are reported to the same officer.
- 4. Multiple entries to vehicles in the same general location within the same time span and with a similar MO must be placed on a single report with multiple victims. This rule only applies to private or semi-private lots (i.e. private businesses, City Hall parking, separate municipal parking lot, apartment complex, shopping center lots, etc.). Exception to any of the above conditions will require a separate report for each vehicle.
- 5. Vehicle Burglaries and Vehicle Vandalism: Where more than one vehicle is involved on private property (example, shopping centers, parking lots and apartment complexes), at the same location and same time range, use one case number. The above incidences, when occurring on the public street, require a separate report and case number for each vehicle.

<u>EMBEZZLEMENT</u> - The fraudulent appropriation of money or other property by a person to whom the money or property has been entrusted.

<u>FRAUDULENT DOCUMENTS</u> - This category should be reserved for those incidents which do not fall within the above categories and involve documents that are fraudulent (i.e. fictitious auto title, purchase order, sales contract, credit card applications). This does not include worthless checks as a result of insufficient funds or closed accounts in which the victim is referred directly to the SAO.

#### INFORMATION REPORT

"INFORMATION REPORT" should only be used as a report title in the following situation:

When the report has no criminal information that relates to a specific crime or indicates that a specific crime has occurred or is suspected, and

the incident does not qualify for any of the other listed report titles.

The victim's request for a declination of prosecution does not qualify for an Information Report, since an actual crime did occur. Use the appropriate report title.

Reports for situations where a potential witness believes he/she has just observed a possible crime should be documented and titled with the suspected crime (i.e. a citizen believes a kidnapping has just occurred because he/she saw a suspect drag a woman screaming into a vehicle would be a "Kidnapping" report.

Use "Suspicious Incident" as a report title in cases where it appears that some possible criminal activity has happened, but there is not enough information available at the time of the report to determine the exact nature of the crime.

When a report is titled "Information Report" (meaning no criminal activity), then it will not normally be routed to CID for review and the potential information will be lost. However, the PACE operator or supervisor may route a copy of the report to CID if they feel the information could be of value. The officer may also request that the report be routed to CID.

The value of stolen documents (i.e. checks) should be \$1. If the document is forged, refer to the Forgery report guideline.
