About the National Institute of Justice

The National Institute of Justice is the research and development agency of the U.S. Department of Justice, established to prevent and reduce crime and to improve the criminal justice system. Specific mandates established by Congress in the Omnibus Crime Control and Safe Streets Act of 1968, as amended, and the Anti-Drug Abuse Act of 1988 direct the National Institute of Justice to:

- *Sponsor special projects and research and development programs* that will improve and strengthen the criminal justice system and reduce or prevent crime.
- *Conduct national demonstration projects* that employ innovative or promising approaches for improving criminal justice.
- *Develop new technologies* to fight crime and improve criminal justice.
- *Evaluate the effectiveness of criminal justice programs* and identify programs that promise to be successful if continued or repeated.
- *Recommend actions* that can be taken by Federal, State, and local governments as well as private organizations to improve criminal justice.
- *Carry out research on criminal behavior.*
- *Develop new methods of crime prevention* and reduction of crime and delinquency.

The National Institute of Justice has a long history of accomplishments, including the following:

- Basic research on career criminals that led to development of special police and prosecutor units to deal with repeat offenders.
- Research that confirmed the link between drugs and crime.
- The research and development program that resulted in the creation of police body armor that has meant the difference between life and death to hundreds of police officers.
- Pioneering scientific advances such as the research and development of DNA analysis to identify suspects and eliminate the innocent from suspicion.
- The evaluation of innovative justice programs to determine what works, including community policing, community anti-drug initiatives, boot camps, violence prevention programs in schools, and efforts to reduce domestic violence.
- Creation of a corrections information-sharing system that enables State and local officials to exchange more efficient and cost-effective concepts and techniques for planning, financing, and constructing new prisons and jails.
- Operation of the world's largest criminal justice information clearinghouse, a resource used by State and local officials across the Nation and by criminal justice agencies in foreign countries.

The Institute Director, who is appointed by the President and confirmed by the Senate, establishes the Institute's objectives, guided by the priorities of the Department of Justice and the needs of the criminal justice field. The Institute actively solicits the views of criminal justice professionals to identify their most critical problems. Dedicated to the priorities of Federal, State, and local criminal justice agencies, research and development at the National Institute of Justice continues to search for answers to what works and why in the Nation's efforts to prevent and reduce crime.

The National Institute of Justice is a component of the Office of Justice Programs, which also includes the Bureau of Justice Assistance, Bureau of Justice Statistics, Office of Juvenile Justice and Delinquency Prevention, and the Office for Victims of Crime.

Introduction

Criminal justice professionals working to reduce violence, drugs, and crime in their communities are faced with tough decisions every day. They need the best information available to guide their decisionmaking. The National Institute of Justice is mandated to help provide that information by putting its research, development, and evaluation findings into the hands of those who can put them into active use.

This *NIJ Publications Catalog* is one vehicle for communicating available information. The *Catalog* lists publications and videotapes produced by the National Institute of Justice between 1985 and September 1995. Products are listed alphabetically by subject. For each publication the title, author, date of publication, number of pages, NCJ number (i.e., the identification number for ordering), and print and electronic availability are stated. Most of the items are free; others are available for a nominal fee. All can be obtained through the order form at the back of the *Catalog*.

The National Institute of Justice makes available several publication and videotape series:

Research in Brief (RIB) synthesizes recent research and evaluation results and summarizes the key findings in 6- to 20-page documents. RIB's offer quick overviews to policymakers, professionals, and researchers. One series of RIB's, Evaluation Bulletins, reports the results of evaluations of specific drug control programs in States and local communities.

Research Previews (Updates) provide brief, two-page summaries of key findings of current NIJ research.

Research in Action (RIA) offers overviews of research activities such as noteworthy demonstration programs and case studies.

Issues and Practices in Criminal Justice explore program options and management issues based on a review of research and evaluation findings, operational experience, and expert opinion. The intent is to give

criminal justice managers and administrators information to help them in planning, implementing, and improving programs and practices.

Program Focus presents highlights of specific State and local criminal justice practices.

Research and Evaluation Reports present comprehensive documentation of NIJ-sponsored research and development projects. Often they include a description of the research methodology and a review of the literature in addition to findings and recommendations. Full final reports are typically available online or for a small fee in paper copies. Research and evaluation findings are sometimes presented as Executive Summaries for criminal justice professionals who want to keep informed but do not have time to read the full report.

Searching for Answers, an annual report to the President, Congress, and the Attorney General, presents the results of NIJ research and development evaluations of State and local programs aimed at controlling drug abuse and crime.

Videotapes are offered in two series. **Research in Progress (RIP)** presents videotapes of leading experts and researchers discussing their work on critical criminal justice issues. A question and answer section with an audience of criminal justice professionals and practitioners is included. **Crime File Videotapes and Study Guides** present unrehearsed panel discussions by criminal justice experts on 32 critical issues facing the public. The Study Guides, which supplement most videotapes, present background information and explain the issues surrounding the topic. Crime File is designed for a diverse audience including educators, policymakers, professionals, and the public.

Perspectives on Policing present reports from the Executive Session on Policing, cosponsored by the National Institute of Justice and Harvard University's John F. Kennedy School of Government, and held with some of the leading figures in American policing. These 8- to 16-page bulletins highlight issues of importance to the improvement and future of policing.

Construction Bulletins summarize case studies of progressive techniques for constructing correctional facilities.

AIDS Bulletins present short, nontechnical summaries of important information on AIDS and related justice policies.
