

In 1995, Florida's reported incidents of domestic violence were up from 1994 by 9.4% (131,152). The rate per 100,000 population increased by 7.3%; a rate which produced one victim of domestic violence every four minutes. Table 1 shows the breakdown for the two years. In contrast, Florida's overall violent crime rate *decreased* almost 6.7% during the same time period.

While domestic violence incidents reported to the police increased substantially from the previous year, more than 80% of the increase occurred in the misdemeanor categories. With the exception of aggravated assault, all felony crimes showed declines. Over the four years that the Florida Department of Law Enforcement (FDLE) has published domestic violence statistics, felony offenses have decreased as a percentage of the total reported domestic violence incidents declining from 25.2% to 22.3%. However, since 1992, over one-third of all violent crime, with the exception of robbery, involved an incident of domestic violence.

In 1995, 39.6% of the category offenses were domestic violence related, up from 35.8% in 1992. Table 2 shows the number of total reported offenses and domestic violence related offenses for the two years, and the portion of total offenses which are domestic violence related with the percentage change from 1992 to 1995.

DOMESTIC VIOLENCE VICTIMS

Women continue to be the victims of domestic violence in much greater numbers than men. In 1995, the victims were female in almost 73% of all cases. In felonies, females were the victims in 63% of the reported incidents; for simple assault it was 76%. Also, in 1995, 39% of all female murder victims were killed during domestic violence incidents compared to 12% of male murder victims (for 1992, the numbers are 36% and 15%, respectively). (All victim data exclude threat/intimidation and arson as victim breakdowns for both offenses are unavailable).

Sadly, children are reported most often as victims of forcible sex offenses in both domestic violence and non-domestic violence related offenses. Overall, those 17 years of age and under were victims in less than 13% of all domestic violence offenses reported (this age group was estimated to comprise 23% of Florida's population in 1995), and yet they made up the majority of domestic violence related


sex crime victims: 60% of forcible rapes; 85% of all cases of forcible sodomy; and 93% of forcible fondling incidents. In overall domestic violence incidents where victim data is reported, the number of juveniles increased by almost 2,300 individuals; while their portion of the total decreased from 13.2% in 1992 to 12.8% in 1995. Table 4 gives the victim breakdown by age for 1994 and 1995.



VICTIM INJURIES

For the past four years, over half of all domestic violence related felonies resulted in minor or serious injury. Most of the injuries reported were categorized as "minor." Minor injury was defined by the Florida *UCR Guide Manual* as having involved "physical contact and caused minor bruises or contusions such as a black eye, bloody nose, etc...." Overall, physical injury to victims declined slightly for the four-year period (technically, murder and manslaughter are classed as fatal injuries—they have been combined with the serious injury category to simplify the chart). Chart 1 provides this victim injury data.

Simple Assaults are not included in Chart 1. The number of domestic violence related simple assaults has climbed from 79,722 in 1992, to 98,628 in 1995; an increase of almost 24%. Most simple assaults do involve physical injury. From 1992 to 1995, the percentage of these offenses involving minor injuries ranged from 65% to 59%.

FIREARM USE IN DOMESTIC VIOLENCE

In 1995, over 65% of the murders committed during an incidence of domestic violence involved use of a firearm.

However, for the four-year period, firearms were slightly less likely to be used in domestic violence murders than in nondomestic violence murders: 63% to 67%, respectively. In 1995, firearms were used in less than three percent of all domestic violence crimes compared with more than ten percent of non-domestic violence related incidents in the same categories. Table 5 gives the breakdown for 1995.

Since July 1994, the Florida Department of Law Enforcement has maintained a domestic violence injunction database. This database currently contains 38,724 records. When an individual against whom an injunction has been filed and entered into the database attempts to purchase a firearm in the state, he or she will have the request denied during the background check conducted by the FDLE's Firearm Purchase Program.

FAMILY RELATED MURDERS

While figures on domestic violence crimes were not specifically reported prior to 1992, information on family related murders has been collected by the FDLE since 1971. This information provides a historical perspective on domestic violence in Florida. Table 6 presents family-related murder over the past two decades.

Two of the three categories of family related murders show sharp drops in the twenty-one

year period covered by Table 6. The third category, children as victims, increased by 52%, but declined in rate per 100,000 population: from 0.25 in 1975 to 0.23 in 1995 (in 1988 the category "Spouse kills Spouse" was changed to "Spouse kills Spouse/Ex-Spouse" and the category "Parent kills Child" was changed to "Parent kills Child/Step-Child"). This decrease in family murders occurred over a period when Florida's population grew by 67%.

BACKGROUND

For the fourth consecutive year—as mandated by Section 943.1702, Florida Statutes—the Florida Department of Law Enforcement compiled data on the incidence of domestic violence in the state. The May 1995 edition of *SAC Notes* presented the findings of the first two years. This edition presents the 1994 and 1995 domestic violence picture and, for further insight, looks at family related homicides from 1975.

In Florida, domestic violence is defined as any "assault, aggravated assault, battery, aggravated battery, sexual assault, sexual battery, stalking, aggravated stalking, or any criminal offense resulting in physical injury or death of one family or household member by another who is or was residing in the same single dwelling unit"; which, with the exception of robbery, includes all violent crimes. Further, "persons who have a child in common regardless of whether they have been married or have resided together at any time" are also covered by the domestic violence law.

The reports by criminal justice agencies on domestic violence related offenses are summarized by the Florida Department of Law Enforcement into seven categories: murder, manslaughter, forcible sex offenses, aggravated assault, arson, simple assault and threat/intimidation. All figures used in this report are taken from <u>Crime in Florida</u> for the years indicated. Σ
