

INTRODUCTION

During the past five years, North Carolina has continued to experience moderate growth in both its population and economy. This growth has occurred as a result of new business and industrial investment in the state, as well as a significant increase in tourism and retirement relocations. While this population growth and economic expansion has been very beneficial to North Carolina, it has also increased the risk for property crime opportunities, drug abuse, and violent criminal behavior.

The impact of this growth on reported crime and the criminal justice system is exaggerated by the problems associated with prison and jail overcrowding, such as a rise in early releases from correctional institutions and a greater percentage of parole admissions. There has also been a substantial increase in the number of inmates sentenced to prison after being previously released. For example, in 1984 there were approximately 1,900 inmates released from prison who were reincarcerated within one year. By 1990 that number had increased by 128 percent, with over 4,500 inmates being released only to be reincarcerated within one year. Furthermore, assessments performed on inmates entering the state's prison system indicated that approximately half of them were under the influence of drugs when they committed the crime for which they were sentenced to prison, and 70 percent were identified as having a substance abuse problem.

Another area of concern is the impact criminal activity is having on North Carolina's rural areas. Smaller police departments and sheriffs' offices do not have the manpower or the resources to combat the growth in criminal activity. One of the biggest obstacles the law enforcement community in North Carolina faces is the lack of adequate communications capabilities due to outdated and incompatible equipment. In most circumstances, an officer working for one agency cannot directly make radio contact or share criminal information with an officer from another agency, even in the same town. Without this basic capability, many violators go undetected.

Although a bleak picture has been painted of the status of North Carolina's criminal justice system, the Division of the Governor's Crime Commission has implemented a strategic planning process for the administration of federal block grant funds. Consistent with its Mission Statement,

“[to] improve the quality of life for the citizens of North Carolina, enhance public safety, and reduce and prevent crime by improving the criminal justice system;”

this planning process develops program and policy recommendations for the Governor, the Secretary of Crime Control and Public Safety, the General Assembly, criminal justice practitioners, local and state agencies, and the citizens of North Carolina. The Governor's Crime Commission is also reintroducing the process of developing a legislative agenda by committee. The goal of the Governor's Crime Commission is to allocate federal block grant and competitive funds to programs that will have a positive impact on crime in North Carolina. The purpose of this publication is to show the positive and effective programs implemented across the state that have been funded by the Commission through federal block grant and competitive funds, and how these programs have benefited the citizens of North Carolina over the last four years.

NORTH CAROLINA CRIME TRENDS

An analysis of reported crime data, as compiled by the State Bureau of Investigation's Division of Criminal Information, reveals the extent to which North Carolina was affected by the *crime wave* of the past decade. During the period of 1984 to 1995, North Carolina's reported index crime rate swelled 40.5 percent with the most pronounced changes occurring for the following offenses:

- ◆ The rate of reported *violent offenses* grew 62 percent
 - ▶ Reported robberies up 140 percent
 - ▶ Reported rapes up 50 percent
 - ▶ The state's murder rate up 23 percent
 - ▶ Aggravated assault rates up 44 percent
- ◆ The rate of reported *property crime* grew 38 percent
 - ▶ The rate of reported burglaries up 26 percent
 - ▶ Larceny rates up 41 percent
 - ▶ Motor vehicle theft rates up 75 percent

The most recently available data on reported crime indicate that this *crime wave* may be subsiding, or at least leveling off. Data for the period of 1993 to 1995 show less significant increases were being reported and in some cases, actual decreases were reported.

- ◆ A .2 percent drop in the *reported index crime* rate
 - ▶ The rate of reported violent offenses declined 5 percent
 - ▶ Reported aggravated assault declined 4 percent
 - ▶ Reported robberies declined 7 percent
 - ▶ Reported murders declined 19 percent
 - ▶ Reported rapes declined 6 percent
- ◆ The rate of reported *property crime* increased .5 percent
 - ▶ The rate of reported larcenies grew 3 percent
 - ▶ Reported motor vehicle thefts increased 8 percent
 - ▶ Reported burglaries declined 6 percent

The leveling off of crime rates is encouraging. There are many explanations for these recent positive trends, which range from system-wide responses to crime and violence to changes in demographics. The emphasis at the Governor's Crime Commission is on policy/program development that improves the criminal justice system. An example of our successful projects is the Center for the Prevention of School Violence, which has been completely funded by grants from Juvenile Justice and Delinquency Prevention and the Edward Byrne Memorial Fund. The center functions as an information clearinghouse, develops programs, offers technical assistance aimed at preventing school violence, and coordinates the implementation of School Resource Officer Programs.

- ◆ The Center for the Prevention of School Violence Programs have reduced reported school violence by:
 - ▶ 63 percent in Wilson County High Schools
 - ▶ 46 percent in the Iredell-Statesville High School District
 - ▶ 43 percent in Montgomery County High Schools
 - ▶ 33 percent in Buncombe County High Schools

We know what works to reduce the effects of crime and violence in our communities. These trends are an indication that we need to continue or even increase our efforts to improve North Carolina's criminal justice system. Much remains to be done, especially to prepare for the wave of juvenile crime predicted during the next twenty years.

PROGRAM INITIATIVES AND EMPHASIS

Edward Byrne Memorial Fund (DCSI)

The Edward Byrne Memorial Fund is allocated to individual states by the Bureau of Justice Assistance for drug control and systems improvement. In North Carolina, these funds are administered by the Law Enforcement, Information Systems, Judicial, and Correction Committees of the Governor's Crime Commission.

Law Enforcement

Law enforcement strategies developed since 1993 address violent crime in North Carolina. For example, drug enforcement strategies provide training, manpower, and equipment in a variety of programs, most notably, community oriented policing. Community policing programs form partnerships between communities, law enforcement, and businesses to recapture a good quality of life and establish safeguards against losing communities to crime and the subsequent problems. Whenever possible, efforts are made to conduct Multi-jurisdictional Task Forces to combat our difficult drug problem. The following describes our work in developing community oriented policing:

Community Policing

The Governor's Crime Commission is actively involved in developing community oriented policing for North Carolina's law enforcement agencies. A recent National Institute of Justice study revealed that 80 percent of surveyed law enforcement officials are using community policing to combat crime and violence in their jurisdictions. Sheriffs and police chiefs in North Carolina reflect the national trend. Community policing is anticipated to remain a primary program strategy for the Governor's Crime Commission.

The Commission has a responsibility to use its limited resources to award meaningful grants and advise on the most effective ways to make community policing work for the long term. It is also important to have as many avenues as possible to identify the most promising ideas and disseminate them as quickly and as widely as possible.

The Commission is conducting complementary studies to understand this strategy and recognize programs with the most potential. It will thus be able to provide the best policy direction for enhanced program development. These studies combine detailed and extensive analysis with a heavy emphasis on practical lessons learned from local law enforcement and citizens in our neighborhoods across the state. The work has the potential for national recognition. The Bureau of Justice Assistance is considering receiving a presentation of the work at this summer's national evaluation conference. Summaries of these projects follow:

North Carolina Liaison for the Development and Recognition of Community Policing

This project with North Carolina Central University addresses the lack of a dedicated mechanism within the state that communicates timely details of successful community policing efforts. It establishes a liaison for successful community policing programs throughout the state and links to federal and national developments in this strategy area. The project is unique in that it also provides the added dimension of a legal advisor to assist local practitioners in relevant law. An example is the application of civil nuisance abatement strategies in community policing. The project assesses statewide community oriented policing efforts, then recognizes and promotes the most effective ones as widely as possible. Its overall objectives are:

- ▶ To increase the level of information sharing and cooperation among federal, state, and local agencies to promote effective community policing and prevent duplication of effort.
- ▶ To survey all law enforcement agencies with regard to their community policing practices.
- ▶ To increase the awareness of law enforcement officials of successful community policing initiatives by recognizing law enforcement agencies and individual officers with awards from the Governor's Office.

Developmental Impact and Policy Analysis of Community Policing in North Carolina

This research project with the University of North Carolina at Chapel-Hill, Center for Urban and Regional Studies (the second oldest university-based urban research center in the United States), assesses the impact of community policing and identifies the most effective community policing practices. Citizens and police personnel are being extensively surveyed in Asheville, Lumberton, Greensboro, Morehead City, Whiteville, and Forsyth County. A report on North Carolina community policing is in production, along with an effective practices handbook, which will assist communities interested in adopting or improving their community oriented policing effort. The project's overall goal is to improve the crime fighting capacity of North Carolina law enforcement agencies.

Information Systems

The Information Systems Committee was created in December 1993. It seeks data quality and criminal justice agency integration, through information and technology, that will maximize the efficiency and effectiveness of the criminal justice process. The committee's work has been motivated by its desire to enhance North Carolina's criminal justice information systems and technology, and is best reflected in its vision statement:

We envision useable information, available where needed and when needed to improve the safety and security of North Carolina citizens.

Under the direction of its former chair, John Wyatt, and its current chair, Sheriff Jim Pendergraph of Mecklenburg County, the committee adopted four policy priorities to guide its work.

These priorities are:

- ▶ *Integrated Justice Information Systems* - Systems that are responsive and freely share information among state and local agencies.
- ▶ *Automated Fingerprint Identification Systems* - Systems at the state and local level that tie into and are compatible with the SBI's automated system.
- ▶ *Criminal History Records Improvement* - Projects which enable the state to comply with federal criteria for improving criminal history and other criminal justice records.
- ▶ *General Systems Improvements/High Crime Areas/ Significant Crime Problems* - Systems that utilize technology to improve the justice process or address specific system or significant crime problems.

From 1993 through 1996, the committee recommended 91 grants, submitted by state and local agencies from all regions of the state. These grants received a total appropriation of over 7 million dollars. The dissemination of this Drug Control and System Improvement money has allowed many state and large urban agencies to continue large scale automation projects. At the same time, these grants have benefited many smaller and rural agencies by providing enabling funds to initiate automation projects which are cost-prohibitive. Some of the most exemplary programs this committee has funded include:

- ▶ Providing for the initial automation of records in Southport, Polk County, and McDowell County
- ▶ Providing funds for significantly enhancing the Buncombe County Criminal Justice Information System
- ▶ Establishing electronic connectivity between Mecklenburg County's Information System and the Administrative Office of the Courts system.
- ▶ Enhancing and connecting statewide criminal justice information systems, such as the SBI, the Department of Correction, and the Administrative Office of the Courts. This emphasis on system-wide connectivity has allowed all criminal justice agencies, irrespective of their location in the state, to obtain more complete and accurate criminal history and criminal justice records. This success is a significant step toward the realization of the Information System Committee's vision for North Carolina.

Members of the Information Systems Committee have been involved in other projects and studies which will significantly enhance criminal justice information systems and technology throughout the state. Committee members contributed their knowledge and expertise to the General Assembly's Criminal Justice Information Network Study (CJIN). This study culminated in a comprehensive strategic plan for developing and implementing a statewide criminal justice information network. The committee has been an advocate of this study and has acted as a champion for the implementation of the CJIN study recommendations. Committee members have spoken to practitioners from all

segments of the criminal justice system in an effort to gain support for State Senate Bill 629 which will provide for the initial establishment of a modern and technologically superior statewide integrated criminal justice information network. In 1996, the Committee recommended funding for the establishment of the statewide law enforcement mobile data network switch. This switch will be maintained by the NC State Highway Patrol and will lay the foundation for the CJIN's statewide mobile data and voice network. Committee members have also assisted in the drafting of the state's Criminal Justice Records Improvement Plan. This federally mandated program describes the current status of the state's criminal justice records, delineates specific improvement strategies, and charts a course for complying with current mandates such as the Brady Bill and the National Child Protection Act.

Additional Funding Sources

NCHIP

In 1995, North Carolina received an award of \$1.4 million to begin its National Criminal History Improvement Program (NCHIP) Plan. Under this award, the following two major activities were either completed or will be completed during the grant cycle. First, the state centralized repository was considerably expanded and upgraded in an effort to manage the anticipated increase in usage as a result of the Brady Bill. Many county agencies have or are in the process of implementing livescan and a few even have remote AFIS latent terminals. Consequently, it was imperative that the central repository be expanded in an effort to proactively manage a significant increase in future usage.

The NCHIP funds were also used for the purpose of establishing an electronic interface between the state AFIS and the Mecklenburg County AFIS system, the state's largest county. Prior to this award, the state's largest county was unable to electronically submit fingerprint data to the state AFIS. Consequently, print cards had to be mailed and then manually entered by SBI/DCI staff. This interface became operational in September 1996 and has significantly improved the quality and comprehensiveness of the state's AFIS and CCH repositories. However, it will also produce a heavy burden on the storage capacity of these systems.

NCHIP - ASAP

North Carolina recently received an NCHIP Advanced States Award in the amount of \$245,000 which will allow for the development and testing of data access protocols for non-criminal background checks. Specifically, this will include persons under domestic violence restraining orders, drug abusers, illegal aliens, and persons who have been adjudicated as mentally defective or have been committed to mental hospitals. System usage and access are anticipated to experience a tremendous increase once these protocols are integrated into the existing system.

North Carolina's efforts in this area have received national recognition and the state's criminal history and AFIS programs have been significantly expanded through the NCHIP program. Consequently, North Carolina is now in a better position to communicate and exchange criminal history and fingerprint data with both the FBI and other states.

Courts

The Governor's Crime Commission recognizes the need to update our courts' systems to reflect the needs of a changing society. We are doing this by sponsoring the Courts Futures Commission. Futures planning involves identifying the trends of a changing society, developing scenarios of how the courts might function in the future, and adopting strategies to implement the overall plan. Since 1993, there have been 16 programs funded that have been beneficial to the enhancement of the Judicial system. These programs represent all judicial districts across the state and address the following priorities of the Judicial subcommittee:

- ▶ *Child Abuse Prevention* - Focuses on programs that provide direct services to child victims through crisis intervention, court support, and identification and coordination of local services.
- ▶ *District Attorney Programs* - Focuses on the needs of district attorneys, judges and public defenders. Recognizes that they need to stay informed and knowledgeable about the many new developments regarding the prosecution and adjudication of criminal cases.
- ▶ *Violent Offender Programs* - Helps attack the escalating rate of violent crime by having limited caseloads and additional sessions of court so the prosecutors and investigators can better concentrate their efforts on preparing quality cases for trial.
- ▶ *Court Management and Efficiency Programs* - Improves case management systems and victim services by providing up-to-date training in computer technology.
- ▶ *Substance Abuse Programs* - Increases the coordination and communication between the court system and those who work with substance abusing criminal offenders.
- ▶ *Drug Court Programs*
 - Felony Drug Court in Mecklenburg County - Provides for the fair, consistent, and efficient handling of felony cases.
 - Drug Treatment Courts - Provide ways to increase collaboration between court officials and people involved in the substance abuse field.

The Judicial subcommittee of the Governor's Crime Commission has adopted five policy priority areas for fiscal year 1996:

- ▶ Commission for the Future of Justice and the Courts
- ▶ Training Issues
- ▶ Court Management and Efficiency

- ▶ Domestic Violence/Child Abuse Prevention
- ▶ Educational Development Initiative

Last year, five grants submitted by state agencies were selected to receive more than eight hundred thousand dollars of Edward Byrne Funds. The projects selected all envision developing a court system that will incorporate the present and future needs of the state, plus gain public trust and respect by being accessible, fair and timely.

Correction

North Carolina's correctional system is strained by overcrowding. Both the prison population and probation and parole caseloads continue to increase faster than available resources. The Governor's Crime Commission uses its grant programs to address identified needs in five areas: System Improvements; Prisoner Idleness; Substance Abuse/Treatment Needs of Criminal Populations; Overcrowding/Alternatives to Incarceration for Non-Violent Offenders; and Probation/Parole caseloads. The Correction Subcommittee designed projects to address these needs. Between the years of 1993-1996, grants were funded in each priority area:

- ◆ Correction System Improvements
 - ▶ Corrections Futures Study
 - ▶ Probation and Parole Study
 - ▶ Automated Exchange of Criminal Justice Information
 - ▶ Automated Inmate Identification System
 - ▶ Department of Correction's Response to Structured Sentencing
- ◆ Prisoner Idleness
 - ▶ N.C. PRIDE - public/private partnership grant that puts prisoners to work.
- ◆ Substance Abuse/Treatment Needs of Criminal Populations
 - ▶ Continuing Care and Linkage
 - ▶ Intensive Chemical Dependency Orientation (DOC)
 - ▶ Substance Abuse Screening (DOC)

- ▶ Treatment for Substance Abusers (Buncombe)
- ▶ Davie County Intensive Outpatient
- ▶ Burke/Catawba Regional Jail Project
- ▶ Community "SOS" (Craven County)

- ◆ Overcrowding/Alternatives to Incarceration for Non-Violent Offenders
 - ▶ Assessing Alternative Punishments (Mecklenburg)
 - ▶ Impacting Probation and Parole Revocations (DOC)
 - ▶ Community Based Correction Plan/Program (Durham)
 - ▶ Prosecution Alternatives to First Time Offenders (Orange)
 - ▶ Vance County Jail Treatment
 - ▶ Project Boot Strap (Randolph County)
 - ▶ Day Reporting Center (Onslow County)
 - ▶ Person County Reporting Center for Substance Abuse

The Division of Adult Probation and Parole was awarded a grant to address Victim Services in the recent 1996 funding cycle. This grant will serve to support current efforts by the Department of Correction to address victim family issues.

Correction priority funding areas are chosen and modified annually to enhance, support, and strengthen correction systems at the state and local levels. The current needs were identified at public forums, from the analysis of local and state data, and by the recommendations of those working in the corrections system at both the state and local level. Additionally, these needs were reviewed for their compliance with federal guidelines and the overall state strategy, which integrates agency and state goals to enhance the criminal justice system in North Carolina.

Juvenile Justice and Children's Justice

Juvenile Justice

The North Carolina Juvenile Justice Committee develops a comprehensive plan of action every three years. Since 1993, the emphasis has been on:

- ▶ Violent juvenile crime
- ▶ Collaboration and linkage of prevention efforts
- ▶ Early intervention
- ▶ Treatment for substance abuse and child abuse
- ▶ Disproportionate minority confinement

By developing programs that teach personal and family responsibility, community responsibility, and systems improvement, state and local agencies served approximately 105,506 youth and their families. The Juvenile Justice Committee feels this is the best method to accomplish the Crime Commission's mission of improving the quality of life for the citizens of North Carolina.

Children's Justice

The Children's Justice Act of 1986 from the Department of Health and Human Services provides for grants to assist North Carolina in developing, establishing, and operating programs designed to improve:

- ▶ the handling of child abuse and neglect cases, particularly cases of child sexual abuse and exploitation, in a manner that limits additional trauma to the child victim.
- ▶ the handling of cases involving suspected child abuse or neglect related fatalities.
- ▶ the investigation and prosecution of cases of child abuse and neglect, particularly child sexual abuse and exploitation.

The Children's Justice Committee's goal is to develop programs that lessen the trauma to the child victim. By providing funds for training, studies, child friendly centers, and developing protocols, there is a greater likelihood of arrest and successful prosecution of the offender. Over 600 professionals have been trained in child abuse, neglect, and exploitation investigation techniques and approximately 4000 child victims have been served.

Safe Schools Initiative

Making North Carolina's schools safe and secure for our children is a priority for Governor Hunt. He began this administration with the implementation of the Safe Schools Initiative; whereby, he created the Center for the Prevention of School Violence, worked with the General Assembly to pass relevant legislation for schools, and gave the people of North Carolina a vision for safe schools in our state.

The North Carolina Center for the Prevention of School Violence

The North Carolina Center for the Prevention of School Violence was established in 1993 within the Department of Crime Control and Public Safety, Division of the Governor's Crime Commission, and provides the following services:

- ▶ The Center functions as a clearinghouse for information, program development and technical assistance aimed at preventing school violence. It collects and analyzes statistics on school violence in North Carolina and evaluates the effectiveness of programs and legislation intended to address the problem of school violence.
- ▶ The Center, in collaboration with the Department of Public Instruction, the Attorney General's Office, the Department of Human Resources, and the Juvenile Services Division of the Administrative Office of the Courts, works with local school boards, law enforcement agencies, and other community leaders to reduce violence in schools.
- ▶ The Center coordinates assistance to schools and communities implementing innovative grant programs focused on the prevention of school violence.
- ▶ The Center has been successful in its efforts to establish statewide chapters of Students Against Violence Everywhere (SAVE). SAVE is a student-led, school-based proactive organization for preventing school violence.
- ▶ The Center also has taken an active role in supporting the School Resource Officer (SRO) program. The SRO program places a sworn law enforcement officer in a school to intervene and make arrests, if necessary, in incidents of violence and to provide a variety of services to students and staff.

The Center for the Prevention of School Violence received approval from the Governor's Crime Commission for continued funding for an additional eighteen months. As of July 1, 1995, the Center became an inter-institutional public service center of the University of North Carolina System and established a partnership with North Carolina State University in the College of Education and Psychology.

Additional Funding Sources

TITLE V

Title V of the Juvenile Justice Delinquency Prevention Act is designed to provide States the

opportunity to fund delinquency prevention and early intervention programs for communities. Title V programs, which are risk-focused, offer positive approaches that emphasize opportunities for healthy social, physical and mental development for the youth. Risk-focused delinquency prevention is a comprehensive approach based on the premise that in order to prevent a problem from occurring, the factors that contribute to the development of that problem must be identified and addressed. These risk-focused programs also take into account the individual, family, peer group, school, and community influences on a child's development.

CHALLENGE

There are ten Challenge areas in which a state can apply. North Carolina funds two Challenge Programs.

One is a program to increase community-based alternatives to incarceration by establishing an intensive probation program as well as developing a set of objective criteria for the appropriate placement of juveniles in the community based program.

The other program is one that develops policies and programs designed to serve as an alternative to suspension and expulsion from school.

Victims of Crime Act (VOCA)

VOCA projects provide direct services to victims of domestic violence, sexual assault and child abuse crimes. Priority is given to under-served areas, multi-disciplinary team projects, projects that have never received funding, victim advocates/victim service projects and projects serving Native American populations. From 1993 - 1995, there were 41,296 victims served statewide as a result of VOCA funded projects and programs.

Programs that offer services to victims of domestic violence, sexual assault, and child abuse typically provide one or more of the following services:

- ▶ Counseling
- ▶ Individual/group therapy or support
- ▶ Information and referral
- ▶ Personal advocacy
- ▶ Criminal justice support/advocacy
- ▶ Safe shelter
- ▶ Crisis hotline/counseling

The VOCA program significantly impacts victims in North Carolina and continues to provide much needed support and resources for the agencies serving the needs of victims.

Violence Against Women Act (VAWA)

The focus of the Violence Against Women Program is to coordinate a statewide multi-disciplinary approach to end violence against women. The program funds projects to prosecutorial districts, law enforcement and victim service agencies. The program also funds projects through a discretionary provision to include other criminal justice components. The single greatest need identified by this program is the need for training, particularly domestic violence and sexual assault training, with an emphasis on multi-disciplinary collaboration.

Since the program's beginning in 1995, 30 projects have received funding. The projects did not start until early 1996 because of budget restrictions at the federal level. The Violence Against Women Committee approved 20 grant projects for 1996. These projects began operation in July. The following is a list of the ten projects funded in 1995 and their progress through June 1996.

- ▶ *Law Enforcement* - The North Carolina Justice Academy will develop training for criminal justice personnel statewide. The grant is in the beginning phase, with the training coordinator position currently being filled. A hired legal expert is researching domestic violence response by law enforcement officers statewide. The ultimate goal of this project is to provide written guidelines for agencies so they can improve efforts to successfully investigate domestic violence cases.
- ▶ *Prosecution*- The Rockingham County District Attorney's Office will provide training for law enforcement personnel, emergency medical staff, judicial officials, and prosecutors to help them better investigate acts of domestic violence, assist victims, and prosecute cases. The district attorney's office has researched and developed a singular, countywide protocol training manual and program. Local law enforcement administrators have met and approved the training manual, which is near completion. The first law enforcement training is set for September 1996.
- ▶ *Specialized Training* - The Pitt County District Attorney's Office will provide specialized training for sexual assault investigation and prosecution through a multi-disciplinary team approach. Meetings are being held with law enforcement, health care providers, prosecution staff and victim service providers. The goal of these meetings is to develop a thorough, consistent rape protocol. This project is in the planning and development stages.
- ▶ *Victims Services* - Family Violence and Rape Crisis Services (Chatham County) - The Bridges Program has provided Chatham County with three Polaroid Spectra cameras which have resulted in a 100 percent conviction rate. Service providers in the two-county district have developed a training schedule that requires every law enforcement officer to receive 12 hours of domestic violence and sexual assault education. The program has also helped the Family Violence and Rape Crisis Agency create a Domestic Violence Task Force.
- ▶ *Court Advocacy* - The Task Force on Family Violence (Cherokee County) hired a court advocate to work with victims of domestic violence and sexual assault. The court advocate attended the NC Domestic Violence Summit and the NC Domestic Violence Coalition Annual Meeting. The advocate is also working with the Chief District Court Judge to organize a

local coordinating council. During the first six months of this grant, the advocate has assisted with support in 19 domestic violence protective orders.

- ▶ *Shelter* - S.A.F.E. of Harnett County was provided funds to establish a shelter and hire a shelter manager. The S.A.F.E. Shelter opened in December 1995 and has a capacity for up to 15 women and children. It will provide child care, client options and support, community resource referrals, transportation, court advocacy, support groups, subsistence needs, and a secure environment.
- ▶ *Service Improvement* - Family Resources (PATH Shelter) of Rutherford County is a pilot project designed to improve existing services, policies, and protocols within the judicial and law enforcement components in a collaborative response to domestic violence. Family Resources has worked with local law enforcement, the chief magistrate, and the district attorney's office to establish the Domestic Advocacy Response Team (DART) project. Two shelter staff members have completed the Basic Law Enforcement Training (BLET) to accomplish a project goal. Participation from local law enforcement continues to increase and the project is reaching its goal of establishing a permanent DART.

Discretionary Fund Allocation

North Carolina plans to use the discretionary portion of STOP VAW (Services-Training-Officers-Prosecutors -- Violence Against Women) funds to support the following programs:

- ▶ *The North Carolina Victim Assistance Network* - The Violence Against Women Protocol Development Summit was held in the spring of 1996 with 256 individuals in attendance. This is the first hands-on policy development summit where 38 of 39 prosecutorial districts in the state were present. The summit consisted of a three day program utilizing a combination of plenary workshops and eight hours of local team development. Each team's plan of action is in the process of being computerized and distributed back to each of the local teams present at the summit. Evaluations completed by attendees have indicated that the summit was a success. The second year of this grant will be dedicated to holding a sexual assault protocol development summit.
- ▶ *Harbor, Inc. (Johnston County)* - Project Response has enabled Harbor, Inc to develop new materials to assist first responders in sexual assault cases as well as increase community awareness. The multi-team approach, including rape survivors and all service providers that assist victims, has been the direct result of a collaboration of services made possible by this project.
- ▶ *The Rape Crisis Volunteers of Cumberland County* will develop a training handbook and implement comprehensive, interactive training programs to foster more effective criminal justice policies and practices regarding the treatment of sexually assaulted victims. These training programs are essential to promote the reporting and prosecution of the crime of rape and other acts of sexual violence. This project will target groups within the criminal justice system that interact with victims of sexual assault. These groups include investigators

working for the city police, the sheriff's department, members of the District Attorney's office, the Clerk of Court's office, the staff of the Magistrate's office and others. A training survey was conducted, in which results reveal that respondents have received no specialized training on sexual assault issues. This survey guided both the director and direct services coordinator in gathering information for the training manual. A rough draft of this manual was presented to the interagency council in June 1996.

CONCLUSION

The Governor's Crime Commission must continue to implement a strategic planning process for the administration of federal block grant funds. As can be seen from this publication, the grant process develops program and policy recommendations which result in the funding of positive and effective programs across the state. These programs have benefited the citizens of North Carolina over the last four years. The following are the federal block grants and a brief summary of how they are allocated in North Carolina.

The Edward Byrne Memorial Fund, administered by the Bureau of Justice Assistance, is used for drug control and system improvements in North Carolina by the Law Enforcement, Information Systems, Judicial, and Correction Committees. The Law Enforcement Committee's program priority during this period has been community policing. Community policing programs form partnerships between communities, law enforcement, and businesses to recapture a good quality of life and establish safeguards against losing communities to crime and the subsequent problems. The Information Systems Committee's program priority is to enhance North Carolina's criminal justice information systems by developing and sharing technology. Funding has been allocated for programs compliant with the CJIN Study; establishing connectivity between Mecklenburg County's Information System and the Administrative Office of the Courts system; and enhancing and connecting statewide criminal justice information systems, such as the SBI, Department of Correction, and the Administrative Office of the Courts. The Judicial Committee's program priority is sponsoring the Courts Futures Commission. Futures planning involves identifying the trends of a changing society, developing scenarios of how the courts might function in the future, and adopting strategies to implement the overall plan. The Correction Committee's program priority is to enhance, support, and strengthen correction systems at the state and local levels. This priority is achieved by supporting correction system improvements, stopping prisoner idleness, evaluating substance abuse treatment needs of criminal populations, and funding alternatives to incarceration for non-violent offenders in order to battle correction facility overcrowding.

Juvenile Justice and Delinquency Prevention and Children's Justice Funds are used by the Juvenile Justice and Children's Justice Committee in North Carolina. This Committee's primary program strategy is developing programs that teach personal and family responsibility, community responsibility, and systems improvement. Over 600 professionals have been trained in child abuse, neglect, and exploitation investigation techniques and approximately 4000 child victims have been served. One of the successful projects is the Center for the Prevention of School Violence. The Center functions as an information clearinghouse, develops programs, offers technical assistance aimed at preventing school violence, and coordinates the implementation of School Resource Officer Programs. As of July 1, 1995, the Center became an inter-institutional public service center of the University of North Carolina System and established a partnership with North Carolina State University in the College of Education and Psychology.

The Victims of Crime Act Program is used by the VOCA Committee to fund programs that offer services to victims of domestic violence, sexual assault, and child abuse. From 1993-1995, there were 41,296 victims served statewide as a result of VOCA funded projects and programs.

The Violence Against Women Program's program priority is to coordinate a statewide multi-disciplinary approach to end violence against women. The greatest need in this area is for training, particularly domestic violence and sexual assault training, with an emphasis on multi-disciplinary collaboration. Programs funded include law enforcement training, prosecution, victims services, court advocacy, shelters, and comprehensive, interactive training programs to foster more effective criminal justice policies and practices regarding the treatment of sexually assaulted victims.

The Governor's Crime Commission's goal is to allocate federal block grant and competitive funds to programs which will have a positive impact on North Carolina's crime rate. With funding sources such as the Edward Byrne Memorial Fund (DCSI), NCHIP, NCHIP ASAP, Juvenile Justice and Delinquency Prevention, Children's Justice Act, Title V, Challenge, Victims of Crime Act, and the Violence Against Women Act, North Carolina has the tools to combat crime and provide a safe and secure environment for its citizens.
