

INTRODUCTION

The Mecklenburg Youth Services Bureau Staff is pleased to have an opportunity to furnish school personnel, social service agency personnel, parents, police, juvenile court personnel, and others who are responsible for assisting youth to gain access to needed services with this document. It is emphasized that this document could not have been developed without splendid cooperation from all agencies included in this youth services inventory.

Information contained herein should provide one with answers to the following questions:

- 1. What services are presently available for youth in Charlotte and Mecklenburg County?
- 2. What are some services which need to be developed, on an immediate basis, for youth in Charlotte and Mecklenburg County?
- 3. What can happen to children when they do not receive services they need?
- 4. What action is being taken by local government to expedite the development of services needed by youth in Charlotte and Mecklenburg County? (Refer to Attachment A.)

Mecklenburg County Commissioners Mr. W. T. Harris, Mrs. Elisabeth Hair, Mr. Phil Gerdes, Mr. Pete Foley, and Mr. Alex McMillan deserve special commendation for their continued demonstration of concern for children as exemplified by their approval of a significant resolution on March 18, 1974 which authorized the Board of County Commissioners to establish a Youth Services Action Board. The YSAB will be responsible for identifying services needed by youth in Charlotte and Mecklenburg County and mobilizing community support for the development of such services. The resolution also states, "the Mecklenburg Youth Services Bureau shall be requested to develop a comprehensive inventory, on an annual basis, of all services available in Charlotte and Mecklenburg County for children six (6) through seventeen (17) years of age. With this kind of leadership from government officials, the chances are excellent that an effective youth services system will soon be created in Charlotte and Mecklenburg County, a system which will truly be responsive to meeting the needs of children, while at the same time saving an enormous amount of both human and economic resources.

A YOUTH SERVICES REFERRAL GUIDE

This referral guide to services available for children in Charlotte and Mecklenburg County identifies medical, social, recreational, psychological, legal, educational, and employment services which might be obtained for children from the agencies enumerated. It is strongly recommended, however, that persons using this guide carefully read information concerning each agency specified as offering a particular service prior to making a decision about the appropriate agency to contact.

The author of this referral guide emphasizes that it is certainly possible that all agencies which might offer an enumerated service may not be listed when in fact they should be; however, it is believed that this guide will facilitate and expedite the process of helping children gain access to services they need.

Critical evaluation of this document by personnel at all youth serving agencies included in this inventory will surely augment the chances that the referral guide included in the 1975-76 youth services inventory, accomplished by the Mecklenburg Youth Services Bureau, will be more inclusive.

Specific Services Offered To Children Ages Six (6) Through Seventeen (17) Years Of Age

Services are offered to children ages six (6) years and older who are legally free and felt to be candidates for adoptive placement.

- 1. The Children's Home Society of North Carolina accepts referral of any child or children from any other agency, either public or private, when that agency has a child in its care for whom it does not have an available adoptive home. Upon referral of the child from the other agency, the entire statewide resources of The Children's Home Society are immediately made available.
- 2. Referral of the child to The Children's Home Society generally includes a written summary on the child, a colored snapshot, and the request that the child be considered for adoptive placement.
- 3. The referring agency can expect an immediate response to the referral including the request for a conference between the referring agency and The Children's Home Society staff in order to discuss the child's general health, his adjustment to his current living situation, his legal status and the kind of adoptive home which

would best meet his needs. Generally it is possible for the caseworker from the Children's Home Society to meet the child and to talk with his foster parents, cottage mother, etc.

4. The legal consultant for The Children's Home Society requests the privilege of reviewing the legal clearance on the child in order to make certain that the child is legally free for adoptive placement.

5. All information about the child is then considered carefully by the staff of The Children's Home Society and a home or homes will be suggested to the referring agency for their consideration as a potential adoptive home for the child.

6. If the two agencies agree that the suggested adoptive home would meet the child's needs, a pre-placement conference is held and plans are made for bringing the child and his new adoptive parents together.

7. The caseworkers from The Children's Home Society and the referring agency work cooperatively in the preparation of the child for meeting his new family.

8. The actual meeting of the child and his new family takes place.

9. If the placement seems to be an appropriate one, arrangements are made for the child to have a visit, sometimes over a weekend and sometimes longer, in the adoptive home.

10. Generally the child returns, with the adoptive parents, to the referring agency to talk about his new adoptive home and to say goodbye. If appropriate, the child also returns to his previous living situation (foster home or child care institution) for this same purpose.

11. The child then returns to the adoptive home with the adoptive parents and, with the close and skilled help of the family's Children's Home Society caseworker, the child and his adoptive parents are helped to learn to live together as a family group.

12. Under the North Carolina Adoption Law, no adoption can be completed in less than a calendar year following placement of the child in the adoptive home. The Society assists the family's attorney in completing the legal procedures through the Final Order of Adoption.

Problem Pregnancy Counseling Services are available to any young women who has a problem pregnancy. Full casework services are also extended to the young woman's family and the alleged father and his family, if requested.

- 1. The caseworker for The Children's Home Society, through the counseling service, assists the young woman in weighing the various alternatives available to her including abortion, marriage, keeping the expected baby, or adoption.
- 2. If abortion is the young woman's decision, the Society's caseworker refers her to an appropriate medical resource.
- 3. If marriage to the baby's father is the young woman's decision, continuing counseling services are available to her and to the baby's father.

4. If keeping the baby is the young woman's decision, and if there is financial need, referral is made to the local Department of Social Services for financial assistance. Continuing casework services are offered to the young woman who keeps her child if such counseling services are requested.

5. If adoption is the young woman's decision, the baby is brought into the direct care of The Children's Home Society, related medical and legal services for the child are immediately available and, when the baby is medically discharged by our medical consultants and legally free for adoptive placement, the infant is placed in the adoptive home. Post-placement counseling for the young woman is available to her at any time.

Children To Whom Services Are Offered

- 1. Services through the Inter-Agency Placement Program are available to any child referred from another agency for whom adoption is an appropriate plan.
- 2. Problem pregnancy counseling services are available to any young woman of any age, to her family, to the baby's alleged father, and to his relatives upon request.

Referral Sources

- 1. Children to be placed through the Inter-Agency Placement Program can be referred to The Children's Home Society for consideration by any agency, either public or private.
- 2. Problem pregnancy counseling services are available to any young woman with a problem pregnancy. Referrals are accepted from any source including public or private agencies, doctors, ministers, attorneys, maternity homes, direct request from the client herself, from someone who has previously received the Society's services, hospitals, clinics, etc.

Primary Agencies To Which Your Agency Refers Children

- 1. Because of the statewide resources of The Children's Home Society, adoptive homes are available for children in its direct care. Only children who have been declared by our medical consultants as unsuitable for adoptive placement because of severe mental retardation, or short life expectancy are referred to other agencies. Through an agreement with the State Department of Social Services, such children are referred to the County Department of Social Services in their county of legal residence for long-term foster care or institutional care.
- 2. The young woman with a problem pregnancy who needs maternity home care is referred to the Florence Crittendon Home in Charlotte, the Baptist Maternity Home in Asheville, or another appropriate maternity home for maternity home care.

Primary Agency Objectives

1. To offer comprehensive Child Welfare Services to residents of Mecklenburg County in accordance with the policies of the North Carolina Department of Human Resources.

Specific Services Offered To Children Birth Through Seventeen (17) Years Of Age

- 1. Protective Services To Children: This unit, composed of one Social Work Supervisor I, and five Social Workers II, receives reports, makes investigations in all cases of reported child neglect and/or abuse, through District Court arranges immediate removal of child from home if necessary, arranges placement in a foster home, offers Protective Service to families in order to help prevent child neglect and abuse and to strengthen family life, makes a social study regarding suitability of the home of a relative for care of a child at the request of an out-of-town social agency. They are responsible for investigating child neglect and/or abuse on a 24-hour basis, and the Social Workers rotate being "on call" through an answering service.
- 2. Foster Care For Children
 - a. Foster home finding: This group is responsible for recruiting, on going-educational process, social study of foster homes, licensing and relicensing homes (as required by North Carolina Department of Human Resources), assisting in selection of best available foster homes for children in care, assisting foster parents with problems that arise in the day by day care of the children in their home.
 - b. Services to foster children: These two units are responsible for providing social services to all children in the custody of the Department of Social Services by arranging the best possible foster placement (either foster home or child caring institution) helping the child to make maximum use of foster care and educational opportunities, working with foster parents, school personnel, Mental Health, other Social Agencies, Medical resources (doctor, clinic, etc.) and assisting the child in all area of his development. Social Services are offered to the natural parents to help them provide adequate child care so that the child may be returned to his own home.

The children who are now being placed in foster care are as a general rule very troubled and acting out young children. They are frequently "runaways" and require a great deal of attention and service.

3. Adoption

a. Service To Unmarried Mothers: This unit is responsible for assisting unmarried pregnant girls make appropriate plans for their pregnancy (referral to abortion if chosen), medical care, frequently living arrangements, referral to maternity home as well as assist her with problems so that she might make a better adjustment to her life situation. Assistance is offered in planning for the baby's care - either by mother keeping or surrendering for adoption.

If child is surrendered, foster care must be arranged and social study and medical evaluation made so that best possible adoptive placement can be made as soon as child is socially, medically, and legally cleared for adoptive placement.

b. Adoption For Older Children: This unit is responsible for offering all foster care services to the children, in addition to screening for possible placement for adoption, securing surrender from parents, or referral to attorney for termination of Parental Rights, preparation of child for adoption, assisting in selection of adoptive family (usually out of county) arranging for visits with adoptive parents; if adoptive placement is made following case until adoption is final (l year or longer from placement).

The North Carolina law permits the Court to terminate Parental Rights of parents of children who are in custody of DSS if the parents do not support child or make any effort to have the child returned to their home.

c. Independent Adoptions: The North Carolina law requires the Department of Social Services to make a report to the Court in all independent adoptions. The investigation is made to determine if a child is suitable for adoption and if the proposed adopting parents are suitable parents for that particular child. This requires visits with proposed adoptive parents, child, natural parents, and a reference.

In related adoptions, the Court may enter a Final Order after receiving the Department of Social Services' report. In non-related adoption, the Department of Social Services must offer supervision for a period of one year after the Interlocutory Decree.

d. Agency Adoption: This unit is responsible for screening and studying applications for all persons in Mecklenburg County who wish to adopt. This includes telephone referrals, group meetings for general information, screening applications, social study of accepted applications, through group and individual sessions, and a social study to determine an applicant's CHILD WELFARE DIVISION OF THE MECKLENBURG COUNTY DEPARTMENT OF SOCIAL SERVICES

suitability for parenthood. If the home is approved, we aid in the selection of the best home for a child available for adoption and prepare Court reports. We provide supervision of a child in home for one year to assist family and child in adjusting to their new relationship.

4. Nursing Service: Responsible for coordinating medical care for all children in foster care - this includes taking ill children to hospital, doctor, clinic, etc. (24 hour call).

Under doctor's orders administers all immunizations to foster children, offers consultation to Social Workers, interprets illness and necessary care to foster parents.

Primary Agency Objectives

- 1. Historic Thompson Orphanage has emerged into a progressive state-wide family and children social service agency. The Episcopal Child Care Services of North Carolina provides direct services through its divisions offering foster family care, community group homes, campus group care, counseling services and a specialized treatment unit for emotionally disturbed children. These services are provided not only here at our Charlotte campus but in Goldsboro, Eden, Lincoln County, Greensboro, etc. Perhaps more important than these services is our effort to strive for excellence in service and to speak to the needs of troubled children and families throughout North Carolina. Mr. Noble and his staff are active in government and private groups seeking new and better ways of meeting human needs in the name of our Lord.
- 2. All request for services originate through Mary M. Wunder, Director of Planning with Families and Children. As a part of our helping process, we attempt to help families sense our conviction that they can, as a family unit, grow and find a more meaning life-style. We first attempt to help families stay together in their own communities through counseling. If children must be separated from their families for a period of time, we help them to realize that placement can be a "new beginning". This "new beginning" can allow both children and parents an opportunity to heal psychological wounds, and prepare for a more meaningful life in the future.

Specific Services Offered To Children Ages Six (6) Through Seventeen (17) Years Of Age

1. Division of Planning with Families and Children - Foster Family
Home (Mary M. Wunder, Director) This Division handles all initial
requests for services. Primary goals are established to help
the family find ways of returning children to his home if
possible. In addition to this overall helping process and planning
function, Mrs. Wunder is responsible for our foster family
care homes. We contract with private families to care for
children under professional supervision. Originally this
program was designed for children with few problems that needed
and could use close relationships. While this is still a major

part of our program, we also serve children with specialized needs in foster family care.

- 2. Division of Group Homes (T. Wade Bunting, Director) Currently our group homes are located in Goldsboro, Lowesville and Greensboro. These homes (either in urban or rural areas) are indistinguishable from other homes in the neighborhood. Children attend community schools, participate in neighborhood games; yet these children are a part of a professionally planned group experience. Houseparents are trained supervised by Mr. Bunting and his staff to understand children individually and as a part of the total group living cottage unit. This division like the other division has its own social workers and psychiatric and psychological consultants. Mr. Bunting also offers consultation to other agencies in relationship to originating and supervising group homes.
- Thompson's Children's Home (John T. Powell, Director) The Thompson Children's Home division is a community of five separate cottage units. Administrators, social workers, cottage parents. educational specialists, recreators, and other important personnel operate as a "team." Each cottage weekly has "team meetings." Children and their families often participate in these meetings to make decisions and formulate plans to avoid crises. Like the other divisions, the campus sees placement as a new beginning for the family. For the child, we attempt to individualize his life - offering special help as needed. In addition to a program of daily planned living experiences in group living, we can help a child with social work counseling, psychiatric consultation, specialized educational opportunities, and one treatment unit for emotionally disturbed children. Our on-campus school offers learning experiences that are individualized. A student there has his learning needs diagnosed. Our Director of Education and his staff prescribe and offer a student opportunities to correct his learning disabilities. Within our campus we have children who function well in school and the community as well as others who need special help. For all these children, our "team" develops with the family the reasons for placement, the goals of placement at Thompson, and long-range goals. We hope that each student and his family can always sense the reality of why he is here, have hope for the future and learn to believe that he has worth as an individual to other people.

1. Since we are a multi-function agency, we are able to offer limited placement in our foster care homes to pre-school children. In our campus and group home program children from 6 - high school age are served. Generally we have found it helpful to begin services to teenagers during their early adolescent years.

Trained tutors seek to establish an informal, helping relationship and although the program is carefully structured, it is designed to remediate the specific problem areas of each child. Student progress is evaluated by re-testing and regular reports and numerous conferences to parents and school personnel. A further purpose of the Foundation program is to teach the student to compensate for his learning disability and to work independently in a normal classroom situation.

The programs and services of the Mecklenburg County Health Department are designed to prevent, detect and treat certain contagious diseases; to educate the people in matters pertaining to better physical, emotional, and mental health; to prevent and correct unsanitary conditions; and to enforce public health laws whenever necessary.

Services as related to youth six (6) through seventeen (17) years of age are primarily rendered through our Nursing Division. Primary objectives are:

- 1. Conducting certain clinics for well babies, pre-school children and to provide medical supervision for the medically indigent.
- Providing immunizations against the diseases diptheria, tetanus, whooping cough, polio, measles, and rubella for children who are medically indigent.
- 3. Counseling parents, often by home visit, in the basic principles of good physical and emotional health for their children.
- 4. Participating in the school health program as consultants and school nurses.

Specific Services Offered To Children Ages Six (6) Through Seventeen (17) Years Of Age

Health Education -

1. Health education, health counseling, interpretation of health services.

Venereal Disease Control -

1. The Venereal Disease Clinic provides diagnosis and treatment for persons having or suspected of having a venereal disease. Venereal disease education, counseling and follow-up are a part of this service.

Nursing Service -

- 1. Annual physical examination for medicaid recipients at a Health Dept. Well Child Clinic including various testing procedures as indicated at a particular age.

Primary Agency Objectives

1. The primary objective of the District Court in the exercise of its juvenile jurisdiction is set forth in the General Statutes of North Carolina General Statute 7A-277 as follows:

The purpose of this Article is to provide procedures and resources for children within the juvenile jurisdiction of the District Court which are different in purpose and philosophy from the procedures applicable to criminal cases involving adults. These procedures are intended to provide a simple judicial process to provide such protection, treatment, rehabilitation or correction as may be appropriate in relation to the needs of each child subject to juvenile jurisdiction and the best interest of the State. The intent of this Article is to assure that, where possible, the court will arrange for the available community resources to be utilized to strengthen the child's family relationships in order to avoid removal of the child from his own home or community. Therefore, this Article should be interpreted as remedial in its purposes to the end that any child subject to the procedures applicable to children in the District Court will be benefitted through the exercise of the court's juvenile jurisdiction.

2. The primary objective of the Court Counselor Services is to assist the court in its remedial and corrective purposes.

Specific Services Offered To Children Ages Six (6) Through Seventeen (17) Years Of Age

1. Court Counselor Services provide intake, referral, counseling and evaluative services for children within the juvenile jurisdiction of the court so that the court may effectively discharge its responsibility to act in the best interests of the child and the community. Designated counselors are "on call" after hours, seven (7) days a week in cases of undisciplined or delinquent children.

In cases of children alleged to be delinquent, dependent or neglected, the statutes provide that jurisdiction extends to the sixteenth (16) birthday.

In cases of children alleged to be undisciplined, jurisdiction extends to the eighteenth (18) birthday except those married, emancipated or members of the Armed Forces of the United States.

Children To Whom Services Are Offered

1. G.S. 7A-281 provides in part "any person having knowledge or information that a case has arisen which invokes the juvenile jurisdiction established by this article may file a verified petition with the Clerk of Superior Court."

Once a petition is filed, services are available to children alleged to be delinquent, dependent, neglected, or undisciplined.

NOTE: Statutory changes enacted by the 1974 session of the General Assembly effective July 1, 1974, provide in part that the Chief Counselor may establish Intake Services with the authority to conduct a preliminary inquiry and make determination "whether it is in the best interest of the child or the state that a juvenile petition be filed."

If determination is made not to file a petition the complainant has the right to have such decision reviewed by a District Court Judge.

During the preliminary inquiry, intake personnel may conduct conferences with the child, the family, the school, and other appropriate community resources for the purpose of effecting an adjustment "so that filing a petition will not be necessary."

- 2. Skills Training Y skills training programs are aimed at individual needs with emphasis on the activity. However, group work methods are used to achieve individual goals. Classes are organized in physical fitness, sports skills, aquatic skills and a wide variety of informal education interests for all ages and both sexes. Team competition is also part of this program.
- 3. <u>Camping</u> Y camping programs include day camping, residence camping, trip and family camping, with emphasis on training youngsters in outdoor skills and self reliance.

4. Individual Program Services - Each Y branch, depending upon its facilities, offers a variety of opportunities for individual participation and services (physical fitness, individual sports, dancing, game room activities, counseling, etc.)

5. Leadership Training - We consider our number one priority task to be the development of Christian leadership among the youth of our community. Youngsters who qualify in skills and leadership potential become members of the Y Junior Leaders Corps at each branch and Counselors in Training in our various camping programs. Regional and National workshops are offered for youth leadership training in various program areas.

Primary Agency Objectives

The Charlotte YWCA shall work toward providing a setting in which women can recognize their potential and exert their collective power toward the development of a society which can make possible peace and justice, freedom and dignity for all its members.

We plan to focus on these areas:

- 1. Helping in reduction of community tensions by working to eliminate racist practices and promoting practices which contribute to the empowerment of all persons as productive members of an open society.
- 2.  During the summer and on holidays the two centers are open all day. The two centers are located in the inner-city.
- 2. A Big Friend's Program in which children ages 6-12, who need additional support from a caring adult, have the opportunity to pursue a special interest with the assistance of an adult.
- 3. A summer day camp for girls ages 6-12 with emphasis on developing good sportsmanship and fair play, appreciation of the out-of-doors, and the learning of new leisure time skills to enhance the development of self-confidence and esteem.

- 4. A summer adventure program for girls ages 6-12 in the inner city and girls whose mothers work in the downtown emphasizing the creative arts, adventure trips in the city, and the understanding and appreciation of persons of different backgrounds and cultures.
- 5. Classes for children who want to pursue special interests in dance, swimming, guitar, handicrafts, art, tumbling.
- 6. Swimming classes for the handicapped child.
- 7. Building-centered and neighborhood activity groups for youth with personal and social problems who are exhibiting socially unacceptable behavior. The youth have the opportunity to set goals for themselves and work out their problems in a group setting.
- 8. Interest groups for youth who are interested in leadership development, youth improvement, societal problems, as well as youth who are interested in learning about themselves and others through the arts.
- 9. Classes for youth who want to learn specific skills in physical education activities, dance, homemaking, and art.

YOUTH SERVICES WHICH MEED TO BE DEVELOPED, ON AN IMMEDIATE BASIS, IN CHARLOTTE AND MECKLENEURG COUNTY

The following services were identified as services which need to be developed in Charlotte and Mecklenburg County for children by youth serving agency personnel representing agencies included in this youth services inventory.

RESIDENTIAL TREATMENT CENTERS

Community-based facilities, staffed by professionals, are needed for children whose behavior makes it difficult for them to make a successful adjustment to their natural home settings or foster care as presently provided by the Mecklenburg County Department of Social Services, or other types of child care facilities. Many times, these children are dumped into state training schools if they are unable to make a successful adjustment to their natural home settings, foster care, or a child care facility.

EMERGENCY SHELTER CARE FACILITIES

Community-based facilities, staffed by professionals, are needed for children who either run away from home or need to be removed from their home settings for brief periods of time to prevent their being physically abused. If this type of service were available, children would have an alternative to running to large cities such as Atlanta or Houston, and also have an opportunity to receive professional assistance to help them and their parents resolve their home conflicts.

PRE-DETENTION FACILITY

A community-based facility, staffed by professionals, is needed for children who have had an undisciplined or delinquent petition signed against them, and who need to be removed from their home settings immediately, but do not need to be placed in a secure custody facility such as the Mecklenburg County Juvenile Diagnostic Center while awaiting their court hearing.

ALTERNATIVE EDUCATIONAL PROGRAMS

Alternative educational programs, such as the Charlotte-Mecklenburg School's Street Academy, are needed to meet the academic, social, emotional, and physical needs of children who are truant or ungovernable at school and who will probably be excluded from school or become involved in the juvenile justice system if they are not offered meaningful educational services.

These services are required to insure that all children enrolled in the Charlotte-Mecklenburg Schools will receive regular diagnostic evaluations to determine if they have academic deficiencies in reading, spelling, or arithmetic which might preclude their achieving to their maximum potential educationally. Remedial educational services will be provided to all youths identified as being academically retarded in reading, spelling, or arithmetic. Regular evaluations will be accomplished to determine what progress remedial educational services have made toward remediating diagnosed academic deficiencies.

The clinical psychologist at the Mecklenburg County Juvenile Diagnostic Center and the Director of the Mecklenburg Youth Services Bureau can document that, since 1971, a high percentage of children who have become involved in the juvenile court and correctional systems in Mecklenburg County for being truant and/or ungovernable at school have been children who have had serious deficiencies in reading, spelling, and arithmetic. These deficiencies are factors which are beyond the control of a child; however, they greatly influence a child's responses toward his (her) school setting.

WHAT CAN HAPPEN TO CHILDREN WHEN THEY DO NOT GAIN ACCESS TO SERVICES THEY NEED?

Many children, because services such as emergency shelter care facilities, residential treatment centers, alternative educational programs, etc. are not available to them, become involved, many of them deeply involved, in the juvenile court and correctional systems. If services these children needed were made available to them, most of them could be diverted from the juvenile justice system.

Tragically, forty-seven percent (47%) of all children incarcerated in North Carolina state training schools in 1973 were placed there for violating conditions of their probation by being either truant from school or ungovernable at school or ungovernable at home, or for running away from home. These acts neither constituted a danger to person or property nor would they have been considered crimes if committed by persons above seventeen (17) years of age. Confinement in state training schools provided these children with an opportunity to become sophisticated delinquents because they were placed with children who had committed serious delinquent acts. Legal and social stigmas were attached to each of these children after they left an institution and returned to their natural home and school settings. Further, the North Carolina Office of Youth Development reported in 1973 that it cost state taxpayers in excess of ninety-five hundred dollars (\$9,500.) to incarcerate one (1) child in a state training school for one (1) year. Removing a child from the home and school environments in which he is experiencing problems does not prepare him and the people in his natural environments to change their ineffective responses to each other; consequently, it is essential that community-based services, such as the ones previously alluded to, be developed for children in Charlotte and Mecklenburg County in order to preclude this continued victimization of children.

Any time a child is unable to develop to his full potential because services he (she) needs are not made available to him, both human and economic resources are lost. When a child is victimized because services which he desperately needs are not made available to him, not only are human and economic resources wasted, but a community has treated its most valuable resource in a most illogical manner.

CONCLUSION

It is my sincere hope that this initial youth services inventory compiled by the Mecklenburg Youth Services Bureau Staff, with excellent cooperation from other youth serving agency personnel, will facilitate youth being referred to services they need, augment the utilization of existing youth services to the maximum extent possible, and aid the Youth Services Action Board to begin its efforts to create a system of youth services in Charlotte and Mecklenburg County which will result in better coordination of services, less duplication of services, and expeditious development of services needed by all youth, particularly services related to diverting children from the juvenile court and correctional system.

A SIGNIFICANT RESOLUTION APPROVED BY THE MECKLENBURG BOARD OF COUNTY COMMISSIONERS ON MARCH 18, 1974

WHEREAS, the Mecklenburg County Board of Commissioners is aware that at least forty percent (40%) of all children who become involved with the juvenile court and correctional systems could be diverted from these systems if services they desperately need were made available to them and,

WHEREAS, the Mecklenburg County Board of Commissioners is deeply concerned that children, whenever possible, be diverted from the juvenile court and correctional systems to services they need, particularly children who do not constitute a danger to person or property and who have not committed an act that would be considered a crime if they were an adult, and

WHEREAS, the Mecklenburg County Board of Commissioners is committed to assuring that needed services are identified, developed, and delivered for children in Mecklenburg County, particularly services which are related to diverting children from the juvenile justice system.

NOW THEREFORE, BE IT RESOLVED that the Mecklenburg County Board of Commissioners create a Youth Services Action Board. The Youth Services

Action Board shall:

- 1. Appoint a Youth Services Professional Advisory Committee. This Committee shall:
 - a. Identify services needed by children in Mecklenburg County, particularly services which enable children to be diverted from the juvenile justice system to services they need.
 - b. Seek to coordinate services offered by their respective agencies in an effort to both close gaps in services and prevent duplication of services for children.
 - c. Have no power to make binding policy decisions.
 - d. Establish a simple and brief, but specific set of by-laws which state the duties of Committee members and the procedures by which the Committee will transact business.
- 2. Advocate and encourage the implementation of services identified by the Youth Services Professional Advisory Committee as being needed for children in Mecklenburg County. The Board will be especially concerned with mobilizing community support for the development of services which are related to diverting children from the juvenile court and correctional systems.
- 3. Submit a semiannual report to the Mecklenburg County Board of Commissioners documenting progress made by the Youth Services Action Board and Youth Services Professional Advisory Committee toward performing their stated functions.
- 4. Have no power to make binding decisions.

5. Establish a simple and brief, but specific set of by-laws which state the duties of board members and the procedures by which the Board will transact business.

The Youth Services Action Board shall consist of not less than twelve (12) or more than fifteen (15) members to be chosen by the Mecklenburg County Board of Commissioners. A list of suggested nominees for the Youth Services Action Board will be submitted to the Mecklenburg County Board of Commissioners by the Mecklenburg Youth Services Bureau Advisory Board.

The Youth Services Professional Advisory Committee shall include, but not be limited to, representatives from the following youth serving agencies:
