



This report describes the characteristics of persons committed by the courts to the Massachusetts Department of Correction (DOC) during 1973. The statistical tables which constitute the report also separately present the characteristics of commitments to Walpole, Concord and Framingham. Not included are court commitments to Bridgewater.

During 1973, 1076 persons were committed to the custody of the DOC. Of these, 451 were committed to Walpole, 577 to Concord and 48 to Framingham. Table I presents the numbers of commitments over each of the last five years.

The reader will note that over the five-year period (1) the number of Walpole commitments has held stable, (2) the number of Concord commitments not only sharply rose in 1971 but also continued to slowly rise during 1972 and 1973, (3) the number of Framingham commitments sharply declined in 1972 and again in 1973, and (4) the total number of commitments has remained stable at about 1100 for each of the last three years. Thus while the total number of persons sentenced each year is not changing, fewer of these persons

are female, and proportionately more of the males are committed to Concord.

This is the second year that this report has been generated from an extensive computerized data base. Thus we can compare the characteristics of commitments during 1972 and 1973. Perhaps the most striking finding is that there are so few differences between the "types of" persons committed during 1972 and 1973, particularly in terms of social background and criminal history.

However, there were four major changes, each primarily relating to offense and sentence (i.e. court actions). These changes were as follows:

- (1) The most serious present offense of 1973 commitments was less likely to be drug offenses and less likely to be property offenses other than burglary.

From 1972 to 1973, the proportion of commitments sentenced for sale or possession of heroin declined from 12% to 5%. In another change that may be related, the proportion of commitments sentenced for property offenses other than burglary declined from 14% to 7%. Thus the epidemic of heroin use is abating, and one might speculate that the drop in property offenses other than burglary represents a drop in drug-related crimes.

- (2) The most serious present offense of 1973 commitments was more likely to be armed robbery. Further, longer records of prior person offenses were more common.

From 1972 to 1973, the proportion of commitments with armed robbery as their most serious offense increased from 25% to 36%. It is perhaps related that the single significant change in the prior criminal histories of commitments was somewhat longer records of prior person offenses, specifically, the proportion of commitments

with two or more prior court appearances for person offenses increased from 58% to 66%.

It might be noted that the joint result of the first two changes noted is that the relative balance of person offenders and property offenders is changing. In 1972 twice as many persons were committed for offenses vs. the person as for offenses vs. property (48% vs. 22%), while in 1973 four times as many persons were committed for offenses vs. the person as for offenses vs. property (62% vs. 15%).

- (3) For sentences to Walpole and to Concord, sentences are becoming longer, as is the length of time to first parole eligibility date. The opposite trend is occurring for Framingham commitments.

From 1972 to 1973, the typical (median) minimum sentence of Walpole commitments increased from 4.8 years to 5.4 years, and the typical period from commitment to first parole eligibility date correspondingly increased from just under three years to just under four years. A similar pattern occurred with Concord commitments. The proportion with sentences of 6 Indefinite or longer increased from 6% to 42% with a corresponding drop in 5 Indefinites, and as a result the proportion of Concord commitments who had to serve over a year until they first saw the Parole Board increased from 1% to 18%. In the case of Framingham sentences, the proportion with maximum sentences of two years or less increased from 44% to 69%; comparative figures on time to first parole eligibility date are not available. Thus the courts are both sentencing fewer women to Framingham and giving them shorter sentences.

The longer sentences to Walpole and to Concord can be expected to bring longer lengths of incarceration and increases in the DOC population.

- (4) Commitments dropped from superior courts in the New Bedford-Fall River area and in the Lowell-Lawrence area, while commitments increased from superior courts in areas around Boston.

Specifically, comparing 1972 to 1973, the number of commitments from Bristol Superior Court (New Bedford-Fall River area) decreased from 92 to 55, and the number from Essex Superior Court (Lowell-Lawrence area) decreased from 109 to 63. The need for halfway house facilities in this area may thus be declining. Further, commitments from Middlesex Superior Court (north and west of Boston) increased from 35 to 62. Thus the great concentration of releasees in the Greater Boston area may be slightly increasing.

Appendix: Last Civilian Address, by Town, City or State

A glossary is included at the end of the report to clarify some of the terms and abbreviations used in the tables.

Because of increased demand for information concerning offenses and geographical area (last civilian address), additional tables have been added to this year's report. Since offenders are typically committed for more than one offense, Table A4 listing the frequency

of the primary offenses persons were committed for, is augmented by Table A4A listing the numbers of persons committed on each offense even if they were not the major offenses. Table A4B splits the population into 2/3 rd and non-2/3rd offenders. Five tables (B5A-5BD and the Appendix) have been added to give a better picture of the numbers of persons coming from various geographical areas. These tables categorize the last civilian address in terms of various geographical units.

Four of the following tables refer to the extent of drug use. In the order of inclusiveness they are as follows: A4 (present offense-most serious charge), A4A (present offense-incidence of various charge not just including most serious one) C1S (court appearances for drug offenses which includes past charges as well as present offense), C14 (drug use which includes various indicators of drug problems beyond court records).
