Dear Ms. Santos:

The above-referenced grant was extended to permit expenditure of \$8,859.40 in remaining funds that were committed to begin the process of designing a new defender leadership and management training program that would permit the National Legal Aid & Defender Association to incorporate and build upon the work of the Vera Institute for Justice National Defender Leadership Project, which BJA funded. As reflected in the enclosed financial report, the project commenced and the funds were expended during the grant period as anticipated.

I am pleased to report that the initial phase of the project has resulted in the establishment of a National Defender Leadership Institute (NDLI), which was designed by a national advisory committee that was convened to work on this BJA-supported project. The committee's report, "A Passion for Justice," details the blueprint pursuant to which the Institute is being created. The report, released this fall, is attached. I am also happy to report that NLADA was able to obtain funding to hire a project director, Cait Clarke, to begin development of the Institute. You may know that Cait was the Project Manager for the Executive Sessions on Indigent Defense, a BJA sponsored project of the Harvard University Kennedy School of Government and Law School. We are thrilled to have Cait join us, not only for the expertise she brings to the development of the Institute, but because it will give us another leadership forum to continue discussing the ideas that the Executive Sessions generated. Ms. Clarke has begun working on developing the curricula for the Institute's first training events, and to develop resources to support the full creation of the Institute that the report envisions. She also has worked on a draft of a "fact sheet" on the Institute, which I hope BJA might consider publishing. The draft is also included herein.

Finally, I am attaching a draft report on federal indigent defense funding. Although essentially complete in substance, the report is in the final stages of publication, which should be completed next week. We will forward the finalized publication as soon as we receive it.

We very much wish to thank you and BJA for the support that has been provided to indigent defense to help achieve balanced justice systems, and for the recognition that if one "leg of the stool" is unsupported, the entire criminal justice system suffers. Of course, please let me know if you have questions.
