

The International City Management Association has completed its final quarter of the third year of its criminal justice project. During this period, the project continued to focus its efforts on meeting the city manager's informational needs in the area of law enforcement. The following report summarizes the progress of the three month period.

Law Enforcement Leadership Seminar

There were no Law Enforcement Leadership Seminars during this quarter, although during the project year, the project sponsored a total of three Law Enforcement Leadership Seminars. The first took place in Gloucester, Massachusetts, June 12-15 and the second took place on Oreas Island (Seattle) Washington, August 14-17. The final Law Enforcement Leadership Seminar for the contract year was held during the previous quarter in Asheville, North Carolina. Twelve pairs of managers and chiefs representing five different states took part in the three day program.

An evaluation of the Law Enforcement Leadership Seminars through feedback from participants was extremely positive and indicates to us that we are fulfilling the objectives of improved communication between these two most important law enforcement administrators.

TARGET

TARGET continues to be well received by its readers. The staff has been extremely active in researching and writing articles for the newsless

During the fourth quarter, the project published four issues of TARGET. The inclusion of a news notes section, as well as the recently added research reports, book reviews and the conference calendar have all been well received by TARGET's readership. STAFFING

Also during the fourth quarter, Ilene Bergsmann joined the staff to work primarily on TARGET. Ilene has a master's degree from the University of Virginia in counseling. She previously worked with the LEAA Office of Regional Operations.

The staff continues its dialogue with various officials concerned with criminal justice planning and administration. Besides field trips for TARGET and the Law Enforcement Leadership Seminars, staff attended SPA
