FOREWORD

Educational materials and resources in the field of law enforcement and criminal justice are limited. This has been pointed out by a number of recent surveys and was emphasized in the summary report by the President's Commission of Law Enforcement and the Ad ministration of Justice.

The Jackson Police Department, Law Enforcement Assistance Division, and other state law enforcement agencies have been able to identify a considerable number of films, presently available, that are applicable to the various components of the criminal justice system.

The primary listing of films in this catalogue has been divided by subject matter rather than into disciplinary categories. This has been done not only to follow the interdisciplinary criminal justice approach, but also because of the realization that in many cases the subject matter actually defies identification with any one specific component of the criminal justice system.

These films can be used for basic and in-service training of law enforcement agencies and in police educational programs. Films of this type supplement, rather than substitute for other efforts already instituted on your part to train your men and educate your law officers. It is for this purpose that this material was prepared for your use.

The Library's training films and this catalogue are available as a result of a grant awarded by the Law Enforcement Assistance Administration, United States Department of Justice, and administered by the Jackson Police Department.

BORROWING FILMS

To be eligible to borrow films, a "BORROWER'S AGREEMENT CARD" must be signed and returned to the Film Library prior to the loan of any audio/visual material. These materials must be used on the borrowing organizations premises (except where permission prior to the loan has been granted from the Film Library), and may not be sold, rented, or loaned to other organizations for reuse.

Clearly stated: they must be obtained, used, and returned by the borrower.

Requests for the use of audio/visual aids may be made by letter, telephone, or in person. The actual show date should be specified at the time the request is made. The desired audio/visual aids should also be requested as far in advance of the show date as possible, as items are often booked well in advance of use.

RESTRICTED AIDS

There are a few audio/visual aids listed in this catalog that are classified as "RESTRICTED"; these aids are to be shown only to sworn law enforcement officers.

There are other films that contain controversial subjects, along with possible strong scenes and language which has been added to add realism to the training process. The "borrower" should first preview these films to see if they are suitable for the group involved.

FILM DAMAGE

The Library asks that all damage be reported upon return of the film so that immediate attention may be placed on it for repair.

SUPPLEMENTS

Supplements and catalog additions will be sent out on a reguar basis to keep all agencies up-to-date on new films and aids that they may borrow through the Film Library.

TRANSPORTATION

The requested materials will be delivered to the borrower prior to the show date and picked up the day after the showing by United Parcel Service. On pick-up, the Parcel Service will present a "call tag" that will be placed on the item for it's return to the Library.

This service is provided to speed up delivery both ways in order to make these materials available to more law enforcement agencies. Also, the items are insured for full value by the Parcel Service to and from destination.

The Film Library pays expense to and from destination, at no cost to the borrower. In any other shipping manner, the borrowing agency must pay the shipping expense (through U.S. Mail or by bus).

A001 Accident I

22 min./color Motorola Film Explores the characteristics of a good Al officer, priorities when arriving on accident scene, classification of accidents, charting of current accident, equipment, vocabulary, and determination of traffic conditions and speed traveled.

A002 Accident II

Reviews arrival procedures, covers attendance to injured, "reasons why" of accident, contributing factors, determining fault, preserving physical evidence, first contact with witnesses, and a detailed study of each phase of the accident, starting with "point of Possible Perception" and concluding with "Final Resting Place."

A003 Accident III 27 min./color

Covers interviewing of accident participants and witnesses, methods of street marking (including position marking, point of impact analysis, measuring skidmarks, use of the nomograph, speed and course measurement), taking photographs, accident reconstruction analysis, vehicle evidence, clearing wreckage, etc.

10 min./color Sid Davis A concise but comprehensive and clearly detailed account of the job to be done at the scene of a traffic accident. How to shield the location, handle injured persons and witnesses, and record evidence are all illustrated in realistic action. The content and importance of an accurate and complete accident report are also stressed.

A005 Hit-And-Run Investigation

10 min./color The pedestrian was dead and the witnesses disagreed in describing the car that hit him. But the perpetrator is tracked down through a combination of techniques and procedures, and sound police logic. A fast-moving, realistic film that covers all the basic approaches to a successful hit-run investigation.

ALCOHOLISM (B)

B001 Alcohol - How Much Is Too Much 11 min./color

AIMS

This vitally important film will stress mature decisions regarding drinking, in terms of respect for one's respect for others. The viewer will have a sound basis for considering alcohol, through such facts as: its abuses as a drug, its effects on the brain and other parts of the human body, and its effects on reaction time, coordination, perception, etc.

B002 Alcohol And Red Flares 20 min./color

Statistical analysis of many automobile accidents involving drinking drivers, substantiates the concept

Police training film which makes the point that the over-use of alcohol conceals many physical and mental illnesses which the police officer must be careful not to overlook. Describes what to look for before making a determination about a person's condition.

B004 Driving Under The Influence

10 min./color Sid Davis How to spot the "under-the-influence" driver, pull him over, and get the evidence that might keep him from contributing to the traffic fatality statistics, are all covered in detail as we watch an officer go through an arrest. Particular emphasis is given on how to secure and report evidence that will "stick." Dependence on chemical tests as anything more than coroborative evidence is discouraged.

AIMS

The role of the court clerks and how these men. and women help our American system of justice is portrayed in this film. This film is to provide a valuable aid for new court personnel and employees in related fields of law enforcement.

C018 Testimony And Courtroom Demeanors

24 min./ Institute of B & W Law Enforcement

The way your officers present evidence and conduct themselves "on the stand" influences not only the public's image of your department and the entire criminal justice system, but may also affect the results of their testimony. Filmed in court, this down-to-earth training aid portrays the wrong and right ways to testify and behave.

C019 Civil Liability Of Police Officers

23 min./color AIMS The number of civil suits against peace officers continues to increase. Whenever any action is taken, on or off duty, the officer exposes himself to liability. What acts can he be sued for and who will pay the costs? The growing vulnerability to civil suits makes this an ever increasing hazard to the man and his department.

CO20 The Federal Civil Rights Act: Criminal Liability Of Peace Officers

35 min./color AIMS

Everytime a law enforcement officer goes into the field, he is placed in a position of peril. He subjects himself and his department to criminal liability under the Federal Civil Rights Act. The nature and scope of this law is explored with a true-life examination of how three officers were so charged. How to avoid this charge is the common theme of this film.

The Witness Stand, Part I: Evidence, Testimony, C021 And Cross Examination AIMS

41 min./color

An officer must be armed with the basic principles of evidence and courtroom demeanor. What is expected of him on direct and on cross examination? When are his opinions and conclusions permissible? These are crucial to any successful prosecution and directly reflected in proper crime-scene procedures. With the information, the officer will be able to gather more effective evidence and accurately evaluate its probative value.

CO22 The Witness Stand, Part II: The Hearsay Trap And Expert Testimony

41 min./color

AIMS

In a criminal proceeding the officer will be better able to prepare for court and testify in a professional manner only if he has an understanding of the law of evidence. If the information secured in the field is hearsay and subject to no exception so as to be inadmissible, time and money have been wasted. When and how may an officer qualify as an expert so as to make his opinions and conclusions admissable? These are essential areas too often overlooked.

CO23 The Witness Stand, Part III: Court Room Tightrope 24 min./color

AIMS An officer can now have a thorough understanding of how the evidence he gathers is further reflected in court. Practical tips are given as to what his report should contain. Types of evidence, requirements of relevancy, authentication, and character evidence are all discussed as relating to what the officer must do in the field. It could mean the difference between a conviction or meeting the defendant again on the streets.

CRIMINAL SEARCH AND SEIZURE (D)

D001 Search And Seizure 25 min./ Institute of B & W Law Enforcement

Dramatizes representative situations to demonstrate what officers can and cannot do lec." wunder search and seizure laws. Includes recommer procedures for obtaining admissible evidence, security search warrants and using warrants. Also defines "reasonable search."

D002 Custodial Arrest - Search And Seizure

This film concerns a United States Supreme Court decision of December of 1973. Where an officer stops a traffic violator, arrests him for drunk driving, and then finds narcotics on the person. This film gives a direct answer to the question of a subject being arrested with illegal narcotics and if he can be charged with the offense.

D003 Chimel: Search Incident To Arrest 18 min./color

A moment's hesitation while making an arrest places the officer's life on the line and can cause the destruction of incriminating evidence. The scope of a search incident to a lawful arrest is sharply limited, vet several well established exceptions do exist that an officer must be aware of. Without this information even the best procedurally trained man remains ineffective.

D004 Confessions, Part I: Miranda Warnings -

When, Where, And How 34 min./color

AIMS

AIMS

Never before has one case (Miranda) made such an impact upon law enforcement. The officer who has to act within the confines of an ever changing court will become aware that such warnings need not be given. For example, if he asking initial questions to determine where the suspect is going, or asking him to explain his actions. While on duty there always seems to be an incident that requires the knowledge of the Miranda principles.

D005 Confessions, Part II: Waiver Of Rights 27 min./color

AIMS

The admonition of rights satisfies only part of the requirement for the admissibility of a suspect's statement. What effect will alcohol, drugs or narcotics have on its validity? Special attention is also given to the waiver as related to juveniles. Is one Miranda warning sufficient? These are all questions that must be answered before a statement can convict.

D006 Confessions, Part III: Voluntary Confessions, Scope And Effect

17 min./color AIMS Confessions and admissions are the most persuasive evidence of guilt but can easily be lost, Promises of leniency, inducements, deceptions, confronting the suspect with the evidence, and secret recordings of the interrogation are fully explored. Special emphasis is also given to confessions of minors. When an officer obtains the confession or admission, he is now operat-

ing in an area of strict limitations and any mistake

could prove to be fatal. D007 The Emergency And Consent Search

18 min./color

The consent search is a valuable tool which does not require the officer to have a warrant nor probable cause. But, too often an officer has acted upon an otherwise perfected consent, only to have the evidence declared illegal. Was the consent voluntary or withdrawn? Did the person have the power of consent in the first place, and what was the scope of the consent?

D008 Forcible Entry And The Oral Search Warrant 32 min./color AIMS

The proper execution of the search warrant poses additional threats to the validity of the evidence. When

can items unnamed in a warrant be lawfully seized? The problem of keeping confidential informants anonymous and the procedure of the forcible entry is also examined in order to make the man and the agency fully informed and highly effective.

D009 Investigatory Procedures - Stop And Frisk, Line-Ups And Incriminating Statements 20 min./color

AIMS

AIMS

The routine "stop and frisk", web of judicial restraints, can pose a trap for the uniformed officer. Identifications through line-ups, photographs, field I.D.'s, and confessions in violation of Miranda are frequently challenged by the defense: yet the officer who knows how to be effective within these limits is an asset to himself, his department and the community.

D010 Legal Limitations On The Physical Seizure Of Evidence

26 min./color

The officer is confronted with a variety of situations when a suspect attempts to destroy or conceal evidence. How much force can he use? How can the officer prevent its destruction? When, where and how are rectal, vaginal or stomach searches permissible? The best evidence is no value to you if the courts do not allow it to be used. This film could prevent that from happening to you.

D011 The Law Of Burglary

28 min./color

Burglary is as old as man himself, yet today, it remains by most measures America's most serious felony crime problem. The elements of a burglary are presented in both a humorous and practical fashion. A thorough understanding by the officer of the nation's burglary dilemma has become mandatory.

D012 On The Outside Looking In'

22 min./color

Officers are frequently confronted with the necessity of making an investigation, yet in most instances they have no warrant to arrest nor probable cause, and the situation is not an emergency. Therefore, when can an officer look through a window, enter a garage, examine a backvard or even a trashcan? The need to investigate as balanced against the individuals reasonable expectation of privacy is examined when the officer is "on the outside looking in."

D013 Search Warrant Preparation: Get the Facts 29 min./color AIMS

"You can't look for an elephant in a match box" stated one court as pertaining to the validity of a search warrant. Now, more than ever, the officer has the responsibility of acquiring sufficient data to support a valid warrant. The place to be searched, and the things

to be seized always come under a close scrutiny, When does the officer have probable cause? Don't be caught on "fishing expedition." A valid search warrant can be easily obtained.

D014 Stop And Frisk

29 min./color

AIMS

The need of law enforcement to conduct brief investigations of criminal conduct without the necessity of making an arrest has continued to come under close scrutiny of the courts. This is counterbalanced with the fact that an inaccurate judgment by the officer could post a high degree of risk. In order to strike a balance between the needs of law enforcement, safety of the officer, and the suspect's right of privacy, full, complete, and accurate information is essential.

D015 Vehicle Searches

31 min./color

AIMS

AIMS

The officer is on routine patrol duty. He has "REA-SONABLE SUSPICION" to believe a suspected vehicle was involved in a crime, has committed a traffic violation, or has faulty equipment; is he justified in conducting or impounding the vehicle for a search? The legal basis and length of time for detentions are also discussed. An otherwise routine vehicle stop could turn into a nightmare of constitutional violations and jeopardize the welfare of the officer.

D016 Emergency, Part I 32 min./color

The police hear a scream - they go to the apartment and demand to enter - upon entry they search the room and discover narcotics - they then arrest the occupants for a narcotic charge. Was this a lawful search and arrest? Will it hold up in court? Why? This

film shows several different situations and circumstances where an officer has to enter a house or a room and then what happens when the case gets to court. The judge then explains if the officer may enter and make an arrest.

D017 Emergency, Part II

32 min./color

AIMS

This film takes up from "EMERGENCY, PART I", and gives several more situations where an officer has to make an emergency entry and what he can and cannot use as evidence.

D018 Forcible Entry: Knock And Notice

22 min./color AIMS This film gives several ways and methods of how to gain entry into a dwelling by first knocking and with no response. It shows the officer what the courts will uphold and explains why the courts will uphold the "knock and notice" entry.

D019 Knock And Notice: Excuse And Trickerv 20 min./color

AIMS The film gives an officer an account of the cases that have been to court concerning "excuse and trickery"; it shows what type excuse and trickery methods are upheld by the courts and not violate a persons constitutional rights.

EMOTIONAL BEHAVIOR (E)

E001 Booked For Safekeeping 33 min./B & W

This film demonstrates the proper management of mentally ill persons by members of the police department who are called on to prepare the mentally ill persons for their subsequent medical treatment. Illustrates police procedures for responding, subduing, transporting, and incarserating the mentally ill person.

E002 The Cry For Help 33 min./B & W

G.S.A.

Designed to develop a feeling of concern and understanding in those who are called to handle the suicidal person. Presents some of the major causes of suicide, teaches police officers to recognize the "cry for help" and be on the lookout for clues of suicide intent.

E003 Under Pressure

31 min./B & W

A mental health film dealing with the problems the police officer faces each day and the effect they have on his mental health. Shows the pressure under which members of a large law agency must work.

E004 Police And The Mentally III

18 min./color Calif. Peace Officers' Assn. A training film on how to recognize and handle mentally ill persons. Illustrates many symptoms of mental illness frequently encountered by law enforcement officers. Some examples shown include a family dispute, a teenage suicide, a lost senile lady, an emotionally distraught housewife, a paranoid office worker, and a religious fanatic with a bomb aboard a commercial airliner.

E005 Shotgun Joe

28 min./color Outstanding study of a young convict in the prison setting. Joe Scanlon's apparently sociopathic personality, and his complete disregard for the outside society he could not live in; emerge as he describes the criminal activities that brought him into the correctional system. As Joe traces his background and family history the viewer develops insight into the reasons he is the way he is.

E006 Suicide Attempt

10 min./color

A woman sprawls unconscious with an empty pill

bottle in her hand. A man stares down the muzzle of a shotgun. A kitchen fills with gas from a hissing stove. And a man on an apartment house roof nerves himself for a jump. What does an officer do to protect the community, himself, and the would-be-suicide? Procedural information and a police psychologist suggest wavs and means of handling a suicide call.

FIREARMS AND EXPLOSIVES (F)

F001 Bombs I (RESTRICTED)

Motorola

24 min./color This is the first of three films that features 'bomb and explosive expert' Thomas G. Brodie as instructor and bomb squad officer: in a fictional bombing situation and the officer's attempt to disarm the bomb and apprehend the bomber. It gives demonstrations of various explosives and devices, their unique packaging, methods of explosive initiation, and the effects of various types of explosive devices are explored in detail in this first series of bomb films.

F002 Bombs II (RESTRICTED)

Motorola

20 min./color This second film in the bomb familiarization series attempts to bring more specific information to the viewer regarding the type of bomb planted. Specific areas include: types of bombs, placement of bombs, automobile bomb search, observation for possible suspects, the uniformed officer's responsibility in bomb situations, and what not to do when faced with a suspected bomb.

F003 Bombs III (RESTRICTED)

20 min./color

Motorola

The purpose of this film is to give the viewer a theoretical knowledge of various disposal options, so that he can judge for himself the danger of acting foolishly in a bomb situation. After each situation, the film freeze frames to allow the instructor to stop the projector and check the responses of his trainees. Bomb scare caller and bomber motivations are also explored in this film.

F004 Plan, Don't Panic - Bomb Threat

15 min. / color Motorola This film dramatizes the problem, establishes the importance of planning, and sets standards for behavior, performance and safety. It shows effective handling of the bomb threat call, and bomb search followthrough; this approach defeats panic and organizes all of those concerned into one effective team. This film is geared toward department heads and all the people directly involved in the threat and search.

F005 The Revolver 18 min./color

AIMS

"The Revolver may save your life" - the difference between life and death is basic training and knowledge of your weapon. This film was produced by the California Highway Patrol in the correct procedures for handling, loading and firing positions for a .38 cal. service revolver.

F006 Explosive Devices (RESTRICTED)

17 min./color Police Science Program Illustrates some of the more common explosives and explosive devices as described in the various militant brochures and bulletins. It includes the incendiary bombs, pipe bombs, low and high explosives, time delay devices, and various common containers. These devices are graphically demonstrated so that any similar devices can be easily recognized.

F007 Recognizing Explosives (RESTRICTED)

17 min./color Police Science Program Shows the basic components that are used in nearly all common explosives, explaining their function in relation to each other. The film is divided into Low and High Explosives sections showing fuses, powders, and caps.

FIRST AID (G)

G001 Sudden Birth

23 min./color Calif. Peace Officers Assn. The scene is the back seat of an automobile, where this situation is usually encountered by police and other public service personnel, and the attending "physician" is a rookie patrolman.

JUVENILE (H)

H001 You Be The Judge 13 min./color

Designed for the 11-14 age group who have not yet hardened into delinguents, and yet are mature enough to understand, this film gives the viewer an opportunity to witness three typical cases affecting juveniles, and judge each case through "stop projector" technique. The entire process of arrest, detention and booking, and judging by the court is vividly depicted as the viewer becomes the judge.

H002 Book Him

10 min./color

The film takes up the story of a young boy who has committed a crime and arrested. It follows him through the whole police booking procedure, including the search, photographing, fingerprinting and the eventual lockup in a cell. The memory of it, along with his police record, can haunt him the rest of his life no matter how minor the crime.

H003 Child Abuse And The Police 29 min./color

The problem of the battered, defenseless child provokes an immediate emotional response; one of shock and disgust. Thus, due to the nature of the crime, and the type of individual involved, the procedure used by the officer could mean the difference between life and death for the helpless child. How can the

officer detect the battered child and what methods should he use in dealing with parents? The full spectrum of prevention and care is examined in this highly unfortunate, but relevant, topic.

H004 Law In The Schools

30 min./color

AIMS

Communities are now demanding greater protection controls in their schools to curb the ever increasing rampage of violence. What is the role and power of the peace officer on school premises? When can an officer remove persons from school grounds, and what is the scope of a search and seizure for officers acting on behalf of school officials? This comprehensive examination of the role of law enforcement and the schools can only further police-community relations. The agency can now, act swiftly and effectively within the law, to curb crime on the campus.

H005 Child Molesters: Fact And Fiction

ACL Films 30 min./color An analysis of pedophilia (abnormal child-adult sexual relations) with typical cases based on fact. L006 Special Situations 25 min./color

This film deals with the officer's first contact response to citizens trouble calls (mostly non-violent and non-criminal). Emphasis is on proper attitude, attention to detail, and the ability to relate sympathetically and effectively to the mental and physical states of the people involved. The responsibility for the protection of life and the necessity for understanding a complex and often violent society are explored. Situations include: suicide by hanging, mental illness, lost child, missing person, diabetic come, and reported rape. An additional sequence at the morgue points out procedures for handling bodies and recognizing symptoms and causes of death.

L007 Domestic Disturbance Calls

24 min./color

Shocking facts grimly point out that mishandling of routine emotional disturbance calls account for 20% of all police fatalities. This film takes the officer through the important steps of the who, what, where, when, and how of any complaint. Shows why it's important to get the facts, so the officer answering the call can exercise caution, yet deal with compassionate authority. Throughout the film, alertness is stressed to prevent the officer from placing himself in jeopardy. This tops the list as a "must" for any law enforcement training program.

LOO8 Hand-To-Hand Tactics

20 min. / color

This film program is designed to aid in teaching the officer the use of defensive tactics without the use of weapons. Re-enacted defensive situations are shown and then applied to gymnasium instruction. The instructor in the film is Jack Williams, black belt judo expert and one of the few men in the world schooled in Japan in their specialized defensive tactics for law enforcement officers. Methods are not only demonstrated, but explained in detail. An excellent program which can be used with or without an instructor.

L009 Shoot/Don't Shoot |

24 min./color

Should you shoot or shouldn't you? What are the factors involved? The risks? And how do you make the crucial decision in what just might be the flash of the other guy's gun? Here's your weapon, officer-now shoot . . . or don't shoot! This stunning film is a vivid lesson to the viewer in the basic rules which apply to all "shoot/don't shoot" situations. In place of the old means-mood position, the new concept of ability-opportunity-jeopardy is offered. Danger to innocent bystanders

is explored. And over a dozen on-the-street segments

This emotionally-charged film deals directly with the problem of extremist attacks. It is geared to aid the officer in self-defense whenever he encounters situations of extreme and unexpected danger. It is not the purpose of this program to teach actual street fighting; but rather to explore the thinking of the adversaries the officer is likely to encounter in situations of this type and to point out the kind of violence they might practice against him.

L012 Use Of The Short Baton

20 min./color

This film directs itself most explicitly to the use of the short baton. Departmental regulations concerning mandatory use of the baton may vary from city to city: but its actual use and value are universally accepted. The baton is presented as an acceptable, publicly approved, second-level weapon. The film stresses the need for such equipment in the police arsenal. Although training scenes are included, it does not attempt to teach actual techniques. Rather, it is intended as an introduction to the ideas for and behind the baton. This film has proven highly successful in police discipline training programs.

L013 Field Problems 25 min./color

This film goes one step further in the handling of citizen trouble calls, combining first contact with follow up response. By viewing a given situation from several different angles, as would witnesses standing in different positions, the officer is given the opportunity to evaluate the interpretation between assumption and fact and the

techniques used in compiling facts from a variety of sources to get at the truth. The analysis of hysteria and the folding of witnesses at the scene are covered, as are getting testimony from witnesses, questioning victims, and the use of discretionary authority.

1014 Vehicle Under Attack

Motorola

15 min./color You receive a call; should you call for back-up units? It's in a suspicious neighborhood; should you pull into the drive? This film gives a brief account of what happens when a gasoline fire bomb is tossed onto a patrol car. It shows you first hand why it may be better to stay in the car than to leave the vehicle, and some safety tips to keep in mind if it ever happens to vou.

L015 Routine Stops

AIMS

15 min./color A California Highway Patrol training film emphasizing that there is no such thing as a "Routine Stop". Basic points that will provide maximum safety for law enforcement officers dealing with traffic violators-a series of dramatic vignettes.

L016 Prowler

27 min./B & W Police Science Program Techniques for searching on prowler calls, methods of apprehension at night, how to approach the scene in a car, interviewing the witnesses, and searching for the prowler without putting the officer into danger. L017 Hot Car

30 min./B & W Police Science Program Methods used by car thieves for entering cars, changing license plates, professional changing the appearance of the vehicle, and principles used in driving a police vehicle in pursuit. Points out what to look for when investigating a stolen car.

L018 Four Against One

Police Science Program 20 min./B & W This is an older version of the film "OUTNUM-BERED" but also includes three different situations that might be encountered, a traffic violator, a fleeing car, and four felony suspects.

L019 Outnumbered

14 min./color Police Science Program Teaches the correct basic methods of stopping a suspicious vehicle. It portrays three situations: a traffic violator, a fleeing car, and four felony suspects. Illustrates the proper method by which each is apprehended. Also shows procedure for a one-man beat car to utilize the support of two other one-man units.

L020 Self Defense

Police Science Program 17 min./color Police training film on self-defense which stresses the necessity for professional performance and the maintenance of outward calm appearances even in times of stress. Illustrates hand holds for control arrest techniques of demonstrators; the gun take-away, and arrest of female suspects.

LO21 The New Police

14 min./color

Motorola

A specially trained family crisis intervention unit of the Oakland, California Police Department is seen on two disturbance calls attempting to handle the delicate and dangerous problems. Two types of calls are presented: 1. The thorough analysis and problem-solving approach where the officers take two hours to get at the roots of an alcoholic's problem and provide counsel; 2. "Oil on the water" approach to keep the lid on the problem and hurry back out on the street as soon as possible. AIMS 26 min./color Alarmingly, twenty-two per cent of all policemen killed nationally and about forty per cent of those injured meet their difficulty while intervening in a family disturbance. Even more startling, is that such injuries can be reduced, and at the same time, the officer can become more effective and be an even greater asset to that family and the community. Problems of diffusing the situation, mediation tactics, fact-finding and referrals, are realistically examined. Improper handling of a family disturbance call is detrimental to all concerned. L023 Landlord-Tenant Disputes And The Police

27 min./color

AIMS The police officer's role as a keeper of the peace requires that we deal with all areas of human conflict, including the handling of landlord-tenant disputes, Very often such disputes involve a misdemeanor violation and therefore, it is important for the officer to be aware of both the practical and legal issues involved, in order to prevent these conflicts from escalating into a violent confrontation. An officer who understands the basic civil and criminal law in this area can be an effective mediator, thus preventing violence and the necessity of an arrest.

L024 Discretionary Decision Making

20 min./cclor Calif. Peace Officers Assn. The film is made up of ten diversified decision making vignette situations. Each vignette shows the action upon to the point where the officer should make his decision, but no decision is made in the film. At the end of each situation, the film asks "what would you do?"

L025 Field Interviewing

24 min./color

Motorola

One of classic and most sophisticated law enforcement skills. Interviewing versus interrogating is dis-

cussed from the standpoint of current legal issues. Film provides motivation for police viewer to develop his interviewing techniques. Written reports ... to most field officers, the dullest and most frustrating part of the police job-to police planners and administrators, a vital source of data, information and evidence-to prosecutors, the first line basis for convictions. This new film strives first to motivate the officer to write clear and accurate reports, then teaches him how to do the job in an effective yet interesting way. In the interruption of a second burglary, the film illustrates techniques and strategy for searching multistoried buildings.

L034 Aggressive Patrol

10 min./color

How the alert officer can discourage crime with random patrol, field inquiries, and good relations with business people and residents on his beat. Particular emphasis is given to the proper handling of field inquiries in terms of public relations as well as the officer's physical safety. Also reminds the viewer of his responsibility in relation to "attractive nuisances" and other neighborhood hazards.

L035 Pursuing Suspects On Foot

10 min./color

A suspected child molester is spotted. An officer moves in for a field inquiry. And the suspect takes off. We follow the chase through to the arrest-and on the way observe all the basic "dos" and "don'ts" of hot pursuit on foot. Then we study a team operation at night winding up in a methodical quandrant search.

L036 Robbery In Progress

10 min./color

A liquor store has been held up, the owner stabbed. From the check out of an officer's personal equipment and briefing at roll call, to the cuffing of a suspect by an area search team, the film follows and details recommended procedures for handling a robbery in progress.

L037 Prisoner Control And Transport

Sid Davis 10 min./color The officer wanted to be a nice guy. That's why he handcuffed the "harmless drunk" with his hands in front of him so he could smoke. And it was near the end of the officer's shift. That's why he didn't take time to search the patrol car thoroughly. The combination was fatal. Against this background, the film details the proper procedures of prisoner control and transport, including handcuffing and seating arrangements for multiple prisoners.

Contrary to popular belief, less than five per cent of police car accidents occur in emergency or pursuit situations. This film is devoted to improving basic skills for normal driving that can substantially reduce "down" time for vehicles and officers alike. Emphasis is given to collision evasion, better steering control, backing procedures, and turn-around maneuvers.
