

PROBATION AND PAROLE TERMINATIONS 1974

# HIGHLIGHTS

- 1. Eight out of 10 adult male probationers and 7 out of 10 adult male parolees successfully completed supervision in 1974.
- 2. Slightly fewer than 9 out of 10 adult female probationers and parolees completed supervision in 1974.
- 3. Nine out of 10 adult males who were self-supporting or earning over \$400 per month while on supervision successfully completed probation.
- 4. Among juvenile boys, 8 out of 10 completed probation supervision successfully and 7 out of 10 successfully completed aftercare.
- 5. Seven of 10 juvenile girls successfully completed probation and 75 percent completed aftercare successfully.
- 6. When the agent reported a 'productive and useful' relationship with a juvenile boy under supervision or aftercare, 9 out of 10 were successful; however, when the agent reported a 'negative' or 'limited' relationship, only 6 of 10 cases were successful.
- Less than half of all adult and juvenile cases succeeded 7. when the supervising agent assessed the personal goals of the client as unrealistic; when goals were assessed as highly realistic, over 95 percent of adult and juvenile cases were successful.

# NCJRS

Information in this bulletin is based on 9,200 terminations from the Division of Corrections Probation and Parole caseloads for calendar year 1974. A case termination is the ending of supervision by either expiration of sentence or revocation because of violation. The bulletin is divided into 39 tables, separating cases by adult or juvenile status, by probation or parole program, and by gender.

Tables are also arranged to relate the outcomes of these major termination groups to various social characteristics, such as age, race, marital status, income level, and to characteristics of supervision such as its duration, use of a case plan, and various assessments of the agent supervising the case.

Data concerning adult male and female probation and parole terminations are covered in Tables 1 to 17. During 1974, cases of 7,169 adult males were terminated, including 6,195 probation and 974 parole. There were 1,009 female terminations, including 952 probation and 57 parole.

Juvenile probation and aftercare cases are presented in Tables 18 to 39. During 1974, 807 juvenile boys and 215 juvenile girls were terminated.

Termination resulting from revocation accounted for 1,464 adult males, 116 adult females, 226 juvenile boys, and 57 juvenile girls. The majority of revocations were for absconding or other rules violations.

#### Tabular Formats

All tables have in common a vertical axis representing population characteristics, and a horizontal axis specifying the number and percent terminated successfully. An outcome coded as successful is by definition a case not terminated by revocation, which is the return of the

probationer or parolee to a correctional institution. The revocation rate is therefore 100 percent minus the reported percentage of success or failure. Reasons for revocation are conviction of a new offense, charged with a new offense but not yet convicted, arrested but not charged with a new offense, absconding,  $\frac{1}{1}$  and other rules violations.

It should be noted that the report of 100 percent success for 18 year olds is an artifact of their automatic case closure upon attaining 18 years of age.

The population covered by these data should not be confused with a release cohort. This is not a follow-up study but a study of all cases terminated without respect to when they were received.

#### Discussion of the Data

Tabular data enable case outcomes to be related to a characteristic of the offender under supervision and to a characteristic of the supervisory process, including perceptions of the supervising agent. Of a group of cases with a given characteristic, the data show percentages of cases successful. The data do not necessarily permit accurate prediction of individual success on the basis of a single characteristic.

### The Supervision Process

Some characteristics of terminated cases describe the process of supervision. Selected for discussion are the agent's report of the relationship with the person under supervision, the agent's assessment of the goals of the person under supervision, the degree to which a case plan was developed and completed, and time under supervision.

Adult cases characterized by the supervising agent as having a productive and useful relationship with the agent displayed success rates of 90.7 to 100 percent. Groups coded as having a negative relationship with the agent did worse (41.7 to 60 percent success) than those having no contact with the agent at all (60.0 to 75 percent success), except for a handful of female parolees who succeeded despite negative relationships. The success range was 82.6 to 88.6 percent for juvenile groups reported as having a "productive and useful" relationship with the agent. For juvenile cases reporting negative relationships, the success rate was 50 to 62.5 percent (see Tables 11 and 26).

The agent's perception of the goals of the person under supervision, whether juvenile or adult, related strongly to the termination outcome. Those clients whose personal goals were assessed by the agent as "unrealistic" were only 33 to 56 percent successful. Of 833 cases coded as having "highly realistic" goals, only seven were revoked, a success rate of over 99 percent (refer to Tables 14 and 36).

When a case plan was reported as completed, the range of success rates across all juvenile and adult categories was 91.5 to 100 percent. For cases where a plan was reported as not completed, success rates ranged from 28.1 percent to 64.7 percent (see Tables 15 and 37).

Time under supervision and success correlate in similar patterns for male and female adults. Adults on probation for 12 to 18 months experienced highest rates of success, 91.8 percent for men and 95.7 percent for women. For both genders, success rates drop markedly with each shorter interval of supervision. In the six to 12 month category, success rates drop to 61.8 percent for men and to 77.2 percent for women. Lowest success rates accrue to the group of cases supervised for less than six months, 40,2 percent for men and 54.2 percent for women. These figures suggest revocations are most likely to occur early in the supervision period.

The second most successful group of adults were those supervised for more than two years but less than three years, 88.6 percent for men and 92.1 percent for women (refer to Tables 3 and 20). It should be kept in mind that this group is largely made up of those with more serious offenses and longer sentences.

# Social and Economic Circumstances of Probationers and Parolees

Outcomes of adult men when compared by marital status varied by as much as 26.9 percentage points. The group showing, lowest proportion of success were paroled males coded "nct reported," at 50.0 percent; thus, case outcomes may be related not only to objective characteristics of clients but also to the pattern of reporting or not reporting the information to the agent. The male groups doing best were reported as married, 89.2 percent successful for probationers and 84.9 percent for parolees. Successful outcomes for divorced or separated men dropped to 72.3 percent for probationers and 64.8 percent for parolees. This pattern was reflected by women on probation but broken by women on parole, where the divorced group did the best at 95.2 percent successful (see Table 6).

The group of juveniles living with one or both parents is naturally by far the largest and does substantially better as a group than those who live in group homes, and somewhat better than children in individual foster homes. Among juvenile boys on probation or aftercare, the highest success rates are for those reporting as living with other relatives (refer to Table 23).

Successful outcomes are related to such economic indicators as time employed, income per month, and degree to which the person under supervision is self-supporting. Men who were reported as supported by others were only 58 percent successful, in contrast to those who were reported as self-supporting, whose success rate for probationers was 91.4 percent and 84.2 percent for parolees. Across all juvenile

categories those reported as wholly or partially self-supporting showed success rates of a higher order than those completely supported by others. Of adult women, all parolees reported to be self-supporting were successfully terminated (Tables 8 and 27).

Income information on terminated cases compares outcomes by dollars earned per month, ranging from no income to \$400 per month and over. Tables 10 and 25 show an increase in percentage of successful cases with each increase in income per month for all but female parolees.

Success rate went hand-in-hand with employment stability across the three most populous adult categories. Unemployment for men is associated with an aggregate success rate of 59.5 percent for probationers and 52.3 percent for parolees. The generally full-time employed have success rates of 81.5 to 93.7 percent. Men and women reporting generally full-time employment do better than those who are sporadically employed, part-time employed, or unemployed. Variance in percentage of success as employment status weakens is more dramatic among men than women, whose probation terminations remained in the 80 and 90 percent decades despite poor employment profiles. Low success was associated with all significant groups when employment information was not reported, 54.8 to 67.6 percent (see Table 9).

#### Chemical Dependency

The non-user of drugs and the non-abuser of alcohol were generally more successful in adult and juvenile outcomes. Disruptive use of alcohol lowered adult success rates by 26.3 percentage points, with the non-disruptive user group achieving 92 percent success. While disruptive use of alcohol did not discriminate so sharply as a success correlate among juveniles, drug usage related to significant differences in juvenile outcomes, 67.7 percent success for those who reported using drugs and 84.1 percent for those who, by report, did not (see Tables 12 and 35).

## The Anthropological Characteristics: Age, Race, and Sex

Among adult probationers, the age groups reporting the highest rate of success were men whose cases were terminated at age 55 or older, 90.7 percent, and women in 40 to 44 age group, 95.4 percent. The most heavily represented age group for both sexes was the 20 to 24 set. In this group, 83.1 percent of men's cases were successful, second only to cases in the 55 and over set. Except for the relatively higher success of men between 20 and 24 years of age, men's cases were stable at 77 to 79 percent successful in groups up to 40 years of age, and thereafter advanced in success with each five year interval. For adult women on probation and for male and female parolees, patterns of correlation between age and case success were less apparent (refer to Table 4).

As a major age group, the entire juvenile caseload was less successful than the caseload of adults, percentages of success ranging from 69.8 to 77.4 percent in contrast to the adult range of 71.3 to 88.5 percent. It has been noted that the report of 100 percent success for 18 year olds is an artifact of their automatic case closure upon attaining 18 years of age (refer to Table 21). In cases of adjudicated juveniles, the highest success rate was among 17 year old boys on probation.

Non-white males in both probation and parole termination groups showed a higher percentage of revocations (32.8 and 35.0) than cases of white males (16.0 and 25.6 percent). Non-whites (Blacks, Native Americans, and a group reported as "Other") made up one-fifth of all cases terminated in 1974. Whites coded "Mexican Origin" comprised less than one percent of all terminations (see Table 5).

When stratified by gender, proportionally more women's than men's cases terminated successfully in both probation and parole programs. Percentage of successful probation cases was 80.6 percent for men, 88.5 percent for women; on parole the comparison was 71.3 percent for men, 87.7 percent for women.

Interestingly, juvenile girls did better than boys on aftercare, 74.4 percent success compared to 69.8 percent, but the boys did better on probation, 70.9 percent to 77.8 percent. Girls who were unemployed, just as boys who were unemployed, had the lowest percentages of successful terminations; however, in 199 of 215 girl's cases, vocational progress was coded as not applicable. This could identify a greater need for vocational services to juvenile girls. The relationship between employment and success of adult women on probation appears to support this need.

Women parolees departed from the general pattern of case success relating to age employed status, intact marriage, and agent's assessments. Divorced and separated women did better than their married counterparts in contrast to the better outcomes of married men terminating parole. Because the population of women terminating on parole numbered only 57, case file reading or other approaches than tabular interpretations or statistical analysis might be more fruitful in learning the dynamics of their success.






