Canada. *Report of the Canadian Committee on Corrections*. Chairman Roger Quimet. Ottawa, Canada: Queen's Printer, 1969. In chapter on the female offender, report recommends that a qualified woman be appointed to a senior administrative position to oversee correctional treatment of inmates.

Ottawa, Canada: Public Affairs Division of the Canadian Penitentiary Service and the National Parole Service, 1975. Two female classification officers are among several hostages taken at B.C. Pen.

Canada. *Report on the National Advisory Committee on the Female Offender*. Ottawa, Canada: Public Affairs Division of the Canadian Penitentiary Service and the National Parole Service, 1977. Many recommendations including elimination of all discriminatory provisions in Federal Prisons and Reformatories Act.

August 1976. This paper scans the literature and cites examples and opinions of experts. Originally prepared as an internal document for male correctional institutions to respond to queries about employing women as CO's.

Ontario, Ministry of Correctional Services, Women's Advisory Committee, *Summary of Proposals for Pilot Project: Staff Exchange Programme for Correctional Officers, Adult Division*. Toronto, March 1976. The study has been completed and the results are to be published in June 1977. Two male and two female correctional officers exchanged working locations for a three month period.

Ontario, Ministry of Labour, Women Crown Employees Office, *Second Annual Report of the Executive Co-ordinator of Women's Programs on the Status of Women Crown Employees in Ontario 1975-76*. In the chapter entitled Ministry of Correctional Services, cases of women breaking into traditionally male positions are cited, including the job of correctional officer and supervisor of juveniles.

Ontario, *Report of the Executive Co-ordinator of Women's Programs on the Status of Women Crown Employees in Ontario, 1974-75*, by Ethel M. McLellan and Kay Eastham, Toronto. Report contains a chapter specifically on women crown employees within the Ministry of Correctional Services, which outlines policy and objectives.

United Nations. Fourth United Nations Congress on the Prevention of Crime and Treatment of Offenders. "United Kingdom National Statement." Kyoto, Japan, August 1970. (Mimeographed). Some possibility that standard minimum rules might be changed to meet therapeutic considerations, in that male and female prisoners are brought together for group therapy.

U.S. American Bar Association. *Minority Recruitment in Corrections - New Federal Aid Requirements*. Washington D.C.: American Bar Association, 1973. Discusses the LEAA requirements about minimum height standards and the problem of site location of correctional facilities, affecting minority hiring.

U.S. American Bar Association. *Women in Detention and Statewide Jail Standards*. By Daniel Skoler. Washington, D.C., 1974. States the recommendation of American Bar Association of hiring males for women's institutions, and vice versa.

U.S. California. California Department of the Youth Authority. *California - Affirmative Action Statistics - Report No. 3*. Sacramento, California, 1975. Goals of minority and female hiring practices, set out before are assessed.

U.S. Department of Justice. Bureau of Prisons. *Female Offenders in the Federal Prison System*. Washington, D.C.: Government Printing Office, 1977. Currently 50 female correctional officers working at all-male institutions.

U.S. Department of Justice. National Institute of Law Enforcement and Criminal Justice. *Careers in the Criminal Justice System: Excerpts from the National Advisory Commission of Criminal Justice*. Washington, D.C.: U.S. Government Printing Office, 1975.

U.S. Department of Health, Education and Welfare. *Crisis of Qualified Manpower for Criminal Justice - An Analytic Assessment with Guidelines for New Policy - V 2 - Correctional Institutions - Pilot Study of Correctional Training and Manpower*. By H. Piven and A. Alcabes. Washington, D.C. 1969. Corrections is a deprived field of service.

U.S. Federal Prison System, Policy Statement, "Expanding Opportunities for Women in the Bureau of Prisons." Washington D.C., January 1976 (mimeographed). Paper sets down a numerical goal (10%) for correctional officer complement to consist of women employees by 1978.

U.S. Jacksonville Office of Criminal Justice Planning. *Urban League - Minority Recruitment Program - Evaluation Report*. Washington D.C.: National Institute of Law Enforcement and Criminal Justice, 1976. Minority personnel and females hired in Florida as police and Correctional officers. Research component.

U.S. Joint Commission on Correctional Manpower and Training. *A Time To Act*. Washington, D.C.: U.S. Government Printing Office, 1969. Increased hiring of women in correctional work force. Do not needlessly exclude females from meaningful work roles.

U.S. Joint Commission on Correctional Manpower and Training. *The Public Looks at Crime and Corrections*. By Louis Harris and Associates. Washington, D.C.: U.S. Government Printing Office, 1967. Women should be employed in correctional institutions if institutions become smaller. Women traditionally have taken initiative in reform movements in corrections.
