"An Empirical Study of Methods Used In Criminal Justice Evaluations," Grant No. 78NI-AX-0007, funded by the U.S. Department of Justice, Law Enforcement Assistance Administration, National Institute of Law Enforcement and Criminal Justice. All 200 evaluations in the sample to be analyzed by the project have now been read by one (or in some cases two) members of the project team. The time to do this extended through September due to the unanticipated magnitude of this task. Work during this quarter included, in addition to completion of the sample, further progress on model-based evaluations, Beiyesian methods of evaluation, process evaluation, and use of evaluation by decision makers. Also, some of our early work is now about to receive national visibility via conference presentation and journal publication.

#### Personnel:

The project staff members described in the first quarterly progress report have continued to contribute to progress on this grant during the third quarter. Vicki Bier, Ed Kaplan, and Cheryl Mattingly each worked full-time for two months during the summer to read the reports in the sample of 200 evaluations. They completed that task on September 30.

Professor Willemain is on leave this academic year at Brandeis University (The Heller School), but retains informal contact with the project.

Mr. Thomas K. Wong of M.I.T.'s Department of Electrical Engineering and Computer Science continues to assist on computer-related project activities. It is anticipated that he will remain as a part-time employee for computer matters for the remainder of the project.

We are fortunate this quarter to have two new graduate students joining our project. Mr. Tim Eckels is a Master-of-City-Planning (MCP) student with prior experience in studying corrections programs. He is quite interested in exploring the interfaces between the qualitative features of process evaluation and the more narrow quantitative attributes of outcome evaluations. Due to the project visibility and centrality in M.I.T.'s Department of Urban Studies and Planning - "DUSP" - (see interview recently published in <u>DUSP News</u>, attached as Appendix A), our project has been designated a "research cluster" in the DUSP. Four incoming MCP students this year are funded by U.S. Office of Education (O.E.) grants, and each is assigned to one of the four research clusters (evaluation research being one of them). Tim is our O.E.-supported student working with the project as a research assistant. This is an example of how a supported project can often attract additional researchers, not directly supported by the project, provided that the project is compatible with the educational and research needs and priorities of the institution.

Nancy Reichman is an incoming PhD student in DUSP, having extensive experience in criminal justice evaluation, primarily through the Vera Institute in New York City. She is a fully supported research assistant on the project. Her special interest is the use of evaluation by LEAA State Planning Agencies (SPA's). Nancy, together with Tim, spent most of September and October reading 25 evaluations from our sample of 200, in order to familiarize themselves with the project.

Delays have occurred with getting the questionaire data onto our newly completed computer system. For that reason we have hired Miss Dawn Richard, a senior at Wellesley College, as a part-time typist to expedite the transfer of the raw data to the computer. Later, Dawn may become involved in some of the substantive issues of the project.

#### Computer Programs:

Mr. Wong has now completed his extensive set of natural language, interactive computer programs for use with the questionaires - both at the input stage and at the analysis stage. A user's manual is available in draft form. The project will release a final version during the next quarter. We are looking forward to demonstrating this package of computer programs to interested individuals at LEAA.

#### Publications and Dissemination:

The project produced two publications during this quarter:

"Analysis of a Contingent Experimental Design, a Before-and-After Experiment with a Baseline Period of Random Duration," Thomas R. Willemain.

"The Congested Median Problem," Oded Berman and Richard C. Larson.

Willemain's piece is a first example of a major developing theme of this project: the need for flexibility, adaptibility, and feedback in the conduct of evaluations. In essence, we see the need for a theory of contingency design of experiments. Such designs would allow for adaptive updating of information regarding parameter estimates, adaptively timing of various evaluation activities, inclusion of certain "unintended consequences" experienced in the evaluation, and incorporation of subjective as well as objective information into the evaluation.

The abstract of Willemain's piece follows:

This paper introduces a simple "contingentexperimental design" and outlines how the contingent design would operate and how it would be evaluated. The familiar "before-and-after" type of experiment is modified so that the duration of the "baseline" period, rather than being fixed before the experiment,

is made contingent on the experimenter's prior estimate of the experimental impact and on the baseline data as they appear. At the conclusion of each day of the baseline period, a decision is made as to whether to terminate the baseline at that time, weighing the costs of extending the baseline by one day against the benefits of better estimating the experimental impact. An analytic framework is proposed for making this decision and for comparing the contingent design against an alternative having a baseline period of fixed duration.

We are also finding a lack of critical thinking about the physical elements of process, particularly in the logistically oriented studies. We cited an example of this in the last progress report, dealing with regression analysis and times, distances, and speeds. Because of these deficiencies, we are directing a major effort on the project toward "model-based evaluation." The term model here suggests axiomatically derived model in contrast to statistically "discovered" model. Ed Kaplan's M.C.P./O.R. Masters thesis will focus on model-based evaluations. Dick Larson plans to present a paper on modelbased evaluation at the next International Meeting of the Institute of Management Sciences (TIMS). One class of model that is useful in police experiments is the hypercube model, which depicts analytically the behavior of a spatially distributed emergency service system operating under alternative deployment options. Recent work on the model is summarized in the paper by Berman and Larson, the abstract of which follows:

> The median problem has been generalized to include queueing-like congestion of facilities (which are assumed to have finite numbers of servers). In one statement of the problem, a closest <u>available</u> server is assumed to handle each service request. More general server assignment policies are allowed, however. The analysis requires keeping track of the states (available or unavailable) of all servers. Paralleling the standard deterministic median problem, the objective is to minimize the expected travel time associated with a random service request, weighted appropriately by the equilibrium state probabilities of the system. Under suitable conditions, it is shown that

at least one set of optimal locations exists solely on the nodes of the network. This analysis ties together previously disparate efforts in network analysis and spatial queueing analysis.

In addition to these two project publications, two earlier project publications have been selected for presentation at the Second Workshop on Criminal Justice Evaluation (Washington, D.C., November 20, 21, 1978):

> KAPLAN, Edward H., "Evaluating the Effectiveness of One- Versus Two-Officer Patrol Units," June, 1978, 61 pp.

WILLEMAIN, Thomas R., "Bayesian Analysis of Crime Rate Changes in Before-and-After Experiments," June, 1978, 16 pp.

Both of these papers will be presented in the "Evaluation Methodology" session of the workshop. In addition, Dick Larson will be the moderator of a session of evaluation in police services.

Ed's paper, cited above, has also been accepted for publication by the

# Journal of Criminal Justice.

#### The Sample of 200:

A complete listing of the 200 evaluations comprising our sample is given as Appendix B. The questionaire responses for each have been read into the computer, using the code list given in Appendix C. Illustrative responses are shown in Appendix D.

#### Publications Acquired:

Ms. Dorothy Green has again been very busy acquiring required project documents. During this quarter, 68 new documents were acquired, all cited in Appendix E.

# Future Activities:

The project is now ahead of schedule in certain areas and behind schedule in others. The area of most serious concern is the processing of the 200 evaluations, which has been much more time consuming than we had expected. Because of this, we anticipate now drafting an interim report for LEAA in January, summarizing our questionaire responses to the sample of 200, without first contacting the original authors or consumers of the evaluations. The questionaire to the original authors would be sent out, tentatively, in February. The areas in which we continue to be slightly ahead of schedule are the methodology-related areas, as evidenced already by anticipated conference presentation and journal publication. We hope to sustain these efforts at an accelerated pace.

Also during the next quarter we anticipate a paper by Ed Kaplan on model-based evaluations in corrections, a paper by Cheryl Mattingly reviewing process evaluation and its relevance to criminal justice programs, and a piece by Vicki Bier that would structure in a comprehensive way Bayesian methods as they apply to evaluation research.

Finally, we hope to continue to maintain the procedure of at least one site visit per quarter to Washington to review our progress with the program monitor.

#### Report on Faculty: Richard Larson

Dick Larson is an Associate Professor of Electrical Engineering and Urban Studies, and the Co-Director of the

Operations Research Center. The following interview took place in October.

Q. Give me a little background on the Operations Research Center.

A. We're like a department without really being a department, from an administrative point of view. We're the only organization on campus which admits its own students, and grants its own degrees, without being a department or a division. In terms of historical background, the ORC was founded by Professor Philip Morse twentyfive years ago, and it has . been an interdepartmental program from the beginning.

Q. And your own background?

A. I was an MIT undergraduate and then a graduate student in the Department of Electrical Engineering. I became interested in Operations Research because I was looking for a way to apply my skills to problems in the public arena; and because I was once the indirect victim of a crime, I became interested in police operations. I did some independent study work in this field in the fall of 1965, and this led to a position on the Science and Technology Task Force of the President's Crime Commission.

So I worked as a Task Force member while I was still a graduate student here, and I was involved in helping to write parts of the Commission's report, which came out in 1967. This provided topics for both my Master's thesis and doctoral dissertation, which examined the process of police deployment. The subject had never really been investigated before, using Operations Research techniques.

At the time, I was working with Al Drake, who is still connected with the Center, and with Amedeo Odoni, a fellow student at the time who shared many of my research interests. When Amedeo and I joined the faculty in 1969, we decided that there was a need for an O.R. course which would address urban issues. We put together an outline for "Analysis of Urban Systems," a problem-oriented course. Aaron Fleisher was interested in the project, and suggested that it be presented as a joint subject with Course 11. This is how I became involved with Course 11, and eventually received a joint appointment.

Currently, my "home department" is Electrical Engineering and Computer Science, and I hold a joint appointment with the DUSP faculty. I seem to spend about an equal amount of time with students from both departments. I became Co-Director of the ORC about a year ago, and so a lot of my time is spent here. Jerry Shapiro is the other Co-Director, and he tends to the deterministic, global analysis kinds of problems, like energy systems. I look at the more probabilistic, public sector and day-to-day management issues.

So the students I deal with range from MCP and doctoral students from Urban Studies, to Master's and doctoral students in Operations Research, to Master's and doctoral students in Electrical Engineering and Computer Science. This means that I'm presented with quite a range of activities every day. For example, we're currently working on a project funded by the Law Enforcement Assistance Administration. It's an eighteen-month project, entitled "Evaluating Evaluations: The Challenge of Finding a Flexible Methodology."

#### Q. That's the title?

A. Yes; titles are important. We have five students working on that project, four of them from the DUSP --Nancy Reichman, Tim Eckels, Cheryl Mattingly, and Ed Kaplan. Ed, by the way, just had a paper accepted for a national conference and for an upcoming journal. The vast majority of papers submitted to the "referee" process are rejected, so it's quite a tribute to the quality of his work.

The substantive issue of the project is examining the effect of actions based on past evaluations, using a sample of 200 such evaluations. We look at the ways evaluations are used, abused, and misused, the extent to which a given evaluation affected subsequent decision-making, how it affected the budget cycle of the agency which funded it, and similar questions. We try to make a "horizontal cut," to find out how evaluations are performed, what their limitations are; and then a "vertical cut," in which each of us in the project tries to pursue a specific evaluation research topic.

For instance, Nancy Reichman is studying the ways in which many State Planning Agencies--SPAs--are utilizing or not utilizing evaluations in their annual budget and planning cycle. Tim Eckels is working on the "Exemplary Project Program," in which certain projects nominate themselves as being "exemplary" in some sense--for example, the outcome variables are great, and should be replicated throughout the country. These projects are then subject to an evaluation performed by ABT Associates in Cambridge, and approximately 93 percent of them are screened out. Since we are evaluating evaluations, it makes sense to evaluate those who evaluate evaluations. Ed Kaplan is working on model-based evaluations, using mathematical models in the evaluation process. and Cheryl Mattingly is focusing on process evaluation.

The Innovative Resource Planning (IRP) Project is another example of an urban studies-oriented project, involving Bob Fogelson, Kent Colton, Gary Marx, Tom Willemain, myself, and others from the Engineering School and the Sloan School. This resulted from a threeyear NSF grant, covering a range of operations research problems, which produced four books and some fifty reports.

Q. Give me an example of a concrete problem which you're currently working on.

A. We have a couple of projects under the general topic of improving urban transportation. For instance, concerning buses: when the headways between buses deviate, they clump together, and the waiting time for passengers at curbside greatly increases. So the idea is that you want to institute some kind of control over the headways. When the headways are perfectly even, you produce the shortest curbside wait.

Q. Finally, can you recall a particular evaluation of an evaluation which turned up some glaring error, unforeseen consequence, or the like?

A. In general terms, we at the ORC have it in for mindless use of multivariate regression analysis, in which you postulate that there exists a linear, additive, functional form limiting the output variables and the input variables in some system. In a specific case, we came across somebody who postulated their regression equation in a way that suggested that the response time of an ambulance or a police car was proportional to the sum of some constant of proportionality of the distance that it traveled. plus another constant of proportionality, times the speed traveled, and a number of other things. Now, anyone who knows the elementary rules of physics knows that there is a fundamental relationship between time, distance, and speed--and don't forget the division step in there !-- and that to speculate that speed would be added on, rather than being the denominator of distance, is absurd. This is the kind of problem we run up against, unexpectedly; in circumstances where people are building elaborate models without a sense of the simplest physical relationships.

Comprehensive Evaluation SUITABILITY OF EVALUATION FOCUS: 6 COMMENT: Evaluators had both a process evaluation and an outcome evaluation in the form of a quasi-experimental design. There was an interesting use of a quasi-experimental design to do a qualitative, process-oriented study of a large program containing many projects. They used a randomized, stratified sampling for the experimental group. It was a quasi-experimental design because the control and comparison groups were chosen form a different population. They could not do a strict experimental design because the evaluation was done after the incertion of the program. However, the groups were very carefully chosen and randomization was employed whenever possible. They chose as the population for their control group those police departments who had requested assistance from MPI but had not yet recieved it. While they had per- formance measures, these were specific to particular parts of the overall program-- certain tangible criteria the evaluators felt to be measures of the program's overall success. 18. yes COMMENT: On the whole quite good. Evaluators were careful to consider that satisfaction of clients only a partial measure of the program's success and that impact in behavior, concrete outcomes, were the most important measures. 19(a). yes COMMENT: Evaluators were careful to look at what activities resulted in what outcomes. 19(b). yes 20. yes COMMENT: Not simply a general overview of a typical program activity but actual historical accounting of how activities unfolded in different proJects. 21(a). yes COMMENT: Yes in sense that program staff objected to or questioned certain feedback which the staff then elaborated as a result. #### FINAL COMMENT:

This is one of the most interesting evaluations I have seen. 工七 combines features of a process evaluation -- while done on aspects of the program completed before the evaluation took place -- and features of an experimental design which allows you to look carefully at a small sample in a systematic way and feel relatively confident your findings can be generalized to the larger population you are actually interested in. The evaluators were faced with looking at a multi- faceted program which had been in operation long before they arrived on the scene. These could not examine, with any depth, all of the things the program had done yet they wanted to evaluate the program overall. Their solution was quite creative. They carefully showe a stratified random sample of police departments who had made use of the MPI. These were matched, randomizing where possible, with a control group of clients awaiting services from MPI and a comparison group of police departments who had never made requests. (Why they chose the former as a control group is unclear and a bit problematic to me.) They then did structured telephone interviewing of subjects in various groups. Where "treatment" had been given, they probed not only for the attitudes of subjects but for documentation as to what had actually changed in their depart- ments as a result of the treatment. While this "investigative reporting" method of data collection does not substitute for direct observation, the interviewing was situation specific enough (as revealed by reported subject responses) to go beyond the initial subjective responses of the clients. One problem whih casts some doubt on the evaluators interpretations of data is that they did sound a bit too anxious to praise the projet staff where they could.
