## FOREWORD

This publication describes the Juvenile Probation Statistical Information System of the California Bureau of Criminal Statistics. The Bureau has been compiling and publishing uniform data describing California's juvenile justice system for over twenty-five years. This has been accomplished through the collection of individual reporting documents outlining the activities of the probation department, juvenile court, and juvenile correctional facilities of each county. This program began in 1947 as a pilot project involving only six counties and has since grown to include all 58 counties in the state.

Included in this publication are copies of reporting forms and applicable instructions used by contributors, record format outlining all data elements and applicable codes, an appendix with glossary of applicable terms, abridged offense and county codes, hierarchy scale, and a catalog of available computerized reports.

# JUVENILE PROBATION STATISTICAL INFORMATION SYSTEM

## Objective

The objective of the Juvenile Probation Statistical Information System is to collect, compile, analyze, and publish statistical data on the administration of juvenile justice in California.

## Authority

The authority for the Bureau of Criminal Statistics (BCS) to collect data from juvenile justice agencies is in Penal Code, Sections 13000-13020 and the Welfare and Institutions Code, Section 586.

## Description

The Bureau maintains a computerized active and closed caseload file for each probation department in the state. Data on new referrals and transactions on currently active cases are routinely reported on individual report forms by county probation departments and processed against this file to create an up-to-date active and closed file.


In addition to collecting data on each offender such as age, race, sex, offense, etc., the Bureau collects and interrelates data on the various processes of the juvenile justice system such as: initial probation department determinations, informal probation placements and terminations, nonward and formal probation placements and terminations, time intervals, initial and subsequent petition adjudications and local correctional institution movement.

## Publications

The Bureau compiles and distributes quarterly, annual, and fiscal reports to its contributors and periodically special reports on specific problem areas within the criminal justice system.

## INTRODUCTION

The instructions for reporting juvenile probation cases are divided into two sections. The first section consists of sample forms and instructions for reporting information on delinquency referrals, juvenile court activity, and probation terminations. The second section includes reporting forms and instructions for reporting institutional movement in juvenile facilities (camps, ranches, homes, and schools). All reporting documents should be received by BCS on the 10th day of the month for the previous month's transactions.

The Bureau assures each contributing agency that the names of minors reported are held in strict confidence. The reporting of juvenile names is used for statistical accounting purposes only.

JUVENILE PROBATION OFFICER'S STATISTICAL REPORT  
FORM JUS 734

The JUS 734 form is to be submitted for each initial delinquent referral<sup>a</sup> to the probation department for a Welfare and Institutions Code, Section 601a, b or 602 violation. It should be completed as accurately as possible in order that maximum value be derived from the reporting program. All items are necessary for processing within the Bureau except area number, address, telephone, and officer number which may be completed at the option of the probation department. If the probation department elects to provide information in these optional areas, Bureau staff should be consulted to ensure that compatible codes are used.

Documents should be arranged in alphabetical order according to name before they are mailed to BCS. This will facilitate easier handling and expedite internal processing within the Bureau.

Itemized Instructions for Completing Form JUS 734

County - Enter the name or code number of the county in which the probation office is located.

Area Number - This is an optional item. It is provided to permit the probation officer to report the area of residence of the child referred. The system allows for a four-digit series to be locally assigned which permits each department to establish up to 9999 different county areas or locations. Once assigned, these area designations should be maintained for several years, and any changes should be made at the beginning of a calendar year.

Case Number - Enter the number assigned to the case by the probation department. Six digits have been provided which will permit the recording of up to 999,999 cases in numerical sequence. Once a number is assigned to a case, it must be retained by that same minor throughout his exposure to probation services.

Date Referred - Enter the date on which the minor is brought to the official attention of the probation officer. This need not be the date on which the petition is filed. In transfers from a juvenile court of another county, give the date that the transfer papers are filed in the receiving county.

Name - Enter the name of the minor in the following sequence: last name, first name, and middle name.

Race - Circle the code number which represents the race of the minor. Classify American Indian, Chinese; Japanese, Filipino, or any other race as "Other" (number 4) and specify the race.

Address and Telephone - These items have been provided for the use of the probation department and will not be recorded in the Bureau of Criminal Statistics.

Sex - Circle the applicable number preceding "Male" or "Female."

Age - Enter the age as of the last birthdate.

Birthdate - Enter the exact date of birth in the following sequence: month, day, and year. If only the year of birth is known, that should be reported.

Reason for Referral - Enter the exact Penal Code Section violation and a brief statement of the occurrence which led to the referral, such as "took fur coat from locked car," or "auto theft." In cases involving drug law violations, please note the type of drug involved. For violations of Section 647f P.C., be specific as to whether influence of alcohol or drugs.

Officer Number - This is an optional item. Enter the department identification number of the officer to which the case is assigned. This field will contain a two-digit number, up to 99 separate officer numbers.

- A. Referred by - Circle the number preceding the appropriate source which brought the case to the attention of the probation department. If the case was referred by a law enforcement agency, enter the name of the agency in the space provided. If the printed selections are not appropriate, circle "Other" and enter the source in the space provided for referral, i.e., welfare department, attorney, neighbor, probation officer, etc. If the case was received as a transfer from another county, please enter the name of the transferring county in the "Remarks" section.
- B. Intake Disposition - Do not submit a report to the Bureau until a specific action is taken. At that time check the appropriate number representing that action on the form.
1. Closed - after investigation. This item should be checked when a case is summarily closed at the intake level.
  2. Closed - referred to other county agency. This item should be checked when the probation department refers the minor to another agency within the county such as the Welfare Department, the Health Department, the Legal Aid Society, etc.

3. Closed - referred to out-of-county agency. This item should be checked when the probation department refers the minor to any agency outside the county in which the probation department is located. If this action is taken, please indicate in the "Remarks" section the name of the county or state to which the case was referred.
4. Closed - returned to CYA. This item is to be checked when it is found that a minor is currently under the jurisdiction of the California Youth Authority (CYA) on a commitment from another county. At the discretion of the probation officer, the minor is released to the custody of CYA without official court processing.
5. Informal supervision (654 W&I). This item is to be checked when a minor is placed under six months supervision upon agreement between the parents and the probation officer as set forth in the Welfare and Institutions Code, Section 654.
6. Petition filed. This item is to be checked when a petition is filed. Additionally, enter in the space provided the Welfare and Institutions Code Section (601a, b or 602) upon which the filing is based.
8. Diversion. This item is to be used when a minor is referred to a diversion program outside the probation department. This option is considered a closure at intake.
9. Diversion. This item is to be used when a minor is referred to a diversion program within the probation department. This option is not considered a closure at intake.

Special Note: The intake dispositions 8 and 9 are not printed on the JUS 734 form. To utilize a diversion code enter the 8 or 9 code in the intake disposition section on the JUS 734.

- C. Intake Disposition Date - Enter the date of the intake disposition. This date does not reflect the court disposition date, but rather, the date the probation officer determines the method in which the case is to be processed or closed.

Status and Date - Disregard this section. It is intended for use by the Bureau.

Special Note: Please note in the "Remarks" section whether or not the juvenile was detained at the time of the referral. If the subject's name has been listed on the daily log in the juvenile hall or jail, please enter "Detained" if not, please enter "Not detained."

Remarks - Use this section for making any necessary clarification for entries in other sections of the form and for noting the initial detention of a juvenile (see Special Note above). This section should also be used to record the name of the county or state for transfer cases. Please make any brief comments necessary to ensure proper classification of a case by BCS. If additional space is needed, use the back of the card.

CHANGE OF STATUS IN JUVENILE PROBATION DEPARTMENT  
FORM JUS 735

Form JUS 735 is to be submitted to BCS whenever a minor has a change of status within the probation department. This includes minors who are dismissed, discharged, or transferred. (This does not include those in which the action resulted from a subsequent petition or any placement changes.) Examples of the types of status changes are:

1. From informal supervision (654 W&I) status to termination, or filing of a petition.
2. From pending court status to termination, transfer, probation without wardship (725a W&I), formal probation, or CYA commitment.
3. From probation without wardship (725a W&I) status to termination, transfer, formal probation, or CYA commitment.
4. From formal status to termination, transfer, CYA commitment, or remand to adult court.

Itemized Instructions for Completing Form JUS 735

County - Enter the name or code number of the county in which the probation department is located.

Case Number - Enter the serial number as recorded on the original reporting form (JUS 734).

Officer Number - Enter the identification number of the officer to which the case is assigned.

Date of Report - Enter the date on which the form is completed.

Name - Enter the name of the juvenile as previously reported on Form JUS 734 or on a previous JUS 735. Give last name first. If an original report identified a case as "John Doe" and the legal name subsequently has been adopted and substituted for record and identification purposes by the department, then verify the change in identification under the "Remarks" section.

Status Change Information

- A. Removal from INFORMAL (654 W&I) status - Enter the date of such removal in the space provided.

Type of Status Removal

1. Supervision terminated. This item is to be checked when supervision is terminated for any reason, including transfer to another county, death of the subject, or outright termination. If the minor is transferred to another county or state, please note in the "Remarks" section the name of the receiving jurisdiction.
3. Petition filed. This item is to be checked when a minor who is under informal supervision progresses to the "pending court" status by the filing of a petition. The offense or reason for the filing should be entered in the "Remarks" section.

- B-1. Removal from PENDING COURT or PROBATION WITHOUT WARDSHIP (725a W&I) status - Enter the date of such removal in the space provided. Enter also the Welfare and Institutions Code Section (601a, b or 602) upon which the finding is based.

Check the appropriate box to indicate whether the allegation was sustained or not sustained. In cases of no finding, write "no finding" in the "Remarks" section.

On all removals from probation without wardship (725a W&I), only Type of Status Removals 1 and 3 need to be reported.

Special Note: In an instance where the minor is sent to CYA or a state hospital for observation and diagnosis, do not submit a report to the Bureau until he has returned and the court has made its disposition. In such cases, make the proper entry in the section entitled "90-day observation" immediately following the enumeration of court dispositions.

Type of Status Removal

1. Closed - dismissed or discharged. This item is to be checked after an official hearing by the court which results in dismissal of the case, regardless of the finding upon the allegation(s), or when a petition has been withdrawn and the case is closed in the probation department.
3. Closed - transferred to other county - This item is to be checked when authority for final disposition is passed to another jurisdiction by the forwarding of documents to the juvenile court in another county. Please enter the name of the receiving jurisdiction in the "Remarks" section. (Do not report outgoing courtesy cases where wardship is maintained in the county of original jurisdiction.)

4. Closed - returned other county's ward to CYA without recommitment.

This item is to be checked when the minor is currently under the jurisdiction of CYA under a commitment from another county and the case is released to the custody of a representative of that agency.

5. Closed - unfit subject for juvenile court. This item should be checked when the case is remanded to adult court.

6. Committed to CYA. This item is to be checked when the case is committed to the jurisdiction and custody of CYA. Do not report such commitment until the minor has been accepted by CYA and has been sent to one of its institutions.

7. Placed under formal supervision. This item is to be checked when the minor is declared a ward of the court (except for those cases committed to CYA) or a dependent child. The asterisk (\*) preceding the number 7 should be disregarded. When item 7 is checked, the court placement should be indicated by circling the appropriate number on that line.

8. Petition dismissed, retained as informal (654 W&I). This item is to be checked when a petition is dismissed and the minor is placed under informal (654 W&I) supervision, or in those instances where informal supervision was already in effect prior to the petition filing and that status is to be resumed, or in those cases where informal supervision is commenced after a petition dismissal.

0. Placed on probation without wardship (725a W&I). This item is to be checked when the court initiates a six-month period of nonwardship supervision as provided in Welfare and Institutions Code, Section 725-a. The asterisk (\*) should be disregarded.

90-day observation. Check the appropriate box indicating the type of predisposition diagnostic placement, if any. Do not submit a Form JUS 735 until the subject has been returned to court from such placement and final disposition has been made.

- (\*) Placed under SPECIAL CASELOAD supervision. Disregard this item.

- B-2. Hearing Representation - Complete this section for any case initially adjudicated under Welfare and Institutions Code, Sections 601 or 602 by the juvenile court. Generally, the format provides two alternatives for indicating the representation of the state (the official representative presenting the case before the court), (1) the probation officer or (2) the district attorney. Under each of these general alternatives five identical possibilities for representation of the minor are enumerated: none (other than the probation officer), private counsel, court-appointed counsel, public defender, or other (specify). Please circle or check the number indicating the appropriate representation of the minor. If none of the selections is applicable, please explain under the "Remarks" section or on the reverse side of the card.

- C. Removed from FORMAL Status - Enter the date of such removal in the space provided.

## Type of Status Removal

1. Discharged or terminated. This item is to be checked when a formal case is terminated (for any reason other than commitment to CYA or remand to adult court), or when complete jurisdiction and supervisory responsibility is transferred to another county. In cases of transfer, please enter the name of the receiving jurisdiction in the "Remarks" section.
3. Committed to CYA. This item is to be checked when a minor previously under formal supervision is committed to CYA. Do not submit such a report until the minor has been accepted by CYA and is sent to one of its institutions.
4. Remanded to adult court or jurisdiction. This item is to be checked when a minor previously under formal supervision is returned to the juvenile court and transferred to adult court. Report only those minors in which the jurisdiction of the juvenile court is terminated with respect to all petitions.

Special Note: In every instance in which a petition is sustained, please note in the "Remarks" section the actual offenses or counts sustained, such as: incorrigible, burglary, possession of marijuana, etc.

Remarks. Use this section for making any necessary clarification of entries in other sections of the form, noting sustained offenses or counts, and naming out-of-county jurisdictions receiving transfers. Please make any additional comments which may aid in processing by the Bureau. If additional space is needed, use the back of the card.

SUBSEQUENT JUVENILE COURT ACTIONS ON CURRENTLY ACTIVE CASE  
FORM JUS 736-A

Form JUS 736-A applies to those cases for which a subsequent petition is filed for delinquency reasons as a result of a new delinquent act. The minor must be currently on active probation and within one of the following status classifications:

1. Probation without wardship within your county as provided under Welfare and Institutions Code, Section 725a.
2. Formal probation within your county.
3. California Youth Authority jurisdiction as a commitment from your county.

Note: Minors meeting the above status criteria but under the jurisdiction of the juvenile court of another county, or under the jurisdiction of CYA as a commitment from another county, should be reported as a new case on Form JUS 734.

Itemized Instructions for Completing Form JUS 736-A

County - Enter the name or code number of the county in which the probation office is located.

Area Number - This is an optional item. This is provided to permit the probation officer to report the area of residence of the minor referred. The system allows for a four-digit series to be locally assigned which permits each department to establish up to 9999 different county areas or locations. Once

assigned, these area designations should be maintained for several years, and any changes should be made at the beginning of the calendar year.

Case Number - Enter the number assigned to the case by the probation department.

Date Referred - Enter the date that the minor was reported to the probation officer for the subsequent offense.

Name - Enter the name of the child in the following sequence: last name, first name, middle name.

Race - Circle the code number which represents the race of the child. Classify American Indian, Chinese, Japanese, Filipino, or any other race as "Other" (number 4) and specify the race.

Sex - Circle the applicable number preceding "Male" or "Female."

Age - Enter the age as of the last birthdate.

Birthdate - Enter the exact date of birth in the following sequence: month, day, and year. If only the year of birth is known, that should be reported.

Omit - This item is to be left blank for use by the Bureau.

7. Committed first time to CYA. This item is to be checked when the minor is initially committed to the jurisdiction of CYA. In such cases, hold this form until the minor has been sent to a CYA institution.
8. Recommitted to CYA. This item is to be checked when the court orders a minor currently under CYA jurisdiction to be recommitted to that agency.
9. Turned back to CYA without recommitment. This item is to be checked when the court orders a minor currently under CYA jurisdiction to be released to a representative of that agency without recommitment.
0. No disposition - taken off calendar. This item is to be checked when the case does not come to court because the minor escaped, or for some other reason.
- X. CYA commitment vacated - continued as ward. This item is to be checked when CYA jurisdiction is terminated, but the minor is to be continued as a ward of the court. Report this item only after the minor is sent

Circle or check the number indicating the appropriate representation of the minor. ## GLOSSARY

This glossary contains definitions of terminology used by the Bureau as they pertain to the Juvenile Probation Statistical Information System.

Delinquent acts - Violation of laws by a juvenile under provisions of the Welfare and Institutions Code, Section 602..

Delinquent tendencies - Unreasonable or incorrigible behavior as described under Welfare and Institutions Code, Section 601.

Formal probation - A probation grant whereby a minor has been declared a ward of the court and is on probation for an indeterminate amount of time.

Informal probation - The contracting of informal supervision between the probation officer and the parent or guardian of a minor in lieu of filing a juvenile court petition as set forth under the Welfare and Institutions Code, Section 654.

Initial referral - Juveniles not actively being supervised or pending juvenile court proceedings at the time of their referral to a given probation department.

Initial petition - The first petition filed in behalf of a minor in juvenile court resulting from an initial referral.

Juvenile - A person 17 years old and under.

Juvenile court - Court specifically delegated to adjudicate juvenile offenders.

Minor - A person 17 years old and under.

Nonward probation - A probation grant without wardship from juvenile court for a specific time not to exceed six months as described under Welfare and Institutions Code, Section 725a.

Petition - The formal presentation of the information to the juvenile court alleging a violation of the Welfare and Institutions Code, Sections 601 or 602.

Subsequent petition - A petition filed on behalf of a minor that is currently being supervised on probation as a ward or nonward (725a W&I).

Wardship - The state or condition of being under the care or guardianship of the juvenile court.
