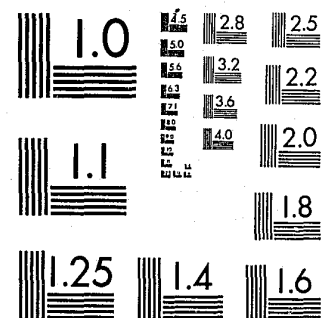

INTERNATIONAL RATES OF IMPRISONMENT

The statistical information in this listing has been derived from various sources, as no single document provides all the relevant data. For each country, all adult inmates are included in imprisonment figures, i.e., all jail and prison inmates, both sentenced and unsentenced.

The Republic of South Africa apparently has the world's highest rate of imprisonment. With 100,000 adult inmates in prisons and jails and a population of 25 million, the imprisonment rate is 400 per 100,000 population. However, many of the inmates are considered political prisoners.

The U.S.S.R. is variously estimated to have 1 million inmates. On the basis of a population of 255 million, this means an imprisonment rate of 391 per 100,000 population. The majority of inmates are regarded as political offenders.

On December 31, 1977, the United States had 290,547 prison inmates and in February 1978, 158,394 inmates in jails, for a combined figure of 448,941 inmates, or a rate of 208 per 100,000 population. Few inmates can be regarded as political offenders and the U.S. thus has the world's highest rate of imprisonment for the

common criminal.

In 1976, the average prison population in Great Britain (England and Wales) was 41,443, or 84 per 100,000 population. Of the inmate population, 86 percent were criminal prisoners under sentence, 8 percent were untried prisoners, and 4 percent were convicted persons awaiting sentencing.

In 1976, West Germany had 37,000 inmates and a population of 62 million. The rate of imprisonment per 100,000 was 60.

On January 1, 1976, France had a total of 29,482 persons in detention. Of the total, 18,463 were sentenced inmates and 11,019 were unsentenced. The combined incarceration rate per 100,000 population was 56.

The 1977 rate of incarceration in Denmark, of sentenced and unsentenced inmates combined, was 54 per 100,000. Of the total, 23 percent were awaiting trial.

On January 1, 1978, there were 3,335 inmates in institutions in Sweden, of which 2,737 were prison inmates and 598 were unsentenced ("jail") inmates. The number of sentenced inmates per 100,000 population was 34 and the number of sentenced and unsentenced inmates combined per 100,000 was 40.

On December 12, 1975, The Netherlands had 859 inmates in prisons and 1,497 in jails, for a combined incarceration rate of 22 per 100,000, the world's lowest rate of imprisonment.
