MICHIGAN SUBSTANCE ABUSE SERVICES NETWORK

The substance abuse services network consists of the Office of Substance Abuse Services of the Michigan Department of Public Health, 30 local substance abuse coordinating agencies, 7 regional substance abuse prevention education programs, and more than 400 local service delivery organizations.

The OSAS administers funds statewide and coordinates all state and public funds for substance abuse treatment, rehabilitation and prevention services. It coordinates with the 30 local coordinating agencies who develop local plans for service delivery, provide technical assistance to service providers, and evaluate local programs. The over 400 local service providers provide prevention services and assist people in obtaining treatment. They provide outpatient, inpatient, and residential treatment and coordinate rehabilitative services with other service providers.
