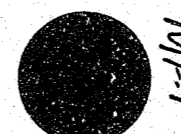

The Forensic Unit of Mississippi State Hospital is the only facility for mentally ill offenders serving the State of Mississippi. It is under the auspices of the Mississippi State Department of Mental Health, Jackson, MS 39201. The unit has a bed capacity of 200.

HALFWAY HOUSES AND OTHER RESIDENTIAL TREATMENT FACILITIES

Halfway houses and other residential treatment facilities provide alcohol and drug treatment services in a controlled atmosphere with an emphasis on group living. A close relationship between such programs as Alcoholics Anonymous and Narcotics Anonymous is a typical program component. Additional services usually include individual, group, and family counseling; a working relationship with vocational rehabilitation services; and referral to other appropriate community programs and agencies. Aftercare services are frequently provided in order to give support to a former resident in his/her move into an independent living situation.

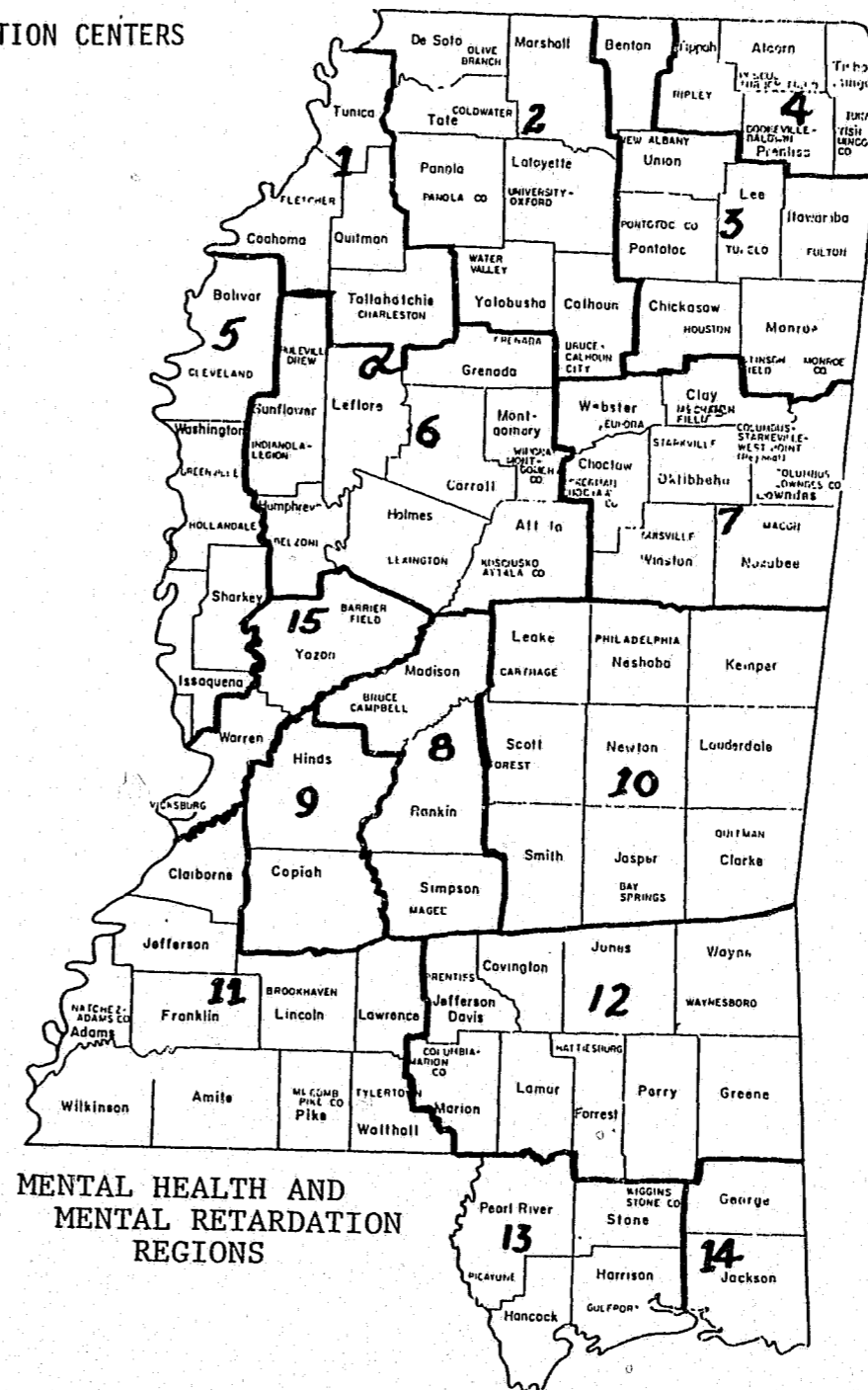

MASEP is a court-referred statewide education program for the first DUI (Driving Under the Influence) offenders. By completing the 10-hour, 4-week course, the offender's driving privilege will be reinstated by the Mississippi Highway Patrol. There are 17 MASEP schools across the state. There is a school geographically located within about 40 miles of any offender.

COUNTY JAILS & COMMUNITY MENTAL HEALTH - MENTAL RETARDATION CENTERS

Each county has been listed in alphabetical order. Under each county jail you will find the Sheriff's name and address and the Community Mental Health - Mental Retardation Center which services that particular jail. In some cases in addition to the regional mental health center there are local satellite centers within the county. Each Community Mental Health Center provides a variety of alcohol and drug services at the local level. Most centers provide the following services: detoxification, individual counseling, group counseling, family counseling, family intervention, crisis intervention, emergency care, after-care, occupational programs, partial hospitalization, residential, vocational counseling, referral to other community services or resources, consultation and education, outreach, inpatient services, speakers available to the community and a 24-hour hotline.
