UNIFORM CRIME REPORTING

This summarized report on Crime in Texas during calendar year 1980 was compiled from data submitted to the Texas Department of Public Safety Uniform Crime Reporting Bureau by 728 Texas Sheriffs and Chiefs of Police whose jurisdictions represent 97.9% of the State's population. Their excellent cooperation is gratefully acknowledged.

The following definitions of index crimes are used in the Uniform Crime Reporting Program:

CRIMINAL HOMICIDE... The willful (nonnegligent) killing of one human being by another.

FORCIBLE RAPE...The carnal knowledge of a female forcibly and against her will.

ROBBERY...The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

AGGRAVATED ASSAULT...An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

BURGLARY...The unlawful entry of a structure to commit a felony or a theft.

LARCENY-THEFT...The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another. (Includes theft from a motor vehicle)

MOTOR VEHICLE THEFT...The theft or attempted theft of a motor vehicle.

ARSON...The willful or malicious burning or attempts to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc. Includes violation of State laws and Municipal ordinances relating to arson and attempted arson.

The collection of arson data under the Uniform Crime Reporting Program began during 1979. The information below was compiled from arson reports submitted by agencies representing 95.3% of the state population and is published as an indication of the extent of arson in Texas during 1980.
