

CRIME VICTIM'S REPARATIONS BOARD
STATE OF NEBRASKA

I. BACKGROUND

This report covers the period of January 1, 1981 through December 31, 1981. 1979 was the first year of the Board's existence.

The Nebraska Crime Victim's Reparations Board was created by L.B. 910, passed by the Nebraska Legislature in 1978, effective January 1, 1979.

Nebraska was the 29th state to implement compensations to victims of crimes. Today, 31 states and the Virgin Islands have established similar kinds of programs. A 32nd state, Rhode Island, has enacted a program that will begin when Congress authorizes federal funding for the states. Two other states, Georgia and Nevada, compensate only persons who try to prevent a crime or who help a police officer ("Good Samaritans").

In the three years, Nebraska has awarded \$111,506 in compensation to persons who otherwise would have sustained a financial loss for medical bills or loss of earnings or support otherwise reimbursed by insurance or public funds.

II. THE ACT

Sections 81-1801 - 81-1841 R.S. Supp. 1980, as amended in 1981.

Nebraska Crime Victim's Reparations Act was created to assist victims of crimes and persons assisting victims of crimes who suffer bodily harm as a direct result of criminal acts. It further compensates dependents of fatally injured victims of criminal acts. The assistance includes compensation for medical care, loss of wages, job retraining or rehabilitation services, pecuniary loss to dependents, and any other loss resulting from personal injury or death of the victim that the Board determines to be reasonable. The maximum award is \$10,000 unless the Board determines there are special circumstances under which an award may exceed that amount.

The operation of the CVRB, including administrative costs and awards to claimants, is funded through the General Fund.

III. THE MERGER

The 1981 Nebraska Legislature passed L.B. 328 to merge the Crime Victim's Reparations Board within the Nebraska Commission on Law Enforcement and Criminal Justice (Crime Commission). The Governor signed the bill and the move was made on July 1, 1981.

The Board's functions are the same as before, but fall under the direction of the Executive Director of the Crime Commission for administrative and budgetary purposes and is a division of the Commission.

The merger has enabled the Board to make use of the Crime Commission's attorney as a hearing officer and Jail Standard's field representatives as investigators on certain claims. The Law Enforcement Training Center in Grand Island is including instructional information on the Crime Victim's Reparations program in their training courses for law enforcement personnel.

IV. THE BOARD

The Act provides for a three member Board. One member must be an attorney licensed to practice in the state. Board Members are appointed by the Governor and approved by the Legislature. Initial appointments were for two, four and six year terms. Successive terms will be six years. Board Members serve part-time and receive \$100 per diem plus expenses.

The Board has continued to treat each claimant not as an adversary, but rather to determine the full and true facts concerning each claim. The Board is dedicated to seeing that those people who are entitled to an award receive the same; and they are equally dedicated in making sure an award is denied to anyone who is not eligible or entitled to one.

The Board reviews the claims in conjunction with the Board Meetings. This enables expenses to be kept at a minimum.

V. THE STAFF

The staff consists of a Division Chief (administrator of the program) and a Staff Assistant with support help from the staff of the Commission, including the Crime Commission Attorney as hearing officer.

IV. ELIGIBILITY REQUIREMENTS

Innocent victims and/or persons aiding victims of a crime who suffer bodily injury as a direct result of a crime are eligible for compensation. Dependents of fatally injured victims are also eligible. The victim must have suffered a financial loss as a result of the incident.

In order to be considered for compensation, the crime must have been reported to the law enforcement within three days and the claim must be submitted within two years of the incident.

No compensation will be awarded to anyone whose injuries or death were caused by a violation of the law, to relatives or anyone living with the offender who aids the offender in the commission of an unlawful act, or to anyone whose injuries resulted from the operation of a motor vehicle, boat or airplane unless the vehicle was used in a deliberate attempt to harm the victim.

Provocation, consent, and other behavior of the victim which directly or indirectly contributed to his injury or death will be taken into account by the Board when making an award. No award will be made for loss of personal property.

VII. APPLICATION AND CLAIM PROCESSING PROCEDURES

All claims must be submitted on a Nebraska Crime Victim's Reparations Board claim form. The application form is a very simplified form that a claimant can easily understand and fill out. The staff is always available to assist claimants in the preparation of the application. The application must be notarized and this service is provided in the CVR office for claimants who bring in their application. The form includes individual data, incident information and an itemization of the amounts being claimed. Itemized bills must be presented. Payroll deduction slips or IRS return (if self employed) are required if the victim is asking for loss of wages. A signed authorization for hospitals, physicians, mortuary, law enforcement agency, etc. is required to enable the staff to investigate and verify the claims.

Upon receipt of the application for compensation, the claim is acknowledged and a law enforcement official's report is requested. The staff verifies all claims completely before the claim is presented to the Board for review and a decision. Verification and information is requested from hospitals, physicians, funeral directors, employers, welfare agencies, insurance companies, county and city attorneys, witnesses, etc. Only after a claim has been thoroughly investigated and authenticated is it turned over to the Board for its decision.

When all of the necessary investigations have been completed, the claim is presented to the Board for review and decision. Board decisions are made in compliance with the Act and, although the Board strives for uniformity in its decisions, each claim is considered on its own merit.

If the claim is approved, a Decision and Order is sent to the claimant. The claimant must sign and return the Consent included with the Decision and Order before a warrant will be issued. When a claim is denied, the claimant receives a Decision and Order stating the reason the award was disallowed.

VIII. EMERGENCY AWARDS

Emergency Awards may be made prior to the final decision of the Board if it appears that compensation for the claim is probable and that undue hardship will result to the applicant if immediate payment is not made. The amount of the emergency award is deducted from the final award at the time the final award is made. Up to \$500 may be requested. The decision of the Board on emergency awards is final.

In 1981, two Emergency Awards totalling \$541.98 were granted.

IX. HEARING OFFICERS

The Board may appoint a hearing officer, who must be licensed to practice law in the state, to conduct hearings.

The Crime Commission has a staff attorney who is available to conduct hearings for the Board. Hearing officers were contracted for 12 claims and the Commission's staff attorney was hearing officer for two claims. The Board held one hearing.

X. HEARINGS

The Board or a hearing officer may order a hearing on the application for compensation. The decision of the Board may be made with or without a hearing. If a decision unfavorable to the claimant is made by the Board without a hearing, the claimant may thereafter request a hearing within thirty (30) days after receipt of the written decision by the Board. Claimants have the right to be represented by counsel at the hearing.

Following the hearing, a Recommended Order is made by the hearing officer. The Board will then consider the Recommended Order at their next Board Meeting and make a decision. If the claimant is not satisfied with the Board's decision, an Appeal may be filed in the District Court.

There were 15 hearings held in 1981.

XI. APPEALS

All determinations, decisions and awards made by the Board may be appealed in the District Court of the county where the action of the Board was taken by filing a Petition with the District Court within thirty days after the service of the final decision by the Board.

There were eight claims filed in District Court in 1981. One claim (Calabretto) was heard and dismissed. The rest are pending.

We acknowledge and appreciate the cooperation and service given by the Nebraska Attorney General's office on appeal cases.

XII. ATTORNEYS

The claimant may be represented by an attorney. The Board may allow reasonable attorney fees not to exceed 5% of a compensation award.

Attorneys assisted 22 claimants in filing their claims. Eight attorneys were paid a total of \$1,587.71. Two claims were held over from 1980. \$500 is encumbered to be paid to one attorney in 1982. The other claims that had an attorney were either denied or are pending.

XIII. AWARDS

Awards totalled \$55,378 in 1981. Of this, \$15,508.35 was for 1980 claims.

There were 69 claims received in 1981. Compensation was awarded to 28 claimants, denied in 15 claims and 26 claims are pending. A number of pending claims are incomplete on the part of the claimant. Seven claims are on appeal in District Court and three claims have been assigned for hearings.

The maximum award of \$10,000 was awarded to two claims. The smallest claim awarded was \$31.80. Approximate average awarded in 1981 was \$1500.

SCRIPNOTE: Figures in this report are based on calendar year and not fiscal year.

XIV. ENCUMBRANCES

The Legislature appropriated \$50,000 for the victim compensation fund for fiscal year 1981-82. In November the Governor asked every state agency to reduce their budget by three percent, bringing our victim fund to \$48,500.

As in 1980, pending claims totalled more than the budgeted victim compensation fund and award payments were encumbered. As before, a \$300 limit was placed on the payment of claims with the exception of claims for loss of wages and out-of-pocket expenses. The remainder of the awards were deferred subject to 81-1814, availability of funds.

Encumbrances at the end of 1981 total \$13,206.14. A \$15,000 deficit request was made in December for FY 1981-82.

XV. RESTITUTION

Restitution was part of the sentence to one of the claimant's offender. Since the victim had been awarded compensation from this Board, the County Court is reimbursing the State this money as it is being paid by the offender. The Award was \$398.35 and the State has received \$30 of that amount.

On a volunteer basis, one offender reimbursed the State \$507.45 to cover the amount that was awarded to a claimant. This was not a court sentence restitution. The offender was sentenced to the Nebraska State Penitentiary for three to five years for his crime.

XVI. PUBLIC AWARENESS

The Board recognizes the continuous need to inform the public. Only a small percentage of the public is aware of the program. We continue to discharge our responsibilities to advise the public concerning the benefits available under the Statute. We consider this duty of informing and advising our citizenry to be an extremely important and continuing one.

Crime Victim's Reparations has been the subject of numerous newspaper stories, various radio stations have aired stories of the program to inform the public and KOLN-TV has had us appear on their "Sunday Report" twice to explain the program. Presentations to numerous groups explaining the program has also been a form of public awareness.

We wish to acknowledge thanks to all those who help in this endeavor to inform the public, but particularly the law enforcement agencies and Douglas County Victim-Witness program who send out letters and/or pass out our information cards to each possible victim of a crime.

BROCHURES -- A brief, easy-to-read brochure is available for public distribution. It explains the CVR program, who is or is not eligible, what compensation may be paid and how to request and file a claim. The brochure explains the provisions of the Act in general terms and is given or sent to every prospective claimant, along with an application form.

INFORMATION CARD -- "Benefits Available to Innocent Victims of Crime", are distributed to all law enforcement agencies for the investigating officer to distribute to the victim. Some agencies send a letter to the victim explaining the program and where to request information and application. County Attorney offices are asked to hand out the cards also.
