## Final Report on NIJ Grant 2001-RC-CX-0003 December 15, 2003

This grant funded \$482,710 in supplies to support the analysis of convicted offender samples in the state of Georgia. Through careful utilization of resources and efficient procedures, each sample analyzed with the core 13 STR loci by the GBI Division of Forensic Laboratory cost approximately \$24 not including labor and building overhead costs. During the time frame of this grant September 1, 2001 to August 31, 2003, a total of 48,446 offender samples were typed and the resulting data entered into CODIS. Based on the per sample cost estimate provided above, approximately 20,100 of these samples were analyzed using the funding from this grant. The remaining samples were analyzed using state funding.

During this same time period, 586 'no suspect' sexual assault cases were analyzed and entered into CODIS. The GBI crime laboratory currently has a policy of analyzing all 'no suspect' sexual assault kits which are submitted to the laboratory. In addition to the analysis of these samples, 307 CODIS matches were identified during the 2 year period of this grant. These included everything from forensic case to case associations to interstate case to offender matches.

This grant program has been an unqualified success. Without this grant funding to supplement limited state funding, it would not have been possible for the State of Georgia to participate in the CODIS program to the extent seen.
